

A-Engrossed House Bill 3265

Ordered by the House May 30

Sponsored by COMMITTEE ON REVENUE (at the request of Oregon Law Commission)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Revises public finance laws and procedures.
Appropriates moneys collected for bond services provided by State Treasurer to State Treasurer.

12 **Be It Enacted by the People of the State of Oregon:**

14 **STATE BONDS**

15
16 **SECTION 1. Sections 2 to 5, 7 to 11, 15 to 26 and 33 of this 2007 Act are added to and**
17 **made a part of ORS chapter 286.**

18
19 **(Definitions)**

20
21 **SECTION 2. As used in this chapter:**

22 **(1) "Agreement for exchange of interest rates" means a contract, or an option or forward**
23 **commitment to enter into a contract, for the exchange of interest rates that provides for:**

24 **(a) Payments based on levels of or changes in interest rates; or**

25 **(b) Provisions to hedge payment, rate, spread or similar exposure including, but not**
26 **limited to, an interest rate floor or cap or an option, put or call.**

27 **(2) "Bond":**

28 **(a) Means a contractual undertaking or instrument of the State of Oregon to repay bor-**
29 **rowed moneys.**

30 **(b) Does not mean a financing agreement, as defined in ORS 283.085, if the principal**
31 **amount of the agreement is \$100,000 or less, or a credit enhancement device.**

32 **(3) "Counterparty" means an entity with whom the State of Oregon enters into an**
33 **agreement for exchange of interest rates.**

34 **(4) "Credit enhancement device":**

35 **(a) Means a letter of credit, line of credit, standby bond purchase agreement, bond in-**
36 **surance policy, reserve surety bond or other device or facility used to enhance the**
37 **creditworthiness, liquidity or marketability of bonds or agreements for the exchange of in-**
38 **terest rates; and**

39 **(b) Does not mean a bond.**

40 **(5) "Credit enhancement device fee" means a payment required to be made to the pro-**
41 **vider of a credit enhancement device securing a bond or securing an agreement for the ex-**
42 **change of interest rates.**

43 **(6) "General obligation bond" means a bond that constitutes indebtedness of the state**
44 **under section 7, Article XI of the Oregon Constitution, and that is exempt from the \$50,000**
45 **limitation on indebtedness set forth in that section.**

1 (7) "Refunding bond" means a bond of the State of Oregon that is issued to refund an-
2 other bond, regardless of whether the refunding is on a current, advance, forward delivery,
3 synthetic or other basis.

4 (8) "Related agency" means the state agency that requests the State Treasurer to issue
5 bonds pursuant to section 7 of this 2007 Act or for which the State Treasurer has issued
6 bonds.

7 (9) "Related bond" means a bond for which the State of Oregon enters into an agreement
8 for exchange of interest rates.

9 (10) "Revenue" means all fees, tolls, excise taxes, assessments, property taxes and other
10 taxes, rates, charges, rentals and other income or receipts derived by a state agency or to
11 which a state agency is entitled.

12 (11) "Revenue bond" means a bond of the State of Oregon that is not a general obligation
13 bond.

14 (12) "State agency":

15 (a) Includes a statewide elected officer, board, commission, department, division, au-
16 thority or other entity, without regard to the designation given to the entity, that is within
17 state government, as defined in ORS 174.111; and

18 (b) Does not include:

19 (A) A statewide elected judge;

20 (B) The State Treasurer;

21 (C) A local government, as defined in ORS 174.116;

22 (D) The Oregon Health and Science University;

23 (E) A special government body, as defined in ORS 174.117, except to the extent a special
24 government body must be considered a state agency in order to achieve the purposes of Ar-
25 ticle XI-K of the Oregon Constitution; or

26 (F) A semi-independent state agency listed in ORS 182.451, 182.454, 377.835 or 674.305, or
27 any other state agency denominated by statute as a semi-independent state agency.

28 (13) "Termination payment" means the amount payable under an agreement for exchange
29 of interest rates by one party to another party as a result of the termination, in whole or
30 part, of the agreement prior to the expiration of the stated term.

31
32 (Duties of State Treasurer)
33

34 **SECTION 3.** (1) The State Treasurer shall issue and sign bonds of the State of Oregon.
35 The State Treasurer may sign a bond by manual or facsimile signature.

36 (2) Unless otherwise authorized by law other than this section, the State Treasurer may
37 issue bonds only if a related agency has requested that the bonds be issued.

38 (3) In determining whether to issue bonds, the State Treasurer shall consider:

39 (a) The bond market for the type of bonds proposed for issuance;

40 (b) The terms and conditions of the proposed issue; and

41 (c) Other relevant factors that the State Treasurer considers necessary to protect the
42 financial integrity of the State of Oregon.

43 (4) The State Treasurer may sell bonds for more than one related agency or for more
44 than one purpose in a single sale or in combination with the sale of other bonds.

45 (5) The State Treasurer is an applicable elected representative for the purpose of ap-

1 proving the issuance of bonds when approval is required under section 147(f) of the Internal
2 Revenue Code.

3 (6) The State Treasurer may adopt rules providing for the procedural or administrative
4 requirements for the issuance of obligations, as defined in section 17 of this 2007 Act.

5 **SECTION 4.** A related agency shall, at the direction of the State Treasurer, provide the
6 State Treasurer with:

7 (1) The information that the State Treasurer considers necessary to determine whether
8 to issue the requested bonds, including assumptions underlying cash flow projections asso-
9 ciated with the repayment of the bonds; and

10 (2) After the requested bonds are issued, the information that the State Treasurer con-
11 siders necessary to:

12 (a) Administer the bonds; and

13 (b) Comply with federal and state securities law and bond covenants.

14 **SECTION 5.** (1) The State Treasurer may charge a related agency for reasonable fees and
15 expenses in connection with the services, duties and activities of the State Treasurer related
16 to the borrowing activities of the State of Oregon, including but not limited to the issuance
17 and administration of obligations, as defined in section 17 of this 2007 Act.

18 (2) The State Treasurer may charge a public body, as defined in section 42 of this 2007
19 Act, reasonable fees and expenses in connection with:

20 (a) The services, duties and activities of the State Treasurer related to obligations, as
21 defined in section 50 of this 2007 Act, of the public body; or

22 (b) Providing assistance to the Oregon Municipal Debt Advisory Commission or to the
23 public body.

24 (3) The State Treasurer shall deposit all moneys received under this section in the Mis-
25 cellaneous Receipts Account established under ORS 286.025.

26 (4) The State Treasurer shall adopt rules to implement the provisions of this section in-
27 cluding, but not limited to, rules identifying the services, duties and activities for which
28 charges are to apply.

29 (5) A related agency or public body shall pay to the State Treasurer reasonable fees and
30 expenses charged under this section or under rules adopted pursuant to this section.

31 **SECTION 6.** Moneys received under section 5 of this 2007 Act are continuously appro-
32 priated to the State Treasurer for the payment of expenses of the State Treasurer in con-
33 nection with bonds of the State of Oregon or a public body as defined in section 42 of this
34 2007 Act.

35
36 (Authority for Borrowing)

37
38 **SECTION 7.** (1) The State Treasurer may, at the request of a related agency:

39 (a) Issue bonds when a law of the State of Oregon authorizes bonds to be issued; and

40 (b) Issue refunding bonds without additional authorization.

41 (2) In consultation with the related agency, the State Treasurer may:

42 (a) Sell bonds at a competitive sale or a negotiated sale or in any other manner deter-
43 mined by the State Treasurer;

44 (b) Issue bonds the interest of which is exempt from federal income taxation or is not
45 exempt from federal income taxation;

1 (c) Establish the principal amounts, redemption provisions, optional or mandatory tender
2 provisions, interest rates or methods for determining variable or adjustable interest rates,
3 denominations and other terms and conditions of the bonds;

4 (d) Establish maturity dates for bonds to provide for short-term, interim or long-term
5 borrowing;

6 (e) Determine the form and content of a bond offering or disclosure document;

7 (f) Structure, market and issue bonds in the manner that the State Treasurer determines
8 is in the best interest of the people of the State of Oregon; and

9 (g) Invest moneys held in connection with or derived from obligations, as defined in sec-
10 tion 17 of this 2007 Act, without regard to the fund or account to which the moneys are
11 credited under other provisions of law, alone or with other invested moneys. In addition, the
12 State Treasurer may:

13 (A) Establish funds and accounts separate and distinct from the General Fund in order
14 to invest the moneys as provided in ORS 293.701 to 293.820 and to arrange for redemption or
15 purchase of bonds; and

16 (B) Segregate or pool moneys in order to promote financial and administrative efficiency
17 and prudence in the management of moneys derived from obligations, as defined in section
18 17 of this 2007 Act, moneys available for bond repayment and other moneys, and in the ad-
19 ministration of bond programs.

20 (3) Subject to the approval of the State Treasurer, moneys described in subsection (2)(g)
21 of this section may be held by a trustee under a trust agreement, indenture, bond declaration
22 or similar instrument and may be invested by the trustee at the direction of the related
23 agency for which the moneys are held by the trustee. If consistent with the trust agreement,
24 indenture, bond declaration or similar instrument, a related agency may authorize a trustee
25 to invest on behalf of the agency in the investment funds or with other moneys invested by
26 the State Treasurer under ORS 293.701 to 293.820 and may authorize a transfer of the moneys
27 from the State Treasurer to the trustee.

28 (4) In addition to authority conferred by law other than this section, the State Treasurer
29 or, with the approval of the State Treasurer, a related agency may:

30 (a) Execute and deliver indentures, trust agreements, auction agent agreements,
31 broker-dealer agreements, tender agent agreements, bond declarations or similar instru-
32 ments and other contracts related to the sale, issuance or security of the bonds;

33 (b) Deposit funds with trustees for the benefit of bond owners and the providers of credit
34 enhancement devices; and

35 (c) Enter into covenants for the benefit of bond owners or the providers of credit en-
36 hancement devices.

37 (5) The covenants authorized by subsection (4)(c) of this section:

38 (a) May include, but are not limited to, covenants regarding the issuance of additional
39 bonds, the priority of payment of bonds and, if authorized by law other than this section, the
40 imposition and collection of rates, fees or other charges; and

41 (b) Are intended to:

42 (A) Improve the security of bond owners or providers of credit enhancement devices; or

43 (B) Maintain the tax-exempt status of interest payable on bonds.

44 (6) In addition to authority conferred by law other than this section, in consultation with
45 the related agency, the State Treasurer may establish a debt service reserve for the purpose

1 of paying when due the amounts owing on the bonds for which the debt service reserve is
2 established. The debt service reserve may be funded out of the proceeds derived from the
3 issuance and sale of the bonds for which the debt service reserve is being established or from
4 other lawfully available funds.

5 (7) In consultation with the related agency, the State Treasurer shall select the under-
6 writers for the sale of the bonds requested by the related agency. An agreement with the
7 underwriters may be executed by the State Treasurer alone or with the related agency. An
8 agreement with underwriters is not subject to the Public Contracting Code.

9 **SECTION 8.** (1) In addition to authority conferred by law other than this section, a re-
10 lated agency, with the approval of the State Treasurer, or the State Treasurer may:

11 (a) Enter into a credit enhancement device agreement in order to provide liquidity or
12 security for bonds or for an agreement for exchange of interest rates. The credit enhance-
13 ment device may be secured only by moneys that the State of Oregon may legally commit
14 to secure payment of the bonds that are secured by the credit enhancement device or related
15 to the agreement for exchange of interest rates.

16 (b) Obtain a credit enhancement device providing additional security for:

17 (A) The payment of all or a portion of amounts owing under bonds;

18 (B) The purpose of funding, in lieu of cash, all or a portion of a debt service reserve es-
19 tablished with respect to bonds; or

20 (C) The payment of amounts owing under an agreement for exchange of interest rates.

21 (2) The related agency, with the approval of the State Treasurer, or the State Treasurer
22 may pledge as security for the obligations of the State of Oregon arising under or with re-
23 spect to a credit enhancement device all or a portion of revenues pledged to the payment of
24 the bonds related to the credit enhancement device.

25 (3) The State Treasurer may issue a bond to the provider of a credit enhancement device
26 to secure the obligations of the State of Oregon to pay amounts due to the provider.

27
28 (Bond Budget Authorization)
29

30 **SECTION 9.** (1) Each related agency shall report the plans of the related agency for the
31 issuance of bonds during the next biennium. The related agency shall submit the related
32 agency's report to the Governor by a date determined by the Governor and shall include in
33 the report a description of bonds that the related agency intends to retire or defease during
34 the next biennium.

35 (2) On or before a date determined by the Governor, the State Treasurer shall advise the
36 Governor on the prudent maximum amount of bonds to be issued for each bond program.
37 The State Treasurer shall consider available economic and financial data in preparing advice
38 to be given to the Governor.

39 (3) As part of the Governor's budget report described in ORS 291.216, the Governor shall:

40 (a) Consider the prudent maximum amounts advised by the State Treasurer pursuant to
41 subsection (2) of this section to determine the Governor's total recommended amount; and

42 (b) Recommend to the Legislative Assembly the total amount of bonds the State Treas-
43 urer may issue for each bond program for a biennium.

44 (4) The Legislative Assembly shall determine the amount of bonds the State Treasurer
45 may issue for each state agency for a biennium. If the Legislative Assembly fails to make

1 the determination described in this subsection by the first day of the biennium, the unused
2 portion of the authorization the Legislative Assembly made for the preceding biennium is
3 deemed to carry forward for the current biennium at the amount authorized for the pre-
4 ceding biennium until the earlier of:

5 (a) The date on which legislation authorizing the amount of bonds for the current
6 biennium is enacted; or

7 (b) The date on which the Legislative Assembly adjourns sine die.

8 (5) The amount of bonds that may be issued under bond programs may be modified by
9 the Governor. However, the Governor may not modify the amount of bonds that may be is-
10 sued under bond programs in a way that would cause the maximum amount established by
11 the Legislative Assembly for a category of bond programs to be exceeded if the Legislative
12 Assembly:

13 (a) Has categorized the bonds that may be issued under bond programs as general obli-
14 gation, direct revenue and pass-through revenue bonds; and

15 (b) Assigned a maximum amount to each category.

16 (6) This section applies to bonds:

17 (a) Unless the bonds are expressly exempted from the requirements of this section.

18 (b) Except refunding bonds.

19
20 (Agreements for Exchange of Interest Rates)

21
22 **SECTION 10.** (1) A related agency with the approval of the State Treasurer, or the State
23 Treasurer on behalf of a related agency, may enter into agreements for exchange of interest
24 rates with counterparties. Agreements for exchange of interest rates may be made to man-
25 age payment, interest rate, spread or similar exposure undertaken in connection with a re-
26 lated bond upon a determination by the related agency, or by the State Treasurer on behalf
27 of the related agency, that the agreement benefits the State of Oregon.

28 (2) Subject to covenants applicable to a related bond and the limitations of this section,
29 payments required under an agreement for the exchange of interest rates by the related
30 agency, or the State Treasurer on behalf of the related agency, may:

31 (a) Be treated as interest payments on the related bond;

32 (b) Be made from revenues or other moneys that are pledged or otherwise committed to
33 pay the related bond; and

34 (c) Rank in an order of priority of payment relative to the payment of the related bond
35 as the related agency, or the State Treasurer on behalf of the related agency, determines.

36 (3) In connection with entering into an agreement under this section, a related agency,
37 or the State Treasurer on behalf of the related agency, may enter into a credit enhancement
38 device for an agreement for exchange of interest rates.

39 (4) An agreement for exchange of interest rates is subject only to the limitations of this
40 section and is not subject to a limitation applicable to the related bond.

41 (5) With the approval of the State Treasurer, a related agency may use moneys derived
42 from the issuance and sale of bonds to pay termination payments due under an agreement
43 entered into under this section.

44 (6) A related agency, with the approval of the State Treasurer, may:

45 (a) Create reserves to pay amounts due under an agreement for exchange of interest

1 rates; and

2 (b) Fund the reserves with moneys derived from the issuance and sale of bonds or from
3 revenues or other moneys described in subsection (2)(b) of this section.

4
5 (Tax Anticipation Bonds)
6

7 **SECTION 11.** (1) The State Treasurer may issue bonds to finance all or a portion of the
8 current expenses of this state. The amount of bonds issued under this section at any time
9 may not exceed the State Treasurer's estimate of the cash flow deficit in revenues available
10 to pay the expenses that are financed with the bonds, plus amounts for reasonable reserves
11 and costs.

12 (2) To estimate the amount of cash flow deficit, the State Treasurer shall take into ac-
13 count the most recent cash flow forecast made by the Oregon Department of Administrative
14 Services and any other information the State Treasurer determines is reliable and relevant.

15 (3) When the State Treasurer issues bonds under this section:

16 (a) The Oregon Department of Administrative Services shall account for and administer
17 the proceeds of the bonds and the repayment of the bonds. The State Treasurer, in consul-
18 tation with the Oregon Department of Administrative Services, shall determine the appro-
19 priate investment strategy for the proceeds of the bonds. The State Treasurer shall notify
20 the Director of the Oregon Department of Administrative Services, the Legislative Fiscal
21 Officer and the Legislative Revenue Officer before issuing bonds under this section.

22 (b) The State Treasurer may pledge:

23 (A) All or a portion of the revenues of the State of Oregon to pay bonds issued under this
24 section.

25 (B) The full faith and credit of the State of Oregon to pay bonds issued under this section
26 if the bonds are payable from the Short Term Borrowing Account established under ORS
27 293.175 and the bonds mature not later than the end of the biennium in which the bonds are
28 issued.

29 (c) A state agency may use the proceeds of bonds issued under this section:

30 (A) For a purpose for which the revenues that are pledged to pay the bonds may be used;

31 (B) To pay principal, interest and premium, if any, on the bonds or a rebate or penalty
32 due to the United States in connection with the bonds;

33 (C) To pay the cost of credit enhancement devices with respect to the bonds;

34 (D) To pay the costs of the State Treasurer and the Oregon Department of Administra-
35 tive Services of issuing, administering or maintaining the bonds including, but not limited
36 to, the cost of a consultant or adviser retained by the State Treasurer or the Oregon De-
37 partment of Administrative Services; or

38 (E) To make payments with respect to agreements for the exchange of interest rates.

39 (4) This section constitutes complete authority for the State Treasurer to issue bonds
40 described in this section.

41 (5) Section 9 of this 2007 Act does not apply to bonds authorized by this section.

42 (6) The requirements and limitations that apply to certificates of indebtedness issued
43 under ORS 293.165 do not apply to bonds issued by the State Treasurer under this section.

44 (7) This section and ORS 293.175 constitute complete authorization by the Legislative
45 Assembly for the use and expenditure of the proceeds of the bonds and the revenues pledged

1 to pay those bonds for the purposes described in subsection (3)(c) of this section. Additional
2 appropriation or authorization is not necessary. The authorization contained in this section
3 and ORS 293.175 to spend moneys for the purposes described in subsection (3)(c) of this sec-
4 tion does not constitute an appropriation for purposes of ORS 291.357.

5 (8) The proceeds of bonds issued by the State Treasurer under this section do not con-
6 stitute revenues received by the General Fund for purposes of section 14, Article IX of the
7 Oregon Constitution, and ORS 291.349.

8 (9) The State Treasurer may perform the duties and exercise the powers of a related
9 agency under this section.

10 **SECTION 12.** ORS 293.175 and 293.177 are added to and made a part of ORS chapter 286.

13 (2) The State Treasurer shall credit the proceeds of [*obligations*] **bonds** issued by the State

24 *for the use and expenditure of the proceeds of the obligations and the taxes and revenues pledged to*
25 *pay those obligations for the purposes described in ORS 293.173 (3)(c). No additional appropriation or*
26 *authorization is necessary. The authorization contained in this section and ORS 293.173 to spend*
27 *moneys for the purposes described in ORS 293.173 (3)(c) does not constitute an appropriation for pur-*
28 *poses of ORS 291.357. The proceeds of obligations issued by the State Treasurer under ORS 288.165*
29 *do not constitute revenues received by the General Fund for purposes of section 14, Article IX of the*
30 *Oregon Constitution, and ORS 291.349.*]

31 **SECTION 14.** ORS 293.177 is amended to read:

32 293.177. Within 90 days following the end of a biennium, the State Treasurer shall report in
33 writing to the Legislative Fiscal Officer and the Legislative Revenue Officer on the amount of [*ob-*
34 *ligations*] **bonds** issued by the State Treasurer under [*ORS 288.165*] **section 11 of this 2007 Act**, the
35 amount spent in repayment of those [*obligations*] **bonds**, the issuance costs and interest costs of

39 (Debt Limit Calculation)

41 **SECTION 15.** (1) When calculating compliance with a constitutional or statutory debt
42 limit:

43 (a) If a bond is issued to a provider of a credit enhancement device for a bond that is
44 subject to a debt limit, the bond issued to the provider must be taken into account only to
45 the extent that the amount of the bond issued to the provider exceeds the amount of the

1 bond that is secured by the credit enhancement device.

2 (b) The amount of interest to be paid on bonds, whether paid currently or deferred, is
3 not taken into account.

4 (c) For a zero coupon bond or other original issue discount bond on which periodic in-
5 terest payments are not made, only the accreted value of the bond on the date the bond is
6 issued is taken into account.

7 (d) The state may deduct from the amount of outstanding bonds:

8 (A) The amount of moneys and investments held by the state or a trustee of the state
9 to pay bonds that have not been defeased; and

10 (B) The principal amount of bonds that have been defeased.

11 (2) For purposes of this section, a bond is defeased if:

12 (a) The state has set aside in an irrevocable escrow government obligations, as defined
13 in section 57 of this 2007 Act, the receipts from which have been calculated by a certified
14 public accountant or other experienced professional to be sufficient, without reinvestment,
15 to pay the principal, interest and premium, if any, due on the bond at maturity or on prior
16 redemption; or

17 (b) The state has complied with the provisions in the documents authorizing the bond
18 that provide for the payment or defeasance of the bond.

21 (Payment of Bonds: Pledges, Liens and Collateral)

22
23 SECTION 17. As used in this section and section 18 of this 2007 Act:

24 (1) "Obligation" means:

25 (a) A bond;

26 (b) An agreement for exchange of interest rates with the State of Oregon; or

27 (c) A credit enhancement device given as additional security for a bond.

28 (2) "Operative document" means a bond declaration, trust agreement, indenture, security
29 agreement or other document in which the State of Oregon pledges property as security for
30 an obligation.

31 (3) "Pledge" means:

32 (a) To create a security interest in or a lien on property to secure payment or perform-
33 ance of an obligation, by mortgaging, assigning or encumbering property or by creating a
34 security interest in property by any other manner.

35 (b) A security interest in or lien on property created under paragraph (a) of this sub-
36 section.

37 (4) "Pledgee" means:

38 (a) A trustee for the holder of an obligation; or

39 (b) The holder of an obligation if a trustee was not appointed in the operative document
40 or if the operative document authorizes the holder of an obligation to foreclose the lien of
41 a pledge and enforce the remedies consequent to the pledge in lieu of the trustee.

42 (5) "Property" means:

43 (a) Real or personal property, tangible or intangible, whether owned when the pledge is
44 made or acquired subsequently to the time the pledge is made; and

45 (b) Revenues, contract rights, receivables or securities.

1 **SECTION 18.** (1) The Uniform Commercial Code does not apply to the creation, per-
2 fection, priority or enforcement of a lien of a pledge made by a state agency or the State
3 Treasurer.

4 (2) When authorized by law to secure obligations with property of the State of Oregon,
5 a state agency, or the State Treasurer acting under the State Treasurer's own authority or
6 on behalf of a state agency with the approval of the state agency, may pledge all or a portion
7 of the property as security for payment of the obligations and for performance of a covenant
8 or agreement entered into in relation to the issuance of the obligations.

9 (3) The lien created by a pledge described in subsection (2) of this section is valid and
10 binding from the time the pledge is made. Pledged property is subject immediately to the lien
11 of the pledge without physical delivery, filing or any other act.

12 (4) Except as otherwise expressly provided in an operative document, the lien of the
13 pledge is superior to and has priority over all other claims and liens of any kind.

14 (5) When property subject to a pledge is acquired by the State of Oregon after the pledge
15 is made:

16 (a) The property is subject to the lien upon acquisition by the State of Oregon without
17 physical delivery, filing or any other act; and

18 (b) The lien relates back to the time the pledge was originally made.

19 (6)(a) The State Treasurer, or the related agency, may reserve the right to pledge prop-
20 erty as security for a subsequently issued obligation.

21 (b) If the State Treasurer or related agency reserves the right described in paragraph (a)
22 of this subsection, subject to the terms of the operative document that created the previous
23 pledge, the lien of the subsequent pledge may be on a parity or pari passu basis with the lien
24 of the previous pledge, on a prior and superior basis with the lien of the previous pledge or
25 on a subordinate basis with the lien of the previous pledge, as specified in the operative
26 document creating the subsequent pledge. The lien of the subsequent pledge:

27 (A) Has the priority specified in the operative document creating the subsequent pledge;
28 and

29 (B) Is superior to and has priority over other claims and liens of any kind except the lien
30 of a pledge with which the lien of the subsequent pledge is on a parity or subordinate basis,
31 as specified in the operative document.

32 (7) Except as provided in subsection (8) of this section, a pledgee may commence an
33 action in a court of competent jurisdiction to foreclose the lien of the pledge and exercise
34 rights and remedies available to the pledgee under the operative document.

35 (8) When pledged property is in a fund for debt service reserves or payments, a pledgee
36 may foreclose the lien of the pledge by applying the property to the payment of obligations
37 subject to the terms, conditions and limitations in the operative document.

38 (9) An initiative or referendum measure approved by the electors of the State of Oregon
39 that purports to change statutory provisions affecting rates, fees, tolls, rentals or other
40 charges may not be given any force or effect if to do so would impair existing covenants
41 made with holders of existing obligations regarding the imposition, levy or collection of the
42 rates, fees, tolls, rentals or other charges pledged to secure outstanding obligations.

43 (10) If authorized by law other than this section to set rates, fees or other charges that
44 are pledged to pay obligations, a state agency may enter into rate covenants. Rate covenants
45 authorized by this subsection may obligate a state agency to periodically set the rates and

1 **charges:**

2 (a) That generate pledged revenues at specific levels including, but not limited to, a spe-
3 cific monetary charge for each unit of commodity or service provided or a schedule of rates
4 and charges that includes fixed and variable components;

5 (b) At levels sufficient to maintain underlying credit ratings assigned to obligations by
6 one or more nationally recognized credit rating services without regard to any improvement
7 in credit ratings due to the provision of additional security for the obligations by a credit
8 enhancement device;

9 (c) That generate pledged revenues each year in amounts at least equal to operations and
10 maintenance expenses of the state agency that produces the pledged revenues, plus debt
11 service on obligations, plus an additional amount that is reasonably required to obtain fa-
12 vorable terms for the obligations; or

13 (d) In accordance with a formula established in the operative document governing obli-
14 gations. The formula may provide for rates to be determined by reference to factors includ-
15 ing, but not limited to:

16 (A) Historical operating expenses;

17 (B) Projected future operating expenses;

18 (C) The funding of depreciation;

19 (D) The costs of capital improvements;

20 (E) The costs of complying with contractual requirements and covenants;

21 (F) The costs of complying with regulatory requirements;

22 (G) Reports of independent consultants regarding the required level of pledged revenues;

23 (H) Debt service on the obligations; and

24 (I) The funds needed to establish or maintain reserves required by law or contract and
25 the funds needed to maintain an unencumbered carryforward fund balance or working capital
26 to meet unanticipated expenses or fluctuations in revenues that may arise.

27 (11) A rate covenant authorized by this section is a contract that binds the State of
28 Oregon and is enforceable against the State of Oregon in accordance with the terms of the
29 rate covenant.

30 (12) The State Treasurer, or a related agency with the approval of the State Treasurer,
31 may pledge the full faith and credit of the State of Oregon as security for the payment of
32 general obligation bonds. A pledge of the full faith and credit authorized by this subsection
33 does not, by itself, create a lien on the revenues or property of the state.

36 (Administration of Bond Programs)

37
38 SECTION 20. (1) The State Treasurer or a related agency may enter into one or more
39 agreements for bond counsel services for a period of not less than one year during any
40 biennium in which there are bonds outstanding that were issued for the state agency or
41 during any biennium in which the state agency expects the State Treasurer to issue bonds
42 for an agency program. A state agency may not enter into an agreement for bond counsel
43 services unless the State Treasurer and the Attorney General have reviewed and approved
44 the terms and conditions of the agreement. Before approving an agreement, the State
45 Treasurer shall consider the reputation, experience and credentials of the bond counsel, in-

1 **cluding the individuals expected to actually fulfill the contract work.**

2 **(2) Except as provided in subsection (3) of this section, the appointment of bond counsel**
3 **may not be construed as authorizing bond counsel to advise or represent the state on mat-**
4 **ters that are committed by statute to the Attorney General.**

5 **(3) The services provided under a bond counsel agreement may include:**

6 **(a) Advising a state agency or the State Treasurer concerning the legality of specific**
7 **proposed taxable or tax-exempt bonds and the compliance of obligations with applicable law,**
8 **including but not limited to federal securities and tax laws;**

9 **(b) Issuing opinions to a state agency, the State Treasurer or other parties concerning**
10 **the enforceability of, authority for and tax status of bonds, agreements for exchange of in-**
11 **terest rates, credit enhancement devices or similar associated documents and on the lawful**
12 **use of the proceeds of the bonds, as may be required by the demands of the marketplace for**
13 **the bonds;**

14 **(c) Advising a state agency or the State Treasurer on legal procedures and practices in**
15 **the bond marketplace, including advice on the structuring and sale of bonds;**

16 **(d) Preparing or assisting in the preparation of documents related to a specific issue of**
17 **bonds, including but not limited to an authorizing resolution or declaration, a trust**
18 **indenture, a prospectus, a preliminary official statement, an official statement, a bond sale**
19 **notice, a bond form, a bid form, a bond purchase agreement, an agreement for exchange of**
20 **interest rates, a credit enhancement device or a similar document necessary or desirable to**
21 **sell bonds;**

22 **(e) Advising a state agency or the State Treasurer concerning the maintenance of the**
23 **tax status of specific bonds, compliance with any requirements for representations or dis-**
24 **losures relating to the bonds, compliance with any documents executed as part of the is-**
25 **suance of the bonds and federal laws related to bond programs that may be available to a**
26 **state agency;**

27 **(f) Advising a state agency or the State Treasurer concerning accounting, investment or**
28 **administrative procedures recommended or required for compliance with federal or state**
29 **securities or tax or rebate requirements relating to bonds that were issued for the agency**
30 **or that the agency expects to issue; and**

31 **(g) Advising and assisting a state agency or the State Treasurer in responding to an in-**
32 **quiry received from or an audit by a federal or state regulatory body concerning:**

33 **(A) The tax status of interest paid on the bonds;**

34 **(B) The marketing of the bonds;**

35 **(C) Requirements of federal law related to the use of bond proceeds or the program for**
36 **which the bonds were issued; or**

37 **(D) Other matters within the jurisdiction of the federal or state regulatory body relating**
38 **to bonds that were issued by the state agency.**

39 **(4) In addition to entering into an agreement described in subsection (3) of this section,**
40 **the State Treasurer or a related agency may appoint bond counsel by letter, certificate or**
41 **otherwise, to provide the services described in subsection (3) of this section for an individual**
42 **conduit revenue bond sale.**

43 **(5) The State Treasurer or, with the approval of the State Treasurer, a related agency**
44 **may enter into an agreement with and retain the services of one or more providers of fi-**
45 **nancial advisory services. When considering whether to enter into or approve an agreement**

1 with a provider of financial advisory services, before approving the agreement, the State
2 Treasurer shall consider the reputation, experience and credentials of the adviser, including
3 the individuals expected to actually fulfill the contract work.

4 (6) Except for the expenses of bond counsel services provided under subsection (4) of this
5 section for conduit revenue bond sales, the related agency shall pay the expenses of any
6 agreements entered into under this section and may use bond proceeds to pay those ex-
7 penses.

8 (7) The Public Contracting Code does not apply to agreements entered into under this
9 section.

10 **SECTION 21.** (1) In addition to authority conferred by law other than this section, the
11 State Treasurer or, with the approval of the State Treasurer, a related agency may enter
12 into an agreement with and retain the services of one or more:

13 (a) Providers of investment advisory services or advisory services related to agreements
14 for exchange of interest rates;

15 (b) Providers of banking services;

16 (c) Escrow agents;

17 (d) Providers of fiscal or paying agent services;

18 (e) Collateral custodians;

19 (f) Providers of investment contracts;

20 (g) Remarketing agents; or

21 (h) Other bond-related or credit enhancement device-related agents or service profes-
22 sionals, or other persons with relevant expertise, to assist the State Treasurer or the related
23 agency in the performance of the duties of the State Treasurer or the related agency under
24 this chapter.

25 (2) The related agency shall pay the expenses incurred in providing the services described
26 in this section unless the related agency requires a recipient of bond sale proceeds to pay the
27 expenses.

28 (3) The Public Contracting Code does not apply to an agreement entered into under this
29 section.

30 (4) When the Oregon Constitution or a law of this state authorizes bond proceeds to be
31 spent for a particular purpose, the authorization also includes authorization to spend bond
32 proceeds for bond counsel, attorney, consultant, fiscal or paying agent, trustee or other
33 professional fees and other expenses incurred by the related agency or the State Treasurer
34 to authorize, issue, administer and repay the bonds, including fees payable to the State
35 Treasurer.

36
37 (State Taxation of Bond Interest)

38
39 **SECTION 22.** Interest on all bonds of the State of Oregon is exempt from personal in-
40 come tax under ORS chapter 316.

41
42 (Federal Taxation of Bond Interest)

43
44 **SECTION 23.** The State Treasurer or a related agency may enter into covenants for the
45 benefit of owners of bonds that are intended to allow the bonds to bear interest that is

1 **excludable from gross income under the federal Internal Revenue Code or that is otherwise**
2 **exempt from taxation by the United States. The State Treasurer or a related agency may**
3 **adopt rules or procedures that are intended to facilitate compliance with those covenants,**
4 **and may take any action that is required to comply with those covenants. Covenants au-**
5 **thorized by this section include, but are not limited to, covenants to:**

6 (1) **Pay any rebates of earnings or penalties to the United States;**

7 (2) **Invest proceeds alone or in combination with other moneys in investments that have**
8 **different maturities, yields or credit qualities than the state would acquire under the in-**
9 **vestment standards specified in ORS 293.721 and 293.726 and other similar laws, but only if**
10 **those investments facilitate compliance with covenants described in this section; or**

11 (3) **Restrict the expenditure of bond proceeds or restrict the operation of, or otherwise**
12 **limit the use of, facilities that are financed with bonds.**

14 **(Remitting Funds)**
15

16 **SECTION 24. (1) The State Treasurer may adopt rules, or establish by contract or policy,**
17 **procedures and requirements for the cancellation, purchase or redemption of bonds, the re-**
18 **mittance of funds to pay bonds, or the replacement of lost or destroyed evidence of bonds**
19 **or interest coupons.**

20 (2) **If the State Treasurer decides:**

21 (a) **To replace lost or destroyed evidence of bonds or coupons, or to make payment in lieu**
22 **of replacement, the State Treasurer may require indemnity, deposit or other form of assur-**
23 **ance or proof of ownership to ensure against conflicting, duplicative or fraudulent claims.**
24 **The State Treasurer may charge a fee to the person seeking replacement or payment in lieu**
25 **of replacement under this section, in an amount sufficient to reimburse the State Treasurer**
26 **for costs incurred in providing replacement or payment under this subsection.**

27 (b) **Not to replace or make payment with respect to a lost or destroyed bond or coupon,**
28 **the person seeking replacement or payment under this section may appeal the determination**
29 **as a review of an order other than a contested case under ORS 183.484.**

31 **(Public Records)**
32

33 **SECTION 25. The records of bond ownership are not public records for purposes of ORS**
34 **192.410 to 192.505 or other law governing the disclosure of information.**

35
36 **(Secretary of State Audits)**
37

38 **SECTION 26. (1) The Secretary of State shall conduct a financial audit of the bond pro-**
39 **grams of each state agency at least annually. The Secretary of State shall publish the audit**
40 **as soon as possible following the end of the audit period.**

41 (2) **The Oregon Department of Administrative Services may, on an annual basis, exempt**
42 **a bond program from the requirements of subsection (1) of this section.**

44 **(State Debt Policy Advisory Commission)**

SECTION 27. ORS 286.555 is amended to read:

286.555. The State Debt Policy Advisory Commission shall advise the Governor and the Legislative Assembly regarding policies and actions that enhance and preserve the state's credit rating and maintain the future availability of low-cost capital financing. In carrying out this function, the commission shall **at least annually prepare a report showing the consolidated bond profile of this state. The report must include:**

(1) The total amount of outstanding bonds for the most recently concluded fiscal year.

[(1)] (2) [Develop] A six-year forecast of [debt] the state's borrowing capacity targets by [debt type and] repayment source based on the policies and actions established under this section.

[(2) Convert debt capacity targets to net available capacity estimates by reflecting amounts of capacity currently issued, the planned issuance of prior authorized debt and estimates of debt repayment.]

[(3) Report findings, including net debt capacity, and recommendations to the Governor and to the Legislative Assembly by April 1 of each even-numbered year.]

(3) A calculation of the state's net remaining borrowing capacity by repayment source.

(Private Activity Bond Committee)

SECTION 28. ORS 286.605 is amended to read:

286.605. As used in ORS 286.605 to 286.645:

(1) "Issuer" means an entity that may issue private activity bonds that are qualified bonds on which the interest is exempt from federal taxation.

(2) "Private activity bonds" has the meaning given in section 141 of the Internal Revenue Code *[of 1986]*.

SECTION 29. ORS 286.615 is amended to read:

286.615. (1) The Private Activity Bond Committee is established. It shall consist of **the State Treasurer or the designee of the State Treasurer**, one representative *[each]* from the Oregon Department of Administrative Services and *[from the State Treasurer and]* one public representative appointed to serve at the pleasure of the Governor.

(2) The *[representative from the department]* **State Treasurer, or the State Treasurer's designee**, shall serve as chair of the committee.

(3) The purpose of private activity bonding in this state *[shall be]* **is** to maximize the economic benefits of *[such]* **private activity** bonding to the citizens of this state. *[To this end,]* The committee shall adopt by rule standards for amounts *[allotted to it]* **allocated to the committee** for further allocation for economic development, housing, education, redevelopment, public works, energy, waste management, waste and recycling collection, transportation and other activities *[which]* **that** the committee determines will benefit the citizens of this state. In developing standards, the committee shall:

(a) Survey the expected need for private activity bond allocations at least once each year;

(b) Develop strategies for reserving and allocating the limit *[which]* **that** are designed to maximize the availability of tax exempt financing among competing sectors of the Oregon economy; and

(c) Ensure that *[such]* **the** standards include but are not limited to **standards that:**

(A) Support projects that increase the number of family wage jobs in this state.

(B) Promote economic recovery in small cities heavily dependent on a single industry.

(C) Emphasize development in underdeveloped rural areas of this state.

1 (D) Utilize educational resources available at institutions of higher education.

2 (E) Support development of the state's small businesses, especially businesses owned by women
3 and members of minority groups.

4 (F) Encourage use of Oregon's human and natural resources in endeavors *[which]* **that** harness
5 Oregon's economic comparative advantages.

6 *[(G) Limit assistance to projects that assist businesses selling goods and services in markets for
7 which national or international competition exists.]*

8 (4) The state private activity bond *[limit allotted]* **volume cap allocated** to the Private Activity
9 Bond Committee as provided in *[ORS 286.635]* **section 31 of this 2007 Act** shall be allocated and
10 reallocated among issuers by the Private Activity Bond Committee as follows:

11 (a) Any amounts not reserved to an issuer or a class of issuers under the *[limitation]* **authori-**
12 **zation adopted by the Legislative Assembly** under *[ORS 286.525]* **section 9 of this 2007 Act** shall
13 be allocated or reallocated by the committee under rules adopted under subsection (3) of this sec-
14 tion.

15 (b) Any amounts provided for in the *[limitation under ORS 286.525]* **authorization adopted by**
16 **the Legislative Assembly under section 9 of this 2007 Act** that are unused shall be carried for-

9 (d) Rebates or penalties due to the United States in connection with lottery bonds; and

10 (e) Any other costs or expenses that the State Treasurer or the Director of the Oregon De-
11 partment of Administrative Services determines are necessary or desirable in connection with issu-
12 ing lottery bonds or maintaining the lottery bond program.

13 (3) "Lottery bonds" means:

14 (a) The state park lottery bonds authorized by ORS 390.060 to 390.067, the infrastructure lottery
15 bonds authorized by ORS 285B.530 to 285B.548 and the education lottery bonds authorized by ORS
16 327.700 to 327.711;

17 (b) Any other bonds payable from the revenues of the Oregon State Lottery unless the legis-
18 lation authorizing those bonds expressly provides that those bonds [*shall*] **may** not be issued under
19 ORS 286.560 to 286.580 [*and 348.716*]; and

20 (c) Any refunding lottery bonds.

21 (4) "Lottery Bond Administrative Fund" means the fund created by ORS 286.573.

22 (5) "Lottery Bond Fund" means the fund created by ORS 286.570.

23 (6) "Lottery bond program" means a financing program authorized by:

24 (a) ORS 285B.530 to 285B.548, 327.700 to 327.711 or 390.060 to 390.067; or

25 (b) Any other Act of the Legislative Assembly authorizing the issuance of bonds that are paya-
26 ble from the revenues of the Oregon State Lottery, unless the legislation authorizing those bonds
27 expressly provides that those bonds [*shall*] **may** not be issued under ORS 286.560 to 286.580 [*and*
28 *348.716*].

29 (7) "Refunding lottery bonds" means any bonds issued for the purpose of refunding any lottery
30 bonds.

31 (8) "Unobligated net lottery proceeds" means all revenues derived from the operation of the
32 Oregon State Lottery except for:

33 (a) The revenues used for the payment of prizes and expenses of the Oregon State Lottery as
34 provided in section 4 (4)(d), Article XV of the Oregon Constitution, and ORS 461.500 and 461.510;

35 (b) The revenues required to be applied, distributed or allocated as provided in ORS 461.543; and

36 (c) The revenues required to be allocated to pay the Westside lottery bonds and any bonds is-
37 sued to refund the Westside lottery bonds, to fund reserves for any of those bonds and to pay related
38 costs of the Department of Transportation.

39 (9) "Westside lottery bonds" means the bonds issued by this state under the authority granted
40 in ORS 391.140 that, notwithstanding ORS 267.334, 285B.419, 285B.422, 285B.482, 285B.530 to
41 285B.548, 286.560 to 286.580, 327.700 to 327.711[, *348.716*] and 390.060 to 390.067, shall have a claim
42 on lottery funds that is superior to the claim of the lottery bonds authorized by ORS 286.560 to
43 286.580 [*and 348.716*].

44 **SECTION 36.** ORS 286.563 is amended to read:

45 286.563. (1) The Legislative Assembly declares that the purpose of ORS 286.560 to 286.580 [*and*

1 348.716] is to combine previously enacted legislation authorizing lottery bonds into a single Act that
 2 provides uniform administrative procedures for all lottery bonds issued by the State of Oregon.

3 (2) The lottery bonds issued under ORS 286.560 to 286.580 [and 348.716] shall be special obli-
 4 gations of the State of Oregon that are payable solely from unobligated net lottery proceeds,
 5 amounts available in the Lottery Bond Fund and in any reserve accounts established for lottery
 6 bonds under ORS 286.560 to 286.580 [and 348.716] and any appropriated funds. The faith and credit
 7 of the State of Oregon or any of its taxing power shall not be pledged or committed to the payment

10 **SECTION 37.** ORS 286.566 is amended to read:

11 286.566. (1) Any legislation authorizing issuance of lottery bonds under ORS 286.560 to 286.580
 12 [and 348.716] shall:

- 13 (a) State the purposes for which the proceeds of lottery bonds may be spent;
- 14 (b) Contain findings that those uses are lawful uses of lottery revenues;
- 15 (c) Indicate the amount of lottery bonds that may be issued under the legislation;
- 16 (d) Specify the fund into which the net proceeds of those lottery bonds shall be deposited; and
- 17 (e) Provide for the payment of the bond-related costs for the lottery bonds.

18 (2) Unless specifically prohibited by the legislation authorizing lottery bonds:

19 (a) Any agency or other entity holding net proceeds of lottery bonds shall, upon the written
 20 request of the Director of the Oregon Department of Administrative Services, transfer to the Oregon
 21 Department of Administrative Services for deposit in the Lottery Bond Administrative Fund the

24 (b) The agencies or other entities receiving proceeds of lottery bonds shall, if so directed by the
 25 Oregon Department of Administrative Services, take any action specified by the Oregon Department
 26 of Administrative Services that is necessary to maintain the excludability of lottery bond interest
 27 from gross income under the Internal Revenue Code.

28 **SECTION 38.** ORS 286.580 is amended to read:

29 286.580. (1) [In accordance with any applicable provisions of ORS chapters 286 and 288 and ORS
 30 286.560 to 286.580 and 348.716,] The State Treasurer, [with the concurrence] **at the request** of the
 31 Director of the Oregon Department of Administrative Services, may issue lottery bonds from time
 32 to time to finance any lottery bond program and to pay costs of issuing lottery bonds and adminis-
 33 tering the lottery bond program, and the State Treasury may be paid for all bond-related costs the
 34 State Treasury incurs.

35 (2) Lottery bond proceeds and unobligated net lottery proceeds may be used to pay bond-related
 36 costs.

37 (3) In addition to lottery bonds for any lottery bond program, the State Treasurer may, at the
 38 request of the affected agency or the Oregon Department of Administrative Services, issue one or
 39 more series of refunding lottery bonds. The refunding lottery bonds shall be structured so that the

2 (4) All lottery bonds issued under this section shall be payable from:

3 (a) The amount pledged for payment under subsection (7) of this section; and

4 (b) Any appropriated funds.

5 (5) The lottery bonds shall not be general obligations of this state and shall not be secured by
6 or payable from any funds or assets of this state other than the amounts pledged for payment or
7 security and any appropriated funds. The Legislative Assembly shall not be under any legal
8 compulsion or obligation to provide any appropriated funds and shall not be liable to any party for
9 any failure to provide appropriated funds. All lottery bonds issued under ORS 286.560 to 286.580
10 [and 348.716] shall contain a statement that this state is not obligated to pay lottery bond principal,
11 interest or premium thereon from any source other than the amounts pledged for payment and any

29 sembly or the Emergency Board shall not have any legal obligation to provide any appropriated
30 funds.

31 (7) Notwithstanding any other provision of law, the State Treasurer may pledge all or any por-

43 net lottery proceeds that is superior to, subordinate to, or on a parity with, the lien of the pledge
44 securing other series of lottery bonds. Nothing in this section shall be construed to limit the powers
45 granted in any other part of ORS 286.560 to 286.580 [and 348.716].

1 (8) Any covenants made under this section for the benefit of owners of lottery bonds shall con-
2 stitute contracts between the State of Oregon and the owners of lottery bonds. The State Treasurer,
3 or the Director of the Oregon Department of Administrative Services with the consent of the State
4 Treasurer, may, on behalf of the State of Oregon and in addition to the covenants authorized by
5 subsection (6) of this section, make the following covenants for the benefit of the owners of lottery
6 bonds and any providers of credit enhancement or instruments authorized by subsection (6) of this

8 (a) Except as permitted by a pledge made under subsection (7) of this section, this state shall
9 not create any lien or encumbrance on the unobligated net lottery proceeds that is superior to the
10 liens of the pledges authorized by subsection (7) of this section.

11 (b) Subject only to the availability of unobligated net lottery proceeds, the State of Oregon shall
12 budget and appropriate in each fiscal year an amount of unobligated net lottery proceeds that, when
13 added to other funds lawfully budgeted and appropriated and available for the purpose, will be suf-
14 ficient:

15 (A) To pay in full the principal, interest and premium due and to become due on all outstanding
16 lottery bonds in the fiscal year;

17 (B) To maintain the required balance in any reserves established for lottery bonds; and

19 authorized by subsection (6) of this section.

20 (c) This state shall apply the unobligated net lottery proceeds and any other amounts so budg-
21 eted and appropriated for those purposes.

22 (d) This state shall continue to operate the Oregon State Lottery until all lottery bonds are paid
23 or defeased.

24 (9) In connection with the issuance of any lottery bonds, the State Treasurer may establish such
25 accounts and subaccounts within the Lottery Bond Fund that the State Treasurer determines are
26 necessary or appropriate. In addition, the State Treasurer or the Director of the Oregon Department
27 of Administrative Services may, on behalf of this state, enter into any agreements that the State
28 Treasurer determines are necessary or appropriate to issue lottery bonds and carry out the pro-

38 **SECTION 39.** ORS 286.585 is amended to read:

39 286.585. (1) Pursuant to ORS 286.560 to 286.580 [and 348.716] and subject to future legislative
40 approval, lottery bonds may be issued to make grants or loans to Oregon cities to fund projects for
41 the reconstruction, renovation or development of community sports facilities in order to make the
42 facilities suitable for use by a major league baseball team if a city is selected as an expansion site
43 by major league baseball or if a major league baseball team agrees to relocate to a city.

44 (2) The use of lottery bond proceeds is authorized based on the following findings:

45 (a) The financial assistance to cities will assist in the construction, improvement and expansion

1 of infrastructure and community facilities that comprise the physical foundation for commercial ac-
2 tivity and provide the basic framework for continued and expanded economic opportunities and
3 quality communities throughout Oregon.

4 (b) Such financial assistance to cities will therefore promote economic development within this
5 state, and thus the use of net proceeds derived from the operation of the Oregon State Lottery to
6 pay debt service on lottery bonds issued under this section to provide such financial assistance to
7 cities is an appropriate use of state lottery funds under section 4, Article XV of the Oregon Con-
8 stitution, and ORS 461.510.

9 (3) Lottery bonds issued pursuant to this section shall be issued only at the request of the Di-
10 rector of the Economic and Community Development Department.

11 (4) The net proceeds of lottery bonds issued pursuant to this section shall be deposited in the
12 Economic Infrastructure Project Fund established by ORS 285B.551. The Director of the Economic
13 and Community Development Department shall allocate the moneys deposited in the Economic

20 **(State Bond Guarantee Intercept Program)**

22 **SECTION 40.** ORS 328.346 is amended to read:

23 328.346. (1)(a) If one or more payments on school bonds are made by the State Treasurer as
24 provided in ORS 328.341, the State Treasurer shall pursue recovery from the school district of all
25 moneys necessary to reimburse the state for all amounts paid by the treasurer to the paying agent,
26 as well as interest, penalties and any additional costs incurred by the treasurer as described in this
27 section. In seeking recovery, the State Treasurer may:

28 (A) Intercept any payments from the General Fund, the State School Fund, the income of the
29 Common School Fund and any other source of operating moneys provided by **or through** the state
30 to the school district that issued the school bonds that would otherwise be paid to the school district
31 by the state; and

32 (B) Apply any intercepted payments to reimburse the state for payments made pursuant to the
33 state guaranty until all obligations of the school district to the state arising from those payments,
34 including interest and penalties, and any additional costs incurred by the treasurer as described in
35 this section are paid in full.

36 (b) The state has no obligation to the school district or to any person or entity to replace any
37 moneys intercepted under authority of this section.

38 **(c) The authority of the State Treasurer to intercept payments under this subsection has**
39 **priority over all claims against money provided by the state to a school district, including a**
40 **claim that is based on a funds diversion agreement under ORS 238.698. A funds diversion**
41 **agreement under ORS 238.698 has priority over all other claims against money provided by**
42 **the state to a school district.**

43 (2) The school district that issued school bonds for which the state has made all or part of a
44 debt service payment shall:

45 (a) Reimburse all moneys drawn or paid by the State Treasurer on its behalf;

1 (b) Pay interest to the state on all moneys paid by the state from the date the moneys were
2 drawn to the date they are repaid at a rate to be determined by the State Treasurer, in the State
3 Treasurer's discretion, to be sufficient to cover the costs of funds to the state plus the costs of ad-
4 ministration of the state guaranty obligation and of collection of reimbursement; and

5 (c) Pay any applicable penalties as described in subsection (3) of this section.

6 (3)(a) The State Treasurer shall establish the reimbursement interest rate after considering the
7 circumstances of any prior draws by the school district on the state, market interest and penalty
8 rates and the cost of funds, if any, that were required to be used or borrowed by the state to make
9 payment on the school bonds. The State Treasurer shall have authority to establish, by negotiations
10 with the school district or otherwise, any plan of reimbursement by the school district that will re-
11 sult in full and complete reimbursement to the state. Subject to the requirement for full and com-
12 plete reimbursement, the State Treasurer may consider incorporating into the reimbursement plan
13 the means and methods to allow the school district to continue its operations during the time the
14 reimbursement plan is in effect.

15 (b) The State Treasurer may, after considering the circumstances giving rise to the failure of
16 the school district to make payment on its school bonds in a timely manner, impose on the school
17 district a penalty of not more than five percent of the amount paid by the state pursuant to the state
18 guaranty for each instance in which a payment by the state is made.

19 (4)(a) If the State Treasurer determines that amounts obtained under this section will not reim-
20 burse the state in full within the time determined by the State Treasurer or incorporated in the
21 reimbursement plan from the state's payment of a school district's debt service payment, the State
22 Treasurer shall pursue any legal action, including but not limited to mandamus, against the school
23 district or school district board to compel the school district to:

24 (A) Levy and provide property tax revenues to pay debt service on its school bonds and other
25 obligations when due; and

26 (B) Meet its repayment obligations to the state.

27 (b) With respect to any school bonds for which the State Treasurer has made payment under the
28 state guaranty, and in addition to any other rights or remedies available at law or in equity, the
29 state shall have the same substantive and procedural rights as would a holder of the school bonds
30 of a school district.

31 (c) The Attorney General shall assist the State Treasurer in the discharge of the duties under
32 this section.

33 (d) The school district shall pay the attorney fees, expenses and costs of the State Treasurer and
34 the Attorney General.

35 (5)(a) Except as provided in paragraph (c) of this subsection, any school district whose funds
36 were intercepted under this section may replace those funds from other school district moneys or
37 from ad valorem property taxes, subject to the limitations provided in this subsection.

38 (b) A school district may use ad valorem property taxes or other moneys to replace intercepted
39 funds only if the ad valorem property taxes or other moneys were derived from:

40 (A) Taxes originally levied to make the payment, but which were not timely received by the
41 school district;

42 (B) Taxes from a special levy imposed to make up the missed payment or to replace the inter-
43 cepted moneys;

44 (C) Moneys transferred from any lawfully available funds of the school district or the undis-
45 tributed reserves, if any, of the school district; or

1 (D) Any other source of moneys on hand and legally available.

2 (c) Notwithstanding paragraphs (a) and (b) of this subsection, a school district may not replace
3 operating funds intercepted by the state with moneys collected and held to make payments on school
4 bonds if that replacement would divert moneys from the payment of future debt service on the
5 school bonds and increase the risk that the state guaranty would be called upon a second time.

7 **LOCAL BONDS**

8
9 **SECTION 41.** Sections 42 to 59 and 64 to 70 of this 2007 Act are added to and made a part
10 of ORS chapter 287.

11
12 **(Definitions)**

13
14 **SECTION 42.** As used in this chapter:

15 (1) "Advance refunding bond" means a bond all or part of the proceeds of which are to
16 be used to pay an outstanding bond one year or more after the advance refunding bond is
17 issued.

18 (2) "Agreement for exchange of interest rates" means a contract, or an option or forward
19 commitment to enter into a contract, for an exchange of interest rates for related bonds
20 that provides for:

21 (a) Payments based on levels or changes in interest rates; or

22 (b) Provisions to hedge payment, rate, spread or similar exposure including, but not
23 limited to, an interest rate floor or cap or an option, put or call.

24 (3) "Bond":

25 (a) Means a contractual undertaking or instrument of a public body to repay borrowed
26 moneys.

27 (b) Does not mean a credit enhancement device.

28 (4) "Capital construction" has the meaning given that term in ORS 310.140.

29 (5) "Capital improvements" has the meaning given that term in ORS 310.140.

30 (6) "Credit enhancement device":

31 (a) Means a letter of credit, line of credit, standby bond purchase agreement, bond in-
32 surance policy, reserve surety bond or other device or facility used to enhance the
33 creditworthiness, liquidity or marketability of bonds or agreements for exchange of interest
34 rates.

35 (b) Does not mean a bond.

36 (7) "Current refunding bond" means a bond the proceeds of which are to be used to pay
37 an outstanding bond less than one year after the current refunding bond is issued.

38 (8) "Forward current refunding" means execution and delivery of a purchase agreement
39 or similar instrument under which a public body contracts to sell current refunding bonds
40 for delivery at a future date that is one year or more after execution of the purchase
41 agreement or similar instrument.

42 (9) "General obligation bond" means exempt bonded indebtedness, as defined in ORS
43 310.140, that is secured by a commitment to levy ad valorem taxes outside the limits of
44 sections 11 and 11b, Article XI of the Oregon Constitution.

45 (10) "Lawfully available funds" means revenues or other moneys of a public body includ-

1 ing, but not limited to, moneys credited to the general fund of the public body, revenues from
2 an ad valorem tax and revenues derived from other taxes levied by the public body that are
3 not dedicated, restricted or obligated by law or contract to an inconsistent expenditure or
4 use.

5 (11) "Operative document" means a bond declaration, trust agreement, indenture, secu-
6 rity agreement or other document in which a public body pledges revenue or property as
7 security for a bond.

8 (12) "Pledge" means:

9 (a) To create a lien on property pursuant to section 50 of this 2007 Act.

10 (b) A lien created on property pursuant to section 50 of this 2007 Act.

11 (13) "Public body" means:

12 (a) A county of this state;

13 (b) A city of this state;

14 (c) A local service district as defined in ORS 174.116 (2);

15 (d) A special government body as defined in ORS 174.117;

16 (e) Oregon Health and Science University; or

17 (f) Any other political subdivision of this state that is authorized by the Legislative As-
18 ssembly to issue bonds.

19 (14) "Refunding bond" means an advance refunding bond, a current refunding bond or a
20 forward current refunding bond.

21 (15) "Related bond" means a bond for which the public body enters into an agreement for
22 exchange of interest rates or obtains a credit enhancement device.

23 (16) "Revenue" means all fees, tolls, excise taxes, assessments, property taxes and other
24 taxes, rates, charges, rentals and other income or receipts derived by a public body or to
25 which a public body is entitled.

26 (17) "Revenue bond" means a bond that is not a general obligation bond.

27 (18) "Termination payment" means the amount payable under an agreement for exchange
28 of interest rates by one party to another party as a result of the termination, in whole or
29 part, of the agreement prior to the expiration of the stated term.

30
31 (City General Obligation Bond Authority)

32
33 **SECTION 43.** (1) A city may issue general obligation bonds to finance capital construction
34 or capital improvements upon approval of the electors of the city.

35 (2) Unless the city charter provides a lesser limitation, a city may not issue or have
36 outstanding at the time of issuance general obligation bonds in a principal amount that ex-
37 ceeds three percent of the real market value of the taxable property within its boundaries,
38 calculated as provided in ORS 308.207.

39 (3) The limitation described in subsection (2) of this section does not apply to general
40 obligation bonds issued to finance the costs of local improvements assessed and paid for in
41 installments under statutory or charter authority or to finance capital construction or cap-
42 ital improvements for:

43 (a) Water supply, treatment or distribution;

44 (b) Sanitary or storm sewage collection or treatment;

45 (c) Hospitals or infirmaries;

- 1 (d) Gas, power or lighting; or
- 2 (e) Off-street motor vehicle parking facilities.

3
4 (County General Obligation Bond Authority)

5
6 **SECTION 44.** (1) Unless the county charter expressly provides otherwise, a county may
7 issue general obligation bonds to finance capital construction or capital improvements upon
8 approval of the electors of the county.

9 (2) Unless the county charter provides a lesser limitation, a county may not issue or have
10 outstanding at the time of issuance general obligation bonds in a principal amount that ex-
11 ceeds two percent of the real market value of the taxable property in the county, calculated
12 as provided in ORS 308.207.

13
14 (County Limitation on Bonded Indebtedness)

15
16 **SECTION 45.** (1) A county may incur bonded indebtedness within the meaning of section
17 10, Article XI of the Oregon Constitution, by issuing revenue bonds when a county is ex-
18 pressly authorized to issue revenue bonds by a law other than this section. The amount of
19 revenue bonds permitted by this section may not exceed the lesser of:

20 (a) One percent of the real market value of all taxable property in the county, calculated
21 as provided in ORS 308.207; or

22 (b) A limitation on bonded indebtedness in the county charter.

23 (2) The limitation on bonded indebtedness in subsection (1) of this section does not apply
24 to revenue bonds issued to finance pension liabilities under ORS 238.692 to 238.698 or any
25 other law in effect prior to enactment of ORS 238.692 to 238.698.

26
27 (Public Body Revenue Bond Authority)

28
29 **SECTION 46.** (1) In addition to any other authority to issue revenue bonds, a public body
30 may authorize revenue bonds by resolution or nonemergency ordinance pursuant to this
31 section for a public purpose.

32 (2) If revenue bonds are authorized by nonemergency ordinance, a public body may not
33 sell the revenue bonds pursuant to this section until the period for referral of the ordinance
34 has expired. If electors of a public body refer a nonemergency ordinance authorizing issuance
35 of revenue bonds, the public body may not sell the revenue bonds unless the electors approve
36 issuance of the revenue bonds.

37 (3) If revenue bonds are authorized by resolution:

38 (a) A public body may not sell the revenue bonds until at least 60 days following publi-
39 cation of the notice required in subsection (4) of this section.

40 (b) The resolution must provide that electors residing within the public body may file a
41 petition with the public body asking the public body to refer the question of whether to issue
42 the revenue bonds to a vote. If within 60 days after the publication of the notice described
43 in subsection (4) of this section, electors file petitions with the public body containing valid
44 signatures of at least five percent of the public body's electors, the public body:

45 (A) Shall place the question of issuing the revenue bonds on the ballot at the next law-

1 fully available election date; and

2 (B) May not sell the revenue bonds described in the notice unless a majority of the
3 electors voting on the question of issuing the revenue bonds approve.

4 (4) A public body authorizing revenue bonds by resolution shall publish a notice describ-
5 ing the purposes for which the revenue bonds will be sold in at least one newspaper of gen-
6 eral circulation within the boundaries of the public body in the same manner as other public
7 notices of the public body. At a minimum, the notice must contain:

8 (a) The date the resolution was adopted and the number thereof, if any;

9 (b) The expected source of revenue for repayment of the revenue bonds;

10 (c) The estimated principal amount of the revenue bonds to be sold;

11 (d) The procedures by which electors may cause the question of issuing the revenue
12 bonds to be referred to a vote;

13 (e) The period within which electors must file signed petitions to cause referral; and

14 (f) The fact that the resolution is available for inspection at the appropriate office of the
15 public body.

16 (5) If revenue bonds are authorized by nonemergency ordinance under subsection (2) of
17 this section, the revenue bonds may be secured by the revenues or other property of the
18 public body that is described in the nonemergency ordinance. If revenue bonds are authorized
19 by resolution under subsection (3) of this section, the revenue bonds may be secured by the
20 revenues or other property of the public body that is described in the notice required under
21 subsection (4) of this section.

22 (6) A public body may issue refunding bonds under sections 54 to 59 of this 2007 Act to
23 pay revenue bonds that were authorized by this section. The procedures and limitations of
24 subsections (1) to (5) of this section do not apply to refunding bonds.

25 SECTION 47. (1) In addition to any other authority to issue revenue bonds, but subject
26 to applicable limitations imposed by the Oregon Constitution or the charter or ordinance of
27 the public body, a public body may issue revenue bonds pursuant to this section:

28 (a) In anticipation of tax revenues or other moneys;

29 (b) To provide interim financing for capital projects to be undertaken by the public body;

30 or

31 (c) To refund revenue bonds issued pursuant to this section.

32 (2) To secure revenue bonds authorized under this section, a public body may:

33 (a) Pledge all or part of the revenues of the public body that may lawfully be used to
34 secure payment of the revenue bonds.

35 (b) Obtain credit enhancement devices for the revenue bonds authorized by this section.

36 (c) Establish debt service reserves.

37 (d) Enter into covenants, by ordinance, resolution or agreement, for the protection and
38 security of the owners of revenue bonds authorized by this section. The covenants constitute
39 enforceable contracts with the owners of the revenue bonds.

40 (3) Revenue bonds authorized by this section that are issued in anticipation of revenues
41 and revenue bonds issued under subsection (1)(c) of this section:

42 (a) Must mature within 13 months after they are issued; and

43 (b) May not be issued in a principal amount that exceeds 80 percent of the taxes or other
44 revenues, except grant moneys, that the public body has budgeted or otherwise reasonably
45 expects to have available to pay the revenue bonds.

1 (4) Revenue bonds authorized by this section that are issued in anticipation of grant
2 moneys or to provide interim financing for capital projects and revenue bonds issued under
3 subsection (1)(c) of this section must mature not later than five years after the revenue
4 bonds are issued.

5 (5) The debt limitations imposed by law or the charter of a public body do not apply to
6 revenue bonds or credit enhancement devices authorized by this section.

7
8 (Public Body Bond Administration)
9

10 **SECTION 48.** (1) Notwithstanding a limitation in a local charter, when a public body is
11 authorized by law to issue bonds, the public body may:

12 (a) Combine bonds authorized by different laws or actions of the governing body into a
13 single issue and use a single disclosure document if the bonds in the issue will have the same
14 security, or may use a single disclosure document for bonds authorized by different laws or
15 actions of the governing body if the bonds have different security.

16 (b) Structure, market and issue bonds in the manner that the public body determines is
17 in the best interest of the people served by the public body.

18 (c) Sell bonds at a competitive sale or a negotiated sale or in any other manner deter-
19 mined by the public body.

20 (d) Issue bonds the interest on which is exempt from federal income taxes or is not ex-
21 empt from federal income taxes.

22 (e) Establish the maturity dates for bonds to provide for short-term, interim or long-
23 term borrowing and establish the principal amounts, redemption provisions, optional or
24 mandatory tender provisions, interest rates or method for determining a variable or adjust-
25 able interest rate, denominations and other terms and conditions of the bonds.

26 (f) Determine the form and content of bond disclosure documents.

27 (g) Enter into an agreement with and retain the services of bond counsel and other pro-
28 viders of bond-related services.

29 (h) Execute and deliver indentures, bond purchase agreements, trust agreements, re-
30 marketing agreements, auction agent agreements, broker dealer agreements, tender agent
31 agreements, escrow agreements and other contracts related to the sale, issuance, security
32 for or administration of the bonds.

33 (i) Enter into agreements with bond trustees and deposit moneys with trustees for the
34 benefit of bond owners and the providers of credit enhancement devices for bonds.

35 (j) Enter into covenants for the benefit of bond owners or the providers of credit en-
36 hancement devices or agreements for exchange of interest rates, including but not limited
37 to covenants regarding the issuance of additional bonds and rate covenants.

38 (k) Enter into covenants for the benefit of owners of bonds that are intended to allow
39 bonds to bear interest that is excludable from gross income under the federal Internal Re-
40 venue Code or that is otherwise exempt from taxation by the United States.

41 (L) Take action to comply with covenants.

42 (m) Establish bond debt service reserves.

43 (n) Fund debt service reserves out of bond proceeds or from other revenues.

44 (o) Specify the individuals who may sign the bonds on behalf of the public body.

45 (2) When the Oregon Constitution, a charter, a statute, an ordinance or a resolution

1 authorizes a public body to spend bond proceeds for a particular purpose, the public body
2 may also spend bond proceeds to finance costs of issuing, administering and repaying the
3 bonds, including costs of the services of bond counsel or other providers of bond-related
4 services, and to pay the costs of a credit enhancement device or agreement for exchange of
5 interest rates.

6 (3) When a public body redeems bonds, the public body shall give notice of redemption in
7 the manner specified in the documents authorizing the bonds to be redeemed.

8 **SECTION 49.** A public body may delegate to an elected or appointed official or an em-
9 ployee of the public body the authority to take an action described in section 48 (1) of this
10 2007 Act.

11 **SECTION 50.** (1) As used in this section and section 50a of this 2007 Act:

12 (a) "Obligation" means:

13 (A) A bond;

14 (B) The commitment of a public body in connection with a credit enhancement device;
15 or

16 (C) An agreement for exchange of interest rates.

17 (b) "Property" means:

18 (A) Real or personal property, tangible or intangible, whether owned when a pledge is
19 made or acquired subsequently to the time the pledge is made; and

20 (B) Revenues, contract rights, receivables or securities.

21 (2) The Uniform Commercial Code does not apply to the creation, perfection, priority or
22 enforcement of a lien of a pledge made by a public body.

23 (3) When otherwise authorized by statute, charter, ordinance or resolution to issue
24 bonds, a public body may pledge as security for payment of obligations all or part of the
25 property of the public body expressly authorized to be pledged by the governing body of the
26 public body.

27 (4) The lien created by a pledge is valid and binding from the time the pledge is made.
28 Pledged property is subject immediately to the lien of the pledge without physical delivery,
29 filing or any other act.

30 (5) Except as otherwise expressly provided in an operative document, the lien of the
31 pledge is superior to and has priority over all other claims and liens.

32 (6) When property subject to a pledge is acquired by a public body after the pledge is
33 made:

34 (a) The property is subject to the lien upon acquisition by the public body without phys-
35 ical delivery, filing or any other act.

36 (b) The lien relates to the time the pledge was originally made.

37 (7) A public body may reserve a right to pledge a pledged property as security for bonds
38 subsequently issued by the public body. If the public body reserves the right, subject to the
39 terms of the operative document that created a previous pledge, the lien of the subsequent
40 pledge may be on a parity or pari passu basis with the lien of the previous pledge, on a prior
41 and superior basis with the lien of the previous pledge or on a subordinate basis with the lien
42 of the previous pledge, as specified in the operative document creating the subsequent pledge.
43 The lien of the subsequent pledge:

44 (a) Has the priority specified in the operative document creating the subsequent pledge;
45 and

1 (b) Is superior to and has priority over all other claims and liens except the lien of a
2 pledge with which the lien of the subsequent pledge is on a parity or subordinate basis, as
3 specified in the operative document.

4 (8) A pledgee may commence an action in a court of competent jurisdiction to foreclose
5 the lien of the pledge and exercise rights and remedies available to the pledgee under the
6 operative document.

7 (9) When pledged property consists of moneys or property that is in a fund for debt ser-
8 vice reserves or payments, a pledgee may foreclose the lien of the pledge by applying the
9 moneys or property in the fund to the payment of the bonds subject to the terms, conditions
10 and limitations in the operative document.

11 **SECTION 50a.** (1) A public body may pledge its full faith and credit and taxing power
12 when the public body issues:

13 (a) A general obligation bond; or

14 (b) An obligation that is secured by all lawfully available funds of the public body.

15 (2) When a public body pledges its full faith and credit and taxing power to pay an obli-
16 gation, the pledge constitutes an enforceable promise or contract by the public body:

17 (a) To pay the obligation out of lawfully available funds of the public body; and

18 (b) If lawfully available funds are insufficient to pay when due the amounts owing on the
19 obligation, to levy, impose and collect a tax that is within the authority of the public body
20 to levy, impose and collect in an amount sufficient to pay the amounts owing under the ob-
21 ligation, including past due amounts and penalties.

22 (3) If a public body fails to pay when due an amount owing under an obligation secured
23 by a pledge of the full faith and credit and taxing power of the public body, the owner of the
24 obligation, or the trustee appointed to act on behalf of the owner, may bring an action in the
25 circuit court of the county in which the principal offices of the public body are located to
26 compel the public body:

27 (a) To appropriate and expend sufficient lawfully available funds to pay the amounts ow-
28 ing on the obligation; or

29 (b) If lawfully available funds are insufficient to pay when due the amounts owing on the
30 obligation, to levy, impose and collect a tax that is within the authority of the public body
31 to levy, impose and collect in an amount sufficient to pay the amounts owing under the ob-
32 ligation, including past due amounts and penalties.

33 (4) An owner of the obligation, or a trustee appointed to act on behalf of the owner, may
34 initiate a proceeding to impose remedial sanctions under ORS 33.055 against members of the
35 governing body of a public body for failure to comply with an order of the court under this
36 section.

37 (5) A pledge of the full faith and credit and taxing power authorized by this section does
38 not, by itself, create a lien on the revenues or property of the public body.

39 **SECTION 51.** (1) The Legislative Assembly finds that:

40 (a) It is a matter of statewide concern that certain covenants made by public bodies re-
41 garding a pledge of revenues to secure bonds not be impaired by subsequent initiative or
42 referendum measures.

43 (b) The covenants described in paragraph (a) of this subsection usually are in the form
44 of a promise to charge and collect rates, fees, tolls, rentals or other charges sufficient to
45 produce moneys to maintain a specified level of debt service coverage.

1 (c) The possibility that the covenants described in paragraph (a) of this subsection might
2 be rolled back, frozen or otherwise subjected to subsequently imposed conditions or re-
3 strictions negatively affects the ability of public bodies to market their bonds, to obtain
4 credit enhancement and to obtain satisfactory ratings on their bonds.

5 (2) Therefore, the Legislative Assembly declares that covenants are material to the se-
6 curity for bonds and to investors' expectations regarding timely payment of the bonds.

7 (3) An elector-approved initiative or referendum measure that purports to change ordi-
8 nances or resolutions affecting rates, fees, tolls, rentals or other charges has no force or
9 effect if giving force and effect to the change would impair existing covenants made with
10 existing bond owners.

11 (4) A public body may enter into rate covenants that obligate the public body to period-
12 ically set rates and charges:

13 (a) That generate pledged revenues at specific levels including, but not limited to, a spe-
14 cific monetary charge for each unit of commodity or service provided or a schedule of rates
15 and charges that includes fixed and variable components;

16 (b) At levels sufficient to maintain underlying credit ratings assigned to bonds by one or
17 more nationally recognized credit rating services without regard to improvement in credit
18 ratings due to the additional security provided for the bonds by a credit enhancement device;

19 (c) That generate pledged revenues each year in amounts at least equal to operations and
20 maintenance expenses of the system that produces the pledged revenues, plus debt service
21 on revenue bonds and other borrowings, plus an additional amount that is reasonably re-
22 quired to obtain favorable terms for the revenue bonds and other borrowings; or

23 (d) In accordance with a formula established in the operative document governing re-
24 venue bonds or other borrowings. The formula may provide for rates and charges to be de-
25 termined by reference to factors including, but not limited to:

26 (A) Historical operating expenses;

27 (B) Projected future operating expenses;

28 (C) The funding of depreciation;

29 (D) The costs of capital improvements;

30 (E) The costs of complying with contractual obligations and covenants;

31 (F) The costs of complying with regulatory requirements;

32 (G) Reports of independent consultants regarding the level of pledged revenues required
33 to operate and maintain a utility in accordance with prudent utility practice;

34 (H) Debt service on the revenue bonds or other borrowings bonds; and

35 (I) The moneys needed to establish or maintain reserves required by law or contract and
36 the moneys needed to maintain an unencumbered carryforward fund balance or working
37 capital to meet unanticipated expenses or fluctuations in revenues that may arise.

38 (5) Without regard to the date of execution of a rate covenant, a rate covenant author-
39 ized by this section is a contract that binds the public body and is enforceable against the
40 public body in accordance with the terms of the rate covenant.

41
42 (Credit Enhancement)

43
44 **SECTION 52.** (1) A public body may obtain a credit enhancement device and enter into
45 related agreements.

1 exchange of interest rates may not be paid from ad valorem property taxes levied outside the
2 limitations of section 11 or 11b, Article XI of the Oregon Constitution.

3 (8) The Oregon Municipal Debt Advisory Commission shall adopt administrative rules
4 establishing required terms, conditions, annual or periodic reporting requirements and other
5 requirements for an agreement for exchange of interest rates entered into by a public body,
6 if the commission determines those requirements are desirable to protect the interests of
7 the public body.

8 (9) A public body may create reserves to pay amounts due under agreements for ex-
9 change of interest rates and fund the reserves with moneys derived from the issuance and
10 sale of bonds or from revenues or other moneys described in subsection (4)(b) of this section.

11
12 (Refunding Bonds)
13

14 **SECTION 54.** (1) In addition to any other authority to issue refunding bonds, a public
15 body may issue current refunding bonds to refund its outstanding bonds pursuant to this
16 section.

17 (2) A public body may secure current refunding bonds with any of the revenues and
18 covenants that the public body could have used to secure the refunded bonds and with re-
19 venues and covenants authorized by law when the refunding bonds are issued.

20 (3) A public body may issue:

21 (a) General obligation bonds to refund outstanding general obligation bonds without ob-
22 taining approval of the electors of the public body.

23 (b) Revenue bonds to refund revenue bonds that were issued in accordance with section
24 46 of this 2007 Act without complying with the procedures prescribed in section 46 of this
25 2007 Act.

26 (c) General obligation bonds as current refunding bonds with a maturity date not more
27 than 30 days after the maturity date of the elector-approved general obligation bonds to be
28 refunded or the latest maturity date permitted in the elector-approved measure authorizing
29 the refunded bonds, whichever is later. If the total debt service on the current refunding
30 general obligation bonds does not exceed the total debt service on the general obligation
31 bonds to be refunded, the amounts maturing on a given date may be changed, and the cur-
32 rent refunding general obligation bonds may mature earlier than the bonds to be refunded.

33 (4) A public body may not issue current refunding bonds in an amount that, together with
34 amounts on deposit in sinking funds or other moneys pledged to payment of the principal,
35 exceeds the amount that the public body estimates is required to:

36 (a) Pay the refunded bonds or pay a termination payment with respect to an agreement
37 for exchange of interest rates related to the refunded bonds;

38 (b) Fund reserves for the current refunding bonds;

39 (c) Pay costs of issuing the current refunding bonds and obtaining credit enhancement
40 devices; and

41 (d) Pay other costs related to the current refunding bonds.

42 **SECTION 55.** (1) The Legislative Assembly declares that the issuance of advance refund-
43 ing bonds and the authority to effect a forward current refunding are matters of general
44 statewide concern, and sections 54 to 59 of this 2007 Act preempt all local statutory or
45 charter authority to issue advance refunding bonds or to effect a forward current refunding.

1 (2) A public body may issue advance refunding bonds or enter into forward current re-
2 fundings in compliance with:

3 (a) Sections 54 to 59 of this 2007 Act; and

4 (b) Rules adopted by the State Treasurer.

5 (3) A public body may secure advance refunding bonds with any of the revenues and
6 covenants that the public body could have used to secure the refunded bonds and with re-
7 venues and covenants authorized by law when the refunding bonds are issued.

8 **SECTION 56.** (1) The State Treasurer shall review the plan of a public body to issue ad-
9 vance refunding bonds or to enter into a forward current refunding to determine whether
10 the plan complies with applicable rules of the State Treasurer, as provided in this section.

11 (2) After adoption of an ordinance or resolution approving a plan to issue advance re-
12 funding bonds or to enter into a forward current refunding, a public body shall submit the
13 refunding plan to the State Treasurer for review and approval.

14 (3) After review of a proposed refunding plan, the State Treasurer shall advise the public
15 body, in writing, whether the plan is approved. If the State Treasurer does not notify the
16 public body within 30 business days after receipt of the plan, the plan is deemed approved.
17 A public body may issue advance refunding bonds or enter into a forward current refunding
18 in accordance with a refunding plan approved by the State Treasurer.

19 (4) The State Treasurer may adopt rules to regulate forward current refunding and the
20 issuance of advance refunding bonds.

21 (5) The State Treasurer may charge public bodies fees and expenses as provided in sec-
22 tion 5 of this 2007 Act in connection with the activities of this section.

23 **SECTION 57.** (1) As used in this section, “government obligations” means:

24 (a) Direct obligations of the United States of America or obligations the principal of and
25 interest on which are unconditionally guaranteed by the United States of America and bank
26 certificates of deposit secured by the obligations;

27 (b) Bonds, debentures, notes, certificates of participation or other obligations issued by
28 a federal agency or other instrumentality of the federal government; or

29 (c) Other debt obligations determined by administrative rule of the State Treasurer to
30 be highly secured and widely accepted in the marketplace as obligations for a defeasance
31 escrow.

32 (2) A public body may not issue advance refunding bonds in a principal amount in excess
33 of the minimum principal amount that is estimated at the time of sale to be necessary:

34 (a) To purchase a principal amount of government obligations that is, together with the
35 interest earnings thereon, sufficient to pay the installments of principal, interest and re-
36 demption premiums, if any, on the bonds being refunded when due in accordance with the
37 advance refunding plan; and

38 (b) To pay all costs in connection with issuing the advance refunding bonds and obtaining
39 credit enhancement devices.

40 (3) If the public body that issues advance refunding bonds receives an amount of proceeds
41 that exceeds the actual amount required under subsection (2) of this section, the public body
42 must use the excess amount of proceeds to pay interest on the advance refunding bonds.

43 (4) Before applying advance refunding bond proceeds to the purposes for which the re-
44 funding bonds have been issued, a public body may invest advance refunding bond proceeds,
45 together with other moneys set aside for the payment of the bonds to be refunded, only in

1 **government obligations.**

2 (5) **The public body shall make investments pursuant to subsection (4) of this section at**
3 **times and in a manner required to provide funds sufficient to pay principal, interest and re-**
4 **demption premiums, if any, in accordance with the advance refunding plan.**

5 **NOTE:** Section 58 was deleted by amendment. Subsequent sections were not renumbered.

6 **SECTION 59. (1) Pursuant to section 67 of this 2007 Act, a public body shall levy taxes**
7 **to pay the maturing interest and principal of advance refunding bonds that are general obli-**
8 **gation bonds.**

9 (2) **Notwithstanding section 67 of this 2007 Act or any other provision of law, a public**
10 **body may not cause a tax to be levied to pay the maturing interest and principal of general**
11 **obligation bonds that have been defeased as described in section 64 (2) of this 2007 Act, unless**
12 **the amounts held to defease the bonds are insufficient.**

16 **SECTION 60.** ORS 287.030 is amended to read:

17 287.030. (1) *[There is created]* The Oregon Municipal Debt Advisory Commission **is hereby cre-**
18 **ated**, consisting of **the following** seven members^[, selected as follows]:

19 (a) The State Treasurer or *[designate]* **the State Treasurer's designee.**

20 (b) Three *[local government]* **public body** finance officers^[,] appointed by the Governor^{[, one each}
21 *among persons]*:

22 (A) **One of whom is an individual** recommended by the Association of Oregon Counties^[,].

23 (B) **One of whom is an individual recommended by** the League of Oregon Cities^[,].

24 (C) **One of whom is an individual recommended by** the Oregon School Boards Association.

25 *[and]*

26 (c) One representative of special districts appointed by the Governor.

27 *[(c)]* (d) Two public members not represented in the other categories of appointment, appointed
28 by the Governor.

29 (2) The term of office of an appointed member is four years, but appointed members serve at the
30 pleasure of the Governor. *[Before the expiration of the term of an appointed member, the Governor*
31 *shall appoint a successor to assume the duties of the member on July 1, next following.]* A member is
32 eligible for reappointment for *[not to exceed]* **no more than** one additional term.

33 (3) **Before the expiration of the term of an appointed member, the Governor shall appoint**
34 **a successor to assume the duties of the member on July 1 next following.** In case of a vacancy
35 for any cause, the Governor shall make an appointment to become effective immediately for the
36 unexpired term.

37 *[(3)]* (4) The Governor shall designate one of the appointed members *[as chairperson]* to serve
38 a **one-year** term *[of one year]* **as chairperson**, subject to reappointment.

39 *[(4)]* (5) Appointed members of the commission *[shall be]* **are** entitled to compensation and ex-
40 penses as provided in ORS 292.495.

41 **SECTION 61.** ORS 287.032 is amended to read:

42 287.032. (1) The Oregon Municipal Debt Advisory Commission shall meet:

43 (a) At the call of the chairperson; or

44 (b) At the request of:

45 (A) A majority of the members;

1 (B) The State Treasurer; or

2 (C) The Governor.

3 (2) A majority of all members of the advisory commission constitutes a quorum for the trans-
4 action of business.

5 (3) *[All]* **The office of the State Treasurer shall provide the commission with** administrative
6 and clerical assistance required by the *[advisory]* commission *[shall be furnished by the office of the*
7 *State Treasurer]*.

8 **SECTION 62.** ORS 287.034 is amended to read:

9 287.034. (1) The Oregon Municipal Debt Advisory Commission may:

10 *[(1)]* (a) Provide assistance and consultation, upon request of the state or *[of local government*
11 *units]* **a public body**, to assist them in the planning, preparation, marketing and sale of new bond
12 issues to reduce the cost of the issuance to the issuer and to assist in protecting the issuer's credit.

13 *[(2)]* (b) Collect, maintain and provide financial, economic and social data on *[local government*
14 *units]* **public bodies** pertinent to their ability to *[assume and service bonded obligations]* **issue and**
15 **pay bonds.**

16 *[(3)]* (c) Collect, maintain and provide information on bonds sold and outstanding and serve as
17 a clearinghouse for all local bond issues.

20 *[(5) Prepare, advertise and distribute, upon request of issuers, preliminary official statements re-*
21 *quired by ORS 287.018 and notices of bond sales required by ORS 287.022.]*

22 *[(6)]* (e) Undertake or commission studies on methods to reduce the costs of state and local **bond**
23 issues.

24 *[(7)]* (f) Recommend changes in state law and local practices to improve the sale and servicing
25 of local bonds.

26 *[(8)]* (g) Perform any other function required or authorized by law.

27 *[(9)]* (h) Pursuant to ORS chapter 183, adopt rules necessary to carry out its duties.

28 **(2) The commission shall publish:**

29 (a) **A periodic newsletter describing proposed bond issues, bond sales, refundings, credit**
30 **rating changes and other information relating to municipal bonds that is pertinent to**
31 **issuers, underwriters, investors and the public.**

32 (b) **An annual report describing and evaluating the operations of the commission during**
33 **the preceding year.**

34 (3) **The commission may charge reasonable fees for providing services under subsection**
35 **(1) of this section.**

36 (4) **The commission shall transfer the amounts received under this section to the State**
37 **Treasurer for deposit in the Miscellaneous Receipts Account in the General Fund for the**

44 **SECTION 66. (1) If a court of competent jurisdiction determines that the proceeds of an**
45 **issue of general obligation bonds have been used by a public body for expenditures that are**

1 not capital construction or capital improvements, the court may order the public body to:

2 (a) Replace the misspent proceeds with interest, on a reasonable schedule determined by

35 190.265. (1) Pursuant to ORS 190.010, 190.020 and 190.085, counties may establish, by agreement
36 ratified by the governing body of each county as provided in ORS 190.085, an intergovernmental
37 corrections entity for the purposes of:

38 (a) Making application under ORS 423.525 to provide local correctional facilities including, but
39 not limited to, facilities funded under ORS 423.525, including land, structures, equipment, supplies

 27 permits, engineering, financing, reasonable program delinquencies, return on investment, required

 29 pair or replacement and debt service, including debt service payments or payments into reserve ac-
 30 counts for debt service and payment of amounts necessary to meet debt service coverage

 33 exceed the actual cost incurred by a unit of government for design, construction and financing of
 34 a local improvement.

5 studies, acquisition of permits or licenses or other services connected with the construction.

7 capital construction.

27 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
28 contractually obligated to be spent before June 20, 1997, has the meaning given that term in para-
29 graph (a) of this subsection, except that “capital improvements”:

30 (A) Includes public safety and law enforcement vehicles with a projected useful life of five years
31 or more; and

32 (B) Does not include:

33 (i) Maintenance and repairs, the need for which could be reasonably anticipated;

10 (12) "Routine obligations of ownership" means a standard of operation, maintenance, use or care

45 **Sec. 2.** (1) Pursuant to ORS 286.560 to 286.580, lottery bonds may be issued by the **State**

1 **Treasurer at the request of the** Department of Higher Education for deferred maintenance
2 projects.

3 (2) The use of lottery bond proceeds is authorized based on the following findings:

4 (a) Major subsystems within university buildings are wearing out and must be replaced in order
5 that universities have adequate facilities for teaching.

40 (14) Initiate or assist appropriate state agencies, governmental bodies and public or private
41 housing sponsors in the development, construction, acquisition, ownership, leasing, rehabilitation or
42 management of housing to carry out the purposes of ORS 456.515 to 456.725 and ORS chapter 458
43 where such housing is not otherwise affordable or available in the area.

44 (15) Execute and record written instruments that contain terms, including but not limited to
45 restrictive covenants or equitable servitudes, pertaining to the use and enjoyment of housing

1 projects. Notwithstanding any other provision of law, the executed instruments shall constitute and
 2 create restrictive covenants affecting and running with the property according to the terms of the
 3 instruments when recorded in the records of the county where the property is located. County clerks

34 (3) Shall contain a recital that principal of and interest on and premium, if any, on the revenue
 35 bonds are payable solely out of revenues and property of the port pledged to the payment thereof
 36 by the ordinance of the board authorizing the issue of which the bonds are a part.

37 *[(4) May be in coupon form with or without privilege of registration or may be in registered form,*
 38 *or both, with the privilege of converting and reconverting from one form to another.]*

39 *[(5)]* (4) May contain covenants of the port to protect and safeguard the security and rights of
 40 holders of any such bonds and such other terms and conditions, in conformity with ORS 778.145 to
 41 778.175, which the board in its discretion determines are necessary or desirable to protect the port
 42 or increase the marketability of the bonds. ORS 778.145 to 778.175 and any such ordinance which
 43 constitutes a contract with the holders of the bonds, and the provisions thereof shall be enforceable
 44 by any holder or any number of holders of the bonds, as the board may determine.

45 *[(6) Shall be in the form prescribed by the board and shall be signed by the president and by the*

1 secretary or an assistant secretary of the port, either manually or by their printed, engraved or
 2 lithographed signature; provided, however, that at least one signature is manual, with the seal of the
 3 port or a facsimile thereof printed, engraved or lithographed thereon or affixed thereto. Coupons, if any,
 4 attached to the bonds need bear only the printed, engraved or lithographed facsimile signature of the
 5 president and the secretary or an assistant secretary. Pending the preparation and delivery of definitive
 6 bonds, the port may issue interim certificates or temporary bonds, exchangeable for definitive bonds
 7 when such bonds shall have been executed and are available for delivery. Such interim certificates or
 8 temporary bonds may contain such terms and conditions as the board may determine.]

9 [(7) May be issued with the right reserved to the board to redeem the bonds at par or at par plus
 10 a premium, in such order, and at such time or times prior to the final maturity date or dates of the
 11 bonds, as the ordinance may provide or as otherwise determined by the board. Notice of redemption
 12 shall be given in the manner specified in the bonds, as provided in ORS 288.520. Newspaper publi-
 13 cation of notice of redemption is not required for bonds that are in registered form.]

14 **(5) Shall be issued under ORS chapter 287. However, the requirements of section 46 of**
 15 **this 2007 Act do not apply to revenue bonds issued under this section.**

16 **SECTION 232.** ORS 838.065 is amended to read:

17 838.065. (1) For the purpose of performing any service that the district has power to perform,
 18 the district, when authorized at any properly called election held for such purpose, shall have the
 19 power to borrow money by the issuance and sale of general obligation bonds. Such bonds shall never
 20 exceed in the aggregate 10 percent of the real market value of all taxable property within the dis-
 21 trict computed in accordance with ORS 308.207. The bonds shall be so conditioned that the district
 22 shall promise and agree therein to pay the bearer at a place named therein payable semiannually
 23 in accordance with the tenor and terms of the interest coupons attached. The bonds shall mature
 24 serially not to exceed 30 years from the date of issue[, *in like manner as bonds issued under the*
 25 *authority of ORS 287.008*].

26 (2) For the purpose of performing any of the powers conferred by this chapter a district, without
 27 the necessity of an election held for such purpose, shall have the power to borrow money by the
 28 issuance and sale also of revenue bonds and to pledge as security therefor, all or any part of the
 29 unobligated net income or revenue of the district. The revenue bonds shall be [*issued in the same*
 30 *manner and form as are general obligation bonds of the district but they shall be*] payable both as to
 31 principal and interest from revenues only. The revenue bonds shall not be subject to the percentage
 32 limitation applicable to general obligation bonds and shall not be a lien on any of the taxable
 33 property within the limits of the district and shall be payable solely from such part of revenues of
 34 the district as remains after the payment of obligations having a priority and of all expenses of op-
 35 eration and maintenance of the district. All revenue bonds shall contain a provision that both the
 36 principal and interest are payable solely from the operating revenues of the district remaining after
 37 paying such obligations and expenses.

38 (3) All general obligation bonds and revenue bonds shall be [*advertised for sale and sold in the*
 39 *manner prescribed in ORS 287.014 to 287.022 for the sale of bonds of cities*] **issued as prescribed in**
 40 **ORS chapter 287.**

41 **SECTION 232a.** ORS 468.423 is amended to read:

6 (a) The devices and systems used in the storage, treatment, recycling and reclamation of mu-

9 (A) Intercepting sewers, outfall sewers, sewage collection systems, pumping power and other
10 equipment, and any appurtenance, extension, improvement, remodeling, addition or alteration to the
11 equipment;

12 (B) Elements essential to provide a reliable recycled water supply including standby treatment
13 units and clear well facilities; and

14 (C) Any other acquisitions that will be an integral part of the treatment process or used for
15 ultimate disposal of residues resulting from such treatment, including but not limited to land used
16 to store treated waste water in land treatment systems prior to land application.

17 (b) Any other method or system for preventing, abating, reducing, storing, treating, separating
18 or disposing of municipal waste, storm water runoff, industrial waste or waste in combined storm
19 water and sanitary sewer systems.

20 (c) Any other facility that the Environmental Quality Commission determines a public agency
21 must construct or replace in order to abate or prevent surface or ground water pollution.

22 the State Treasurer, to authorize or issue bonds under the laws of this state in effect on the
23 day before the effective date of this 2007 Act.

24 (2) The State Treasurer shall by rule prescribe how and when an election may be made
25 under this section.
