SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Expands criminal homicide to include causing death of unborn child. Provides exception for lawful termination of pregnancy and acts committed by pregnant woman. Creates crime of assault of unborn child. Punishes by maximum of 10 years' imprisonment, \$250,000 fine, or both.

ORS 163.005 is amended to read: 6 7 163.005. (1) As used in this section: 8 (a) "Criminal homicide" is murder, manslaughter or criminally negligent homicide. 9 (b) "Human being" means: (A) A person who has been born and was alive at the time of the criminal act; and 10 (B) An unborn child. 11 12 (c) "Unborn child" means a member of the species Homo sapiens at any stage of development while carried in the womb. 13 [(1)] (2) A person commits criminal homicide if, without justification or excuse, the person in-14 15tentionally, knowingly, recklessly or with criminal negligence causes the death of another human 16 being. [(2) "Criminal homicide" is murder, manslaughter or criminally negligent homicide.] 1718 [(3) "Human being" means a person who has been born and was alive at the time of the criminal 19 act.] 20 (3) A person does not commit criminal homicide if the death is of an unborn child and 21occurs: 22(a) During the lawful termination of a pregnancy performed with the pregnant woman's 23consent or with the consent of a person authorized to act on the pregnant woman's behalf; 24 or (b) As the result of acts committed by the pregnant woman. 25 26 (4) In a prosecution for a criminal homicide involving the death of an unborn child, it is 27no defense that the defendant did not know or could not reasonably have known that the 28woman was pregnant. 29 SECTION 2. The proceeding shall be conducted in the man-4 ner prescribed for a contested case hearing under ORS chapter 183 except that:

5 (A) The prisoner shall have the burden of proving by a preponderance of the evidence the like-6 lihood of rehabilitation within a reasonable period of time; and

7 (B) The prisoner shall have the right, if the prisoner is without sufficient funds to employ an 8 attorney, to be represented by legal counsel, appointed by the board, at board expense.
