**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires city to allow electors, **if any**, in surrounded territory proposed to be annexed to vote if city charter, ordinance or resolution requires city to hold election in city. Requires that votes from city and territory be combined to determine single majority in election.

**A BILL FOR AN ACT**

2 Relating to island annexation; creating new provisions; and amending ORS 222.750.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 222.750 is amended to read:

5 222.750. (1) When territory not within a city is surrounded by the corporate boundaries of the  
6 city, or by the corporate boundaries of the city and the ocean shore or a stream, bay, lake or other  
7 body of water, it is within the power and authority of that city to annex such territory. However,  
8 this section does not apply when the territory not within a city is surrounded entirely by water.

9 (2) Unless otherwise required by its charter, annexation by a city under this section shall be  
10 by ordinance or resolution subject to referendum, with or without the consent of any owner of  
11 property within the territory or resident in the territory.

12 (3) **If a city charter, ordinance or resolution requires the city to conduct an election in**  
13 **the city, the city shall allow electors, if any, in the territory proposed to be annexed to vote**  
14 **in the election on the question of annexation. If the governing body of the city finds that a**  
15 **majority of the votes cast in the city and the territory combined favor annexation, the gov-**  
16 **erning body, by ordinance or resolution, shall proclaim the annexation approved. The proc-**  
17 **lamation shall contain a legal description of each territory annexed.**

18 **SECTION 2.** The amendments to ORS 222.750 by section 1 of this 2007 Act apply to an  
19 annexation under ORS 222.750 that takes effect on or after the effective date of this 2007 Act.
