

HOUSE AMENDMENTS TO HOUSE BILL 3308

- 1 In line 2 of the printed bill, after "Guard" insert a period and delete the rest of the line.
2 Delete lines 4 through 22 and insert:
3 **"SECTION 1. (1) As used in this section and section 2 of this 2007 Act:**
4 **"(a) 'Enrollment deadline' means the day immediately preceding the beginning of in-**
5 **struction in a limited enrollment class.**
6 **"(b) 'Limited enrollment class' means a class in which enrollment is limited to a specified**
7 **number of students.**
8 **"(c) 'Member of the Oregon National Guard' means a person who:**
9 **"(A) Is an active member of the Oregon National Guard;**
10 **"(B) Is a resident of Oregon;**
11 **"(C) Is academically qualified to enroll at a state institution or would benefit from a**
12 **community college course; and**
13 **"(D) Does not possess a baccalaureate or higher degree at the time of enrollment.**
14 **"(d) 'State institution' means institutions of higher education listed in ORS 352.002.**
15 **"(2) If a state institution or a community college offers a limited enrollment class and**
16 **the specified number of students have not enrolled in the class by the enrollment deadline**
17 **and after all students on a waiting list have been offered the opportunity to enroll, the re-**
18 **maining unfilled spaces in the class shall be offered to members of the Oregon National**
19 **Guard.**
20 **"(3) A member of the Oregon National Guard may enroll in the limited enrollment class**
21 **upon proof of membership in the Oregon National Guard.**
22 **"(4) A member of the Oregon National Guard may enroll in one limited enrollment class**
23 **per academic term.**
24 **"SECTION 2. (1)(a) The Oregon Military Department shall reimburse a state institution,**
25 **from federal funds, the full amount of the total tuition for a course in which a member of**
26 **the Oregon National Guard has enrolled.**
27 **"(b) If sufficient federal funds are not available, the department shall reimburse the state**
28 **institution at least 75 percent of the total amount of the tuition.**
29 **"(c) The state institution shall waive the tuition amounts that remain due under this**
30 **subsection.**
31 **"(2)(a) The department shall reimburse a community college, from federal funds, the full**
32 **amount of the total tuition for a course in which a member of the Oregon National Guard**
33 **has enrolled.**
34 **"(b) If sufficient federal funds are not available, the department shall reimburse the**
35 **community college at least 75 percent of the total amount of the tuition.**

1 “(c) A community college shall adopt policies regarding tuition amounts that remain due
2 under this subsection.

3 “(3) A member of the Oregon National Guard who enrolls in a limited enrollment class
4 is responsible for paying all applicable fees and other expenses, such as books and materials.

5 “SECTION 3. Sections 1 and 2 of this 2007 Act first apply to the 2008-2009 academic
6 year.”.
