

SENATE AMENDMENTS TO A-ENGROSSED HOUSE BILL 3314

1 On page 1 of the printed A-engrossed bill, delete line 3 and insert “and amending ORS 41.905,
2 153.061, 153.090, 153.099, 809.411 and 811.135.”.

3 Delete lines 5 through 25 and delete pages 2 through 6 and insert:

4 **“SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Oregon Vehicle**
5 **Code.**

6 **“SECTION 2. ‘Vulnerable user of a public way’ means a pedestrian, a highway worker, a**
7 **person riding an animal or a person operating any of the following on a public way, crosswalk**
8 **or shoulder of the highway:**

9 **“(1) A farm tractor or implement of husbandry without an enclosed shell;**

10 **“(2) A skateboard;**

11 **“(3) Roller skates;**

12 **“(4) In-line skates;**

13 **“(5) A scooter; or**

14 **“(6) A bicycle.**

15 **“SECTION 3. ORS 811.135 is amended to read:**

16 **“811.135. (1) A person commits the offense of careless driving if the person drives any vehicle**
17 **upon a highway or other premises described in this section in a manner that endangers or would**
18 **be likely to endanger any person or property.**

19 **“(2) The offense described in this section, careless driving, applies on any premises open to the**
20 **public and is a Class B traffic violation unless commission of the offense contributes to an accident.**
21 **If commission of the offense contributes to an accident, the offense is a Class A traffic violation.**

22 **“(3) In addition to any other penalty imposed for an offense committed under this sec-**
23 **tion, if the court determines that the commission of the offense described in this section**
24 **contributed to the serious physical injury or death of a vulnerable user of a public way, the**
25 **court shall:**

26 **“(a) Impose a sentence that requires the person to:**

27 **“(A) Complete a traffic safety course; and**

28 **“(B) Perform between 100 to 200 hours of community service, notwithstanding ORS**
29 **137.129. The community service must include activities related to driver improvement and**
30 **providing public education on traffic safety;**

31 **“(b) Impose, but suspend on the condition that the person complete the requirements of**
32 **paragraph (a) of this subsection:**

33 **“(A) A fine of up to \$12,500, notwithstanding ORS 153.018; and**

34 **“(B) A suspension of driving privileges as provided in ORS 809.411; and**

35 **“(c) Set a hearing date up to one year from the date of sentencing.**

1 **“(4) At the hearing described in subsection (3)(c) of this section, the court shall:**

2 **“(a) If the person has successfully completed the requirements described in subsection**
3 **(3)(a) of this section, dismiss the penalties imposed under subsection (3)(b) of this section;**
4 **or**

5 **“(b) If the person has not successfully completed the requirements described in sub-**
6 **section (3)(a) of this section:**

7 **“(A) Grant the person an extension based on good cause shown; or**

8 **“(B) Impose the penalties under subsection (3)(b) of this section.**

9 **“(5) The police officer issuing the citation for an offense under this section shall note on**
10 **the citation if the cited offense contributed to the serious physical injury or death of a vul-**
11 **nerable user of a public way.**

12 **“SECTION 4.** ORS 809.411 is amended to read:

13 **“809.411. (1)(a) Upon receipt of a record of conviction for an offense described in this section,**
14 **the Department of Transportation shall suspend the driving privileges of the person convicted.**

15 **“(b) A person is entitled to administrative review under ORS 809.440 of a suspension under this**
16 **section.**

17 **“(c) Except as otherwise provided in subsections (7), (8), (9), [and] (10) and (11) of this section,**
18 **the suspension shall be for the period of time described in Schedule I of ORS 809.428, except that**
19 **the department may not reinstate driving privileges of any person whose privileges are suspended**
20 **under this section until the person complies with future responsibility filings.**

21 **“(2) The department shall take action under subsection (1) of this section upon receipt of a re-**
22 **cord of conviction of any degree of recklessly endangering another person, menacing or criminal**
23 **mischief resulting from the operation of a motor vehicle.**

24 **“(3) The department shall take action under subsection (1) of this section upon receipt of a re-**
25 **cord of conviction of reckless driving under ORS 811.140.**

26 **“(4) The department shall take action under subsection (1) of this section upon receipt of a re-**
27 **cord of conviction of failure to perform duties of a driver when property is damaged under ORS**
28 **811.700.**

29 **“(5) The department shall take action under subsection (1) of this section upon receipt of a re-**
30 **cord of conviction of fleeing or attempting to elude a police officer under ORS 811.540.**

31 **“(6) The department shall take action under subsection (1) of this section upon receipt of a re-**
32 **cord of conviction of reckless endangerment of highway workers under ORS 811.231 (1).**

33 **“(7) The department shall take action under subsection (1) of this section upon receipt of a re-**
34 **cord of conviction of theft under ORS 164.043, 164.045 or 164.055 when the theft was of gasoline. A**
35 **suspension under this subsection shall continue for a period of six months from the date of suspen-**
36 **sion.**

37 **“(8) The department shall take action under subsection (1) of this section upon receipt of a re-**
38 **cord of conviction of criminal trespass under ORS 164.245 that involves the operation of a motor**
39 **vehicle. A suspension under this subsection shall continue for a period of six months from the date**
40 **of suspension.**

41 **“(9) The department shall take action under subsection (1) of this section upon receipt of a re-**
42 **cord of conviction of an offense described in ORS 809.310. A suspension under this subsection shall**
43 **continue for a period of one year from the date of the suspension.**

44 **“(10)(a) The department shall take action under subsection (1) of this section upon receipt of a**
45 **record of conviction of assault in the second, third or fourth degree resulting from the operation of**

1 a motor vehicle.

2 “(b) A person who is convicted of assault in the second degree and whose driving privileges are
3 suspended under this subsection may apply for reinstatement of driving privileges eight years from
4 the date the person is released from incarceration for the conviction, if the sentence includes
5 incarceration. If the sentence for the conviction does not include incarceration, the person may ap-
6 ply for reinstatement of driving privileges eight years from the date the department suspended the
7 privileges under this subsection.

8 “(c) A person who is convicted of assault in the third degree and whose driving privileges are
9 suspended under this subsection may apply for reinstatement of driving privileges five years from
10 the date the person is released from incarceration for the conviction, if the sentence includes
11 incarceration. If the sentence for the conviction does not include incarceration, the person may ap-
12 ply for reinstatement of driving privileges five years from the date the department suspended the
13 privileges under this subsection.

14 “(d) A person who is convicted of assault in the fourth degree and whose driving privileges are
15 suspended under this subsection may apply for reinstatement of driving privileges one year from the
16 date the person is released from incarceration for the conviction, if the sentence includes
17 incarceration. If the sentence for the conviction does not include incarceration, the person may ap-
18 ply for reinstatement of driving privileges one year from the date the department suspended the
19 privileges under this subsection.

20 **“(11) The department shall take action under subsection (1) of this section upon receipt**
21 **of a record of conviction for careless driving under ORS 811.135. A suspension under this**
22 **subsection is for the period of time described in Schedule II of ORS 809.428.**

23 **“SECTION 5.** ORS 153.061 is amended to read:

24 **“153.061. (1) Except as provided in subsection (2) of this section,** a defendant who has been
25 issued a violation citation must either:

26 **“(a) Make a first appearance by personally appearing in court at the time indicated in the**
27 **summons; or**

28 **“(b) Make a first appearance in the manner provided in subsection [(2)] (3) of this section before**
29 **the time indicated in the summons.**

30 **“(2) If a defendant has been issued a violation citation for careless driving under ORS**
31 **811.135 on which a police officer noted that a vulnerable user of a public way suffered serious**
32 **physical injury or death, the defendant must make a first appearance by personally appearing**
33 **in court at the time indicated in the summons.**

34 **“[(2)] (3)** A defendant who has been issued a violation citation may make a first appearance in
35 the matter before the time indicated in the summons by one of the following means:

36 **“(a)** The defendant may submit to the court a written or oral request for a trial.

37 **“(b)** The defendant may enter a plea of no contest by delivering to the court the summons, a
38 check or money order in the amount of the base fine set forth in the summons, and a statement of
39 matters in explanation or mitigation of the violation charged. The delivery of a statement of matters
40 in explanation or mitigation under the provisions of this paragraph constitutes a waiver of trial and
41 consent to the entry of a judgment forfeiting the base fine based on the statement and any other
42 testimony or written statements that may be presented to the court by the citing officer or other
43 witnesses.

44 **“(c)** The defendant may execute the appearance, waiver of trial and plea of guilty that appears
45 on the summons and deliver the summons and a check or money order in the amount of the base fine

1 set forth in the summons to the court. The defendant may attach a statement of matters in expla-
2 nation or mitigation of the violation.

3 “[3] (4) The court may require that a defendant requesting a trial under subsection [(2)(a)]
4 (3)(a) of this section deposit the base fine specified under ORS 153.125 to 153.145 or such other
5 amount as the court determines appropriate if the defendant has failed to appear in any court on
6 one or more other charges in the past. If the defendant does not deposit the amount specified by the
7 court, the defendant must personally appear in court at the time indicated in the summons. The
8 amount deposited by the defendant may be applied against any fine imposed by the court, and any
9 amount not so applied shall be refunded to the defendant at the conclusion of the proceedings.

10 “[4] (5) If the defendant personally appears in court at the time indicated in the summons and
11 enters a plea of guilty, the judge shall consider any statement in explanation or mitigation made by
12 the defendant.

13 “[5] (6) The court may require a defendant to appear personally in any case, or may require
14 that all defendants appear in specified categories of cases.

15 “[6] (7) If a defendant has entered a no contest plea or guilty plea in the manner provided in
16 subsection [(2)(b) or (c)] (3)(b) or (c) of this section, and the court determines that the base fine
17 amount is not adequate by reason of previous convictions of the defendant, the nature of the offense
18 charged or other circumstances, the court may require that a trial be held unless an additional fine
19 amount is paid by the defendant before a specified date. Notice of an additional fine amount under
20 this subsection may be given to the defendant by mail. In no event may the court require a total fine
21 amount in excess of the maximum fine established for the violation by statute.

22 “[7] (8) If a defendant fails to make a first appearance on a citation for a traffic violation, as
23 defined by ORS 801.557, fails to make a first appearance on a citation for a violation of ORS 471.430,
24 or fails to appear at any other subsequent time set for trial or other appearance, the driving privi-
25 leges of the defendant are subject to suspension under ORS 809.220.

26 “**SECTION 6.** ORS 41.905 is amended to read:

27 “41.905. (1) A judgment of conviction or acquittal of a person charged with a traffic offense is
28 not admissible in the trial of a subsequent civil action arising out of the same accident or occur-
29 rence to prove or negate the facts upon which such judgment was rendered.

30 “(2) A plea of guilty by a person to a traffic offense may be admitted as evidence in the trial
31 of a subsequent civil action arising out of the same accident or occurrence as an admission of the
32 person entering the plea, and for no other purpose.

33 “(3) Evidence that a person has entered a plea of no contest in the manner described in ORS
34 153.061 [(2)(b)] (3)(b) to a charge of a traffic offense shall not be admitted as evidence in the trial
35 of a subsequent civil action arising out of the same accident or occurrence.

36 “**SECTION 7.** ORS 153.090 is amended to read:

37 “153.090. (1) Judgments entered under this chapter may include:

38 “(a) Imposition of a sentence to pay a fine;

39 “(b) Costs, assessments and restitution authorized by law;

40 “(c) A requirement that the fine, costs, assessments and restitution, if any, be paid out of any
41 base fine;

42 “(d) Remission of any balance of a base fine to the defendant or to any other person designated
43 by the defendant; and

44 “(e) Any other provision authorized by law.

45 “(2) Notwithstanding ORS 137.106, if the court orders restitution in a default judgment entered

1 under ORS 153.102, a defendant may allege an inability to pay the full amount of monetary sanctions
2 imposed, including restitution, and request a hearing to determine whether the defendant is unable
3 to pay or to establish a payment schedule by filing a written request with the court within one year
4 after the entry of the judgment. The court shall set a hearing on the issue of the defendant's ability
5 to pay upon receipt of the request and shall give notice to the district attorney. The district attor-
6 ney shall give notice to the victim of the date, time and place of the hearing. The court may deter-
7 mine a payment schedule for monetary sanctions imposed, including restitution ordered under this
8 subsection, if the defendant establishes at the hearing that the defendant is unable to pay the or-
9 dered restitution in full.

10 “(3) If a trial is held in a violation proceeding, or a default judgment is entered against the de-
11 fendant under ORS 153.102, the court may impose any fine within the statutory limits for the vio-
12 lation. If a defendant pleads no contest under ORS 153.061 [(2)(b)] **(3)(b)**, or pleads guilty under ORS
13 153.061 [(2)(c)] **(3)(c)**, and the court accepts the plea and enters judgment against the defendant, the
14 amount of the fine imposed against the defendant by the court may not exceed the amount of the
15 base fine established for the violation under ORS 153.125 to 153.145.

16 “(4) A judge may suspend operation of any part of a judgment entered under this chapter upon
17 condition that the defendant pay the nonsuspended portion of a fine within a specified period of
18 time. If the defendant fails to pay the nonsuspended portion of the fine within the specified period
19 of time, the suspended portion of the judgment becomes operative without further proceedings by the
20 court and the suspended portion of the fine becomes immediately due and payable.

21 “(5) The court may not recommend a suspension of the defendant's driving privileges unless a
22 trial has been required. The failure of the defendant to appear at the trial does not prevent the
23 court from recommending suspension of the defendant's driving privileges.

24 “(6) Entry of a default judgment under ORS 153.102 does not preclude the arrest and prosecution
25 of the defendant for the crime of failure to appear in a violation proceeding under ORS 153.992.

26 “(7) If a person holds a commercial driver license, a court may not defer entry of a judgment
27 or allow an individual to enter into a diversion program that would prevent a conviction for a traffic
28 offense from appearing on the driving record of the holder. This subsection applies to all traffic of-
29 fenses, whether committed while driving a motor vehicle or a commercial motor vehicle, but does
30 not apply to parking violations.

31 “**SECTION 8.** ORS 153.099 is amended to read:

32 “153.099. (1) If a trial is held in a violation proceeding, the court shall enter a judgment based
33 on the evidence presented at the trial.

34 “(2) If the defendant appears and enters a plea of no contest in the manner described in ORS
35 153.061 [(2)(b)] **(3)(b)**, and a trial is not otherwise required by the court or by law, the court shall
36 make a decision based on the citation, the statement filed by the defendant and any other informa-
37 tion or materials submitted to the court.

38 “(3) If the defendant enters a plea of guilty in the manner described in ORS 153.061 [(2)(c)]
39 **(3)(c)**, a trial is not otherwise required by the court or by law and the court accepts the plea of
40 guilty, judgment shall be entered against the defendant based on the violation citation.”.
