

House Bill 3332

Sponsored by Representative GELSER; Representatives BARKER, BONAMICI (at the request of Officer Pete Dunn)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates crime of possession of property with obscured identification number. Punishes by maximum of one year's imprisonment, \$6,250 fine, or both.

2 Relating to crime; creating new provisions; and amending ORS 131.602.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Section 2 of this 2007 Act is added to and made a part of ORS 164.015 to**
5 **164.135.**

6 **SECTION 2. (1) A person commits the crime of possession of property with an obscured**
7 **identification number if the person, with the intent to conceal or misrepresent the identity**
8 **of the property, possesses tangible personal property that has an obscured identification**
9 **number.**

10 **(2) Possession of property with an obscured identification number is a Class A**
11 **misdemeanor.**

12 **(3) As used in this section:**

13 **(a) "Identification number" means the manufacturer's serial number or any other dis-**
14 **tinguishing identification number or mark created by a manufacturer to identify the prop-**
15 **erty.**

16 **(b) "Obscured" means removed, concealed, defaced, altered, destroyed or otherwise ren-**
17 **dered unidentifiable.**
