SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Adds member of order Crocodylia to definition of exotic animal. Prohibits breeding of exotic animals **except for small exotic felines**. Exempts certain organizations, institutions and facilities **from permit requirement or from prohibition against [possession] breeding** of exotic animal. *[Imposes fee for exotic animal permit. Allows temporary authorization to possess offspring of exotic animal. Allows permit for possession of animal of order Crocodylia under certain circumstances.]*

Allows possession of exotic animal if person applies for permit by certain date or possessed permit on certain date. Allows State Department of Agriculture to charge fee for permit.

[Declares emergency, effective on passage.]

2 Relating to exotic animals; creating new provisions; and amending ORS 609.305, 609.309, 609.312,
3 609.315, 609.319 and 609.335.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 609.305 is amended to read:

6 609.305. As used in ORS 609.305 to 609.335 and 609.992[.];

7 (1) "Exotic animal" means:

8 [(1)] (a) Any member of the family Felidae not indigenous to Oregon, except the species *Felis*
9 *catus* (domestic cat);

10 [(2)] (b) Any nonhuman primate;

11 [(3)] (c) Any wolf (*Canis lupus*);

12 [(4)] (d) Any nonwolf member of the family Canidae not indigenous to Oregon, except the species
13 *Canis familiaris* (domestic dog); *[and]*

14 [(5)] (e) Any bear, except the black bear (*Ursus americanus*)[.]; **and**

15 (f) **Any member of the order Crocodylia.**

16 (2) "Wildlife sanctuary":

17 (a) **Means a nonprofit organization described in section 501(c)(3) of the Internal Revenue**
18 **Code that operates a place of refuge where an abused, neglected, unwanted, impounded,**
19 **abandoned, orphaned or displaced exotic animal is provided care for the animal's lifetime or**
20 **until released into the wild.**

21 (b) **Does not mean an organization that:**

22 (A) **Involves an exotic animal in an activity that is not inherent to the animal's nature;**

23 (B) **Uses exotic animals as a type of entertainment;**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (C) Sells, trades or barter exotic animals or exotic animal body parts; or

2 (D) Breeds exotic animals.

3 **SECTION 2.** ORS 609.309 is amended to read:

4 609.309. It is the policy of this state [*that the keeping of exotic animals be regulated so as*] to
5 **protect the public against health and safety risks that exotic animals pose to the community,**
6 ensure the health, welfare and safety of [*those*] **exotic animals** and [*to*] ensure the security of facil-
7 ities in which [*they*] **exotic animals** are kept, so as to avoid undue physical or financial risk to the
8 public. [*It is the policy of this state that regulation place no more burden upon the keepers of exotic*
9 *animals than is required to accomplish the purposes expressed in this section.*]

10 **SECTION 3.** ORS 609.312 is amended to read:

11 609.312. A person who sells an exotic animal must, prior to accepting the offer to purchase,
12 provide the prospective purchaser of the animal with informational material approved by the State
13 Department of Agriculture regarding the care, husbandry, health and nutritional needs of the ani-
14 mal. **This section does not allow the sale of an exotic animal to a person located in this state**
15 **other than an entity described in ORS 609.315.**

16 **SECTION 4.** ORS 609.315 is amended to read:

17 609.315. The requirements for a permit in ORS 609.319 and 609.335 [*shall*] **do not apply to the**
18 **following:**

19 (1) A wildlife rehabilitation center operated under a valid permit issued by the State Fish and
20 Wildlife Commission pursuant to ORS 497.308. [*or*]

21 (2) A facility operated under a valid license or **research facility** registration issued by the
22 United States Department of Agriculture pursuant to the federal Animal Welfare Act of 1970 (7
23 U.S.C. 2133 or 2136).

24 (3) **An exotic animal protection organization incorporated under ORS chapter 65 that**
25 **houses an exotic animal at the written request of state or local government.**

26 (4) **A law enforcement agency.**

27 (5) **A licensed veterinary hospital or clinic.**

28 (6) **A wildlife sanctuary.**

29 (7) **An educational facility that houses a member of the order Crocodylia pursuant to a**
30 **written request of the state, a local government or a state agency stating the need to house**
31 **a member of the order Crocodylia at the educational facility.**

32 **SECTION 5.** ORS 609.319 is amended to read:

33 609.319. (1) [*No*] **A person may not keep an exotic animal in this state unless, *before acquiring*
34 *the animal,* the person possesses a valid State Department of Agriculture permit for that animal
35 [*issued pursuant to ORS 609.335. No*] **issued prior to the effective date of this 2007 Act or issued**
36 **as provided in section 7 of this 2007 Act.****

37 (2) **Except as provided in subsection (4) of this section, a person keeping an exotic animal**
38 **in this state may not breed the exotic animal.**

39 (3) **A person may not keep an exotic animal in this state for more than 30 days after the expi-**
40 **ration, revocation or suspension of a permit.**

41 (4) **A person may breed a small exotic feline (family Felidae) if the person:**

42 (a) **Is exempt from the requirements for a permit under ORS 609.315; or**

43 (b) **Breeds a small exotic feline with a member of the species Felis catus (domestic cat),**
44 **and:**

45 (A) **The person has a permit issued by the State Department of Agriculture under section**

1 **7 of this 2007 Act; and**

2 **(B) The person provides written documentation, including the person’s business license,**
3 **that the person bred the animals for the purpose of retail sale of the offspring.**

4 **(5) As used in this section, “small exotic feline” means a member of the family Felidae,**
5 **except the species Felis catus (domestic cat), that weighs 50 pounds or less when fully ma-**
6 **ture.**

7 **SECTION 6.** ORS 609.335 is amended to read:

8 609.335. *[(1) The State Department of Agriculture shall issue permits for the keeping of exotic an-*
9 *imals, as defined in ORS 609.305.]*

10 *[(2)]* **(1) The [department] State Department of Agriculture** shall adopt reasonable rules for
11 issuing permits to keep exotic animals and establishing conditions thereof. The conditions shall be
12 directed toward ensuring the health, welfare and safety of the animals and, where necessary, the
13 security of facilities in which the animals are kept so as to avoid undue physical or financial risk
14 to the public. The rules shall be no more restrictive upon keepers of exotic animals than is reason-
15 ably necessary to carry out *[subsection (1) of this section and]* the purposes of ORS 609.309.

16 *[(3) A separate permit shall be required for each species of exotic animal kept. A permit shall be*
17 *valid for a period of two years from the date of issue and may be renewed.]*

18 *[(4) The department may charge a fee for the issuance and renewal of permits under this section.*
19 *The fee shall not exceed \$300 for each issuance and \$100 for each renewal.]*

20 *[(5)]* **(2) The department may revoke a permit upon finding a violation of rules adopted under**
21 **this section, or the department may issue a finding of violation and a warning to remedy the vio-**
22 **lation by a specified date.**

23 **SECTION 7.** **(1) As used in this section, “exotic animal” has the meaning given that term**
24 **in ORS 609.305.**

25 **(2) The State Department of Agriculture may issue a permit to a person to keep an exotic**
26 **animal if the person applies for the permit within 90 days after the effective date of this 2007**
27 **Act.**

28 **(3) The department may, within one year of the effective date of this 2007 Act, issue a**
29 **permit to a person to possess an exotic animal if the person submits satisfactory proof to**
30 **the department that the person possessed the animal prior to the effective date of this 2007**
31 **Act and that the person meets requirements of rules adopted by the department as provided**
32 **in ORS 609.335.**

33 **(4) The department may charge a fee to issue or renew a permit under this section. The**
34 **fee may not exceed \$100. Each permit or renewal of a permit is valid for two years.**
