

House Bill 3515

Sponsored by Representatives ROBLAN, SHIELDS, GELSER, MACPHERSON; Representatives BARKER, BARNHART, COWAN, C EDWARDS, GALIZIO, HUNT

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates crime of online sexual corruption of child in second degree. Punishes by maximum of five years' imprisonment, \$125,000 fine, or both.

Creates crime of online sexual corruption of child in first degree. Punishes by maximum of 10 years' imprisonment, \$250,000 fine, or both.

Requires person convicted of online sexual corruption of child in any degree to report as sex offender and authorizes seizure of instrumentalities of crime.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Sections 2 to 4 of this 2007 Act are added to and made a part of ORS 163.305**
5 **to 163.467.**

6 **SECTION 2. (1) A person commits the crime of online sexual corruption of a child in the**
7 **second degree if the person is more than 21 years of age and, for the purpose of arousing**
8 **or gratifying the sexual desire of the person or another, knowingly uses an online commu-**
9 **nication to:**

10 (a) **Solicit a child to engage in sexual contact or sexually explicit conduct; or**

11 (b) **Subject a child to an explicit verbal description or narrative account of sexual contact**
12 **or sexually explicit conduct.**

13 (2) **Online sexual corruption of a child in the second degree is a Class C felony.**

14 **SECTION 3. (1) A person commits the crime of online sexual corruption of a child in the**
15 **first degree if the person violates section 2 of this 2007 Act and:**

16 (a) **Offers or agrees to physically meet with the child; or**

17 (b) **Takes a substantial step toward physically meeting with the child.**

18 (2) **Online sexual corruption in the first degree is a Class B felony.**

19 **SECTION 4. (1) As used in sections 2 and 3 of this 2007 Act:**

20 (a) **"Child" means a person:**

21 (A) **Who represents the person as being less than 16 years of age; or**

22 (B) **Whom the defendant reasonably believes to be less than 16 years of age.**

23 (b) **"Online communication" means communication that occurs via electronic mail, per-**
24 **sonal or instant messaging, chat rooms, bulletin boards or any other method of communi-**
25 **cating over the Internet.**

26 (c) **"Sexual contact" has the meaning given that term in ORS 163.305.**

27 (d) **"Sexually explicit conduct" has the meaning given that term in ORS 163.665.**

28 (e) **"Solicit" means to seduce, lure, entice, persuade, prevail upon, coax, coerce or at-**

1 **tempt to do so.**

2 **(2) It is not a defense to a prosecution for online sexual corruption of a child in the first**
 3 **or second degree that the person was in fact communicating with a law enforcement officer,**
 4 **as defined in ORS 163.730, or a person working under the direction of a law enforcement of-**
 5 **ficer, who is more than 16 years of age.**

6 **(3) Online sexual corruption of a child in the first or second degree is committed in either**
 7 **the county in which the communication originated or the county in which the communi-**
 8 **cation was received.**

9 **SECTION 5.** ORS 181.594 is amended to read:

33 (L) Kidnapping in the first degree if the victim was under 18 years of age;

35 (n) Sexual misconduct if the offender is at least 18 years of age;

1 (5) "Sex offender" means a person who:

2 (a) Has been convicted of a sex crime;

3 (b) Has been found guilty except for insanity of a sex crime;

4 (c) Has been found to be within the jurisdiction of the juvenile court for having committed an
5 act that if committed by an adult would constitute a sex crime; or

6 (d) Is paroled to this state under ORS 144.610 after being convicted in another jurisdiction of a
7 crime that would constitute a sex crime if committed in this state.

8 (6) "Works" or "carries on a vocation" means full-time or part-time employment for more than
9 14 days within one calendar year whether financially compensated, volunteered or for the purpose
10 of governmental or educational benefit.

5 (b) The Teacher Standards and Practices Commission may refuse to issue a license or registra-
6 tion to any person who has been convicted of a crime involving the illegal use, sale or possession

9 follow the procedure set forth in ORS 342.176 and 342.177.
