SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Appropriates moneys from General Fund to State Department of Agriculture for certain biennial expenses.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and certain federal funds, but excluding lottery funds and other federal funds, collected or received by department.

Limits biennial expenditures by department from lottery moneys.

Limits biennial expenditures by department from federal funds.

Declares emergency, effective July 1, 2007.

SECTION 4. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2007, as the maximum limits for payment of expenses from federal funds other than those described in section 2 of this 2007 Act collected or received by the State Department of Agriculture, for the following purposes:

- (1) Food Safety...... \$ 343,761
- (2) Natural Resources \$ 4,020,984
- 8 (3) Agricultural Development...... \$ 162,570

SECTION 5. Notwithstanding any other law limiting expenditures, the amount of \$35,190 is established for the biennium beginning July 1, 2007, as the maximum limit for payment of expenses from lottery moneys allocated from the Administrative Services Economic Development Fund to the State Department of Agriculture for deposit in the County Fair Account established by ORS 565.445, to support county fairs.

SECTION 6. This 2007 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect July 1, 2007.
