SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Department of State Lands for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department for certain purposes.

Limits biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2007.

A BILL FOR AN ACT

Relating to financial administration of the Department of State Lands; appropriating money; limiting expenditures; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There are appropriated to the Department of State Lands, for the biennium beginning July 1, 2007, out of the General Fund, the following amounts for the following purposes:

- (1) **Natural Heritage Advisory Council**..... \$ 25,452
- (2) **Common School Fund programs**..... \$ 196,325

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2007, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Department of State Lands, for the following purposes:

- (1) **Natural Heritage Advisory Council**..... \$ 1,382
- (2) **South Slough National Estuarine Research Reserve operations**..... \$ 1,764,963
- (3) **Common School Fund programs**..... \$ 34,867,702
- (4) **Capital improvements**..... \$ 636,129

4 **SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts**
 5 **are established for the biennium beginning July 1, 2007, as the maximum limits for payment**
 6 **of expenses from federal funds collected or received by the Department of State Lands, for**
 7 **the following purposes:**

- 8 **(1) Natural Heritage Advisory**
- 9 **Council..... \$ 130,166**
- 10 **(2) South Slough National**
- 11 **Estuarine Research**
- 12 **Reserve operations..... \$ 2,501,974**
- 13 **(3) Common School Fund**
- 14 **programs..... \$ 1,309,094**

15 **SECTION 4. For the biennium beginning July 1, 2007, expenditures by the Department**
 16 **of State Lands for unclaimed property finders fees and State Treasurer charges for**
 17 **investment-related transactions are not limited.**

18 **SECTION 5. This 2007 Act being necessary for the immediate preservation of the public**
 19 **peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect**
 20 **July 1, 2007.**
