## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

## Establishes deadlines for completion of consideration of legislative measures. CONCURRENT RESOLUTION 1 2 Whereas it is of paramount importance to establish deadlines for the consideration of measures 3 during the regular session of the Seventy-fourth Legislative Assembly; now, therefore, Be It Resolved by the Legislative Assembly of the State of Oregon: 4 (1) The Senate and the House of Representatives shall adhere to the following schedule and 5 6 deadlines for the regular session of the Seventy-fourth Legislative Assembly: 7 (a) The Senate and the House of Representatives shall convene in regular session on January 8 8, 2007. 9 (b) The Senate and the House of Representatives shall convene their respective floor sessions one day each week from \_\_\_\_\_, 2007, through \_\_\_\_\_, 2007. 10 (c) Members and committees shall submit requests for drafts of measures to the Office of the 11 12 Legislative Counsel on or before\_\_\_\_\_, 2007. 3 (3) The Seventy-fourth Legislative Assembly declares that an emergency exists and will continue
4 through January 2008, and the members agree as follows:

5 (a) In \_\_\_\_\_ 2008, the presiding officers shall provide notice to the Legislative Adminis-6 trator of the intent to invoke ORS 171.015 (1).

7 (b) The Legislative Administrator shall follow the special session protocol set forth in ORS8 171.015.

9 (c) Upon receipt of the notice described in ORS 171.015 (1), the presiding officers shall invoke 10 the provisions of section 10a, Article IV of the Oregon Constitution.

(d) Upon convening the 2008 special session, the presiding officers shall ensure that the 2008 special session adjourns sine die not more than 40 calendar days after the special session convenes and that the special session is limited to consideration of the most pressing fiscal and policy issues.
