

House Concurrent Resolution 6

Sponsored by Representative NOLAN, Senator BURDICK; Senator BROWN

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

In memoriam: Doreen Margolin, 1947-2007.

2 Whereas Doreen Margolin was born in New York in 1947 and moved to Oregon in 1971, where
3 she worked as a computer programmer for the State of Oregon and Portland State University until
4 she enrolled in Lewis & Clark Law School; and

5 Whereas Doreen Margolin began her law practice in Portland in 1981, specializing in family law
6 and serving her profession as chair of the Multnomah Bar Association Continuing Education and
7 Judicial Selection Committees, as chair of the Oregon State Bar Professional Liability Fund, as chair
8 of the Lewis & Clark Law School Alumni Association and as a judge pro tempore in the state circuit
9 court; and

10 Whereas Doreen Margolin expressed her passion and commitment to public higher education in
11 Oregon through many years of service to Portland Community College and to the community college
12 ideal; and

13 Whereas Doreen Margolin was a member and chair of the Portland Community College Foun-
14 dation Board of Trustees from 1986 to 1996 and was elected to the Portland Community College
15 Board of Directors in 1999 where, at the time of her death, she was board chair; and

16 Whereas Doreen Margolin served in a leadership role on the boards of directors of the Associ-
17 ation of Community College Trustees and the Oregon Community College Association, and was
18 honored for her work on behalf of community colleges and their students with the Howard Cherry
19 Award as Oregon's outstanding college board member; and

20 Whereas Doreen Margolin was devoted to making Oregon a better place for all Oregonians, but
21 especially for those who were disadvantaged and, through higher education, wished to participate
22 more fully in the American and the Oregon dream; and

23 Whereas Doreen Margolin passed away on January 8, 2007, leaving her husband Phil Margolin,
24 her children Dan and Ami, and her parents; now, therefore,

Be It Resolved by the Legislative Assembly of the State of Oregon:

25 That we, the members of the Seventy-fourth Legislative Assembly, recognize and express our
26 appreciation for Doreen Margolin's outstanding service and numerous achievements throughout her
27 life on behalf of community colleges, the disadvantaged, and the people and the State of Oregon.
