

A-Engrossed Senate Bill 10

Ordered by the Senate April 5
Including Senate Amendments dated April 5

Sponsored by Senators BROWN, COURTNEY (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Oregon Government Standards and Practices Commission to charge public bodies [*amount based on number of public officials serving public body*], **special government bodies, local governments and local service districts specified amounts** for purposes of funding activities of commission.

[Requires] **Increases amount of reportable lobbying expenditures. Requires, on January 1, 2010,** quarterly online filing of expenditure statements by lobbyists and persons on whose behalf lobbyist was registered. Directs commission to allow public access to statements using Internet.

Increases amount of civil penalties that may be imposed for violation of lobbying or government ethics law from \$1,000 to \$5,000. Prohibits candidate from using political contributions to pay criminal or civil penalties. Exempts civil penalties [*imposed under election laws*] **related to or arising from course and scope of duties of public official.**

Prohibits former member of Legislative Assembly from being compensated lobbyist during period beginning on date person ceases being member and ending on date of adjournment sine die of next regular legislative session.

Prohibits public official from receiving in calendar year gifts with value exceeding \$50 from source with legislative or administrative interest.

Allows public official to receive items exempted from definition of gift from person with legislative or administrative interest. Allows public official to receive gift from source that does not have legislative or administrative interest in governmental agency in which official has official position.

Exempts judges or public officials serving judicial department from gift limits.

Modifies required contents of statement of economic interest.

Requires public officials and candidates to file quarterly statements with commission listing gifts with value exceeding \$15 received from person with legislative or administrative interest, expenses received when participating in an official meeting, honoraria exceeding \$15 and each source of income exceeding aggregate amount of \$1,000 from source that does business with or has legislative or administrative interest in governmental agency served by public official or candidate.

Requires person with legislative or administrative interest who gives gift with value exceeding \$15 to public official, pays expenses of official meeting or provides honoraria to report to commission and to notify recipient of value. Sets schedule for filing reports. Prescribes content of reports.

Prohibits public officials and candidates for public office from receiving honoraria in connection with official duties. Exempts honoraria or other items with value of \$50 or less.

Authorizes public official to establish legal expense trust fund to defray legal expenses incurred by public official in defending public official in legal proceeding relating to or arising from status of person as public official. Requires approval by Oregon Government Standards and Practices Commission.

Prohibits personal use of legal expense trust fund proceeds. Prohibits public official from soliciting contributions to trust fund. Directs trustee of trust fund to file with commission quarterly reports of contributions received and expenditures made.

Declares emergency, effective on passage.

COMMISSION FUNDING

SECTION 1. Section 2 of this 2007 Act is added to and made a part of ORS chapter 244.

SECTION 2. (1) The Oregon Government Standards and Practices Commission shall estimate in advance the expenses that it will incur during the biennium in carrying out the provisions of ORS 171.725 to 171.785 and 171.992 and this chapter.

(2)(a) The commission shall charge each public body as defined in ORS 174.109 for the public body's share of the expenses described in subsection (1) of this section for the biennium.

(b) For public bodies in state government as defined in ORS 174.111, and special government bodies as defined in ORS 174.117 that are not subject to the Municipal Audit Law, the commission shall set the charges at a rate that is not less than \$_____ and not more than \$_____ per public official serving the public body or special government body against which the fee is charged. The commission shall charge each public body in state government and special government body the same rate.

(c) For local governments and local service districts as defined in ORS 174.116, and special government bodies as defined in ORS 174.117 that are subject to the Municipal Audit Law, the commission shall set the charges at a rate equal to _____ percent of the annual municipal audit filing fee paid by the local government, local service district or special government body under ORS 297.485. If a local government, local service district or special government body is not required to file an audit report, the commission shall set the charge for that local government, local service district or special government body at a rate equal to _____ percent of the annual municipal audit filing fee that would apply under ORS 297.485 if the local government, local service district or special government body were required to file an audit report.

(3) Each public body shall pay to the credit of the commission the charge described in this section as an administrative expense from funds or appropriations available to it in the same manner as other claims against the public body are paid.

(4) All moneys received by the commission under this section shall be credited to the Oregon Government Standards and Practices Commission Account established under ORS 244.345.

(5) The commission shall adopt rules specifying the methods for calculating and collecting the charges described in this section.

(6) Beginning on July 1, 2011, the commission shall adjust the dollar range specified in subsection (2) of this section annually based upon the change in the Portland-Salem, OR-WA, Consumer Price Index for All Urban Consumers for All Items, as published by the Bureau of Labor Statistics of the United States Department of Labor or its successor during the preceding 12-month period. The commission shall round the amount determined under this subsection to the nearest dollar.

(7) Notwithstanding ORS 244.020 (13), as used in this section, "public official" means any person who, on the date the commission charges the public body under this section, is serving the public body as an officer, employee, agent or otherwise, irrespective of whether the person is compensated for the services.

SECTION 3. The Oregon Government Standards and Practices Commission shall first impose charges under section 2 of this 2007 Act for the biennium beginning July 1, 2009.

REPORTING REQUIREMENTS

SECTION 4. Section 5 of this 2007 Act is added to and made a part of ORS 171.725 to 171.785.

SECTION 5. Statements required to be filed with the Oregon Government Standards and Practices Commission under ORS 171.745 and 171.750 shall be filed in each calendar year:

(1) Not later than April 15, for the accounting period beginning January 1 and ending March 31;

(2) Not later than July 15, for the accounting period beginning April 1 and ending June 30;

(3) Not later than October 15, for the accounting period beginning July 1 and ending September 30; and

(4) Not later than January 7 of the following calendar year, for the accounting period beginning October 1 and ending December 31.

SECTION 6. ORS 171.745 is amended to read:

171.745. (1) A lobbyist registered with the Oregon Government Standards and Practices Commission or required to register with the commission shall, *[on January 31 and July 31, of each even-numbered year, and on January 31, April 30 and July 31 of each odd-numbered year]* **according to the schedule described in section 5 of this 2007 Act**, file with the commission a statement showing **for the applicable reporting period**:

(a) The total amount of all moneys expended by the lobbyist for the purpose of lobbying *[in the preceding reporting period]* for:

(A) Food, refreshments and entertainment;

(B) Printing, postage and telephone;

(C) Advertising, public relations, education and research; and

(D) Miscellaneous; and

[(b) The name of any legislative or executive official to whom or for whose benefit, on any one occasion, an expenditure in excess of \$25 is made for the purposes of lobbying, and the date, name of payee, purpose and amount of that expenditure.]

(b) The name of any legislative or executive official to whom or for whose benefit, on any one occasion, an expenditure is made for the purposes of lobbying, and the date, name of payee, purpose and amount of that expenditure. This paragraph applies if the total amount expended on the occasion by one or more persons exceeds \$50.

(2) Beginning on July 1, *[1979]* **2009**, the dollar amount specified in subsection (1)(b) of this section shall be adjusted annually by the commission based upon the change in the Portland Consumer Price Index for All Urban Consumers for All Items as prepared by the Bureau of Labor Statistics of the United States Department of Labor or its successor during the preceding 12-month period. The amount determined under this subsection shall be rounded to the nearest dollar.

(3) Statements required by this section need not include amounts expended by the lobbyist for personal living and travel expenses and office overhead, including salaries and wages paid for staff and secretarial assistance, and maintenance expenses. If the amount of any expenditure required to be included in a statement is not accurately known at the time the statement is required to be filed, an estimate of the expenditure shall be submitted in the statement and designated as an estimate. The exact amount expended for which a previous estimate was made shall be submitted in a subsequent report when the information is available.

1 (4) Notwithstanding ORS 171.735, 171.740 and subsections (1) to (3) of this section, a registered
2 lobbyist, who engages in lobbying activities without compensation on behalf of an organization is
3 not required to register as a lobbyist for the organization as long as the lobbying activity does not
4 exceed the financial or time limits set in ORS 171.735 (4).

5 (5) A statement required by this section shall include a copy of any notice provided to a public
6 official under ORS 244.100 [(3)] (2).

7 (6) For each statement required by this section, an entity comprised of more than one lobbyist
8 may file one statement that reports expenditures by the entity and not by individual lobbyists.

9 **SECTION 7.** ORS 171.750 is amended to read:

10 171.750. (1) Any person on whose behalf a lobbyist was registered, or was required to register,
11 with the Oregon Government Standards and Practices Commission at any time during the

24 **total amount expended on the occasion by one or more persons exceeds \$50. This paragraph**
25 **does not apply to information reported in compliance with ORS 171.745.**

26 (2) Using July 1, [1979] **2009**, as the base, the dollar amount specified in subsection (1)(b) of this
27 section shall be adjusted annually by the commission based upon the change in the Portland Con-
28 sumer Price Index for All Urban Consumers for All Items as prepared by the Bureau of Labor Sta-
29 tistics of the United States Department of Labor, or its successor, during the preceding 12-month
30 period. The amount determined under this subsection shall be rounded to the nearest dollar.

31 (3) A statement required under subsection (1) of this section shall include a copy of any notice
32 provided to a public official under ORS 244.100 [(3)] (2).

43 son acting in a capacity as a public official, the effect of which would be to the private pecuniary
44 benefit or detriment of the person or the person's relative or any business with which the person
45 or a relative of the person is associated unless the pecuniary benefit or detriment arises out of cir-

1 cumstances described in subsection [(14)] (11) of this section.

2 (2) "Business" means any corporation, partnership, proprietorship, firm, enterprise, franchise,
3 association, organization, self-employed individual and any other legal entity operated for economic
4 gain but excluding any income-producing not-for-profit corporation that is tax exempt under section
5 501(c) of the Internal Revenue Code with which a public official or a relative of the public official
6 is associated only as a member or board director or in a nonremunerative capacity.

7 (3) "Business with which the person is associated" means:

8 (a) Any private business or closely held corporation of which the person or the person's relative
9 is a director, officer, owner or employee, or agent or any private business or closely held corpo-
10 ration in which the person or the person's relative owns or has owned stock, another form of equity
11 interest, stock options or debt instruments worth \$1,000 or more at any point in the preceding cal-
12 endar year;

40 (D) An unsolicited token or award of appreciation in the form of a plaque, trophy, desk
41 item, wall memento or similar item.

42 (E) Unsolicited informational material, publications or subscriptions related to the re-

44 (F) Admission provided to or the cost of food or beverage consumed by a public official,
45 or a member of the household or staff of the public official when accompanying the public

1 official, at a reception, meal or meeting held by an organization before whom the public of-
2 ficial appears to speak or to answer questions as part of a scheduled program.

3 (G) Reasonable expenses paid by any unit of the federal government, a state or local
4 government, a Native American Tribe that is recognized by federal law or formally ac-

6 174.109 pays membership dues or a not-for-profit corporation that is tax exempt under sec-

30
31 **SECTION 28.** Sections 29 to 37 of this 2007 Act are added to and made a part of ORS
32 chapter 244.

33 **SECTION 29.** (1) Subject to the authorization of the Oregon Government Standards and
34 Practices Commission as described in section 31 of this 2007 Act, a public official may es-
35 tablish a legal expense trust fund if the public official incurs or reasonably expects to incur
36 legal expenses described in subsection (2) of this section.

37 (2) Proceeds from the trust fund may be used by the public official to defray legal ex-
38 penses incurred by the public official in any civil, criminal or other legal proceeding or in-
39 vestigation that relates to or arises from the course and scope of duties of the person as a
40 public official.

41 (3) Except as provided in subsection (2) of this section, a public official may not use
42 proceeds from the trust fund for any personal use.

43 (4) A public official may not establish or maintain more than one legal expense trust fund
44 at any one time.

45 (5) A public official who establishes a legal expense trust fund may not solicit, receive

1 or handle any contributions to the fund.

2 (6) The provisions of ORS chapter 130 do not apply to a trust fund established under
3 sections 29 to 37 of this 2007 Act.

4 **SECTION 30.** (1) The proceeds of a legal expense trust fund may be used to:

5 (a) Defray legal expenses described in section 29 of this 2007 Act;

6 (b) Defray costs reasonably incurred in administering the trust fund, including but not
7 limited to costs incident to the solicitation of funds; and

8 (c) Discharge any tax liabilities incurred as a result of the creation, operation or admin-
9 istration of the trust fund.

10 (2) The proceeds of a trust fund may also be used to defray or discharge expenses, costs
11 or liabilities incurred before the fund was established if the expenses, costs or liabilities are
12 related to the legal proceeding for which the fund was established.

13 **SECTION 31.** (1) A public official may apply to establish a legal expense trust fund by
14 filing an application with the Oregon Government Standards and Practices Commission. The
15 application must contain:

16 (a) A copy of an executed trust agreement described in subsection (2) of this section;

17 (b) A sworn affidavit described in subsection (3) of this section signed by the public offi-
18 cial; and

19 (c) A sworn affidavit described in subsection (4) of this section signed by the trustee.

20 (2) The trust agreement must contain the following:

21 (a) A provision incorporating by reference the provisions of sections 29 to 37 of this 2007

30 (4) The affidavit of the trustee must state that the trustee:

32 (b) Consents to administer the trust fund in compliance with sections 29 to 37 of this 2007

34 (5) Upon receiving an application under this section, the commission shall review the
35 trust agreement, the affidavits and any supporting documents or instruments filed to deter-
36 mine whether the application meets the requirements of sections 29 to 37 of this 2007 Act.

39 establish the trust fund.

1 (8) A public official may not establish a legal expense trust fund without receiving prior
2 written authorization of the commission as described in this section.

3 (9) A public official may file an amendment to a trust agreement approved as part of a
4 trust fund under this section. The commission shall approve the amendment if the commis-
5 sion determines the amendment meets the requirements of sections 29 to 37 of this 2007 Act.

6 **SECTION 32.** (1) The trustee of a legal expense trust fund is responsible for:

7 (a) The receipt and deposit of contributions to the trust fund;

8 (b) The authorization of expenditures and disbursements from the trust fund;

9 (c) The filing of quarterly statements required under section 35 of this 2007 Act; and

10 (d) The performance of other tasks incident to the administration of the trust fund.

11 (2) The trustee may not:

12 (a) Be a public official who serves the same public body as the public official who estab-
13 lishes the trust fund;

14 (b) Be a relative of the public official who establishes the trust fund;

15 (c) Be an attorney for the public official in the legal proceeding for which the trust fund
16 is established, or a member, partner, associate or employee of the firm employing the at-
17 torney; or

18 (d) Have a business or employment relationship with the public official who establishes
19 the trust fund.

20 **SECTION 33.** (1) Except as provided in subsection (3) of this section, any person may
21 contribute to a legal expense trust fund established under sections 29 to 37 of this 2007 Act.

22 (2) A person may make contributions of moneys to a legal expense trust fund in unlim-
23 ited amounts. Pro bono legal assistance and other in-kind assistance may also be provided
24 without limit and is considered a contribution subject to the reporting requirements of sec-
25 tion 35 of this 2007 Act.

26 (3) A political committee as defined in ORS 260.005 that is a principal campaign commit-
27 tee may not contribute to a legal expense trust fund.

28 **SECTION 34.** (1) A trustee of a legal expense trust fund shall establish a single exclusive
29 account in a financial institution, as defined in ORS 706.008. The financial institution must
30 be located in this state and must ordinarily conduct business with the general public in this
31 state.

32 (2) The trustee shall maintain the account in the name of the trust fund.

33 (3) All expenditures made by the trustee shall be drawn from the account and:

34 (a) Issued on a check signed by the trustee; or

35 (b) Paid using a debit card or other form of electronic transaction.

36 (4) A contribution received by a trustee shall be deposited into the account not later than
37 seven calendar days after the date the contribution is received. This subsection does not
38 apply to in-kind contributions received.

39 (5) This section does not prohibit the transfer of any amount deposited in the account
40 into a certificate of deposit, stock fund or other investment instrument.

41 (6) The account may not include any public or private moneys or any moneys of any

8 than \$75, and the total amount contributed by that person;

43 the trustee of the fund shall return any moneys remaining in the fund to contributors to the
44 fund on a pro rata basis.

1 of attorney fees, costs or any other money judgment award to or in favor of the public official, amounts awarded shall be distributed in the following order:

2 (a) To pay outstanding legal expenses;

3 (b) To contributors to the trust fund on a pro rata basis; and

4 (c) To the public official or, if required by the trust agreement, to an organization exempt
5 from taxation under section 501(c)(3) of the Internal Revenue Code.

31 (2) Section 24 of this 2007 Act is added to and made a part of ORS chapter 244.

32 **SECTION 40.** (1) Sections 1 to 5, 15a, 15b, 18, 22, 23, 24, 28 and 29 to 37 of this 2007 Act
33 and the amendments to ORS 171.745, 171.750, 171.772, 171.992, 244.020, 244.040, 244.045, 244.050,
34 244.060, 244.070, 244.100, 244.280, 244.290, 244.350, 244.360, 260.407, 293.708, 351.067 and 353.270
35 by sections 6 to 8, 9, 10 to 15, 16, 17, 19 to 21, 25 to 27 and 38 of this 2007 Act become oper-
36 ative January 1, 2008.

37 (2) The Oregon Government Standards and Practices Commission and any other public
38 body as defined in ORS 174.109 may adopt rules or take any other action before the operative
39 date specified in subsection (1) of this section that is necessary to enable the commission or
40 public body to exercise, on or after the operative date specified in subsection (1) of this sec-
41 tion, all the duties, functions and powers conferred on the commission or public body by this
42 2007 Act.

4 (3) Notwithstanding ORS 171.750, as amended by section 7 of this 2007 Act, a person re-
5 quired to file a statement under ORS 171.750 for the calendar year 2007 shall file the state-
6 ment not later than January 31, 2008.

7 (4) The amendments to ORS 171.772 and 244.290 by sections 8 and 9 of this 2007 Act apply
8 to statements required to be filed on or after January 1, 2008.

9 (5) The amendments to ORS 171.992 and 244.350 by sections 10 and 11 of this 2007 Act
10 apply to:

44 **SECTION 44.** (1) Any proceeding, action, prosecution or other business or matter
45 undertaken or commenced before January 1, 2008, by the Oregon Government Standards and

1 Practices Commission under any provision of ORS chapter 244 and still pending on January
2 1, 2008, shall be conducted and completed by the commission in the same manner, under the
3 same terms and conditions and with the same effect as though undertaken, conducted or
4 completed before January 1, 2008.

5 (2) Nothing in this 2007 Act relieves any person of any obligation with respect to any tax,
6 fee, fine, civil penalty or other charge, interest, penalty, forfeiture or other liability, duty or
7 obligation.

8 **SECTION 45.** (1) The amendments to ORS 244.020, 244.050, 244.060 and 244.070 by sections
9 13, 16, 19 and 20 of this 2007 Act apply to statements required to be filed with the Oregon
10 Government Standards and Practices Commission for reporting periods beginning on or after
11 January 1, 2008.

12 (2) Section 23 of this 2007 Act and the amendments to ORS 244.100 by section 21 of this
13 2007 Act apply to statements required to be filed and notices required to be provided for re-
14 porting periods beginning on or after January 1, 2008.

15 **SECTION 46.** The unit captions used in this 2007 Act are provided only for the conven-
16 ience of the reader and do not become part of the statutory law of this state or express any
17 legislative intent in the enactment of this 2007 Act.

18 **SECTION 47.** This 2007 Act being necessary for the immediate preservation of the public
19 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect
20 on its passage.
