## C-Engrossed Senate Bill 10

Ordered by the House June 26

### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Oregon Government Standards and Practices Commission to charge public bodies, special government bodies, local governments and local service districts proportionate amounts for purposes of funding activities of commission.

Increases amount of reportable lobbying expenditures. Requires, on January 1, 2010, quarterly online filing of expenditure statements by lobbyists and persons on whose behalf lobbyist was registered. Directs commission to allow public access to statements using Internet. **Modifies other lobbying laws.**

Increases amount of civil penalties that may be imposed for violation of lobbying or government ethics law from \$1,000 to \$5,000. Prohibits candidate from using political contributions to pay criminal or civil penalties or legal expenses. Exempts civil penalties related to certain election law violations.

Prohibits former member of Legislative Assembly from being compensated lobbyist during period beginning on date person ceases being member and ending on date of adjournment sine die of next regular legislative session.

Prohibits public official from receiving in calendar year gifts with value exceeding \$50 from source with legislative or administrative interest. **Exempts certain items from definition of "gift." Prohibits giving or receipt of entertainment. Sets exceptions.**

Allows public official to receive items exempted from definition of "gift" from person with legislative or administrative interest. Allows public official to receive gift from source that does not have legislative or administrative interest in governmental agency in which official has official position.

Exempts [*judges or public officials serving judicial department*] **public officials subject to Oregon Code of Judicial Conduct** from gift limits.

Modifies required contents of statement of economic interest.

Requires public officials and candidates to file quarterly statements with commission listing expenses received when participating in an official meeting, honoraria exceeding \$15 and each source of income exceeding aggregate amount of \$1,000 from source that does business with or has legislative or administrative interest in governmental agency served by public official or candidate.

Requires person with legislative or administrative interest who pays expenses of official meeting or provides honoraria to report to commission and to notify recipient of value. Sets schedule for filing reports. Prescribes content of reports.

Prohibits public officials and candidates for public office from receiving honoraria in connection with official duties. Exempts honoraria or other items with value of \$50 or less.

Authorizes public official to establish legal expense trust fund to defray legal expenses incurred by public official in **maintaining action related to protective order or** defending public official in legal proceeding relating to or arising from status of person as public official. Requires approval by Oregon Government Standards and Practices Commission.

Prohibits personal use of legal expense trust fund proceeds. Prohibits public official from soliciting contributions to trust fund. Directs trustee of trust fund to file with commission quarterly reports of contributions received and expenditures made.

Declares emergency, effective on passage.

6 **COMMISSION FUNDING**  
7

8 **SECTION 1.** Section 2 of this 2007 Act is added to and made a part of ORS chapter 244.

9 **SECTION 2.** (1) The Oregon Government Standards and Practices Commission shall es-  
10 timate in advance the expenses that it will incur during a biennium in carrying out the pro-  
11 visions of ORS 171.725 to 171.785 and 171.992 and this chapter. The commission shall also  
12 determine what percentage of the expenses should be borne by the following two groups of  
13 public bodies:

14 (a) Public bodies in state government; and

15 (b) Local governments, local service districts and special government bodies that are  
16 subject to the Municipal Audit Law.

17 (2) The commission shall charge each public body for the public body's share of the ex-  
18 penses described in subsection (1) of this section for the biennium. The amount to be charged  
19 each public body shall be determined as follows:

20 (a) The commission shall determine the rate to be charged public bodies in state gov-  
21 ernment. The same rate shall be applied to each public body described in this paragraph. To  
22 determine the amount of the charge for each public body, the commission shall multiply the  
23 rate determined under this paragraph by the number of public officials serving the public  
24 body.

25 (b) The commission shall set the charge for local governments, local service districts and  
26 special government bodies that are subject to the Municipal Audit Law so that each local  
27 government, local service district or special government body described in this paragraph  
28 pays an amount of the total expenses for the group that bears the same proportion to the  
29 total expenses that the amount charged to the local government, local service district or  
30 special government body for the municipal audit fee under ORS 297.485 bears to the total  
31 amount assessed for the municipal audit fee.

32 (3) Each public body shall pay to the credit of the commission the charge described in  
33 this section as an administrative expense from funds or appropriations available to the public  
34 body in the same manner as other claims against the public body are paid.

35 (4) All moneys received by the commission under this section shall be credited to the  
36 Oregon Government Standards and Practices Commission Account established under ORS  
37 244.345.

38 (5) The commission shall adopt rules specifying the methods for calculating and collecting  
39 the rates and charges described in this section.

40 (6) As used in this section:

41 (a) "Local government" and "local service district" have the meanings given those terms  
42 in ORS 174.116.

43 (b) "Public body" has the meaning given that term in ORS 174.109.

44 (c) "Public official," notwithstanding ORS 244.020 (13), means any person who, on the date  
45 the commission charges the public body under this section, is serving the public body as an

2 (d) **“Special government body” has the meaning given that term in ORS 174.117.**

3 (e) **“State government” has the meaning given that term in ORS 174.111.**

4 **SECTION 3. The Oregon Government Standards and Practices Commission shall first**

11 **SECTION 5. Statements required to be filed with the Oregon Government Standards and**  
12 **Practices Commission under ORS 171.745 and 171.750 shall be filed in each calendar year:**

13 (1) **Not later than April 15, for the accounting period beginning January 1 and ending**  
14 **March 31;**

15 (2) **Not later than July 15, for the accounting period beginning April 1 and ending June**  
16 **30;**

17 (3) **Not later than October 15, for the accounting period beginning July 1 and ending**  
18 **September 30; and**

19 (4) **Not later than January 15 of the following calendar year, for the accounting period**  
20 **beginning October 1 and ending December 31.**

25 **anything of value, and includes a contract, promise or agreement, whether or not legally enforcea-**  
26 **ble.**

27 (3) **“Executive agency” means a commission, board, agency or other body in the executive**  
28 **branch of state government that is not part of the legislative or judicial branch.**

29 (4) **“Executive official” means any member or member-elect of an executive agency and any**  
30 **member of the staff or an employee of an executive agency. A member of a state board or commis-**  
31 **sion, other than a member who is employed in full-time public service, is not an executive official**  
32 **for purposes of ORS 171.725 to 171.785.**

33 (5) **“Judge” means an active judge serving on the Oregon Supreme Court, Court of Appeals,**  
34 **Oregon Tax Court, or an Oregon circuit court.**

35 (6) **“Legislative action” means introduction, sponsorship, testimony, debate, voting or any other**  
36 **official action on any measure, resolution, amendment, nomination, appointment, or report, or any**  
37 **matter that may be the subject of action by either house of the Legislative Assembly, or any com-**  
38 **mittee of the Legislative Assembly, or the approval or veto thereof by the Governor.**

39 (7) **“Legislative official” means any member or member-elect of the Legislative Assembly, any**  
40 **member of an agency, board or committee that is part of the legislative branch, and any staff person,**  
41 **assistant or employee thereof.**

42 (8) **“Lobbying” means influencing, or attempting to influence, legislative action through oral or**  
43 **written communication with legislative officials, solicitation of [others] executive officials or other**  
44 **persons to influence or attempt to influence legislative action or attempting to obtain the goodwill**  
45 **of legislative officials.**

1 (9) "Lobbyist" means:

2 (a) Any individual who agrees to provide personal services for money or any other consideration  
3 for the purpose of lobbying.

4 (b) Any person not otherwise subject to paragraph (a) of this subsection who provides personal  
5 services as a representative of a corporation, association, organization or other group, for the pur-  
6 pose of lobbying.

7 (c) Any public official who lobbies.

8 (10) "Public agency" means a commission, board, agency or other governmental body.

9 (11) "Public official" means any member or member-elect of any public agency and any member  
10 of the staff or an employee of the public agency.

11 **SECTION 6a.** ORS 171.730 is amended to read:

12 171.730. The Legislative Assembly finds that, to preserve and maintain the integrity of the leg-  
13 islative process, persons who engage in efforts to [*persuade members of the Legislative Assembly or*  
14 *the executive branch to take specific actions*] **influence legislative action**, either by direct communi-  
15 cation with [*members or employees of the Legislative Assembly or the executive branch*] **legislative**  
16 **officials** or by solicitation of [*others*] **executive officials or other persons** to engage in those ef-  
17 forts, should regularly report their efforts to the public.

42 and Practices Commission by filing with the commission a statement containing the following in-  
43 formation:

44 (a) The name, address and telephone number of the lobbyist.

45 (b) The name, address and telephone number of each person that employs the lobbyist or in

1 whose interest the lobbyist appears or works.

2 (c) A general description of the trade, business, profession or area of endeavor of any person  
3 designated under paragraph (b) of this subsection, and a statement by the person that the lobbyist  
4 is officially authorized to lobby for the person.

12 that employs the lobbyist or in whose interest the lobbyist appears or works.

13 (3) **A lobbyist must file a separate registration statement under this section for each**  
14 **person that employs the lobbyist or in whose interest the lobbyist appears or works.** If a  
15 lobbyist appears **or works** for a person for whom the lobbyist has not registered, the lobbyist shall  
16 register with the commission [*within three working days of the lobbyist's appearance*] **not later than**  
17 **three business days after the day the lobbyist first appears or works for the person.**

18 (4) If any of the information submitted by a lobbyist in the statement required under subsection

44 **one occasion, an expenditure is made for the purposes of lobbying, and the date, name of**  
45 **payee, purpose and amount of that expenditure. This paragraph applies if the total amount**

2 [(2) *Beginning on July 1, 1979, the dollar amount specified in subsection (1)(b) of this section shall*  
3 *be adjusted annually by the commission based upon the change in the Portland Consumer Price Index*  
4 *for All Urban Consumers for All Items as prepared by the Bureau of Labor Statistics of the United*  
5 *States Department of Labor or its successor during the preceding 12-month period. The amount deter-*

21 [of the state] **as defined in ORS 174.109** as an [officer] **elected official, appointed official**, employee,  
22 agent or otherwise, [and] irrespective of whether the person is compensated for [such] **the** services.

23 [(16)] **(14) “Relative”** means [the spouse of the public official, any children of the public official  
24 or of the public official’s spouse, and brothers, sisters or parents of the public official or of the public

11 **LEGAL EXPENSE TRUST FUND**

13 **SECTION 28.** Sections 29 to 37 of this 2007 Act are added to and made a part of ORS  
14 chapter 244.

15 **SECTION 29.** (1) Subject to the authorization of the Oregon Government Standards and  
16 Practices Commission as described in section 31 of this 2007 Act, a public official may es-  
17 tablish a legal expense trust fund if the public official incurs or reasonably expects to incur  
18 legal expenses described in subsection (2) of this section.

19 (2) Proceeds from the trust fund may be used by the public official to defray legal ex-  
20 penses incurred by the public official in any civil, criminal or other legal proceeding or in-  
21 vestigation that relates to or arises from the course and scope of duties of the person as a  
22 public official. The legal expenses must be incurred in connection with:

23 (a) The issuance of a court's stalking protective order under ORS 30.866 or 163.738;

24 (b) The issuance of a citation under ORS 163.735;

25 (c) A criminal prosecution under ORS 163.732;

26 (d) A civil action under ORS 30.866; or

27 (e) Defending the public official in a proceeding or investigation brought or maintained  
28 by a public body as defined in ORS 174.109.

29 (3) Except as provided in subsection (2) of this section, a public official may not use  
30 proceeds from the trust fund for any personal use.

31 (4) A public official may not establish or maintain more than one legal expense trust fund  
32 at any one time.

33 (5) A public official who establishes a legal expense trust fund may not solicit, receive  
34 or handle any contributions to the fund.

35 (6) The provisions of ORS chapter 130 do not apply to a trust fund established under  
36 sections 29 to 37 of this 2007 Act.

37 **SECTION 30.** (1) The proceeds of a legal expense trust fund may be used to:

38 (a) Defray legal expenses described in section 29 of this 2007 Act;

39 (b) Defray costs reasonably incurred in administering the trust fund, including but not  
40 limited to costs incident to the solicitation of funds; and

41 (c) Discharge any tax liabilities incurred as a result of the creation, operation or admin-  
42 istration of the trust fund.

43 (2) The proceeds of a trust fund may also be used to defray or discharge expenses, costs  
44 or liabilities incurred before the fund was established if the expenses, costs or liabilities are  
45 related to the legal proceeding for which the fund was established.

1       **SECTION 31.** (1) A public official may apply to establish a legal expense trust fund by  
2 filing an application with the Oregon Government Standards and Practices Commission. The

35 written authorization of the commission as described in this section.

36       (9) A public official may file an amendment to a trust agreement approved as part of a  
37 trust fund under this section. The commission shall approve the amendment if the commis-  
38 sion determines the amendment meets the requirements of sections 29 to 37 of this 2007 Act.

39       **SECTION 32.** (1) The trustee of a legal expense trust fund is responsible for:

40       (a) The receipt and deposit of contributions to the trust fund;

41       (b) The authorization of expenditures and disbursements from the trust fund;

42       (c) The filing of quarterly statements required under section 35 of this 2007 Act; and

43       (d) The performance of other tasks incident to the administration of the trust fund.

44       (2) The trustee may not:

45       (a) Be a public official who serves the same public body as the public official who estab-

lishes the trust fund;

(b) Be a relative of the public official who establishes the trust fund;

(c) Be an attorney for the public official in the legal proceeding for which the trust fund is established, or a member, partner, associate or employee of the firm employing the attorney; or

(d) Have a business or employment relationship with the public official who establishes the trust fund.

**SECTION 33.** (1) Except as provided in subsection (3) of this section, any person may contribute to a legal expense trust fund established under sections 29 to 37 of this 2007 Act.

(2) A person may make contributions of moneys to a legal expense trust fund in unlimited amounts. Pro bono legal assistance and other in-kind assistance may also be provided without limit and is considered a contribution subject to the reporting requirements of section 35 of this 2007 Act.

(3) A political committee as defined in ORS 260.005 that is a principal campaign committee may not contribute to a legal expense trust fund.

**SECTION 34.** (1) A trustee of a legal expense trust fund shall establish a single exclusive account in a financial institution, as defined in ORS 706.008. The financial institution must be located in this state and must ordinarily conduct business with the general public in this state.

(2) The trustee shall maintain the account in the name of the trust fund.

(3) All expenditures made by the trustee shall be drawn from the account and:

(a) Issued on a check signed by the trustee; or

(b) Paid using a debit card or other form of electronic transaction.

(4) A contribution received by a trustee shall be deposited into the account not later than seven calendar days after the date the contribution is received. This subsection does not apply to in-kind contributions received.

(5) This section does not prohibit the transfer of any amount deposited in the account into a certificate of deposit, stock fund or other investment instrument.

(6) The account may not include any public or private moneys or any moneys of any other person, other than contributions received by the trustee.

(7) A trustee shall retain a copy of each financial institution account statement from the account described in this section for not less than two years after the date the statement is issued by the financial institution.

**SECTION 35.** (1) The trustee of a legal expense trust fund shall, according to the schedule described in subsection (3) of this section, file with the Oregon Government Standards and Practices Commission a statement for the applicable reporting period showing contributions received by the trustee and expenditures made from the trust fund account established under section 34 of this 2007 Act.

(2) Each statement shall list:

(a) The name and address of each person who contributed an aggregate amount of more than \$75, and the total amount contributed by that person;

(b) The total amount of contributions not listed under paragraph (a) of this subsection as a single item, but shall specify how those contributions were obtained;

(c) The amount and purpose of each expenditure and the name and address of each payee; and

1 (d) The name and address of any person contributing pro bono legal assistance and the  
2 fair market value of the assistance provided by the person.

34 of attorney fees, costs or any other money judgment award to or in favor of the public offi-  
35 cial, amounts awarded shall be distributed in the following order:

36 (a) To pay outstanding legal expenses;

38 (c) To the public official or, if required by the trust agreement, to an organization exempt  
39 from taxation under section 501(c)(3) of the Internal Revenue Code.
