SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Requires state and local agencies to conduct tsunami emergency drills. Directs Office of Emergency Management, in consultation with State Department of Geology and Mineral Industries, to adopt rules governing conduct of emergency drills.]

Requires Director of Office of Emergency Management to appoint regional search and rescue coordinators and to adopt rules, after consultation with Oregon State Sheriffs' Association, to implement authority of coordinators.

Appropriates moneys to Office of Emergency Management for payment of costs related to implementation.

A BILL FOR AN ACT

2 Relating to emergency preparedness; amending ORS 401.550; and appropriating money.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 401.550 is amended to read:

5 401.550. **(1)** The Director of the Office of Emergency Management shall appoint a Search and
6 Rescue Coordinator to:

7 [(1)] **(a)** Coordinate the search and rescue function of the Office of Emergency Management;

8 [(2)] **(b)** Coordinate the activities of state and federal agencies involved in search and rescue;

9 [(3)] **(c)** Establish liaison with the Oregon State Sheriffs' Association and other public and pri-
10 vate organizations and agencies involved in search and rescue;

11 [(4)] **(d)** Provide on-scene search and rescue coordination when requested by an authorized per-
12 son;

13 [(5)] **(e)** Coordinate and process requests for the use of emergency service workers and equip-
14 ment;

15 [(6)] **(f)** Assist in developing training and outdoor education programs;

16 [(7)] **(g)** Gather statistics in search and rescue operations; and

17 [(8)] **(h)** Gather and disseminate resource information of personnel, equipment and materials
18 available for search and rescue.

19 **(2) The Director of the Office of Emergency Management shall appoint regional search**
20 **and rescue coordinators to:**

21 **(a) Support the Search and Rescue Coordinator in the performance of duties described**
22 **in subsection (1) of this section; and**

23 **(b) Collaborate with counties to ensure that each county's search and rescue plan, poli-**
24 **cies and procedures comply with the requirements of the National Incident Management**
25 **System Incident Command System established by Homeland Security Presidential Directive**

2 **(3) The Office of Emergency Management, after consultation with the Oregon State**
3 **Sheriffs' Association, shall adopt rules to implement the authority granted in this section.**

4 **SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-**
5 **ated to the Office of Emergency Management, for the biennium beginning July 1, 2007, out**
6 **of the General Fund, the amount of \$_____ for payment of costs to implement section 1**
7 **of this 2007 Act.**
