Senate Bill 14

Sponsored by Senator WALKER; Senator BATES

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Requires health benefit plans to provide coverage for hearing aids for children.

1 A BILL FOR AN ACT

- Relating to health benefit plan coverage of hearing aids for children; creating new provisions; and amending ORS 750.055 and 750.333.
 - Be It Enacted by the People of the State of Oregon:
 - SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Insurance Code.
 - <u>SECTION 2.</u> (1) All health benefit plans, as defined in ORS 743.730, shall include coverage of hearing aids prescribed for beneficiaries under the plan who are under 18 years of age.
 - (2) The coverage required by subsection (1) of this section may be made subject to provisions of a health benefit plan that apply to other benefits under the plan, including, but not limited to, provisions relating to deductibles, coinsurance and prior authorization.
 - (3) The provisions of ORS 743.700 do not apply to this section.
