8	<b>"MANUFACTURED DWELLING PARK CLOSURE OR CONVERSION</b>
9	
10	"SECTION 1. Sections 2 to 4 of this 2007 Act are added to and made a part of ORS 90.505
11	to 90.840.
12	"SECTION 2. (1) If a manufactured dwelling park, or a portion of the park that includes
13	the space for a manufactured dwelling, is to be closed and the land or leasehold converted
14	to a use other than as a manufactured dwelling park, and the closure is not required by the
15	exercise of eminent domain or by order of federal, state or local agencies, the landlord may
16	terminate a month-to-month or fixed term rental agreement for a manufactured dwelling
17	park space:
18	"(a) By giving the tenant not less than 365 days' notice in writing before the date desig-
19	nated in the notice for termination; and
20	"(b) By paying a tenant, for each space for which a rental agreement is terminated, one
21	of the following amounts, adjusted as described in ORS 446.543:
22	"(A) \$5,000 if the manufactured dwelling is a single-wide dwelling;
23	"(B) \$7,000 if the manufactured dwelling is a double-wide dwelling; or
24	"(C) \$9,000 if the manufactured dwelling is a triple-wide or larger dwelling.
25	"(2) Notwithstanding subsection (1) of this section, if a landlord closes a manufactured
26	dwelling park under this section as a result of converting the park to a subdivision under
27	ORS 92.830 to 92.845, the landlord:
28	"(a) May terminate a rental agreement by giving the tenant not less than 180 days' notice
29	in writing before the date designated in the notice for termination.
30	"(b) Is not required to make a payment under subsection (1)(b) of this section to a tenant
31	who:
32	"(A) Buys the space or lot on which the tenant's manufactured dwelling is located and
33	does not move the dwelling; or
34	"(B) Sells the manufactured dwelling to a person who buys the space or lot.
35	"(3) A notice given under subsection (1) or (2) of this section shall, at a minimum:

- 1 "(a) State that the landlord is closing the park, or a portion of the park, and converting
- 2 the land or leasehold to a different use;

3 **"(b) Designate the date of closure; and** 

"(c) Include the tax credit notice described in ORS 90.635.

5 "(4) Except as provided in subsections (2) and (5) of this section, the landlord must pay 6 a tenant the full amount required under subsection (1)(b) of this section regardless of 7 whether the tenant relocates or abandons the manufactured dwelling. The landlord shall pay 8 at least one-half of the payment amount to the tenant within seven days after receiving from 9 the tenant the notice described in subsection (5)(a) of this section. The landlord shall pay the 10 remaining amount no later than seven days after the tenant ceases to occupy the space.

"(5) Notwithstanding subsection (1) of this section:

12 "(a) A landlord is not required to make a payment to a tenant as provided in subsection 13 (1) of this section unless the tenant gives the landlord not less than 30 days' and not more 14 than 60 days' written notice of the date within the 365-day period on which the tenant will 15 cease tenancy, whether by relocation or abandonment of the manufactured dwelling.

"(b) If the manufactured dwelling is abandoned:

"(A) The landlord may condition the payment required by subsection (1) of this section
upon the tenant waiving any right to receive payment under ORS 90.425 or 90.675.

"(B) The landlord may not charge the tenant to store, sell or dispose of the abandoned
 manufactured dwelling.

"(6)(a) A landlord may not charge a tenant any penalty, fee or unaccrued rent for moving
out of the manufactured dwelling park prior to the end of the 365-day notice period.

23 "(b) A landlord may charge a tenant for rent for any period during which the tenant oc-24 cupies the space and may deduct from the payment amount required by subsection (1) of this 25 section any unpaid moneys owed by the tenant to the landlord.

26 "(7) A landlord may not increase the rent for a manufactured dwelling park space after 27 giving a notice of termination under this section to the tenant of the space.

"(8) This section does not limit a landlord's right to terminate a tenancy for nonpayment
of rent under ORS 90.394 or for other cause under ORS 90.380 (5)(b), 90.396, 90.398 or 90.632
by complying with ORS 105.105 to 105.168.

"(9) If a landlord is required to close a manufactured dwelling park by the exercise of 3132eminent domain or by order of a federal, state or local agency, the landlord shall notify the 33 park tenants no later than 15 days after the landlord receives notice of the exercise of emi-34nent domain or of the agency order. The notice to the tenants shall be in writing, designate 35 the date of closure, state the reason for the closure, describe the tax credit available under section 17 of this 2007 Act and any government relocation benefits known by the landlord to 36 be available to the tenants and comply with any additional content requirements under ORS 37 90.635. 38

<sup>39</sup> "<u>SECTION 3.</u> (1) A landlord that gives a notice of termination under section 2 of this 2007 <sup>40</sup> Act shall, at the same time, send one copy of the notice to the Office of Manufactured <sup>41</sup> Dwelling Park Community Relations by first class mail. The landlord shall, at the same time, <sup>42</sup> send a copy of the notice, both by first class mail and by certified mail with return receipt <sup>43</sup> requested, for each affected manufactured dwelling, to any person:

44 "(a) That is not a tenant; and

45 "(b)(A) That the landlord actually knows to be an owner of the manufactured dwelling;

2 "(B) That has a lien recorded in the title or ownership document records for the manufactured dwelling.

4 "(2) A landlord that terminates rental agreements for manufactured dwelling park spaces under section 2 of this 2007 Act shall, no later than 60 days after the manufactured dwelling 5 park or portion of the park closes, report to the office: 6

"(a) The number of dwelling unit owners who moved their dwelling units out of the park; 7 8 and

9

"(b) The number of dwelling unit owners who abandoned their dwelling units at the park.

"SECTION 4. (1) Sections 2 and 3 of this 2007 Act preempt the adoption, application or 10 enforcement of any local law regulating a closure or partial closure of a manufactured 11 12dwelling park.

"(2) Subsection (1) of this section does not limit the adoption or application of a local law 13providing incentives or bonuses to landlords that voluntarily preserve or create affordable 14 housing related to the closing or partial closing of a manufactured dwelling park. 15

"SECTION 5. (1) Section 4 of this 2007 Act applies to the adoption, application or 16 enforcement of a local law regulating the closure or partial closure of a manufactured 1718 dwelling park for which the closure notice is given on or after the effective date of this 2007 19 Act.

"(2) Section 4 of this 2007 Act does not render moot any appeal pending on the effective 20 21date of this 2007 Act from a trial court final judgment in an action or suit regarding the 22application of a local law regulating manufactured dwelling park closures or partial closures. "SECTION 6. ORS 90.100 is amended to read: 23

24

"90.100. As used in this chapter, unless the context otherwise requires:

25"(1) 'Accessory building or structure' means any portable, demountable or permanent structure, 26 including but not limited to cabanas, ramadas, storage sheds, garages, awnings, carports, decks, 27steps, ramps, piers and pilings, that is:

"(a) Owned and used solely by a tenant of a manufactured dwelling or floating home; or 28

29 "(b) Provided pursuant to a written rental agreement for the sole use of and maintenance by a tenant of a manufactured dwelling or floating home. 30

"(2) 'Action' includes recoupment, counterclaim, setoff, suit in equity and any other proceeding 31in which rights are determined, including an action for possession. 32

33 "(3) 'Applicant screening charge' means any payment of money required by a landlord of an applicant prior to entering into a rental agreement with that applicant for a residential dwelling 34unit, the purpose of which is to pay the cost of processing an application for a rental agreement for 35 36 a residential dwelling unit.

"(4) 'Building and housing codes' includes any law, ordinance or governmental regulation con-37 38 cerning fitness for habitation, or the construction, maintenance, operation, occupancy, use or ap-39 pearance of any premises or dwelling unit.

40

"(5) 'Conduct' means the commission of an act or the failure to act.

41 "(6) 'Dealer' means any person in the business of selling, leasing or distributing new or used manufactured dwellings or floating homes to persons who purchase or lease a manufactured dwelling 42or floating home for use as a residence. 43

44 "(7) 'Domestic violence' has the meaning given that term in ORS 135.230.

"(8) 'Drug and alcohol free housing' means a dwelling unit described in ORS 90.243. 45

"(9) 'Dwelling unit' means a structure or the part of a structure that is used as a home, residence or sleeping place by one person who maintains a household or by two or more persons who maintain a common household. 'Dwelling unit' regarding a person who rents a space for a manufactured dwelling or recreational vehicle or regarding a person who rents moorage space for a floating home as defined in ORS 830.700, but does not rent the home, means the space rented and not the manufactured dwelling, recreational vehicle or floating home itself.

7 "(10) 'Essential service' means:

8 "(a) For a tenancy not consisting of rental space for a manufactured dwelling, floating home or 9 recreational vehicle owned by the tenant and not otherwise subject to ORS 90.505 to 90.840:

"(A) Heat, plumbing, hot and cold running water, gas, electricity, light fixtures, locks for exterior doors, latches for windows and any cooking appliance or refrigerator supplied or required to
be supplied by the landlord; and

"(B) Any other service or habitability obligation imposed by the rental agreement or ORS 90.320, the lack or violation of which creates a serious threat to the tenant's health, safety or property or makes the dwelling unit unfit for occupancy.

16 "(b) For a tenancy consisting of rental space for a manufactured dwelling, floating home or 17 recreational vehicle owned by the tenant or that is otherwise subject to ORS 90.505 to 90.840:

"(A) Sewage disposal, water supply, electrical supply and, if required by applicable law, anydrainage system; and

"(B) Any other service or habitability obligation imposed by the rental agreement or ORS 90.730,
the lack or violation of which creates a serious threat to the tenant's health, safety or property or
makes the rented space unfit for occupancy.

"(11) 'Facility' means[:] a manufactured dwelling park or a marina.

24 "[(a) A place where four or more manufactured dwellings are located, the primary purpose of 25 which is to rent space or keep space for rent to any person for a fee; or]

26 "[(b) A moorage of contiguous dwelling units that may be legally transferred as a single unit and 27 are owned by one person where four or more floating homes are secured, the primary purpose of which 28 is to rent space or keep space for rent to any person for a fee.]

"(12) 'Facility purchase association' means a group of three or more tenants who reside in a facility and have organized for the purpose of eventual purchase of the facility.

"(13) 'Fee' means a nonrefundable payment of money.

"(14) 'First class mail' does not include certified or registered mail, or any other form of mail that may delay or hinder actual delivery of mail to the recipient.

34 "(15) 'Fixed term tenancy' means a tenancy that has a fixed term of existence, continuing to a 35 specific ending date and terminating on that date without requiring further notice to effect the ter-36 mination.

"(16) 'Floating home' has the meaning given that term in ORS 830.700. 'Floating home' includes
an accessory building or structure.

39

"(17) 'Good faith' means honesty in fact in the conduct of the transaction concerned.

40 "(18) 'Hotel or motel' means 'hotel' as that term is defined in ORS 699.005.

"(19) 'Informal dispute resolution' means, but is not limited to, consultation between the landlord
or landlord's agent and one or more tenants, or mediation utilizing the services of a third party.

43 "(20) 'Landlord' means the owner, lessor or sublessor of the dwelling unit or the building or 44 premises of which it is a part. 'Landlord' includes a person who is authorized by the owner, lessor 45 or sublessor to manage the premises or to enter into a rental agreement. 1 "(21) 'Landlord's agent' means a person who has oral or written authority, either express or 2 implied, to act for or on behalf of a landlord.

"(22) 'Last month's rent deposit' means a type of security deposit, however designated, the primary function of which is to secure the payment of rent for the last month of the tenancy.

5 "(23) 'Manufactured dwelling' means a residential trailer, a mobile home or a manufactured 6 home as those terms are defined in ORS 446.003. 'Manufactured dwelling' includes an accessory 7 building or structure. 'Manufactured dwelling' does not include a recreational vehicle.

8 "(24) 'Manufactured dwelling park' means a place where four or more manufactured 9 dwellings are located, the primary purpose of which is to rent space or keep space for rent 10 to any person for a charge or fee.

"(25) 'Marina' means a moorage of contiguous dwelling units that may be legally transferred as a single unit and are owned by one person where four or more floating homes are secured, the primary purpose of which is to rent space or keep space for rent to any person for a charge or fee.

15 "[(24)] (26) 'Month-to-month tenancy' means a tenancy that automatically renews and continues 16 for successive monthly periods on the same terms and conditions originally agreed to, or as revised 17 by the parties, until terminated by one or both of the parties.

18 "[(25)] (27) 'Organization' includes a corporation, government, governmental subdivision or 19 agency, business trust, estate, trust, partnership or association, two or more persons having a joint 20 or common interest, and any other legal or commercial entity.

21 "[(26)] (28) 'Owner' includes a mortgagee in possession and means one or more persons, jointly 22 or severally, in whom is vested:

23 "(a) All or part of the legal title to property; or

24 "(b) All or part of the beneficial ownership and a right to present use and enjoyment of the 25 premises.

26 "[(27)] (29) 'Person' includes an individual or organization.

27 "[(28)] (**30**) 'Premises' means:

"(a) A dwelling unit and the structure of which it is a part and facilities and appurtenancestherein;

30 "(b) Grounds, areas and facilities held out for the use of tenants generally or the use of which 31 is promised to the tenant; and

32 "(c) A facility for manufactured dwellings or floating homes.

"[(29)] (31) 'Prepaid rent' means any payment of money to the landlord for a rent obligation not
 yet due. In addition, 'prepaid rent' means rent paid for a period extending beyond a termination date.
 "[(30)] (32) 'Recreational vehicle' has the meaning given that term in ORS 446.003.

"[(31)] (33) 'Rent' means any payment to be made to the landlord under the rental agreement, periodic or otherwise, in exchange for the right of a tenant and any permitted pet to occupy a dwelling unit to the exclusion of others. 'Rent' does not include security deposits, fees or utility or service charges as described in ORS 90.315 (4) and 90.532.

"[(32)] (34) 'Rental agreement' means all agreements, written or oral, and valid rules and regulations adopted under ORS 90.262 or 90.510 (6) embodying the terms and conditions concerning the
use and occupancy of a dwelling unit and premises. 'Rental agreement' includes a lease. A rental
agreement shall be either a week-to-week tenancy, month-to-month tenancy or fixed term tenancy.

44 "[(33)] (35) 'Roomer' means a person occupying a dwelling unit that does not include a toilet and 45 either a bathtub or a shower and a refrigerator, stove and kitchen, all provided by the landlord, and 1 where one or more of these facilities are used in common by occupants in the structure.

2 "[(34)] (36) 'Screening or admission criteria' means a written statement of any factors a landlord considers in deciding whether to accept or reject an applicant and any qualifications required for 3 4 acceptance. 'Screening or admission criteria' includes, but is not limited to, the rental history, character references, public records, criminal records, credit reports, credit references and incomes 5 or resources of the applicant. 6

7 "[(35)] (37) 'Security deposit' means a refundable payment or deposit of money, however desig-8 nated, the primary function of which is to secure the performance of a rental agreement or any part of a rental agreement. 'Security deposit' does not include a fee. 9

10

"[(36)] (38) 'Sexual assault' has the meaning given that term in ORS 147.450.

11 "[(37)] (39) 'Squatter' means a person occupying a dwelling unit who is not so entitled under a rental agreement or who is not authorized by the tenant to occupy that dwelling unit. 'Squatter' 1213does not include a tenant who holds over as described in ORS 90.427 (4).

"[(38)] (40) 'Stalking' means the behavior described in ORS 163.732. 14

15"[(39)] (41) 'Statement of policy' means the summary explanation of information and facility 16 policies to be provided to prospective and existing tenants under ORS 90.510.

"[(40)] (42) 'Surrender' means an agreement, express or implied, as described in ORS 90.148 be-1718 tween a landlord and tenant to terminate a rental agreement that gave the tenant the right to oc-19 cupy a dwelling unit.

"[(41)] (43) 'Tenant' means a person, including a roomer, entitled under a rental agreement to 20 21occupy a dwelling unit to the exclusion of others, including a dwelling unit owned, operated or 22controlled by a public housing authority. 'Tenant' also includes a minor, as defined and provided for 23in ORS 109.697. As used in ORS 90.505 to 90.840, 'tenant' includes only a person who owns and oc-24 cupies as a residence a manufactured dwelling or a floating home in a facility and persons residing 25with that tenant under the terms of the rental agreement.

26

"[(42)] (44) 'Transient lodging' means a room or a suite of rooms.

27"[(43)] (45) 'Transient occupancy' means occupancy in transient lodging that has all of the fol-28lowing characteristics:

29

"(a) Occupancy is charged on a daily basis and is not collected more than six days in advance;

"(b) The lodging operator provides maid and linen service daily or every two days as part of the 30 regularly charged cost of occupancy; and 31

32

"(c) The period of occupancy does not exceed 30 days.

33 "[(44)] (46) 'Vacation occupancy' means occupancy in a dwelling unit, not including transient occupancy in a hotel or motel, that has all of the following characteristics: 34

35 "(a) The occupant rents the unit for vacation purposes only, not as a principal residence;

36 "(b) The occupant has a principal residence other than at the unit; and

37 "(c) The period of authorized occupancy does not exceed 45 days.

38 "[(45)] (47) 'Victim' means a person who is the subject of domestic violence, sexual assault or stalking. 'Victim' includes a parent or guardian of a minor who is the subject of domestic violence, 39 40 sexual assault or stalking.

41 "[(46)] (48) 'Week-to-week tenancy' means a tenancy that has all of the following characteristics: "(a) Occupancy is charged on a weekly basis and is payable no less frequently than every seven 4243 days;

44 "(b) There is a written rental agreement that defines the landlord's and the tenant's rights and 45 responsibilities under this chapter; and

1 "(c) There are no fees or security deposits, although the landlord may require the payment of 2 an applicant screening charge, as provided in ORS 90.295.

3 "SECTION 7. ORS 90.635 is amended to read:

4 "90.635. (1) If a [facility is closed] manufactured dwelling park or a portion of a [facility] manufactured dwelling park is closed, resulting in the termination of the rental agreement be-5 tween the landlord of the [facility] park and a tenant renting space for a manufactured dwelling, 6 7 whether because of the exercise of eminent domain, by order of [the] a federal, state or local 8 [agencies,] agency or as provided under [ORS 90.630 (5)] section 2 (1) of this 2007 Act, the landlord shall provide notice to the tenant of the tax credit provided under [ORS 316.153] section 17 of this 9 10 2007 Act. The notice shall state the eligibility requirements for the credit, information on how to 11 apply for the credit and any other information required by the Office of Manufactured Dwelling Park Community Relations or the Department of Revenue by rule. The notice shall also state that 1213the closure may allow the taxpayer to appeal the property tax assessment on the manufac-14 tured dwelling.

"(2) The office shall adopt rules establishing a sample form for the notice described in
 this section and the notice described in section 2 (3) of this 2007 Act.

"(3) The department, in consultation with the office, shall adopt rules establishing a
 sample form and explanation for the property tax assessment appeal.

"[(2) The landlord shall send the notice described under subsection (1) of this section to a tenant
 affected by a facility closure on or before:]

21 "[(a) The date notice of rental termination must be given to the tenant under ORS 90.630 (5), if 22 applicable; or]

23 "[(b) In the event of facility closure by exercise of eminent domain or by order of a state or local 24 agency, within 15 days of the date the landlord received notice of the closure.]

25 "[(3) The landlord shall forward to the office a list of the names and addresses of tenants to whom 26 notice under this section has been sent.]

"(4) The office may adopt rules to [implement] administer this section[, including rules specifying
the form and content of the notice described under this section].

"<u>SECTION 8.</u> ORS 92.840 is amended to read:

"92.840. (1) Notwithstanding the provisions of ORS 92.016 (1), prior to the approval of a tentative
plan, the declarant may negotiate to sell a lot in a manufactured dwelling park or a mobile home
park for which approval is required under ORS 92.830 to 92.845.

"(2) Prior to the sale of a lot in a park, the declarant shall offer to sell the lot to the tenant who occupies the lot. The offer required under this subsection:

35 "(a) Terminates 60 days after receipt of the offer by the tenant or upon written rejection of the 36 offer, whichever occurs first; and

37

"(b) Does not constitute a notice of termination of the tenancy.

38 "(3) The declarant may not sell the lot to a person other than the tenant for 60 days after ter-39 mination of the offer required under subsection (2) of this section at a price or on terms that are 40 more favorable to the purchaser than the price or terms that were offered to the tenant.

41 "(4) After the park has been submitted for subdivision under ORS 92.830 to 92.845 and until a 42 lot is offered for sale in accordance with subsection (2) of this section, the declarant shall notify a 43 prospective tenant, in writing, prior to the commencement of the tenancy, that the park has been 44 submitted for subdivision and that the tenant is entitled to receive an offer to purchase the lot under 45 subsection (2) of this section. "(5) Prior to any sale of a lot in a subdivision created in the park, the declarant must provide the tenant or other potential purchaser of the lot with information about the homeowners association formed by the declarant as required by ORS 94.625. The information must, at a minimum, include the association name and type and any rights set forth in the declaration required by ORS 94.580.

6 "(6) The declarant may not begin improvements or rehabilitation to the lot during the period 7 described in [ORS 90.630 (5)] the landlord's notice of termination under section 2 of this 2007 8 Act without the permission of the tenant.

9 "(7) The declarant may begin improvements or rehabilitation to the common property as defined 10 in the declaration during the period described in [ORS 90.630 (5)] **the landlord's notice of termi**-11 **nation under section 2 of this 2007 Act**.

"(8) Nothing in this section prevents the declarant from terminating a tenancy in the park in compliance with ORS 90.630[,] and 90.632 and [90.635] section 2 of this 2007 Act. However, the declarant shall make the offer required under subsection (2) of this section to a tenant whose tenancy is terminated after approval of the tentative plan unless the termination is for cause under ORS 90.392, 90.394, 90.396, 90.630 (1) or [(12)] (8) or 90.632.

17 "SECTION 9. ORS 446.543 is amended to read:

"446.543. (1) An Office of Manufactured Dwelling Park Community Relations is established in
the Housing and Community Services Department.

20 "(2) Office personnel shall:

"(a) Undertake, participate in or cooperate with persons and agencies in such conferences, inquiries, meetings or studies as might lead to improvements in manufactured dwelling park landlord and tenant relationships;

24 "(b) Develop and implement a centralized resource referral program for tenants and landlords 25 to encourage the voluntary resolution of disputes;

"(c) Maintain a current list of manufactured dwelling parks in the state, indicating the total
 number of spaces;

"(d) Not be directly affiliated, currently or previously, in any way with a manufactured dwelling park within the preceding two years; and

"(e) Take other actions or perform such other duties as the Director of the Housing and Community Services Department deems necessary or appropriate.

"(3) The office shall adopt rules to administer sections 2 and 3 of this 2007 Act. The office
may annually adopt rules adjusting the payment amounts described in section 2 (1) of this
2007 Act to reflect changes in the Portland-Salem Consumer Price Index for All Urban Consumers for All Items, as reported by the United States Bureau of Labor Statistics.

### **"RELOCATION OF DISPLACED MANUFACTURED DWELLINGS**

"SECTION 10. ORS 197.485 is amended to read:

"197.485. (1) A jurisdiction may not prohibit placement of a manufactured dwelling, due solely
to its age, in a mobile home or manufactured dwelling park in a zone with a residential density of
eight to 12 units per acre.

43 "(2) A jurisdiction may not prohibit placement of a manufactured dwelling, due solely to its age,
44 on a buildable lot or parcel located outside urban growth boundaries or on a space in a mobile
45 home or manufactured dwelling park, if the manufactured dwelling is being relocated due to the

1 closure of a mobile home or manufactured dwelling park or a portion of a mobile home or manu-2 factured dwelling park. "(3) A jurisdiction may impose reasonable safety and inspection requirements for homes that 3 4 were not constructed in conformance with the National Manufactured Housing Construction and Safety Standards Act of 1974 (42 U.S.C. 5403). 5 6 **"TENANT TAX EXEMPTIONS AND CREDITS** 7 8 "SECTION 11. lienholder or owner must contact a landlord to arrange for the disposition of abandoned personal

42 "(a) For abandoned recreational vehicles, manufactured dwellings or floating homes, not less

"(b) For all other abandoned personal property, not less than five days after personal delivery
or eight days after mailing of the notice.

1 "(7) After notifying the tenant as required by subsection (3) of this section, the landlord:

2 "(a) Shall store any abandoned manufactured dwelling or floating home on the rented space and 3 shall exercise reasonable care for the dwelling or home;

45 "(19)(a) Except as provided by subsection (20)(d) and (e) of this section, if a lienholder makes a

timely response to a notice of abandoned personal property pursuant to subsections (6) and (8) of this section and so requests, a landlord shall enter into a written storage agreement with the lienholder providing that the personal property may not be sold or disposed of by the landlord for up to 12 months. A storage agreement entitles the lienholder to store the personal property on the previously rented space during the term of the agreement, but does not entitle anyone to occupy the personal property.

"(B) The lienholder pay a late charge or fee for failure to pay a storage charge by the date required in the agreement, if the amount of the late charge is no greater than for late charges imposed on facility tenants;

"(C) The lienholder maintain the personal property and the space on which the personal property is stored in a manner consistent with the rights and obligations described in the rental agreement that the landlord currently provides to tenants as required by ORS 90.510 (4); and

33 "(D) The lienholder repair any defects in the physical condition of the personal property that 34existed prior to the lienholder entering into the storage agreement, if the defects and necessary re-35 pairs are reasonably described in the storage agreement and, for homes that were first placed on 36 the space within the previous 24 months, the repairs are reasonably consistent with facility stan-37 dards in effect at the time of placement. The lienholder shall have 90 days after entering into the 38 storage agreement to make the repairs. Failure to make the repairs within the allotted time consti-39 tutes a violation of the storage agreement and the landlord may terminate the agreement by giving 40 at least 14 days' written notice to the lienholder stating facts sufficient to notify the lienholder of 41 the reason for termination. "(2) Except as otherwise provided in this section, a landlord may require the payment of a security deposit. A security deposit or prepaid rent shall be held by the landlord for the tenant who is a party to the rental agreement. The claim of a tenant to the security deposit or prepaid rent shall be prior to the claim of any creditor of the landlord, including a trustee in bankruptcy. The holder of the landlord's interest in the premises at the time of termination of the tenancy is responsible to the tenant for any security deposit or prepaid rent and is bound by this section.

"(3)(a) A landlord may not change the rental agreement to require the payment of a new or increased security deposit during the first year after the tenancy has begun, except that an additional deposit may be required if the landlord and tenant agree to modify the terms and conditions of the rental agreement to permit a pet or for other cause and the additional deposit relates to that modification. This paragraph does not prevent the collection of a security deposit that was provided for under an initial rental agreement but remained unpaid at the time the tenancy began.

"(b) If a landlord requires a new or increased security deposit after the first year of the tenancy, the landlord shall allow the tenant at least three months to pay that deposit.

"(4) The landlord may claim all or part of the security deposit only if the security deposit was made for any or all of the purposes provided by subsection (5) of this section.
