SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Eliminates] **Extends** sunset on continuous appropriation of cigarette tax revenues and tobacco products tax revenues to reimburse Department of Revenue, Oregon State Police and Department of Justice for cigarette tax administration and enforcement and tobacco products tax administration and enforcement.

A BILL FOR AN ACT

2 Relating to distribution of tobacco tax revenues; and appropriating money.

3 Whereas it is good policy that the tobacco tax task force be funded for at least eight years; and

4 Whereas it would be beneficial for the continuation and enhancement of the important work of
5 the task force that the sunset of the funding provisions of this 2007 Act be extended by four years
6 after each quadrennial report of the task force to the Legislative Assembly; now, therefore,

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** Section 2 of this 2007 Act is added to and made a part of ORS 323.005 to
9 **323.482.**

10 **SECTION 2.** Notwithstanding ORS 323.455 or 323.457 or any other provision of ORS 323.005
11 to **323.482**, amounts necessary to pay the expenses incurred by the Department of Revenue
12 and to reimburse the Oregon State Police and the Department of Justice for the adminis-
13 tration and enforcement of ORS 323.005 to 323.482 are continuously appropriated to the De-
14 partment of Revenue from revenues raised under ORS 323.005 to 323.482 prior to any other
15 appropriation or distribution of revenues raised under ORS 323.005 to 323.482.

16 **SECTION 3.** Section 4 of this 2007 Act is added to and made a part of ORS 323.500 to
17 **323.645.**

18 **SECTION 4.** Notwithstanding ORS 323.625 or any other provision of ORS 323.500 to
19 **323.645**, amounts necessary to pay the expenses incurred by the Department of Revenue and
20 to reimburse the Oregon State Police and the Department of Justice for the administration
21 and enforcement of ORS 323.500 to 323.645 are continuously appropriated to the Department
22 of Revenue from revenues raised under ORS 323.500 to 323.645 prior to any other appropri-
23 ation or distribution of revenues raised under ORS 323.500 to 323.645.

24 **SECTION 5.** Sections 2 and 4 of this 2007 Act apply to calendar years beginning on or
25 after January 1, 2008, and ending before January 1, 2016.

26 **SECTION 6.** The Oregon State Police and the Department of Justice shall report in the

1 **manner provided by ORS 192.245 to the Seventy-sixth Legislative Assembly no later than**

4 **2009-2011 biennia.**
