

SENATE AMENDMENTS TO SENATE BILL 222

By COMMITTEE ON BUSINESS, TRANSPORTATION AND WORKFORCE DEVELOPMENT

- 1 On page 1 of the printed bill, line 2, delete “and” and after “825.005,” insert “825.022,”.
- 2 In line 3, after “825.470” insert “; and declaring an emergency”.
- 3 After line 22, insert:
- 4 “(5) The department may adopt rules necessary to administer the provisions of this section.”.
- 5 In line 24, before “For” insert “(1)”.
- 6 After line 27, insert:
- 7 “(2) The department may adopt rules necessary to administer the provisions of this section.”.
- 8 On page 2, line 3, after “firming” insert “federal”.
- 9 In line 4, delete “based outside Oregon”.
- 10 Delete lines 13 through 27 and insert:
- 11 “**SECTION 5.** ORS 825.104 is amended to read:
- 12 “825.104. *[(1) A for-hire or private carrier engaged or to engage in interstate operations shall apply*
- 13 *to the Department of Transportation for a permit.]*
- 14 “*[(2) The department shall issue a permit to the carrier without a hearing and as a matter of course*
- 15 *if:]*
- 16 “*[(a) The carrier files with the department a statement that its operations either are authorized by*
- 17 *the United States Department of Transportation or are exempt from such regulation; and]*
- 18 “*[(b) The carrier furnishes to the department either evidence of coverage by public liability or*
- 19 *property damage insurance, as required by ORS 825.160 to 825.166, or evidence that it qualifies as a*
- 20 *self-insurer under ORS 825.168.]*
- 21 “*[(3) No for-hire or private carrier engaged or to engage in interstate operations shall perform any*
- 22 *transportation service upon the public highways of this state without first having applied for and se-*
- 23 *cured a permit in compliance with subsection (1) of this section.]*
- 24 “**An interstate for-hire carrier or private carrier required to obtain a United States De-**
- 25 **partment of Transportation registration number engaged or to engage in interstate oper-**
- 26 **ations may not perform transportation services on the public highways of this state without**
- 27 **having first complied with federal registration and financial responsibility requirements.”.**
- 28 On page 8, line 16, delete “Oregon-based”.
- 29 After line 17, insert:
- 30 “**SECTION 11.** ORS 825.022 is amended to read:
- 31 “825.022. The provisions of ORS [*825.104,*] 825.160, 825.450, 825.454, 825.470, 825.472, 825.474,
- 32 825.476, 825.480, 825.484, 825.488, 825.490, 825.492, 825.494, 825.496 and 825.515 do not apply to any
- 33 vehicle or combination of vehicles with a combined weight of 26,000 pounds or less.
- 34 “**SECTION 12. This 2007 Act being necessary for the immediate preservation of the public**
- 35 **peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect**
