

Senate Bill 233

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Theodore R. Kulongoski for Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes State Accident Insurance Fund Corporation to contract with Oregon Department of Administrative Services to process certain claims filed by inmates of institutions of Department of Corrections.

2 Relating to processing of claims by State Accident Insurance Fund Corporation for certain injuries
3 sustained by inmates of institutions of Department of Corrections; amending ORS 656.752.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 656.752 is amended to read:

6 656.752. (1) The State Accident Insurance Fund Corporation is created for the purpose of
7 transacting workers' compensation insurance and reinsurance business. The State Accident Insur-
8 ance Fund Corporation also may insure an Oregon employer against any liability such employer may
9 have on account of bodily injury to a worker of the employer arising out of and in the course of
10 employment as fully as any private insurance carrier.

11 (2) The functions of the State Accident Insurance Fund Corporation shall be:

12 (a) To confer with and solicit employers and to determine, handle, audit and enforce collection
13 of premiums, assessments and fees of insured employers insured with the State Accident Insurance
14 Fund Corporation;

15 (b) To make insurance available to as many Oregon employers as inexpensively as may be con-
16 sistent with the overall integrity of the Industrial Accident Fund, in accordance with ORS 656.634
17 and sound principles of insurance;

18 (c) To receive and handle and process the claims of workers and beneficiaries of workers injured
19 in the employ of insured employers insured with the State Accident Insurance Fund Corporation;
20 and

21 (d) To perform all other functions which the laws of this state specifically authorize or which
22 are necessary or appropriate to carry out the functions expressly authorized.

23 (3) The State Accident Insurance Fund Corporation in its name may sue and be sued.

24 (4) The State Accident Insurance Fund Corporation may authorize self-insured employers or
25 other insurers to use any physical rehabilitation center operated by the State Accident Insurance
26 Fund Corporation on such terms as the State Accident Insurance Fund Corporation deems reason-
27 able.

28 (5) The State Accident Insurance Fund Corporation in its own name, may acquire, lease, rent,
29 own and manage real property. It may construct, equip and furnish buildings or other structures as
30 are necessary to accommodate its needs. It may purchase, rent, lease or otherwise acquire for its

1 use all supplies, materials, equipment and services necessary to carry out its functions. It may sell
2 or otherwise dispose of any property acquired under this subsection.

3 (6) Any real property acquired and owned by the State Accident Insurance Fund Corporation
4 under this section shall be subject to ad valorem taxation.

5 (7) The State Accident Insurance Fund Corporation may furnish advice, services and excess
6 workers' compensation and employer liability insurance to any employer qualified as a self-insured
7 employer under the provisions of ORS 656.407, on such terms and conditions as the State Accident
8 Insurance Fund Corporation deems reasonable.

9 (8) With the approval of the Director of the Department of Consumer and Business Services, the
10 State Accident Insurance Fund Corporation may provide reinsurance coverage to Oregon employers
11 on such terms and conditions as the State Accident Insurance Fund Corporation deems reasonable.

12 **(9) The State Accident Insurance Fund Corporation may contract with the Oregon De-**
13 **partment of Administrative Services to provide claim management services for claims filed**
14 **under ORS 655.505 to 655.555 by inmates of institutions of the Department of Corrections.**
