## Senate Bill 238

## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Increases maximum permissible license fees for certain weighing or measuring instruments or devices. Applies to fees established for licensing periods beginning on or after July 1, 2007. Declares emergency, effective on passage.

## A BILL FOR AN ACT

Relating to State Department of Agriculture maximum license fees; creating new provisions; amending ORS 618.141; and declaring an emergency.

## Be It Enacted by the People of the State of Oregon:

**SECTION 1.** ORS 618.141 is amended to read:

618.141. The license fees established pursuant to ORS 618.136 for weighing or measuring instruments or devices shall not exceed the following:

<u>SECTION 2.</u> The amendments to ORS 618.141 by section 1 of this 2007 Act apply to fees established by the State Department of Agriculture for licensing periods that begin on or after July 1, 2007.

SECTION 3. This 2007 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect on its passage.
