

Senate Bill 243

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Judiciary)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates crime of subjecting another to involuntary servitude in first degree. Punishes by maximum of 10 years' imprisonment, \$250,000 fine, or both.

Creates crime of subjecting another to involuntary servitude in second degree. Punishes by maximum of five years' imprisonment, \$125,000 fine, or both.

Creates crime of trafficking in persons. Punishes by maximum of 10 years' imprisonment, \$250,000 fine, or both.

2 Relating to crime; creating new provisions; and amending ORS 131.602, 137.103, 161.005 and 166.715.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. As used in sections 2 and 3 of this 2007 Act, "services" means activities**
5 **performed by one person under the supervision or for the benefit of another person.**

6 **SECTION 2. (1) A person commits the crime of subjecting another to involuntary**
7 **servitude in the first degree if the person knowingly and without lawful authority forces or**
8 **attempts to force another person to engage in services by:**

9 (a) **Causing or threatening to cause the death of or serious physical injury to a person;**
10 **or**

11 (b) **Physically restraining or threatening to physically restrain a person.**

12 (2) **Subjecting another to involuntary servitude in the first degree is a Class B felony.**

13 **SECTION 3. (1) A person commits the crime of subjecting another to involuntary**
14 **servitude in the second degree if the person knowingly forces or attempts to force another**
15 **person to engage in services by:**

16 (a) **Abusing or threatening to abuse the law or legal process if the other person does not**
17 **engage in the services;**

18 (b) **Destroying, concealing, removing, confiscating or possessing an actual or purported**
19 **passport or immigration document or another actual or purported government identification**
20 **document of another person;**

21 (c) **Threatening to report another person to a government agency for the purpose of ar-**
22 **rest or deportation if the other person does not engage in the services;**

23 (d) **Threatening to collect an unlawful debt if the other person does not engage in the**
24 **services; or**

25 (e) **Instilling in the other person a fear that, if the other person does not engage in the**
26 **services, the actor will withhold from the other person the necessities of life, including but**
27 **not limited to lodging, food and clothing.**

28 (2) **Subjecting another to involuntary servitude in the second degree is a Class C felony.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **SECTION 4. (1) A person commits the crime of trafficking in persons if the person**
 2 **knowingly:**

3 **(a) Recruits, entices, harbors, transports, provides or obtains by any means, or attempts**
 4 **to recruit, entice, harbor, transport, provide or obtain by any means, another person know-**
 5 **ing that the other person will be subjected to involuntary servitude as described in section**
 6 **2 or 3 of this 2007 Act; or**

7 **(b) Benefits financially or receives something of value from participation in a venture**
 8 **that involves an act prohibited by this section or section 2 or 3 of this 2007 Act.**

9 **(2) Trafficking in persons is a Class B felony.**

10 **SECTION 5. In determining the length of sentence within the maximum allowed upon**
 11 **conviction of a crime defined in section 2, 3 or 4 of this 2007 Act, the court shall consider**
 12 **the length of time during which the victim was held in servitude and the number of victims**
 13 **of the defendant's acts.**

 31 mines that the person has suffered economic damages as a result of the offense.

32 (b) Any person not described in paragraph (a) of this subsection whom the court determines has
 33 suffered economic damages as a result of the defendant's criminal activities.

34 (c) The Criminal Injuries Compensation Account, if it has expended moneys on behalf of a victim
 35 described in paragraph (a) of this subsection.

36 (d) An insurance carrier, if it has expended moneys on behalf of a victim described in paragraph
 37 (a) of this subsection.

38 (5) "Victim" does not include any coparticipant in the defendant's criminal activities.

7 (1) "Documentary material" means any book, paper, document, writing, drawing, graph, chart,
 8 photograph, phonograph record, magnetic tape, computer printout, other data compilation from
 9 which information can be obtained or from which information can be translated into usable form,
 10 or other tangible item.
