## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Adds requirement for reporting abuse of persons with developmental disabilities who are 18 years of age or older and are currently receiving, or were previously determined eligible for, services from community program or facility. Modifies definition of "adult protective services" to include petitioning for protective order.
