SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Adds requirement for reporting abuse of persons with developmental disabilities who are 18 years of age or older and do not receive services from community program or facility.

- 6 (1) "Abuse" means one or more of the following:
- 7 (a) Any death caused by other than accidental or natural means.
 - (b) Any physical injury caused by other than accidental means, or that appears to be at variance with the explanation given of the injury.
 - (c) Willful infliction of physical pain or injury.
 - (d) Sexual harassment or exploitation, including but not limited to any sexual contact between an employee of a facility or community program and an adult.
 - (e) Neglect that leads to physical harm through withholding of services necessary to maintain health and well-being. For purposes of this paragraph, "neglect" does not include a failure of the state or a community program to provide services due to a lack of funding available to provide the services.
 - [(2) "Adult" means a person who is mentally ill or developmentally disabled, who is 18 years of age or older and receives services from a community program or facility.]
 - (2) "Adult" means a person 18 years of age or older with:
 - (a) A developmental disability; or
 - (b) A mental illness who is receiving services from a community program or facility.
 - (3) "Adult protective services" means the necessary actions taken to prevent abuse or exploitation of an adult, to prevent self-destructive acts and to safeguard an adult's person, property and funds. Any actions taken to protect an adult shall be undertaken in a manner that is least intrusive to the adult and provides for the greatest degree of independence.
 - (4) "Care provider" means an individual or facility that has assumed responsibility for all or a portion of the care of an adult as a result of a contract or agreement.
 - (5) "Community program" means a community mental health and developmental disabilities program as established in ORS 430.610 to 430.695.
 - (6) "Department" means the Department of Human Services.

- 1 (7) "Facility" means a residential treatment home or facility, residential care facility, adult fos-2 ter care home, residential training home or facility or crisis respite facility.
- 3 (8) "Law enforcement agency" means:
- 4 (a) Any city or municipal police department;
- 5 (b) Any county sheriff's office;
- 6 (c) The Oregon State Police; or
- 7 (d) Any district attorney.
- 8 (9) "Public or private official" means:
- 9 (a) Physician, naturopathic physician, osteopathic physician, psychologist, chiropractor or 10 podiatric physician and surgeon, including any intern or resident;
- 11 (b) Licensed practical nurse, registered nurse, nurse's aide, home health aide or employee of an 12 in-home health service;
- 13 (c) Employee of the Department of Human Services, county health department, community 14 mental health and developmental disabilities program or private agency contracting with a public 15 body to provide any community mental health service;
- 16 (d) Peace officer;
- 17 (e) Member of the clergy;
- 18 (f) Licensed clinical social worker;
- 19 (g) Physical, speech or occupational therapist;
- 20 (h) Information and referral, outreach or crisis worker;
- 21 (i) Attorney;
- 22 (j) Licensed professional counselor or licensed marriage and family therapist; or
- 23 (k) Any public official who comes in contact with adults in the performance of the official's du-24 ties.
