#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies administrative provisions for economic and community development. Revises economic and community development programs.

Eliminates statutory references to Ports Division and International Trade Commission.

Establishes Industry Outreach Fund. Continuously appropriates moneys in fund to Economic and Community Development Department for specified purposes.

Declares emergency, effective on passage.

sion and need not, but may be, limited by political boundaries. 1 2 (3) "Department" means the Economic and Community Development Department. (4) "Director" means the Director of the Economic and Community Development Department. 3 (5) "Distressed area" means a county, city, community or other geographic area that is desig-4 nated as a distressed area by the department, based on indicators of economic distress or dislo-5 cation, including but not limited to unemployment, poverty and job loss. 6 (6) "International trade" means the export and import of products and services and the move-7 ment of capital for the purpose of investment. 8 9 (7) "Rural area" means an area located entirely outside of the acknowledged Portland Metropolitan Area Regional Urban Growth Boundary and the acknowledged urban growth boundaries of 10 [the] cities with populations of 30,000 or more [in population, including Albany, Bend, Corvallis, 11 12 Eugene, Springfield, Salem, Keizer or Medford]. 13 [(8) "Rural community" means a community located in a rural area.] [(9)] (8) "Traded sector" means industries in which member firms sell their goods or services 14 15 into markets for which national or international competition exists. 16(9) "Small business" means a business having 100 or fewer employees. SECTION 2. ORS 285A.020 is amended to read: 17 18 285A.020. (1) There is established the Oregon Economic and Community Development Commis-38 sion consisting of [seven] nine members appointed as follows: (a) One nonvoting, ex officio member appointed from among the members of the Senate by the 39 President of the Senate; 40 (b) One nonvoting, ex officio member appointed from among the members of the House of Rep-41 resentatives by the Speaker of the House of Representatives; and 42(c) [Five] Seven members appointed by the Governor, subject to confirmation by the Senate in 43 the manner prescribed in ORS 171.562 and 171.565. The Governor shall appoint members of the 44

45 commission in compliance with all of the following:

1 (A) Members shall be appointed with [due] consideration given to representation of the different

2 geographic regions of the state, and at least one member shall be a resident of the area east of the

(2)(a) The term of office of each member appointed by the Governor is four years, but a member serves at the pleasure of the Governor. Before the expiration of the term of a member appointed by the Governor, the Governor shall appoint a successor whose term begins on July 1 [next following] of the following year. A member appointed by the Governor is eligible for reappointment. In case of a vacancy among the members appointed by the Governor for any cause, the Governor shall appoint a person to fill the office for the unexpired term.

(b) The term of office of the member appointed by the President of the Senate is four years. In
case of a vacancy for any cause, the President of the Senate shall appoint a Senator to fill the office
for the unexpired term.

(c) The term of office of the member appointed by the Speaker of the House of Representatives
is two years. In case of a vacancy for any cause, the Speaker of the House of Representatives shall
appoint a Representative to fill the office for the unexpired term.

(3) A member of the commission who is appointed by the Governor is entitled to compensation
 and expenses as provided by ORS 292.495. Ex officio members of the commission are prohibited
 from receiving compensation and reimbursement for expenses.

(4) Subject to confirmation by the Senate, the Governor shall appoint one of the voting commissioners as presiding officer of the commission. The presiding officer shall have duties and powers as the commission determines are necessary for the office.

(5) [Three] Five voting members of the commission constitute a quorum for the transaction of
 business.

(6) The commission shall meet at least quarterly at a time and place determined by the commission. The commission shall also meet at [*such*] other times and places as are specified by the call
of the presiding officer or by the call of a majority of the voting members of the commission.

(7) A vacancy among the voting members of the commission does not impair the right of the
remaining voting commissioners to exercise all the powers of the commission. If the remaining voting commissioners are unable to agree, the Governor shall have the right to vote as a member of
