SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires Department of Human Services or another agency having guardianship or legal custody of child or ward to make diligent efforts to preserve familial relationships. Requires court placing child or ward in custody of department to make written findings on whether department actions constitute diligent efforts. Modifies provisions governing when permanency hearings must be held.

Removes requirement that child be placed in nonprofit private child-caring agency for purposes of temporary assistance to needy families program.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 419A.004 is amended to read:

6 419A.004. As used in this chapter and ORS chapters 419B and 419C, unless the context requires
7 otherwise:

8 (1) "CASA Volunteer Program" means a program approved or sanctioned by the juvenile court
9 to recruit, train and supervise volunteer persons to serve as court appointed special advocates.

10 (2) "Child care center" means a residential facility for wards or youth offenders that is licensed
11 under the provisions of ORS 418.240.

12 (3) "Community service" has the meaning given that term in ORS 137.126.

13 (4) "Conflict of interest" means a person appointed to a local citizen review board who has a
14 personal or pecuniary interest in a case being reviewed by that board.

15 (5) "Counselor" means a juvenile department counselor or a county juvenile probation officer.

16 (6) "Court" means the juvenile court.

17 (7) "Court appointed special advocate" or "CASA" means a person appointed by the court pur-
18 suant to a CASA Volunteer Program to act as special advocate pursuant to ORS 419A.170.

19 (8) "Court facility" has the meaning given that term in ORS 166.360.

20 (9) "Department" means the Department of Human Services.

21 (10) "Detention" or "detention facility" means a facility established under ORS 419A.010 to
22 419A.020 and 419A.050 to 419A.063 for the detention of children, wards, youths or youth offenders
23 pursuant to a judicial commitment or order.

24 (11) "Director" means the director of a juvenile department established under ORS 419A.010 to
25 419A.020 and 419A.050 to 419A.063.

1 (12) "Guardian" means guardian of the person and not guardian of the estate.

2 (13) "Indian child" means any unmarried person less than 18 years of age who is:

3 (a) A member of an Indian tribe; or

4 (b) Eligible for membership in an Indian tribe and is the biological child of a member of an In-
5 dian tribe.

6 (14) "Juvenile court" means the court having jurisdiction of juvenile matters in the several
7 counties of this state.

8 (15) "Local citizen review board" means the board specified by ORS 419A.090 and 419A.092.

9 (16) "Parent" means the biological or adoptive mother and the legal father of the child, ward,
10 youth or youth offender. As used in this subsection, "legal father" means:

11 (a) A man who has adopted the child, ward, youth or youth offender or whose paternity has been
12 established or declared under ORS 109.070 or 416.400 to 416.465 or by a juvenile court; and

20 adoption, placement with a relative or placement with a legal guardian that is consistent with the
21 case plan and in the best interests of the ward.

23 (20) "Reasonable time" means a period of time that is reasonable given a child or ward's emo-
24 tional and developmental needs and ability to form and maintain lasting attachments.

40 holding children, youths and youth offenders pending further placement.

41 **(27) "Sibling" means one of two or more children or wards related:**

43 **(b) Through the marriage of the children's or wards' legal or biological parents.**

19 [(32)] (33) “Youth care center” has the meaning given that term in ORS 420.855.

20 [(33)] (34) “Youth offender” means a person who has been found to be within the jurisdiction
21 of the juvenile court under ORS 419C.005 for an act committed when the person was under 18 years
22 of age.

23 **SECTION 2.** ORS 419A.004, as amended by section 1, chapter 843, Oregon Laws 2005, is
24 amended to read:

25 419A.004. As used in this chapter and ORS chapters 419B and 419C, unless the context requires
26 otherwise:

27 (1) “CASA Volunteer Program” means a program approved or sanctioned by the juvenile court
28 to recruit, train and supervise volunteer persons to serve as court appointed special advocates.

29 (2) “Child care center” means a residential facility for wards or youth offenders that is licensed
30 under the provisions of ORS 418.240.

31 (3) “Community service” has the meaning given that term in ORS 137.126.

32 (4) “Conflict of interest” means a person appointed to a local citizen review board who has a
33 personal or pecuniary interest in a case being reviewed by that board.

16 under ORS 419C.411 and placed under the jurisdiction of the Psychiatric Security Review Board.

17 [(32)] (33) “Youth” means a person under 18 years of age who is alleged to have committed an
18 act that is a violation, or, if done by an adult would constitute a violation, of a law or ordinance
19 of the United States or a state, county or city.

20 [(33)] (34) “Youth care center” has the meaning given that term in ORS 420.855.

21 [(34)] (35) “Youth offender” means a person who has been found to be within the jurisdiction
22 of the juvenile court under ORS 419C.005 for an act committed when the person was under 18 years
23 of age.

24 **SECTION 3.** ORS 419B.090 is amended to read:

25 419B.090. (1) The juvenile court is a court of record and exercises jurisdiction as a court of
26 general and equitable jurisdiction and not as a court of limited or inferior jurisdiction. The juvenile
27 court is called “The _____ Court of _____ County, Juvenile Department.”

28 (2)(a) It is the policy of the State of Oregon to recognize that children are individuals who have
29 legal rights. Among those rights are the right to:

30 (A) Permanency with a safe family;

31 (B) Freedom from physical, sexual or emotional abuse or exploitation; and

32 (C) Freedom from substantial neglect of basic needs.

33 (b) Parents and guardians have a duty to afford their children the rights listed in paragraph (a)
34 of this subsection. Parents and guardians have a duty to remove any impediment to their ability to
35 perform parental duties that afford these rights to their children. When a parent or guardian fails
36 to fulfill these duties, the juvenile court may determine that it is in the best interests of the child
37 to remove the child from the parent or guardian either temporarily or permanently.

38 (c) The provisions of this chapter shall be liberally construed to the end that a child coming
39 within the jurisdiction of the court may receive such care, guidance, treatment and control as will
40 lead to the child’s welfare and the protection of the community.

41 **(3) It is the policy of the State of Oregon to safeguard and promote each child’s right to**
42 **safety, stability and well-being. The State of Oregon recognizes the importance of a child’s**
43 **relationships with parents, siblings, grandparents and other relatives.**

44 [(3)] (4) It is the policy of the State of Oregon to guard the liberty interest of parents protected
45 by the Fourteenth Amendment to the United States Constitution and to protect the rights and in-

1 terests of children, as provided in subsection (2) of this section. The provisions of this chapter shall
2 be construed and applied in compliance with federal constitutional limitations on state action es-
3 tablished by the United States Supreme Court with respect to interference with the rights of parents
4 to direct the upbringing of their children, including, but not limited to:

- 5 (a) Guide the secular and religious education of their children;
- 6 (b) Make health care decisions for their children; and
- 7 (c) Discipline their children.

8 [(4)] (5) It is the policy of the State of Oregon, in those cases not described as extreme conduct
9 under ORS 419B.502, to offer appropriate reunification services to parents and guardians to allow
10 them the opportunity to adjust their circumstances, conduct or conditions to make it possible for the
11 child to safely return home within a reasonable time. Although there is a strong preference that
12 children live in their own homes with their own families, the state recognizes that it is not always
13 possible or in the best interests of the child or the public for children who have been abused or
14 neglected to be reunited with their parents or guardians. In those cases, the State of Oregon has the
15 obligation to create or provide an alternative, safe and permanent home for the child.

16 [(5)] (6) The State of Oregon recognizes the value of the Indian Child Welfare Act, 25 U.S.C.
17 1901 to 1923, and hereby incorporates the policies of that Act.

18 **SECTION 4.** ORS 419B.185 is amended to read:

19 419B.185. (1) When a child or ward is taken, or is about to be taken, into protective custody
20 pursuant to ORS 419B.150, 419B.160, 419B.165, 419B.168 and 419B.171 and placed in detention or
21 shelter care, a parent, child or ward shall be given the opportunity to present evidence to the court
22 at the hearings specified in ORS 419B.183, and at any subsequent review hearing, that the child or
23 ward can be returned home without further danger of suffering physical injury or emotional harm,
24 endangering or harming others, or not remaining within the reach of the court process prior to ad-
25 judication. At the hearing:

26 (a) The court shall make written findings as to whether the Department of Human Services has
27 made reasonable efforts or, if the Indian Child Welfare Act applies, active efforts to prevent or
28 eliminate the need for removal of the child or ward from the home and to make it possible for the
29 child or ward to safely return home. When the court finds that no services were provided but that
30 reasonable services would not have eliminated the need for protective custody, the court shall con-
31 sider the department to have made reasonable efforts or, if the Indian Child Welfare Act applies,
32 active efforts to prevent or eliminate the need for protective custody. The court shall include in the
33 written findings a brief description of [what] **the** preventive and reunification efforts [were] made
34 by the department.

35 (b) In determining whether a child or ward shall be removed or continued out of home, the court
36 shall consider whether the provision of reasonable services can prevent or eliminate the need to
37 separate the family.

38 (c) In determining whether the department has made reasonable efforts or, if the Indian Child
39 Welfare Act applies, active efforts to prevent or eliminate the need for removal of the child or ward
40 from the home and to make it possible for the child or ward to safely return home, the court shall
41 consider the child or ward's health and safety the paramount concerns.

42 (d) The court shall make a written finding in every order of removal that describes why it is in
43 the best interests of the child or ward that the child or ward be removed from the home or contin-
44 ued in care.

45 **(e) When the court determines that a child or ward shall be removed from the home or**

1 **continued in care, the court shall make written findings whether the department made dili-**
2 **gent efforts pursuant to ORS 419B.192. The court shall include in its written findings a brief**
3 **description of the efforts made by the department.**

4 [(e)] (f) The court shall determine whether the child or ward is an Indian child as defined in
5 ORS 419A.004 or in the applicable State-Tribal Indian Child Welfare Agreement.

6 [(f)] (g) The court may receive testimony, reports and other evidence without regard to whether
7 the evidence is admissible under ORS 40.010 to 40.210 and 40.310 to 40.585 if the evidence is relevant
8 to the determinations and findings required under this section. As used in this paragraph, “relevant
9 evidence” has the meaning given that term in ORS 40.150.

10 (2) To aid the court in making the written findings required by subsection (1)(a), [and] (d) **and**
11 **(e)** of this section, the department shall present written documentation to the court outlining:

12 (a) The [reasonable or active] efforts made to prevent taking the child or ward into protective
13 custody and to provide services to make it possible for the child or ward to safely return home;

14 (b) **The efforts the department made pursuant to ORS 419B.192;** and

15 (c) Why protective custody is in the best interests of the child or ward.

16 **SECTION 5.** ORS 419B.192 is amended to read:

17 419B.192. (1) If the court finds that a child or ward is in need of placement or continuation in
18 substitute care, there shall be a preference given to placement **of the child or ward** with relatives
19 and persons who have a caregiver relationship with the child or ward as defined in ORS 419B.116.
20 The Department of Human Services shall make [reasonable] **diligent** efforts to place the child or
21 ward with such persons and shall report to the court [what] **the** efforts [were] made **by the de-**
22 **partment** to effectuate [such a] **that** placement.

23 **(2) If a child or ward in need of placement or continuation in substitute care has a sibling**
24 **also in need of placement or continuation in substitute care, the department shall make**
25 **diligent efforts to place the siblings together and shall report to the court the efforts made**
26 **by the department to carry out the placement, unless the court finds that placement of the**
27 **siblings together is not in the best interests of the child or the ward or the child’s or the**
28 **ward’s sibling.**

29 [(2)] (3) In attempting to place the child or ward pursuant to [subsection (1)] **subsections (1)**
30 **and (2)** of this section, the department shall consider, but not be limited to **considering**, the fol-
31 lowing:

32 (a) The ability of the person being considered to provide safety for the child or ward, including
33 a willingness to cooperate with any restrictions placed on contact between the child or ward and
34 others, and to prevent anyone from influencing the child or ward in regard to the allegations of the
35 case;

36 (b) The ability of the person being considered to support the efforts of the department to im-
37 plement the permanent plan for the child or ward;

38 (c) The ability of the person being considered to meet the child or ward’s physical, emotional
39 and educational needs, including the child or ward’s need to continue in the same school or educa-
40 tional placement; [and]

41 (d) Which person has the closest existing personal relationship with the child or ward if more
42 than one person requests to have the child or ward placed with them pursuant to this section; **and**

43 **(e) The ability of the person being considered to provide a placement for the child’s or**
44 **ward’s sibling who is also in need of placement or continuation in substitute care.**

45 [(3)] (4) Notwithstanding subsections (1) [and (2)] **to (3)** of this section, in cases where the Indian

1 Child Welfare Act applies, the placement preferences of the Indian Child Welfare Act shall be fol-
2 lowed.

3 **SECTION 6.** ORS 419B.337 is amended to read:

4 419B.337. (1) When the court determines it would be in the best interest and for the welfare of
5 a ward, the court may place the ward in the legal custody of the Department of Human Services for
6 care, placement and supervision. When the court enters an order removing a ward from the ward's
7 home or an order continuing care, the court shall make a written finding as to whether:

8 (a) Removal of the ward from the ward's home or continuation of care is in the best interest and
9 for the welfare of the ward; *[and]*

10 (b) Reasonable efforts, considering the circumstances of the ward and parent, have been made
11 to prevent or eliminate the need for removal of the ward from the home or to make it possible for
12 the ward to safely return home. In making this finding, the court shall consider the ward's health
13 and safety the paramount concerns; **and**

14 **(c) Diligent efforts have been made to place the ward pursuant to ORS 419B.192.**

15 (2) The court may specify the particular type of care, supervision or services to be provided by
16 the Department of Human Services to wards placed in the department's custody and to the parents
17 or guardians of the wards, but the actual planning and provision of such care, supervision or ser-
18 vices is the responsibility of the department. The department may place the ward in a child care
19 center authorized to accept the ward.

20 **(3) The court may make an order regarding visitation by the ward's parents or siblings.**
21 **The Department of Human Services is responsible for developing and implementing a**
22 **visitation plan consistent with the court's order.**

23 *[(3)]* (4) Uniform commitment blanks, in a form approved by the Director of Human Services,
24 shall be used by all courts for placing wards in the legal custody of the Department of Human Ser-
25 vices.

26 *[(4)]* (5) If the ward has been placed in the custody of the Department of Human Services, the
27 court shall make no commitment directly to any residential facility, but shall cause the ward to be
28 delivered into the custody of the department at the time and place fixed by rules of the department.
29 A ward so committed may not be placed in a Department of Corrections institution.

30 *[(5)]* (6) Commitment of a ward to the Department of Human Services continues until dismissed
31 by the court or until the ward becomes 21 years of age.

32 *[(6)]* (7) A court may dismiss commitment of a ward to the Department of Human Services if:

33 (a)(A) Dismissal is appropriate because the ward has been safely reunited with a parent or be-
34 cause a safe alternative to reunification has been implemented for the ward; and

35 (B) The ward is at least 14 years of age but less than 21 years of age and the court finds that:

36 (i) The department has provided case planning pursuant to ORS 419B.343 that addresses the
37 ward's needs and goals for a successful transition to independent living, including needs and goals
38 relating to housing, physical and mental health, education, employment, community connections and
39 supportive relationships;

40 (ii) The department has provided appropriate services pursuant to the case plan;

41 (iii) The department has involved the ward in the development of the case plan and in the pro-
42 vision of appropriate services; and

43 (iv) The ward has safe and stable housing and is unlikely to become homeless as a result of
44 dismissal of commitment of the ward to the department; or

45 (b) The ward has been committed to the custody of the Oregon Youth Authority.

1 **SECTION 7.** ORS 419B.368 is amended to read:

2 419B.368. (1) The court, on its own motion or upon the motion of a party and after such hearing
3 as the court may direct, may review, modify or vacate a guardianship order.

4 (2) The court may modify a guardianship order if the court determines to do so would be in the
5 child's best interests.

6 (3) The court may vacate a guardianship order, return the child to the custody of a parent and
7 make any other order the court is authorized to make under this chapter if the court determines
8 that:

9 (a) It is in the child's best interests to vacate the guardianship;

10 (b) The conditions and circumstances giving rise to the establishment of the guardianship have
11 been ameliorated; and

12 (c) The parent is presently able and willing to adequately care for the child.

13 (4) The court may vacate a guardianship order after determining that the guardian is no longer
14 willing or able to fulfill the duties of a guardian. Upon vacating a guardianship order under this
15 subsection, the court shall conduct a hearing:

16 (a) Within 14 days, make written findings required in ORS 419B.185 (1)(a), [*to (d)*] **(d) and (e)**
17 and make any order directing disposition of the child that the court is authorized to make under this
18 chapter; and

19 (b) Pursuant to ORS 419B.476 within 90 days.

20 (5) In determining whether it is in the child's best interests to modify or vacate a guardianship,
21 the court shall consider, but is not limited to considering:

22 (a) The child's emotional and developmental needs;

23 (b) The child's need to maintain existing attachments and relationships and to form attachments
24 and relationships, including those with the birth family;

25 (c) The child's health and safety; and

26 (d) The child's wishes.

27 (6) In addition to service required under ORS 419B.851, a party filing a motion to vacate a
28 guardianship shall serve the motion upon the Department of Human Services.

29 (7) Notwithstanding subsection (1) of this section, a parent may not move the court to vacate
30 a guardianship once a guardianship is granted under ORS 419B.365.

32 419B.443. (1) [*The*] **An agency described in ORS 419B.440** shall file the reports required by ORS

36 (a) A description of the problems or offenses that necessitated the placement of the child or

1 (e) **A list of dates of face-to-face contacts the assigned case worker has had with the**
2 **child or ward since the child or ward has been in the guardianship or legal custody of the**
3 **agency and, for a child or ward in substitute care, the place of each contact;**

4 (f) **For a child or ward in substitute care, a list of the visits the child or ward has had**
5 **with the child's or ward's parents or siblings since the child or ward has been in the**
6 **guardianship or legal custody of the agency and the place and date of each visit;**

7 [(c)] (g) A description of agency efforts to return the child or ward to the parental home or find
8 permanent placement for the child or ward, including, when applicable, efforts to assist the parents
9 in remedying factors which contributed to the removal of the child or ward from the home;

10 [(d)] (h) A proposed treatment plan or proposed continuation or modification of an existing
11 treatment plan, including[, *when applicable, terms of visitation to be allowed and expected of*
12 *parents*] **a proposed visitation plan or proposed continuation or modification of an existing**
13 **visitation plan** and a description of efforts expected of the child or ward and the parents to remedy
14 factors that have prevented the child or ward from safely returning home within a reasonable time;
15 and

16 [(e)] (i) If continued substitute care is recommended, a proposed timetable for the [*child*] **child's**
17 or ward's return home or other permanent placement or a justification of why extended substitute
18 care is necessary.

19 (2) Notwithstanding the requirements of subsection (1) of this section, reports following the ini-
20 tial report need not contain information contained in prior reports.

21 **SECTION 9.** ORS 419B.449 is amended to read:

22 419B.449. (1) Upon receiving any report required by ORS 419B.440 [*and 419B.443*], the court may
23 hold a hearing to review the child or ward's condition and circumstances and to determine if the
24 court should continue jurisdiction and wardship or order modifications in the care, placement and
25 supervision of the child or ward. The court shall hold a hearing:

26 (a) In all cases under ORS 419B.440 (3) when the parents' rights have been terminated; or

40 **assigned case worker and visits had with parents or siblings since the child or ward has been**
41 **in the guardianship or legal custody of the agency and whether the frequency of each of**
42 **these is in the best interests of the child or ward.**

43 **(d) For a child or ward 14 years of age or older, whether the child or ward is progressing**
44 **adequately toward graduation from high school and, if not, the efforts that have been made**
45 **by the agency having custody or guardianship to assist the child or ward to graduate.**

1 (3) In making the findings under subsection (2) of this section, the court shall consider the ef-
2 forts made to develop the concurrent case plan, including, but not limited to, identification and se-
3 lection of a suitable adoptive placement for the child or ward when adoption is the concurrent case
4 plan.

5 (4) In addition to findings of fact required by subsection (2) of this section, the court may order
6 the Department of Human Services to consider additional information in developing the case plan
7 or concurrent case plan.

8 (5) Any final decision of the court made pursuant to the hearing provided in subsection (1) of
9 this section is appealable under ORS 419A.200.

11 419B.470. (1) The court shall conduct a permanency hearing within 30 days after a judicial
12 finding is made under ORS 419B.340 (5) if, based upon that judicial finding, the Department of Hu-
13 man Services determines that it will not make reasonable efforts to reunify the family.

14 (2) In all other cases when a child or ward is in substitute care, the court shall conduct a
15 permanency hearing no later than 12 months after the ward was found within the jurisdiction of the
16 court under ORS 419B.100 or 14 months after the child or ward was placed in substitute care,

3 (a) The child or ward has been in substitute care under the responsibility of the department for

7 commit murder or voluntary manslaughter of the child or ward or of another child of the parent or

12 (B) Who has been accepted for placement and care by the Department of Human Services;

13 (C) Who has been placed in a foster home or licensed [*nonprofit*] private child-caring agency as
