Senate Bill 421

Sponsored by Senator GORDLY

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Abolishes Oregon Advocacy Commissions Office. Allows Commission on Hispanic Affairs, Commission on Black Affairs, Commission for Women and Commission on Asian Affairs to hire executive directors and establishes dedicated accounts for those commissions. Appropriates moneys and establishes expenditure limitations for advocacy commissions.

Declares emergency, effective July 1, 2007.

SECTION 8. Sections 9 and 10 of this 2007 Act are added to and made a part of ORS 185.510 to 185.550.

SECTION 10. The Commission for Women Account is established separate and distinct from the General Fund. All moneys received by the Commission for Women, other than appropriations from the General Fund, shall be deposited into the account and are continuously appropriated to the commission to carry out the duties, functions and powers of the commission.

SECTION 11. The Commission on Asian Affairs may employ an executive director and other staff as may be necessary to carry out its functions. The commission may also establish special committees as it considers necessary.

SECTION 12. The Commission on Asian Affairs Account is established separate and distinct from the General Fund. All moneys received by the Commission on Asian Affairs, other than appropriations from the General Fund, shall be deposited into the account and are continuously appropriated to the commission to carry out the duties, functions and powers of the commission.

CONFORMING AMENDMENTS

SECTION 13. ORS 185.320 is amended to read:

185.320. (1) The Commission on Hispanic Affairs shall be comprised of 11 members, to include two representatives from the Legislative Assembly, one appointed by the President of the Senate, one appointed by the Speaker of the House of Representatives. Nine members shall be appointed by the Governor and confirmed by the Senate pursuant to section 4, Article III, Oregon Constitution. To the extent possible, members appointed by the Governor shall provide for representation from all areas of the state. All of the members of the commission shall be residents of this state.

- (2) Members appointed by the Governor shall serve three-year terms. Legislators shall serve two-year terms.
 - (3) The commission members shall elect a chairperson and vice chairperson.
- (4) A majority of the members of the commission [constitute] constitutes a quorum for the transaction of business.
- (5) Appointments to the commission shall be made to ensure representation of Hispanics in Oregon.
- (6) Members of the commission who are not legislators shall be paid compensation and expenses as provided in ORS 292.495 from funds appropriated to the [Oregon Advocacy Commissions Office] commission.
- (7) Members of the commission who are legislators shall be paid compensation and expense reimbursement as provided in ORS 171.072, payable from funds appropriated to the Legislative Assembly.
 - **SECTION 14.** ORS 185.420 is amended to read:
 - 185.420. (1) The Commission on Black Affairs shall be comprised of 11 members, to include two

- representatives from the Legislative Assembly, one appointed by the President of the Senate, one appointed by the Speaker of the House of Representatives. Nine members shall be appointed by the Governor and confirmed by the Senate pursuant to section 4, Article III, Oregon Constitution. To the extent possible, members appointed by the Governor shall provide for representation from all areas of the state. All of the members of the commission shall be residents of this state.
 - (2) Members appointed by the Governor shall serve three-year terms. Legislators shall serve two-year terms.
 - (3) The commission members shall elect a chairperson and vice chairperson.
- (4) A majority of the members of the commission [constitute] constitutes a quorum for the transaction of business.
 - (5) Appointments to the commission shall be made to ensure representation of blacks in Oregon.
- (6) Members of the commission who are not legislators shall be paid compensation and expenses as provided in ORS 292.495 from funds appropriated to the [Oregon Advocacy Commissions Office] commission.
- (7) Members of the commission who are legislators shall be paid compensation and expense reimbursement as provided in ORS 171.072, payable from funds appropriated to the Legislative Assembly.

SECTION 15. ORS 185.550 is amended to read:

- 185.550. (1) Members of the Commission for Women who are not legislators shall be paid compensation and expenses as provided in ORS 292.495 from funds appropriated to the [Oregon Advocacy Commissions Office] commission.
- (2) Members of the commission who are legislators shall be paid compensation and expense reimbursement as provided in ORS 171.072, payable from funds appropriated to the Legislative Assembly.

SECTION 16. ORS 185.610 is amended to read:

- 185.610. (1) The Commission on Asian Affairs is created. The commission has 11 members. Nine of the 11 members shall be appointed by the Governor, subject to confirmation by the Senate under ORS 171.562 and 171.565. The President of the Senate shall appoint one Senator as a member of the commission, and the Speaker of the House of Representatives shall appoint one Representative as a member of the commission. To the extent possible, members appointed by the Governor shall provide for representation from all areas of the state. All of the members of the commission shall be residents of this state.
- (2) The term of office is three years. Appointments to fill a vacancy for an unexpired term shall be made by the person who made the original appointment.
- (3) The commission shall elect a chairperson and vice chairperson for a term of one year and shall determine the duties of the officers.
- (4) A majority of the members of the commission constitutes a quorum for the transaction of business.
- (5) Appointments to the commission shall be made to ensure ethnic representation of Asian Americans in Oregon.
- (6) Members of the commission who are not legislators shall be paid compensation and expenses as provided in ORS 292.495 from funds appropriated to the [Oregon Advocacy Commissions Office] commission.
- (7) Members of the commission who are legislators shall be paid compensation and expense reimbursement as provided in ORS 171.072, payable from funds appropriated to the Legislative As-

sembly.

TRANSITIONAL PROVISIONS

SECTION 17. (1) Any amounts in the Oregon Advocacy Commissions Office Account that are unexpended on the effective date of this 2007 Act are transferred to the Commission on Hispanic Affairs Account, the Commission on Black Affairs Account, the Commission for Women Account and the Commission on Asian Affairs Account in such amounts as may be determined by the Director of the Oregon Department of Administrative Services. The decision of the director on the amounts to be transferred to each account is final and not subject to review.

(2) Any amounts that are unexpended on the effective date of this 2007 Act and that were authorized to be expended by the Oregon Advocacy Commissions Office from revenues dedicated, continuously appropriated, appropriated or otherwise made available for the purpose of administering and enforcing the duties, functions and powers of the office are appropriated and shall be transferred to and are available for expenditure by the Commission on Hispanic Affairs, the Commission on Black Affairs, the Commission for Women and the Commission on Asian Affairs for the biennium beginning July 1, 2007, for the purpose of administering and enforcing the duties, functions and powers of the commissions. The Director of the Oregon Department of Administrative Services shall determine the amount to be transferred to each commission. The decision of the director on the amounts to be transferred to each commission is final and not subject to review.

SECTION 18. All rights and obligations of the Oregon Advocacy Commissions Office legally incurred under contracts, leases and business transactions executed, entered into or begun before the effective date of this 2007 Act are transferred to the Commission on Hispanic Affairs, the Commission on Black Affairs, the Commission for Women and the Commission on Asian Affairs. The Director of the Oregon Department of Administrative Services shall determine the rights and obligations to be transferred to each commission. The decision of the director on the transfer of rights and obligations is final and not subject to review. For the purpose of succession to these rights and obligations, the Commission on Hispanic Affairs, the Commission on Black Affairs, the Commission for Women and the Commission on Asian Affairs are a continuation of the Oregon Advocacy Commissions Office and not new authorities.

APPROPRIATIONS AND EXPENDITURE LIMITATIONS

SECTION 19. There is appropriated to the Commission on Hispanic Affairs, for the biennium beginning July 1, 2007, out of the General Fund, the amount of \$_____ for the purpose of carrying out the duties, functions and powers of the commission.

<u>SECTION 20.</u> Notwithstanding any other law limiting expenditures, the amount of \$_____ is established for the biennium beginning July 1, 2007, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Commission on Hispanic Affairs.

SECTION 21. There is appropriated to the Commission on Black Affairs, for the biennium

16	SECTION 25. There is appropriated to the Commission on Asian Affairs, for the biennium

33	SECTION 28. This 2007 Act being necessary for the immediate preservation of the public
34	peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect
