A-Engrossed Senate Bill 491

Sponsored by Senator DECKERT (at the request of Helen Cotton Leiser)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires health insurers that provide coverage for cochlear implant to provide coverage of bilateral cochlear implants. Provides that for purposes of unfair claim settlement practices, reasonable investigation of claim for bilateral cochlear implants must include recommendation from treating surgeon based on medical literature and findings.

- 5 SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Insurance Code.

 7 a cochlear implant, the insured under the policy is entitled to coverage of bilateral cochlear
