Senate Bill 491

Sponsored by Senator DECKERT (at the request of Helen Cotton Leiser)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Requires health insurers that provide coverage for cochlear implant to provide coverage of bilateral cochlear implants.

A BILL FOR AN ACT

- 2 Relating to insurance coverage of bilateral cochlear implants; creating new provisions; and amend-3 ing ORS 750.055 and 750.333.
- Be It Enacted by the People of the State of Oregon: 4
 - SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Insurance Code.
- 6 SECTION 2. (1) Whenever any policy of health insurance provides for reimbursement of 7 a cochlear implant, the insured under the policy is entitled to coverage of bilateral cochlear 8 implants.
 - (2) This provisions of this section apply to a health benefit plan as defined in ORS 743.730.
 - (3) The provisions of this section are exempt from ORS 743.700.
