

Senate Bill 5504

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Budget and Management Division, Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to State Commission on Children and Families for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and certain federal funds, but excluding lottery funds and other federal funds, collected or received by commission.

Limits biennial expenditures by commission from federal funds.

Declares emergency, effective July 1, 2007.

A BILL FOR AN ACT

2 Relating to financial administration of the State Commission on Children and Families; appropriating
3 money; limiting expenditures; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There is appropriated to the State Commission on Children and Families, for**
6 **the biennium beginning July 1, 2007, out of the General Fund, the amount of \$64,519,003.**

7 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**
8 **\$23,538,795 is established for the biennium beginning July 1, 2007, as the maximum limit for**
9 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**
10 **and including federal funds received from the Department of Human Services and the Em-**
11 **ployment Department for family preservation and support, child care and development and**
12 **other services supporting children and families, but excluding lottery funds and federal funds**
13 **not described in this section, collected or received by the State Commission on Children and**
14 **Families.**

15 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**
16 **\$4,501,054 is established for the biennium beginning July 1, 2007, as the maximum limit for**
17 **payment of expenses from federal funds other than those described in section 2 of this 2007**
18 **Act collected or received by the State Commission on Children and Families.**

19 **SECTION 4. This 2007 Act being necessary for the immediate preservation of the public**
20 **peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect**
21 **July 1, 2007.**
