SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Appropriates moneys from General Fund to Housing and Community Services Department for biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, and including certain federal funds, but excluding lottery funds and other federal funds, collected or received by department.

Limits biennial expenditures by department from certain lottery moneys.

Limits biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2007.

A BILL FOR AN ACT

2 Relating to financial administration of the Housing and Community Services Department; appropri-

Be It Enacted by the People of the State of Oregon: 4

5 SECTION 1. There is appropriated to the Housing and Community Services Department,

6 for the biennium beginning July 1, 2007, out of the General Fund, the amount of \$22,922,600. SECTION 2. Notwithstanding any other law limiting expenditures, the amount of 7 8 \$106,515,665 is established for the biennium beginning July 1, 2007, as the maximum limit for 9 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts

and federal funds from the United States Department of Housing and Urban Development for 10

contract services, but excluding lottery funds and federal funds not described in this section, 11

collected or received by the Housing and Community Services Department. 12

SECTION 3. Notwithstanding any other law limiting expenditures, the amount of 13 \$6,085,943 is established for the biennium beginning July 1, 2007, as the maximum limit for 14 payment of expenses from lottery moneys allocated from the Administrative Services Eco-1516 nomic Development Fund to the Housing and Community Services Department for lottery bonds. 17

SECTION 4. Notwithstanding any other law limiting expenditures, the amount of 18 \$116,576,772 is established for the biennium beginning July 1, 2007, as the maximum limit for 19 20 payment of expenses from federal funds other than those described in sections 2 and 5 of this

22 SECTION 5. For the biennium beginning July 1, 2007, expenditures by the Housing and 23Community Services Department for the following are not limited:

24 (1) Payments for costs resulting from the sale and issuance or redemption of bonds issued under ORS 456.519, 456.645 and 456.650 and chapter 485, Oregon Laws 1977, and payment 2526

of debt service and redemption premium on bonds so issued.
