- 23 **gaming services specified in section 1 (1), chapter 718, Oregon Laws 2005, as modified by**
- 24 **Emergency Board action, is reduced by \$50,000.**
- 25 **“(2) The General Fund appropriation for the Office of Emergency Management, State Fire**
- 26 **Marshal and criminal justice services specified in section 1 (5), chapter 718, Oregon Laws**
- 27 **2005, as modified by Emergency Board action, is reduced by \$636,000.**
- 28 **“(3) The limitation on expenditures from fees, moneys or other revenues, including Mis-**
- 29 **cellaneous Receipts, but excluding lottery funds and federal funds for the Office of Emer-**
- 30 **gency Management, State Fire Marshal and criminal justice services, established by section**
- 31 **2 (5), chapter 718, Oregon Laws 2005, as modified by Emergency Board action, is increased**
- 32 **by \$988,300.”.**
