## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Department of Public Safety Standards and Training for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department.

Limits biennial expenditures by department from federal funds.

Increases, for biennium ending June 30, 2007, limitation on biennial expenditures by department for debt service.

Declares emergency, effective [July 1, 2007] on passage.

A BILL FOR AN ACT

Relating to financial administration of the Department of Public Safety Standards and Training; appropriating money; limiting expenditures; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

<u>SECTION 1.</u> There is appropriated to the Department of Public Safety Standards and Training, for the biennium beginning July 1, 2007, out of the General Fund, the amount of \$11,150,003 for debt service.

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2007, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Department of Public Safety Standards and Training, for the following purposes:

- (1) Operations...... \$ 36,980,702
  - (2) Debt service ...... \$ 238,965
- 15 (3) Public Safety Memorial Fund ... \$ 573,326

<u>SECTION 3.</u> Notwithstanding any other law limiting expenditures, the amount of \$54,635 is established for the biennium beginning July 1, 2007, as the maximum limit for payment of expenses from federal funds collected or received by the Department of Public Safety Standards and Training.

SECTION 4. Notwithstanding any other law limiting expenditures for the payment of expenses of the Department of Public Safety Standards and Training from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, for the biennium ending June 30, 2007, the limitation on expenditures for debt service
