

SENATE AMENDMENTS TO SENATE BILL 5548

By JOINT COMMITTEE ON WAYS AND MEANS

1 In line 2 of the printed bill, delete “limiting expenditures;”.

2 Delete lines 5 through 18 and insert:

3 **“SECTION 1. As used in sections 1 to 4 of this 2007 Act, ‘state agency’ means every state**
4 **officer, board, commission, department, institution, branch or agency of the state govern-**
5 **ment, the costs of which are paid wholly or in part from funds held in the State Treasury.**

6 **“SECTION 2. (1) Notwithstanding ORS 291.230 to 291.260, and subject to any rule that**
7 **may be adopted by the Oregon Department of Administrative Services, any obligations in-**
8 **curring by a state agency on or after July 1, 2007, that do not exceed the level of expenditures**
9 **authorized under ORS 291.230 to 291.260 or otherwise authorized for the last quarter of the**
10 **2005-2007 biennium are hereby authorized, and necessary funds are appropriated therefor,**
11 **unless the Oregon Department of Administrative Services determines that the state agency’s**
12 **expenditure level should be modified, based on pending legislation.**

13 **“(2) The Oregon Department of Administrative Services by rule shall specify the means**
14 **whereby funds expended pursuant to subsection (1) of this section are reconciled and charged**
15 **to the state agency’s 2007-2009 legislatively approved budget during the 2007-2009 biennium.**

16 **“(3) All payments for debt service, certificates of participation and other financing**
17 **agreements are hereby authorized during the period commencing July 1, 2007.**

18 **“SECTION 3. Sections 1 to 4 of this 2007 Act apply to a state agency for which no budget**
19 **has become law on or before July 1, 2007.**

20 **“SECTION 4. (1) If there is no 2007-2009 legislatively adopted budget upon final**
21 **adjournment of the regular session of the Seventy-fourth Legislative Assembly against which**
22 **any expenditure authorized by section 2 (1) of this 2007 Act can be applied, the expenditure**
23 **shall be considered to have been made from funds appropriated to the Oregon Department**
24 **of Administrative Services. For the purpose of paying the incurred expenses of state agen-**
25 **cies, there is appropriated to the Oregon Department of Administrative Services any cash**
26 **or other funds remaining in the accounts of the state agency for which no budget has been**
27 **adopted and for which no expenditure authority exists when the Legislative Assembly ad-**
28 **journs sine die. The Oregon Department of Administrative Services may apply for re-**
29 **imbursement from the Emergency Board of any expenditure made under this subsection**
30 **during the 2007-2009 biennium.**

31 **“(2) If, after final adjournment of the regular session of the Seventy-fourth Legislative**
32 **Assembly, the Governor vetoes a legislatively adopted budget against which any expenditure**
33 **authorized by section 2 (1) of this 2007 Act can be applied, the expenditure shall be considered**
34 **to have been made from funds appropriated to the Oregon Department of Administrative**
35 **Services. For the purpose of paying the incurred expenses of state agencies, there is ap-**

1 **propriated to the Oregon Department of Administrative Services any cash or other funds**
2 **remaining in the accounts of the state agency for which a legislatively adopted budget has**
3 **been vetoed and for which no expenditure authority exists when the Governor vetoes the**
4 **budget. The Oregon Department of Administrative Services may apply for reimbursement**
5 **from the Emergency Board of any expenditure made under this subsection during the**
6 **2007-2009 biennium.**

7 **“SECTION 5. Sections 1 to 4 of this 2007 Act are repealed on July 31, 2007.**

8 **“SECTION 6. This 2007 Act being necessary for the immediate preservation of the public**
9 **peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect**
10 **July 1, 2007.”.**
