SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates crime of subjecting another to involuntary servitude in first degree. Punishes by maximum of 10 years' imprisonment, \$250,000 fine, or both.

Creates crime of subjecting another to involuntary servitude in second degree. Punishes by maximum of five years' imprisonment, \$125,000 fine, or both.

Creates crime of trafficking in persons. Punishes by maximum of 10 years' imprisonment, \$250,000 fine, or both.

Allows victim of involuntary servitude or trafficking in persons to seek restitution.

Subjects crimes of involuntary servitude and trafficking in persons to provisions relating to racketeering.

Allows victim of involuntary servitude or trafficking in persons to raise defense of duress if prosecuted for services performed while victim.

[Creates Task Force on Trafficking in Persons.] Declares emergency, effective on passage.

24 <u>SECTION 10.</u> A person who is the victim of a crime described in section 2, 3 or 4 of this 25 2007 Act may assert the defense of duress, as described in ORS 161.270, if the person is 26 prosecuted for conduct that constitutes services under section 1 of this 2007 Act, that the 27 person was caused to provide.

28 <u>SECTION 11.</u> This 2007 Act being necessary for the immediate preservation of the public 29 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect 30 on its passage.
