22	or deportation;
23	"(d) Threatening to collect an unlawful debt; or
24	"(e) Instilling in the other person a fear that the actor will withhold from the other
25	person the necessities of life, including but not limited to lodging, food and clothing.
26	"(2) Subjecting another person to involuntary servitude in the second degree is a Class
27	C felony.
28	"SECTION 4. (1) A person commits the crime of trafficking in persons if the person
29	knowingly:
30	"(a) Recruits, entices, harbors, transports, provides or obtains by any means, or at-
31	tempts to recruit, entice, harbor, transport, provide or obtain by any means, another person
32	knowing that the other person will be subjected to involuntary servitude as described in
33	section 2 or 3 of this 2007 Act; or
34	"(b) Benefits financially or receives something of value from participation in a venture
35	that involves an act prohibited by this section or section 2 or 3 of this 2007 Act.

39	"(2) Upon prevailing in an action under this section, the plaintiff may recover:
40	"(a) Both special and general damages, including damages for emotional distress; and
41	"(b) Punitive damages.
42	"(3) The court shall award reasonable attorney fees to the prevailing plaintiff in an action
43	under this section. The court may award reasonable attorney fees and expert witness fees
44	incurred by a defendant who prevails in the action if the court determines that the plaintiff
45	had no objectively reasonable basis for asserting a claim or no reasonable basis for appealing

1 an adverse decision of a circuit court.

2 "(4) An action under this section must be commenced within six years of the conduct giving rise to the claim. 3 4 "SECTION 10. A person who is the victim of a crime described in section 2, 3 or 4 of this 2007 Act may assert the defense of duress, as described in ORS 161.270, if the person is 5 prosecuted for conduct that constitutes services under section 1 of this 2007 Act, that the 6 7 person was caused to provide. "SECTION 11. (1) There is created the Task Force on Trafficking in Persons, consisting 8 of: 9 "(a) The Attorney General or the Attorney General's designee; 10 "(b) The Director of Human Services or the director's designee; 11 "(c) The Director of the Employment Department or the director's designee; 12 "(d) The Commissioner of the Bureau of Labor and Industries or the commissioner's 13 14 designee; "(e) Two members, one from the majority party and one from the minority party, from 15 16 among members of the Senate, appointed by the President of the Senate; "(f) Two members, one from the majority party and one from the minority party, from 1718 among members of the House of Representatives, appointed by the Speaker of the House of 19 **Representatives**; and "(g) Seven members appointed by the Attorney General. In appointing members under 20 21this paragraph, the Attorney General shall select persons who represent public and private 22organizations that provide assistance to persons who are victims of trafficking in persons 23or who have other expertise in human trafficking issues. "(2) The task force shall: 24 25"(a) Assess the extent of the problem of trafficking in persons in Oregon; "(b) Measure and evaluate the progress of the state's efforts at preventing trafficking in 26 27 persons; "(c) Identify available federal, state and local programs that provide services to persons 28 29 who are victims of trafficking in persons, including but not limited to health care, human services, housing, education, legal assistance, job training or preparation, interpreting ser-30 vices and victims' compensation; and 31"(d) Make recommendations on methods to provide a coordinated system of support and 3233 assistance to persons who are victims of trafficking in persons. "(3) A majority of the members of the task force constitutes a quorum for the trans-3435 action of business. "(4) Official action by the task force requires the approval of a majority of the members 36 37 of the task force. "(5) The task force shall elect one of its members to serve as chairperson. 38 "(6) If there is a vacancy for any cause, the appointing authority shall make an appoint-39 40 ment to become immediately effective. 41 "(7) The task force shall meet at times and places specified by the call of the chairperson or of a majority of the members of the task force. 42"(8) The task force may adopt rules necessary for the operation of the task force. 43 44 "(9) The task force shall submit a report, and may include recommendations for legis-45 lation, to an interim committee related to the judiciary no later than October 1, 2008.

1 "(10) The Department of Justice shall provide staff support to the task force.

"(11) Notwithstanding ORS 171.072, members of the task force are not entitled to compensation, but may be reimbursed for actual and necessary travel and other expenses incurred by them in the performance of their official duties in the manner and amounts provided for in ORS 292.495. Claims for expenses shall be paid out of funds appropriated to the Department of Justice for that purpose.

"(12) All agencies of state government, as defined in ORS 174.111, are directed to assist the task force in the performance of its duties and, to the extent permitted by laws relating to confidentiality, to furnish such information and advice as the members of the task force consider necessary to perform their duties.

"(13) All appointments to the task force made under subsection (1) of this section must
be completed within 30 days after the effective date of this 2007 Act.

13 "(14) The Department of Justice may accept contributions of moneys and assistance from 14 the United States Government or its agencies or from any other source, public or private, 15 and agree to conditions placed on the moneys not inconsistent with the duties of the task 16 force.

17 "(15) All moneys received by the Department of Justice under subsection (14) of this 18 section shall be used for the purpose of carrying out the duties of the task force.

19 "SECTION 12. Section 11 of this 2007 Act is repealed on January 2, 2009.

20 "SECTION 13. This 2007 Act being necessary for the immediate preservation of the public 21 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect 22 on its passage.".
