**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

*[Allows small employer carriers to provide discounts for employees who do not smoke tobacco.]*  
**Changes definition of "small employer" for purposes of health benefit plans by increasing maximum number of employees placed on small employer carriers.**  
**Modifies requirements placed on small employer carriers.**  
Expands rate band for small employer carriers to 50 percent deviation from geographic average rate. **Specifies factors on which small employer carriers may base variation in premium rate.**  
*[Permits small employer carriers to provide discounts to businesses in which all employees participate in plan, that stay with carrier and that provide dependent coverage.]*  
**Declares emergency, effective on passage.**

**A BILL FOR AN ACT**

2 Relating to small employer carriers; creating new provisions; amending ORS 743.730, 743.733, 743.734  
3 and 743.737; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 743.730 is amended to read:

6 743.730. *[As used in]* **For purposes of ORS 743.730 to 743.773:**

7 (1) "Actuarial certification" means a written statement by a member of the American Academy  
8 of Actuaries or other individual acceptable to the Director of the Department of Consumer and  
9 Business Services that a carrier is in compliance with the provisions of ORS 743.736, 743.760 or  
10 743.761, based upon the person's examination, including a review of the appropriate records and of  
11 the actuarial assumptions and methods used by the carrier in establishing premium rates for small  
12 employer and portability health benefit plans.

13 (2) "Affiliate" of, or person "affiliated" with, a specified person means any carrier who, directly  
14 or indirectly through one or more intermediaries, controls or is controlled by or is under common  
15 control with a specified person. For purposes of this definition, "control" has the meaning given that  
16 term in ORS 732.548.

17 (3) "Affiliation period" means, under the terms of a group health benefit plan issued by a health  
18 care service contractor, a period:

19 (a) That is applied uniformly and without regard to any health status related factors to an  
20 enrollee or late enrollee in lieu of a preexisting conditions provision;

21 (b) That must expire before any coverage becomes effective under the plan for the enrollee or  
22 late enrollee;

23 (c) During which no premium shall be charged to the enrollee or late enrollee; and

1 (d) That begins on the enrollee's or late enrollee's first date of eligibility for coverage and runs  
2 concurrently with any eligibility waiting period under the plan.

3 (4) "Basic health benefit plan" means a health benefit plan for small employers that is required  
4 to be offered by all small employer carriers and approved by the Director of the Department of  
5 Consumer and Business Services in accordance with ORS 743.736.

6 (5) "Bona fide association" means an association that meets the requirements of 42 U.S.C.  
7 300gg-11 as amended and in effect on July 1, 1997.

8 (6) "Carrier" means any person who provides health benefit plans in this state, including a li-  
9 censed insurance company, a health care service contractor, a health maintenance organization, an  
10 association or group of employers that provides benefits by means of a multiple employer welfare  
11 arrangement or any other person or corporation responsible for the payment of benefits or provision  
12 of services.

13 (7) "Committee" means the Health Insurance Reform Advisory Committee created under ORS  
14 743.745.

15 (8) "Creditable coverage" means prior health care coverage as defined in 42 U.S.C. 300gg as  
16 amended and in effect on July 1, 1997, and includes coverage remaining in force at the time the  
17 enrollee obtains new coverage.

18 (9) "Department" means the Department of Consumer and Business Services.

19 (10) "Dependent" means the spouse or child of an eligible employee, subject to applicable terms  
20 of the health benefit plan covering the employee.

21 (11) "Director" means the Director of the Department of Consumer and Business Services.

22 (12) "Eligible employee" means an employee of a small employer who works on a regularly  
23 scheduled basis, with a normal work week of 17.5 or more hours. The employer may determine hours  
24 worked for eligibility between 17.5 and 40 hours per week subject to rules of the carrier. "Eligible  
25 employee" [*includes sole proprietors, partners of a partnership, leased workers as defined in ORS*  
26 *743.522 or independent contractors if they are included as employees under a health benefit plan of a*  
27 *small employer but*] does not include employees who work on a temporary, seasonal or substitute  
28 basis. Employees who have been employed by the small employer for fewer than 90 days are not  
29 eligible employees unless the small employer so allows.

30 **(13) "Employee" means any individual employed by an employer.**

31 [(13)] (14) "Enrollee" means an employee, dependent of the employee or an individual otherwise  
32 eligible for a group, individual or portability health benefit plan who has enrolled for coverage under  
33 the terms of the plan.

34 [(14)] (15) "Exclusion period" means a period during which specified treatments or services are  
35 excluded from coverage.

36 [(15)] (16) "Financially impaired" means a member that is not insolvent and is:

37 (a) Considered by the Director of the Department of Consumer and Business Services to be po-  
38 tentially unable to fulfill its contractual obligations; or

39 (b) Placed under an order of rehabilitation or conservation by a court of competent jurisdiction.

40 [(16)(a)] (17)(a) "Geographic average rate" means the arithmetical average of the lowest pre-  
41 mium and the corresponding highest premium to be charged by a carrier in a geographic area es-  
42 tablished by the director for the carrier's:

43 (A) Small employer group health benefit plans;

44 (B) Individual health benefit plans; or

45 (C) Portability health benefit plans.

1 (b) "Geographic average rate" does not include premium differences that are due to differences  
2 in benefit design or family composition.

3 [(17)] (18) "Group eligibility waiting period" means, with respect to a group health benefit plan,  
4 the period of employment or membership with the group that a prospective enrollee must complete  
5 before plan coverage begins.

6 [(18)(a)] (19)(a) "Health benefit plan" means any hospital expense, medical expense or hospital  
7 or medical expense policy or certificate, health care service contractor or health maintenance or-  
8 ganization subscriber contract, any plan provided by a multiple employer welfare arrangement or  
9 by another benefit arrangement defined in the federal Employee Retirement Income Security Act of  
10 1974, as amended.

11 (b) "Health benefit plan" does not include coverage for accident only, specific disease or condi-  
12 tion only, credit, disability income, coverage of Medicare services pursuant to contracts with the  
13 federal government, Medicare supplement insurance policies, coverage of CHAMPUS services pur-  
14 suant to contracts with the federal government, benefits delivered through a flexible spending ar-  
15 rangement established pursuant to section 125 of the Internal Revenue Code of 1986, as amended,  
16 when the benefits are provided in addition to a group health benefit plan, long term care insurance,  
17 hospital indemnity only, short term health insurance policies (the duration of which does not exceed  
18 six months including renewals), student accident and health insurance policies, dental only, vision  
19 only, a policy of stop-loss coverage that meets the requirements of ORS 742.065, coverage issued as  
20 a supplement to liability insurance, insurance arising out of a workers' compensation or similar law,  
21 automobile medical payment insurance or insurance under which benefits are payable with or  
22 without regard to fault and that is statutorily required to be contained in any liability insurance  
23 policy or equivalent self-insurance.

24 (c) Nothing in this subsection shall be construed to regulate any employee welfare benefit plan  
25 that is exempt from state regulation because of the federal Employee Retirement Income Security  
26 Act of 1974, as amended.

27 [(19)] (20) "Health statement" means any information that is intended to inform the carrier or  
28 insurance producer of the health status of an enrollee or prospective enrollee in a health benefit  
29 plan. "Health statement" includes the standard health statement developed by the Health Insurance  
30 Reform Advisory Committee.

31 [(20)] (21) "Implementation of chapter 836, Oregon Laws 1989" means that the Health Services  
32 Commission has prepared a priority list, the Legislative Assembly has enacted funding of the list  
33 and all necessary federal approval, including waivers, has been obtained.

34 [(21)] (22) "Individual coverage waiting period" means a period in an individual health benefit  
35 plan during which no premiums may be collected and health benefit plan coverage issued is not ef-  
36 fective.

37 [(22)] (23) "Initial enrollment period" means a period of at least 30 days following commence-  
38 ment of the first eligibility period for an individual.

39 [(23)] (24) "Late enrollee" means an individual who enrolls in a group health benefit plan sub-  
40 sequent to the initial enrollment period during which the individual was eligible for coverage but  
41 declined to enroll. However, an eligible individual shall not be considered a late enrollee if:

42 (a) The individual qualifies for a special enrollment period in accordance with 42 U.S.C. 300gg  
43 as amended and in effect on July 1, 1997;

44 (b) The individual applies for coverage during an open enrollment period;

45 (c) A court has ordered that coverage be provided for a spouse or minor child under a covered

1 employee's health benefit plan and request for enrollment is made within 30 days after issuance of  
2 the court order;

3 (d) The individual is employed by an employer who offers multiple health benefit plans and the  
4 individual elects a different health benefit plan during an open enrollment period; or

5 (e) The individual's coverage under Medicaid, Medicare, CHAMPUS, Indian Health Service or  
6 a publicly sponsored or subsidized health plan, including but not limited to the Oregon Health Plan,  
7 has been involuntarily terminated within 63 days of applying for coverage in a group health benefit  
8 plan.

9 [(24)] **(25)** "Multiple employer welfare arrangement" means a multiple employer welfare ar-  
10 rangement as defined in section 3 of the federal Employee Retirement Income Security Act of 1974,  
11 as amended, 29 U.S.C. 1002, that is subject to ORS 750.301 to 750.341.

12 [(25)] **(26)** "Oregon Medical Insurance Pool" means the pool created under ORS 735.610.

13 [(26)] **(27)** "Preexisting conditions provision" means a health benefit plan provision applicable  
14 to an enrollee or late enrollee that excludes coverage for services, charges or expenses incurred  
15 during a specified period immediately following enrollment for a condition for which medical advice,  
16 diagnosis, care or treatment was recommended or received during a specified period immediately  
17 preceding enrollment. For purposes of ORS 743.730 to 743.773:

18 (a) Pregnancy does not constitute a preexisting condition except as provided in ORS 743.766;

19 (b) Genetic information does not constitute a preexisting condition in the absence of a diagnosis  
20 of the condition related to such information; and

21 (c) A preexisting conditions provision shall not be applied to a newborn child or adopted child  
22 who obtains coverage in accordance with ORS 743.707.

23 [(27)] **(28)** "Premium" includes insurance premiums or other fees charged for a health benefit  
24 plan, including the costs of benefits paid or reimbursements made to or on behalf of enrollees cov-  
25 ered by the plan.

26 [(28)] **(29)** "Rating period" means the 12-month calendar period for which premium rates estab-  
27 lished by a carrier are in effect, as determined by the carrier.

28 [(29)] **(30)(a)** "Small employer" means [*any person, firm, corporation, partnership or association*  
29 *actively engaged in business that, on at least 50 percent of its working days during the preceding year,*  
30 *employed no more than 25 eligible employees and no fewer than two eligible employees] **an employer**  
31 **that employed an average of at least two but not more than 50 employees on business days**  
32 **during the preceding calendar year**, the majority of whom are employed within this state, and [*in*  
33 *which a bona fide partnership, independent contractor or employer-employee relationship exists. "Small*  
34 *employer" includes companies that are eligible to file a consolidated tax return pursuant to ORS*  
35 *317.715.*] **that employs at least two eligible employees on the date on which coverage takes**  
36 **effect under a health benefit plan issued by a small employer carrier.***

37 **(b) Any person that is treated as a single employer under subsection (b), (c), (m) or (o)**  
38 **of section 414 of the Internal Revenue Code of 1986 shall be treated as one employer for**  
39 **purposes of this subsection.**

40 **(c) The determination of whether an employer that was not in existence throughout the**  
41 **preceding calendar year is a small employer shall be based on the average number of em-**  
42 **ployees that it is reasonably expected the employer will employ on business days in the cur-**  
43 **rent calendar year.**

44 [(30)] **(31)** "Small employer carrier" means [*any carrier that offers health benefit plans covering*  
45 *eligible employees of one or more small employers. A fully insured multiple employer welfare ar-*

1 rangement otherwise exempt under ORS 750.303 (4) may elect to be a small employer carrier gov-  
2 erned by the provisions of ORS 743.733 to 743.737.

3 **SECTION 2.** Section 3 of this 2007 Act is added to and made a part of ORS 743.733 to  
4 **743.737.**

5 **SECTION 3.** Subsequent to the issuance of a health benefit plan to a small employer, a  
6 small employer carrier shall determine annually the number of employees of the employer  
7 for purposes of determining the employer's ongoing eligibility as a small employer. The pro-  
8 visions of ORS 743.733 to 743.737 shall continue to apply to a health benefit plan issued to a  
9 small employer until the plan anniversary date following the date the employer no longer  
10 meets the definition of a small employer.

11 **SECTION 4.** ORS 743.733 is amended to read:

12 743.733. [(1) For purposes of this section, "qualified employees" means employees who work on a  
13 regularly scheduled basis, with a normal workweek of 17.5 or more hours, but does not include em-  
14 ployees who work on a temporary, seasonal or substitute basis.]

15 [(2)] (1) If an affiliated group of employers [that is eligible to file a consolidated tax return pur-  
16 suant to ORS 317.715 includes one or more small employers,] is treated as a single employer under  
17 subsection (b), (c), (m) or (o) of section 414 of the Internal Revenue Code of 1986, a carrier  
18 may issue a single group health benefit plan to the affiliated group on the basis of the number of  
19 employees in the affiliated group if the group requests such coverage.

20 [(3)] (2) [Subsequent to the issuance of a health benefit plan to an employer pursuant to the pro-  
21 visions of ORS 743.733 to 743.737 and for the purposes of determining eligibility, the number of em-  
22 ployees of an employer shall be determined annually by the small employer carrier. Except as otherwise  
23 provided, the provisions of ORS 743.733 to 743.737 that apply to an employer shall continue to apply  
24 until the plan anniversary date following the date the employer no longer meets the requirements of this  
25 section.] If a small employer carrier determines that an employer has more than 50 employ-  
26 ees, the carrier may provide a quote for a group health benefit plan that is not subject to  
27 ORS 743.733 to 743.737. If the employer's workforce consists of at least two but not more  
28 than 50 eligible employees, the small group carrier shall inform the employer that if coverage  
29 is limited to the eligible employees, the carrier must treat the employer as a small employer  
30 and shall provide a separate quote on that basis.

31 [(4) A carrier that offers health benefit plans covering employees of an employer who employed an  
32 average of at least two but not more than 50 qualified employees on business days during the preceding  
33 calendar year and who employs at least two qualified employees on the first day of the plan year, in  
34 accordance with 42 U.S.C. 300gg as amended and in effect on July 1, 1997, shall be considered a small  
35 employer carrier for purposes of this section and ORS 743.736. A health benefit plan issued to an em-  
36 ployer described in this section, provided the employer does not otherwise qualify as a small employer  
37 in accordance with ORS 743.730, shall be considered a small employer health benefit plan for purposes  
38 of ORS 743.737, except that the plan or carrier shall not be required to comply with ORS 743.737 (7),  
39 (8), (10), (11) and (13).]

40 **SECTION 5.** ORS 743.734 is amended to read:

41 743.734. (1) Every group health benefit plan shall be subject to the provisions of ORS 743.733 to  
42 743.737, if the plan provides health benefits covering one or more employees of a small employer and  
43 if any one of the following conditions is met:

44 (a) Any portion of the premium or benefits is paid by a small employer or any eligible employee  
45 is reimbursed, whether through wage adjustments or otherwise, by a small employer for any portion

1 of the health benefit plan premium; or

2 (b) The health benefit plan is treated by the employer or any of the eligible employees as part  
3 of a plan or program for the purposes of section 106, section 125 or section 162 of the Internal Re-  
4 venue Code of 1986, as amended.

5 (2) Except as provided in ORS 743.733 to 743.737, no law requiring the coverage or the offer of  
6 coverage of a health care service or benefit applies to the basic health benefit plans offered or de-  
7 livered to a small employer.

8 (3) Except as otherwise provided by law or ORS 743.733 to 743.737, no health benefit plan of-  
9 fered to a small employer shall:

10 (a) Inhibit a small employer carrier from contracting with providers or groups of providers with  
11 respect to health care services or benefits; or

12 (b) Impose any restriction on the ability of a small employer carrier to negotiate with providers  
13 regarding the level or method of reimbursing care or services provided under health benefit plans.

14 (4) Except to determine the application of a preexisting conditions provision for a late enrollee,  
15 a small employer carrier shall not use health statements when offering small employer health benefit  
16 plans and shall not use any other method to determine the actual or expected health status of eli-  
17 gible enrollees. Nothing in this subsection shall prevent a carrier from using health statements or  
18 other information after enrollment for the purpose of providing services or arranging for the pro-  
19 vision of services under a health benefit plan.

20 (5) Except in the case of a late enrollee and as otherwise provided in this section, a small em-  
21 ployer carrier shall not impose different terms or conditions on the coverage, premiums or contri-  
22 butions of any eligible employee in a small employer group that are based on the actual or expected  
23 health status of any eligible employee.

24 (6) A small employer carrier may provide different health benefit plans to different categories  
25 of employees of a small employer when the employer has chosen to establish different categories of  
26 employees in a manner that does not relate to the actual or expected health status of such em-  
27 ployees or their dependents. **The categories must be based on bona fide employment-based**  
28 **classifications that are consistent with the employer's usual business practice.** Except as  
29 provided in ORS 743.736 (10):

30 (a) When a small employer carrier offers coverage to a small employer **with no more than 25**  
31 **eligible employees**, the small employer carrier shall offer coverage to all eligible employees of the  
32 small employer, without regard to the actual or expected health status of any eligible employee.

33 (b) **When a small employer carrier offers coverage to a small employer with at least 26**  
34 **but not more than 50 eligible employees, the small employer carrier may limit coverage to**  
35 **the categories of employees that the small employer has established as eligible for coverage,**  
36 **provided that the categories are based on bona fide employment-based classifications that**  
37 **are consistent with the employer's usual business practice.**

38 [(b)] (c) If the small employer elects to offer coverage to dependents of eligible employees, the  
39 small employer carrier shall offer coverage to all dependents of eligible employees, without regard  
40 to the actual or expected health status of any eligible dependent.

41 **SECTION 6.** ORS 743.737 is amended to read:

42 743.737. Health benefit plans covering small employers shall be subject to the following pro-  
43 visions:

44 (1) A preexisting conditions provision in a small employer health benefit plan shall apply only  
45 to a condition for which medical advice, diagnosis, care or treatment was recommended or received

1 during the six-month period immediately preceding the enrollment date of an enrollee or late  
2 enrollee. As used in this section, the enrollment date of an enrollee shall be the earlier of the ef-  
3 fective date of coverage or the first day of any required group eligibility waiting period and the  
4 enrollment date of a late enrollee shall be the effective date of coverage.

5 (2) A preexisting conditions provision in a small employer health benefit plan shall terminate its  
6 effect as follows:

7 (a) For an enrollee, not later than the first of the following dates:

8 (A) Six months following the enrollee's effective date of coverage; or

9 (B) Ten months following the start of any required group eligibility waiting period.

10 (b) For a late enrollee, not later than 12 months following the late enrollee's effective date of  
11 coverage.

12 (3) In applying a preexisting conditions provision to an enrollee or late enrollee, except as pro-  
13 vided in this subsection, all small employer health benefit plans shall reduce the duration of the  
14 provision by an amount equal to the enrollee's or late enrollee's aggregate periods of creditable  
15 coverage if the most recent period of creditable coverage is ongoing or ended within 63 days of the  
16 enrollment date in the new small employer health benefit plan. The crediting of prior coverage in  
17 accordance with this subsection shall be applied without regard to the specific benefits covered  
18 during the prior period. This subsection does not preclude, within a small employer health benefit  
19 plan, application of:

20 (a) An affiliation period that does not exceed two months for an enrollee or three months for a  
21 late enrollee; or

22 (b) An exclusion period for specified covered services, as established by the Health Insurance  
23 Reform Advisory Committee, applicable to all individuals enrolling for the first time in the small  
24 employer health benefit plan.

25 (4) Late enrollees may be excluded from coverage for up to 12 months or may be subjected to  
26 a preexisting conditions provision for up to 12 months. If both an exclusion from coverage period  
27 and a preexisting conditions provision are applicable to a late enrollee, the combined period shall  
28 not exceed 12 months.

29 (5) Each small employer health benefit plan shall be renewable with respect to all eligible  
30 enrollees at the option of the policyholder, small employer or contract holder except:

31 (a) For nonpayment of the required premiums by the policyholder, small employer or contract  
32 holder.

33 (b) For fraud or misrepresentation of the policyholder, small employer or contract holder or,  
34 with respect to coverage of individual enrollees, the enrollees or their representatives.

35 (c) When the number of enrollees covered under the plan is less than the number or percentage  
36 of enrollees required by participation requirements under the plan.

37 (d) For noncompliance with the small employer carrier's employer contribution requirements  
38 under the health benefit plan.

39 (e) When the carrier discontinues offering or renewing, or offering and renewing, all of its small  
40 employer health benefit plans in this state or in a specified service area within this state. In order  
41 to discontinue plans under this paragraph, the carrier:

42 (A) Must give notice of the decision to the Director of the Department of Consumer and Busi-  
43 ness Services and to all policyholders covered by the plans;

44 (B) May not cancel coverage under the plans for 180 days after the date of the notice required  
45 under subparagraph (A) of this paragraph if coverage is discontinued in the entire state or, except

1 as provided in subparagraph (C) of this paragraph, in a specified service area;

2 (C) May not cancel coverage under the plans for 90 days after the date of the notice required  
3 under subparagraph (A) of this paragraph if coverage is discontinued in a specified service area  
4 because of an inability to reach an agreement with the health care providers or organization of  
5 health care providers to provide services under the plans within the service area; and

6 (D) Must discontinue offering or renewing, or offering and renewing, all health benefit plans  
7 issued by the carrier in the small employer market in this state or in the specified service area.

8 (f) When the carrier discontinues offering and renewing a small employer health benefit plan in  
9 a specified service area within this state because of an inability to reach an agreement with the  
10 health care providers or organization of health care providers to provide services under the plan  
11 within the service area. In order to discontinue a plan under this paragraph, the carrier:

12 (A) Must give notice to the director and to all policyholders covered by the plan;

13 (B) May not cancel coverage under the plan for 90 days after the date of the notice required  
14 under subparagraph (A) of this paragraph; and

15 (C) Must offer in writing to each small employer covered by the plan, all other small employer  
16 health benefit plans that the carrier offers in the specified service area. The carrier shall issue any  
17 such plans pursuant to the provisions of ORS 743.733 to 743.737. The carrier shall offer the plans  
18 at least 90 days prior to discontinuation.

19 (g) When the carrier discontinues offering or renewing, or offering and renewing, a health ben-  
20 efit plan for all small employers in this state or in a specified service area within this state, other  
21 than a plan discontinued under paragraph (f) of this subsection. With respect to plans that are being  
22 discontinued, the carrier must:

23 (A) Offer in writing to each small employer covered by the plan, all health benefit plans that  
24 the carrier offers in the specified service area.

25 (B) Issue any such plans pursuant to the provisions of ORS 743.733 to 743.737.

26 (C) Offer the plans at least 90 days prior to discontinuation.

27 (D) Act uniformly without regard to the claims experience of the affected policyholders or the  
28 health status of any current or prospective enrollee.

29 (h) When the director orders the carrier to discontinue coverage in accordance with procedures  
30 specified or approved by the director upon finding that the continuation of the coverage would:

31 (A) Not be in the best interests of the enrollees; or

32 (B) Impair the carrier's ability to meet contractual obligations.

33 (i) When, in the case of a small employer health benefit plan that delivers covered services  
34 through a specified network of health care providers, there is no longer any enrollee who lives, re-  
35 sides or works in the service area of the provider network.

36 (j) When, in the case of a health benefit plan that is offered in the small employer market only  
37 through one or more bona fide associations, the membership of an employer in the association ceases  
38 and the termination of coverage is not related to the health status of any enrollee.

39 (k) For misuse of a provider network provision. As used in this paragraph, "misuse of a provider  
40 network provision" means a disruptive, unruly or abusive action taken by an enrollee that threatens  
41 the physical health or well-being of health care staff and seriously impairs the ability of the carrier  
42 or its participating providers to provide services to an enrollee. An enrollee under this paragraph  
43 retains the rights of an enrollee under ORS 743.804.

44 (L) A small employer carrier may modify a small employer health benefit plan at the time of

21 **SECTION 9. Section 3 of this 2007 Act and the amendments to ORS 743.730, 743.733,**

23 **of insurance issued or renewed on or after the operative date specified in section 10 of this**

25 **SECTION 10. Except as provided in section 8 of this 2007 Act, section 3 of this 2007 Act**
