

A-Engrossed Senate Bill 716

Ordered by the Senate April 10
Including Senate Amendments dated April 10

Sponsored by COMMITTEE ON HEALTH POLICY AND PUBLIC AFFAIRS (at the request of Oregon Paralyzed Veterans of America)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates "Wheelchair User Only" accessible parking space. Directs Department of Transportation to issue "Wheelchair User" placard or decal to person who qualifies. Prohibits person from parking in parking space marked or signed "Wheelchair User Only" unless vehicle displays "Wheelchair User" placard or decal.

Allows local governments to provide free or unlimited parking to persons holding disabled person parking permits or displaying "Wheelchair User" placards or decals.

A BILL FOR AN ACT

Relating to parking for persons with disabilities; creating new provisions; and amending ORS 447.233, 811.602, 811.615 and 811.635.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 447.233 is amended to read:

447.233. (1) The Director of the Department of Consumer and Business Services shall include in the state building code, as defined in ORS 455.010, a requirement that the number of accessible parking spaces specified in subsection (2) of this section be provided for affected buildings subject to the state building code and that the spaces be signed as required by subsection (2) of this section. Spaces may also be marked in a manner specified in the state building code.

(2)(a) The number of accessible parking spaces shall be:

29 (b) In addition, one in every eight accessible spaces, but not less than one, shall be van acces-
 30 sible. **Where five or more parking spaces are designated accessible, any space that is desig-**
 31 **notated as van accessible shall be reserved for wheelchair users.** A van accessible parking space
 32 shall be at least nine feet wide and shall have an adjacent access aisle that is at least eight feet
 33 wide.

34 (c) Accessible parking spaces shall be at least nine feet wide and shall have an adjacent access
 35 aisle that is at least six feet wide.

36 (d) The access aisle shall be located on the passenger side of the parking space except that two
 37 adjacent accessible parking spaces may share a common access aisle.

38 (e) A sign shall be posted for each accessible parking space. The sign shall be clearly visible
 39 to a person parking in the space, shall be marked with the International Symbol of Access and shall
 40 indicate that the spaces are reserved for persons with disabled person parking permits. **A van ac-**
 41 **cessible parking [spaces] space shall have an additional sign marked “Van Accessible” mounted be-**
 42 **low the sign. A van accessible parking space reserved for wheelchair users shall have a sign**
 43 **that includes the words “Wheelchair User Only.”**

44 (f) Accessible parking spaces and signs shall be designed in compliance with the standards set
 45 forth by the Oregon Transportation Commission in consultation with the Oregon Disabilities Com-

1 mission.

2 (3) No ramp or obstacle may extend into the parking space or the aisle, and curb cuts and ramps
3 may not be situated in such a way that they could be blocked by a legally parked vehicle.

4 (4) Parking spaces required by this section shall be maintained so as to meet the requirements
5 of this section at all times and to meet the standards established by the state building code.

6 (5) The director is authorized to inspect parking spaces and facilities and buildings subject to
7 the provisions of this section, and to do whatever is necessary to enforce the requirements, including
8 the maintenance requirements, of this section. Municipalities and counties may administer and en-
9 force the requirements of this section in the manner provided under ORS 455.148 or 455.150 for ad-
10 ministration and enforcement of specialty codes. All plans for parking spaces subject to the
11 provisions of this section must be approved by the director prior to the creation of the spaces.

12 (6) Requirements adopted under this section do not apply to long-term parking facilities at the
13 Portland International Airport.

14 (7) Any reported violation of this section shall be investigated by the administrative authority.
15 The administrative authority shall make a final decision and order correction, if necessary, within
16 30 days of notification. Any aggrieved person may appeal within 30 days of the decision by the ad-
17 ministrative authority to the appropriate municipal appeals board or, at the option of the local ju-
18 risdiction, directly to the Building Codes Structures Board established under ORS 455.132. The
19 appeal shall be acted upon within 60 days of filing. The decision of the municipal appeals board may
20 be appealed to the board. The board shall act on the appeal within 60 days of filing. All appeals to
21 the board shall be filed in accordance with ORS 455.690.

22 **SECTION 2. The amendments to ORS 447.233 by section 1 of this 2007 Act apply to con-
23 struction or repainting of accessible parking spaces and access aisles commencing on or af-
24 ter the effective date of this 2007 Act.**

25 **SECTION 3. Section 4 of this 2007 Act is added to and made a part of the Oregon Vehicle
26 Code.**

27 **SECTION 4. (1) The Department of Transportation shall issue a “Wheelchair User” dis-
28 abled person parking permit in the form of a “Wheelchair User” placard or decal for use by
29 a person who uses a wheelchair or similar low-powered motorized or mechanically propelled
30 vehicle designed specifically for use by a person with a physical disability.**

31 **(2) The department shall determine the form, size and content of the placards or decals,
32 except that the department shall require that the placards or decals:**

33 **(a) Include the words “Wheelchair User.”**

34 **(b) Have an expiration date that is visible from outside the vehicle when the placard or
35 decal is displayed on or in the vehicle.**

36 **(3) The department shall by rule determine how a person may qualify for a “Wheelchair
37 User” placard or decal under this section.**

38 **(4) An applicant for a “Wheelchair User” placard or decal issued by the department under
39 this section must have a driver license, a disability golf cart driver permit or an identifica-
40 tion card issued by the department. The placard or decal shall be valid as long as the license,
41 permit or identification card is valid and may be renewed when the license, permit or iden-
42 tification card is renewed.**

43 **(5) The expiration date shall be the same as the expiration date of the driver license,
44 disability golf cart driver permit or identification card of the holder of the placard or decal.**

45 **SECTION 5. ORS 811.602 is amended to read:**

1 811.602. (1) A disabled person parking permit is a means of identifying vehicles being used to
2 exercise the parking privileges described in ORS 811.635. The following are disabled person parking
3 permits:

4 (a) A special decal described in ORS 811.605 issued by the Department of Transportation to be
5 affixed to a golf cart or substantially similar vehicle;

6 (b) An individual placard described in ORS 811.605;

7 (c) A program placard issued by the department under ORS 811.607;

8 (d) A family placard issued by the department under ORS 811.609; [and]

9 (e) A foreign visitor placard issued by the department under ORS 811.611; and

10 (f) **A “Wheelchair User” placard or decal issued by the department under section 4 of this**
11 **2007 Act.**

12 (2) The department shall issue a disabled person parking permit in the form of a decal or indi-
13 vidual placard to any person who submits an application that complies with ORS 811.604. Nothing
14 in this section prohibits the department from issuing a decal or individual placard to a person who
15 has disabled veteran registration plates issued under ORS 805.100 and who qualifies for the decal
16 or placard.

17 (3) Except as otherwise provided in this subsection, the department may not issue more than one
18 individual placard to an applicant. The department may issue a replacement placard upon receipt
19 of proof satisfactory to the department that the original placard has been lost, mutilated or de-
20 stroyed. The department may issue a temporary duplicate permit to a person who needs a duplicate
21 permit for travel purposes. A temporary duplicate permit shall be valid for 30 days. The department
22 shall adopt rules governing application for and issuance of temporary duplicate permits. Nothing in
23 this subsection prohibits issuance of an individual placard to a person who has been issued a decal.

24 (4) Permits issued under this section, other than temporary duplicate permits, may be renewed
25 by mail.

26 (5) Permits for use on vehicles that are regularly used as part of a program for the transporta-
27 tion of disabled persons are issued as provided in ORS 811.607.

28 (6) Except as provided in subsection (7) of this section, the department shall determine the form,
29 size and content of any decal or placard issued under this section and shall adopt rules governing
30 their issuance, display and use as necessary to carry out this section.

31 (7)(a) Except as provided in paragraph (b) of this subsection, the department may not require a
32 decal or placard issued under this section to an individual or a family to contain any identifying
33 information about the person to whom the decal or placard is issued, including any of the following:

34 (A) Name;

35 (B) Address;

36 (C) Telephone number;

37 (D) Social Security number;

38 (E) Driver license number;

39 (F) Golf cart driver permit number;

40 (G) Identification card number;

41 (H) Passport or visa number; or

42 (I) Photograph.

43 (b) The department may require a decal or placard issued under this section to an individual
44 or a family to contain not more than four digits of the driver license or identification card number
45 of the person to whom the decal or placard is issued.

1 **SECTION 6.** ORS 811.615 is amended to read:

2 811.615. (1) A person commits the offense of unlawful parking in a space reserved for disabled
3 persons if:

4 (a) The person parks a vehicle in any parking space that is on private or public property and
5 that is marked or signed to provide parking for disabled persons and the vehicle does not conspic-
6 uously display a disabled person parking permit described [*under*] **in** ORS 811.602 or 811.606 or a
7 disabled parking permit issued by another jurisdiction; [*or*]

8 (b) The person parks a vehicle in the aisle required by ORS 447.233 regardless of whether or
9 not the vehicle displays a disabled person parking permit; **or**

10 (c) **The person parks a vehicle in a parking space that is on private or public property**
11 **and that is marked or signed “Wheelchair User Only” as described in ORS 447.233 and the**
12 **vehicle does not conspicuously display a “Wheelchair User” placard or decal issued under**
13 **section 4 of this 2007 Act.**

14 (2) This section does not apply to any of the following:

15 (a) Momentarily parking a vehicle in a parking space marked or signed for disabled persons for
16 the purposes of allowing a disabled person to enter or leave the vehicle.

17 (b) Any parking space that is marked or signed to provide parking for disabled persons and that
18 is subject to different provisions or requirements under city or county ordinance if the different
19 provisions or requirements are clearly posted.

20 (3) Unless the police officer or other authorized person issuing the citation witnesses the park-
21 ing of the vehicle, a rebuttable presumption exists that a vehicle parked in violation of this section
22 was parked by the registered owner of the vehicle and the citation issued for the violation may be
23 placed upon the vehicle. If the parking of the vehicle is witnessed by the police officer or other
24 person authorized to issue a citation for the offense, the operator of the vehicle is in violation of
25 this section.

26 (4) The penalties provided by this section shall be imposed regardless of the text or symbol
27 displayed on the marking or sign reserving the space or aisle for disabled persons. The penalties are
28 in addition to the following:

29 (a) A vehicle parked on private property in violation of this section is subject to removal under
30 ORS 98.810 and to lien and sale under ORS 98.812.

31 (b) A vehicle parked in violation of this section may be removed and sold as provided under ORS
32 811.620.

33 (5) The offense described in this section, unlawful parking in a space reserved for disabled per-
34 sons, is a Class A traffic violation except that a person in violation of this section shall pay a
35 minimum fine of \$190 for the first offense and a minimum fine of \$450 for each subsequent offense.

36 (6) Notwithstanding any other provision of law and except as otherwise provided in subsection
37 (7) of this section:

38 (a) A court may not suspend imposition or execution of a sentence to pay at least the minimum
39 fine required by this section for a person’s first offense unless the court finds from clear and con-
40 vincing evidence that compelling circumstances require a suspension of a portion of the fine in the
41 interests of justice. In no event shall a court suspend under this paragraph more than \$140 of the
42 minimum \$190 fine.

43 (b) A court may not suspend imposition or execution of a sentence to pay a fine for a second
44 or subsequent offense.

45 (7) If the court finds that the person who was issued a citation for the offense described in this

1 section lawfully held, but failed to properly display, a valid permit at the time of citation, then the
2 court may suspend all but \$20 of the fine.

3 **SECTION 7.** ORS 811.635 is amended to read:

4 811.635. All of the following apply to the parking privileges granted to disabled persons under
5 a disabled person parking permit other than a program placard described in ORS 811.607:

6 (1) The privileges granted under a permit may be exercised notwithstanding ORS 811.575, any
7 authority granted under ORS 810.160 or parking restrictions imposed by any city or county and
8 without violation thereof.

9 (2) Subject to the limitations under subsection [(3)] (4) of this section, a [permit] **“Wheelchair
10 User” placard or decal** allows its holder, or another person while transporting its holder to or from
11 the parking location, to exercise the following privileges:

12 (a) Park a motor vehicle in any public parking zone restricted as to the length of time permitted
13 therein without incurring penalties imposed for overtime parking in such zones.

14 (b) Park a motor vehicle in any public parking zone with metered parking without being re-
15 quired to pay any parking meter fee.

16 **(3) A city or county may allow any person who holds a disabled person parking permit
17 to exercise the rights described in subsection (2) of this section.**

18 [(3)] (4) The privileges granted under subsection (2) of this section do not include any of the
19 following:

20 (a) Parking in zones where stopping, parking or standing of all motor vehicles is prohibited.

21 (b) Parking in the late evening or overnight where such parking is prohibited.

22 (c) Parking in zones reserved for special types of motor vehicles or activities.

23 (d) Parking in zones where parking is permitted only for 30 minutes or less.

24 **(e) Parking in a parking space marked or signed for “Wheelchair User Only,” unless
25 displaying a “Wheelchair User” placard or decal issued under section 4 of this 2007 Act.**

26 [(4)] (5) In addition to other privileges granted under a permit, the person issued a permit, or
27 another person while transporting the person issued the permit to or from the parking location, may
28 use the permit to park in a parking space that is marked or signed to provide parking for disabled
29 persons without violation of ORS 811.615.

30 **SECTION 8. The amendments to ORS 811.602, 811.615 and 811.635 by sections 5, 6 and 7
31 of this 2007 Act apply to persons parking in accessible parking spaces marked or signed for
32 “Wheelchair User Only” on or after the effective date of this 2007 Act.**

33
