## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies and repeals laws relating to elections conducted at polling places.

### A BILL FOR AN ACT

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1.** ORS 254.465 is amended to read:

254.465. *[The following rules apply to elections conducted by mail:]*

*[(1) An election held on the date of the primary or general election shall be conducted by mail.]*

*[(2) A state election not described in subsection (1) of this section may be conducted by mail. The Secretary of State by rule shall direct that a state election authorized to be conducted by mail under this subsection be conducted uniformly by mail or at polling places.]*

*[(3) A county clerk may conduct an election not described in subsections (1) and (2) of this section by mail in the county, in a city or in a district defined in ORS 255.012, under the supervision of the Secretary of State. In deciding to conduct an election by mail, the county clerk may consider requests from the governing body of the county, city or district and shall consider whether conducting the election by mail will be economically and administratively feasible.]*

**(1) County clerks shall conduct all elections in this state by mail.**

**[(4)] (2) The Secretary of State shall adopt rules to:**

1 (a) [To] Provide for uniformity in the conduct of state elections by mail; **and**

2 (b) **Govern the procedures for conducting elections by mail.**

3 **SECTION 2.** ORS 246.025 is amended to read:

4 246.025. (1) A person with a disability who is unable because of the disability to sign any  
5 election document, including a voter registration card[,] **or** ballot return envelope [*or poll book*], may  
6 use a signature stamp or other indicator of the person's signature, as specified by the Secretary of  
7 State by rule, whenever the signature of the person is required under any election law.

8 (2) A person who desires to use a signature stamp or other indicator of the person's signature  
9 as described in subsection (1) of this section shall attest that the person needs to use the stamp or  
10 indicator due to a disability. The attestation shall be made at the time the person registers to vote  
11 or updates a registration and shall be made on a form designed and supplied by the Secretary of  
12 State.

13 **SECTION 3.** ORS 246.160 is amended to read:

14 246.160. The Secretary of State shall:

15 (1) Prepare and print, in appropriate and convenient form, periodic compilations and digests of  
16 the state election statutes.

17 (2) Distribute in appropriate quantities to the county clerks for use by the county clerks [*and*  
18 *by election boards,*] copies of [*such*] **the** compilations and digests and [*such*] **any** supplies and mate-  
19 rials necessary to the conduct of elections as the Secretary of State considers appropriate.

20 (3) Make the compilations and digests available for distribution, free or at cost, to interested  
21 persons.

22 **SECTION 4.** ORS 246.200 is amended to read:

23 246.200. (1) Except as [*specifically provided otherwise in the statute laws of this state*] **otherwise**  
24 **provided by law**, the county clerk [*shall be*] **is** the only elections officer [*to*] **who may** conduct  
25 [*any*] **an** election in this state. For [*the purpose*] **purposes** of this section, the conduct of an election  
26 includes, but is not limited to, establishing precincts [*and polling places*], preparing ballots and  
27 sample ballots, and receiving and processing votes.

28 (2) Notwithstanding subsection (1) of this section:

29 (a) The county clerk is not the only elections officer who may accept and verify a filing for  
30 nomination or filing of a petition, prepare a voters' pamphlet or ballot title, or prepare or publish  
31 an election notice; and

32 (b) The Secretary of State may receive ballots as provided in ORS 253.585.

33 **SECTION 5.** ORS 246.250 is amended to read:

34 246.250. (1) The county clerk may employ personnel and procure equipment, supplies, materials,  
35 books, papers, records and facilities of every kind as the clerk considers necessary to facilitate and  
36 assist in administering the election laws.

37 (2) The necessary expenses incurred by the county clerk in administering the election laws[,  
38 *including reasonable rental for polling places,*] shall be allowed by the county governing body and  
39 paid out of the county treasury.

40 (3) The county clerk and deputies may administer oaths and affirmations in connection with the  
41 performance of their functions in administering the election laws.

42 **SECTION 6.** ORS 247.290 is amended to read:

43 247.290. (1) An elector shall update a registration if:

44 (a) The residence address of the elector is changed for any reason within the county in which  
45 the elector is registered, except as provided in subsection (3) of this section[.];

1 (b) The elector desires to change or adopt a political party affiliation[.];

2 (c) The mailing address of the elector is changed, except as provided in subsection (3) of this  
3 section[.]; **or**

4 (d) The name of the elector is changed, except as provided in ORS 254.411.

5 (2) A registration may be updated by an elector in the same manner as an original registration  
6 or by the county clerk as provided in this chapter.

7 *[(3) Notwithstanding subsection (1) of this section:]*

8 *[(a)]* (3) An elector need not update a registration if:

9 *[(A)]* (a) The United States Postal Service or a city or county changes the residence or mailing  
10 address of the elector and the residence of the elector has not been relocated; or

11 *[(B)]* (b) The registration of the elector has been updated by the county clerk under ORS 247.292  
12 or 247.296.

13 *[(b) An elector whose mailing address has changed but whose residence address has not changed,  
14 and whose registration has not been canceled, may vote once in the precinct in which the elector is  
15 registered. The following apply:]*

16 *[(A) The election board clerk shall enter into the poll book the fact that the elector's mailing ad-  
17 dress has changed. Following the election, the county clerk shall send the elector the notice described  
18 in ORS 247.563 and the registration of the elector shall be considered inactive.]*

19 *[(B) The registration of an elector whose mailing address has changed must be updated in order  
20 for the elector to vote in any subsequent election.]*

21 **SECTION 7.** ORS 247.307 is amended to read:

22 247.307. (1) *[In an election conducted by mail as provided in ORS chapter 254,]* If the county clerk  
23 receives information updating the registration of an elector after the deadline in ORS 247.025:

24 (a) The county clerk shall issue a ballot to the elector if the elector's registration was inactive  
25 prior to updating[.]; **or**

26 (b) The county clerk shall issue a replacement ballot upon request from the elector if the elec-  
27 tor's registration was active prior to updating.

28 (2) Ballots issued under this section need not be mailed **to electors** after the fifth day before  
29 the date of the election and may be obtained **by the elector** in person from the county clerk up until  
30 and including the date of the election.

31 **SECTION 8.** ORS 249.078 is amended to read:

32 249.078. (1) The name of a candidate for a major political party nomination for President of the  
33 United States shall be printed on the ballot *[or ballot label]* only:

34 (a) By direction of the Secretary of State who in the secretary's sole discretion has determined  
35 that the candidate's candidacy is generally advocated or is recognized in national news media; or

36 (b) By nominating petition described in this section and filed with the Secretary of State.

37 (2) A petition nominating a candidate under this section shall contain from each congressional  
38 district the signatures of at least 1,000 electors who are registered in the district and who are  
39 members of the major political party of the candidate. The electors in each congressional district  
40 shall include electors registered in at least five percent of the precincts in each of at least one-  
41 fourth of the counties in the congressional district. The petition shall contain the printed name,  
42 residence address and name or number of the precinct, if known, of each elector whose signature  
43 appears on the petition. The signatures shall be certified for genuineness by the county clerks under  
44 ORS 249.008.

45 (3) Before circulating the **nominating** petition, the chief sponsor shall file with the Secretary

1 of State a signed copy of the prospective petition. The chief sponsor shall include with the pro-  
2 spective petition a statement declaring whether one or more persons will be paid money or other  
3 valuable consideration for obtaining signatures of electors on the petition. After the prospective  
4 petition is filed, the chief sponsor shall notify the Secretary of State not later than the 10th day  
5 after the chief sponsor first has knowledge or should have had knowledge that:

6 (a) Any person is being paid for obtaining signatures, when the statement included with the  
7 prospective petition declared that no such person would be paid.

8 (b) No person is being paid for obtaining signatures, when the statement included with the pro-  
9 spective petition declared that one or more such persons would be paid.

10 **SECTION 9.** ORS 249.091 is amended to read:

11 249.091. Unless otherwise provided by a home rule charter, [*when*] **if** a nominating petition or  
12 declaration of candidacy is filed by no more than two candidates for the office of sheriff, the office  
13 of county treasurer or the office of county clerk or by no more than two candidates to fill a vacancy  
14 in a nonpartisan office[,]:

15 (1) The candidate or candidates shall be the nominee or nominees for the office; and

16 (2) The name or names of the candidate or candidates [*shall*] **may** not be printed on the ballot  
17 [*or ballot label*] at the nominating election.

18 **SECTION 10.** ORS 250.037 is amended to read:

19 250.037. (1) The ballot title of any measure requesting elector approval of bonds, the principal  
20 and interest on which will be payable from taxes imposed on property or property ownership that  
21 are not subject to the limitations of sections 11 and 11b, Article XI of the Oregon Constitution, shall  
22 contain, in addition to the matters required by ORS 250.035, the following statement immediately  
23 after the ballot title question and appearing with it, in this manner:

27 Question: (herein the question is stated) If the bonds are approved, they will be payable from  
28 taxes on property or property ownership that are not subject to the limits of sections 11 and 11b,

33 (2) The words of the statement required by subsection (1) of this section [*shall not be*] **are not**  
34 counted for purposes of ORS 250.035.

35 (3) The ballot title statement for any measure requesting elector approval of bonds, the principal  
36 and interest on which is to be payable from taxes imposed on property or property ownership that  
37 are not subject to the limitations of sections 11 and 11b, Article XI of the Oregon Constitution, shall  
38 contain, in addition to the other requirements of ORS 250.035 and this section, a reasonably detailed,  
39 simple and understandable description of the use of proceeds.

40 (4) [*If the election for a measure to which this section applies is to be conducted by mail,*] The front  
41 of the outer envelope in which the ballot title is [*mailed*] **delivered** shall state, clearly and boldly  
42 printed in red, "CONTAINS VOTE ON PROPOSED TAX INCREASE."

43 **SECTION 11.** ORS 250.038 is amended to read:

44 250.038. In addition to meeting other applicable requirements of this chapter:

45 (1) The ballot title for a measure authorizing the imposition of local option taxes shall contain

1 the statement required by ORS 280.070 (4)(a) and the information required by ORS 280.070 (5);

2 (2) The ballot title for a measure authorizing the establishment of a permanent rate limitation  
3 shall contain the information required by ORS 280.070 (6); and

4 (3) *[If the election on a measure authorizing the imposition of local option taxes or the establish-*  
5 *ment of a permanent rate limitation is to be conducted by mail,]* The front of the outer envelope in  
6 which the ballot title is *[mailed]* **delivered** shall state, clearly and boldly printed in red, “CON-  
7 TAINS VOTE ON PROPOSED TAX INCREASE.”

8 **SECTION 12.** ORS 251.175 is amended to read:

9 251.175. (1) Except as provided in subsection (2) of this section, not later than the 20th day be-  
10 fore a primary election, general election or special election for which a voters’ pamphlet has been  
11 prepared, the Secretary of State shall cause the voters’ pamphlet to be mailed to each post-office  
12 mailing address in Oregon, and shall use any additional means of distribution necessary to make the  
13 pamphlet available to electors.

14 (2) For any special election described in ORS 251.022 that is not held statewide, or for any other  
15 state special election that is not held statewide, the Secretary of State by rule may prescribe  
16 methods for distributing the voters’ pamphlet prepared for the election. The rule shall require the  
17 secretary to mail the pamphlet to at least each elector whose registration is determined to be active  
18 on the 21st day before the date of the election and who is eligible to vote in the election. The rule  
19 may specify other methods of distribution. *[If the special election is conducted by mail,]* Voters’  
20 pamphlets prepared for the election shall be mailed not later than the date ballots are mailed to  
21 electors as provided in ORS 254.470.

22 **SECTION 13.** ORS 251.315 is amended to read:

23 251.315. (1) If a county produces a county voters’ pamphlet, the county voters’ pamphlet shall  
24 include, when applicable, at least the following information:

25 *[(a) If the election is conducted at polling places under ORS chapter 254, a sample ballot contain-*  
26 *ing the names of candidates for all offices appearing on the ballot, and the ballot titles of all measures*  
27 *appearing on the ballot in the county.]*

28 *[(b)]* (a) Requirements for a citizen to qualify as an elector.

29 *[(c)]* (b) Requirements for registration and updates of registration.

30 *[(d)]* (c) Elector instructions, including the right of an elector to request a second ballot if the  
31 first ballot is spoiled and the right of an elector to seek assistance in marking the ballot.

32 *[(e)]* (d) The hours and locations of *[sites]* **places** designated under ORS 254.470 *[(2)]* for deposit  
33 of official ballots.

34 *[(f)]* (e) Any portraits and statements relating to candidates submitted in accordance with the  
35 provisions of ORS 251.305 to 251.435.

36 *[(g)]* (f) Any ballot titles, explanatory statements and arguments submitted in accordance with  
37 the provisions of ORS 251.305 to 251.435.

38 *[(h) If the election is to be at the polls, a listing of the polling places.]*

39 *[(i)]* (g) Such other information as the county clerk considers to be appropriate or necessary to  
40 inform the voters.

41 (2) The county clerk shall mail or otherwise distribute the county voters’ pamphlet not later  
42 than *[the seventh day before the election or the last day for mailing ballots if the election is conducted*  
43 *by mail]* **the last day for mailing ballots to electors as provided in ORS 254.470.**

44 **SECTION 14.** ORS 253.005 is amended to read:

45 253.005. As used in this chapter:

1 (1) "Clerk" means the county clerk.

2 (2) "County clerk" means the county clerk or the county official in charge of elections.

3 (3) "Elector" means an individual qualified to vote under section 2, Article II, Oregon Consti-  
4 tution.

5 (4) "Absent elector" means a person to whom the county clerk has issued a ballot prior to [8  
6 *p.m. the day of the election in the case of an election conducted at polling places, or prior to the mailing*  
7 *of ballots under ORS 254.470 (3)(a) for an election conducted by mail]* **the date that ballots are**  
8 **mailed to electors as provided in ORS 254.470 (2)(a) or (b).**

9 **SECTION 15.** ORS 253.045 is amended to read:

10 253.045. (1) The clerk shall print as many absentee ballots as may be necessary as soon as possible  
11 after receiving the information concerning candidates and measures to be voted on at an  
12 election, but not later than the 45th day before the election.

13 [(2) *For an election conducted at polling places as provided in ORS chapter 254:*]

14 [(a) *The initials of the clerk may be placed on each ballot stub to identify it as an absentee*  
15 *ballot.*]

16 [(b) *The ballot stubs of each set of ballot forms containing the same information may be numbered*  
17 *consecutively.*]

18 [(3)] (2) The clerk [*shall be*] **is** responsible for the safekeeping and disposition of the ballots, and  
19 shall destroy all unused ballots as soon as practicable after the election.

20 **SECTION 16.** ORS 253.055 is amended to read:

21 253.055. (1) Absentee ballots may be the regular ballots used at the election or special ballots  
22 and, except as provided in [*subsections (2) and (3)*] **subsection (2)** of this section, shall be in sub-  
23 stantially the same form as the regular ballots used at the election.

24 (2) In counties in which voting machines are used, paper ballots may be used as absentee ballots.

25 [(3) *Ballot stubs are not required on absentee ballots.*]

26 [(4)] (3) The ballot delivered to each absent elector shall contain the names and other informa-  
27 tion concerning all candidates and the information concerning all measures for which the absent  
28 elector is entitled to vote. In lieu of the names and other information concerning candidates for  
29 precinct committeeperson, blank spaces shall be provided on the ballot, in which the absent elector  
30 may write the name of a candidate for that office.

31 **SECTION 17.** ORS 253.135 is amended to read:

32 253.135. (1) An elector who, on the day of an election, will be absent from the county in which  
33 the elector is registered may vote at the elections office of any county clerk [*or at any polling site*  
34 *in this state*].

35 (2) An elector voting under this section shall complete and sign a voter registration card.

36 [(3) *The elector shall insert the ballot into a small envelope provided by the election board and then*  
37 *shall insert the small envelope into a larger envelope. The larger envelope shall be deposited into the*  
38 *ballot box.*]

39 [(4)] (3) A ballot cast under this section shall be forwarded to the county clerk of the county in  
40 which the elector resides not later than the eighth day after the election. The ballot shall be  
41 counted in the county in which the elector resides if the elector is qualified to vote in that county.  
42 A vote shall be counted only if the elector is qualified to vote for the particular office or on the  
43 measure.

44 [(5)] (4) This section does not apply to persons registered under ORS 247.410 and 247.420.

45 **SECTION 18.** ORS 253.700 is amended to read:

1 253.700. (1) The county clerk, [*a member of the election board or special counting board*] **an**  
2 **elections official** or any elector shall challenge the absentee ballot of any person offering to vote  
3 as an absent elector whom the clerk, [*member*] **official** or elector knows or suspects not to be  
4 qualified as an elector. The person's ballot may be challenged at any time before the ballot is re-  
5 moved from its return envelope for processing.

6 (2) A challenge to an absentee ballot of a person offering to vote shall be made[,] under oath  
7 or affirmation before the clerk[, *a member of the election board or special counting board,*] and shall  
8 be in writing on a numbered challenge form. The statement shall contain the name and residence  
9 address of the challenger, the name of the person challenged and a statement of the facts upon  
10 which the challenge is based. Any elections official [*or member of an election board or special*  
11 *counting board*] may administer the oath or affirmation required under this subsection.

12 **SECTION 19.** ORS 254.005 is amended to read:

13 254.005. As used in this chapter:

14 (1) "Ballot" means any material on which votes may be cast for candidates or measures. In the  
15 case of a recall election, "ballot" includes material posted in a voting compartment or delivered to  
16 an elector by mail.

17 [(2) "*Ballot label*" means the material containing the names of candidates or the measures to be  
18 voted on.]

19 [(3)] (2) "Chief elections officer" means the:

20 (a) Secretary of State, regarding a candidate for a state office or an office to be voted on in the  
21 state at large or in a congressional district, or a measure to be voted on in the state at large.

22 (b) County clerk, regarding a candidate for a county office, or a measure to be voted on in a  
23 county only.

24 (c) City clerk, auditor or recorder, regarding a candidate for a city office, or a measure to be  
25 voted on in a city only.

26 [(4)] (3) "County clerk" means the county clerk or the county official in charge of elections.

27 [(5)] (4) "Elector" means an individual qualified to vote under section 2, Article II, Oregon  
28 Constitution.

29 [(6)] (5) "Major political party" means a political party that has qualified as a major political  
30 party under ORS 248.006.

31 [(7)] (6) "Measure" includes any of the following submitted to the people for their approval or  
32 rejection at an election:

33 (a) A proposed law.

34 (b) An Act or part of an Act of the Legislative Assembly.

35 (c) A revision of or amendment to the Oregon Constitution.

36 (d) Local, special or municipal legislation.

37 (e) A proposition or question.

38 [(8)] (7) "Minor political party" means a political party that has qualified as a minor political  
39 party under ORS 248.008.

40 [(9)] (8) "Nonpartisan office" means the office of judge of the Supreme Court, Court of Appeals,  
41 circuit court or the Oregon Tax Court, Superintendent of Public Instruction, Commissioner of the  
42 Bureau of Labor and Industries, any elected office of a metropolitan service district under ORS  
43 chapter 268, justice of the peace, county clerk, county assessor, county surveyor, county treasurer,  
44 county judge who exercises judicial functions, sheriff, district attorney or any office designated  
45 nonpartisan by a home rule charter.

1 [(10)] (9) "Prospective petition" means the information, except signatures and other identifica-  
2 tion of petition signers, required to be contained in a completed petition.

3 [(11)] (10) "Regular district election" means the election held each year for the purpose of  
4 electing members of a district board as defined in ORS 255.005 (2).

5 [(12)] (11) "Vote tally system" means one or more pieces of equipment necessary to examine and  
6 tally automatically the marked ballots.

7 [(13)] (12) "Voting machine" means any device that will record every vote cast on candidates  
8 and measures and that will either internally or externally total all votes cast on that device.

9 **SECTION 20.** ORS 254.035 is amended to read:

10 254.035. (1) It is the intention of the [legislature] **Legislative Assembly** to carry out the pro-  
11 visions of section 14a, Article II, Oregon Constitution.

12 (2) All elections for city officers shall be held at the same time and place as elections for state  
13 and county officers. [*The election boards for state and county elections shall be the election boards for*  
14 *the city elections.*] Unless a city charter or ordinance provides otherwise, the ballots [*and ballot la-*  
15 *belts*] used for state and county elections, if the county clerk considers it practicable, shall be ar-  
16 ranged to include city offices and measures.

17 **SECTION 21.** ORS 254.071 is amended to read:

18 254.071. Prior to each election, the county clerk shall make every reasonable effort to acquaint  
19 electors with the ballot format to be used in the election and the methods used to mark [*or punch*]  
20 ballots to cast a valid vote.

21 **SECTION 22.** ORS 254.076 is amended to read:

22 254.076. The chief elections officer shall keep a register of candidates for nomination at the  
23 primary election. The register, if applicable, shall contain for each major political party:

24 (1) The title of each office for which the major political party will nominate candidates at the  
25 primary election.

26 (2) The name and mailing address of each candidate for nomination at the primary election.

27 (3) The name of the major political party with which the candidate is registered as affiliated.

28 (4) The date of filing of the prospective petition for nomination of the candidate.

29 (5) The date of filing of the completed petition for nomination of the candidate, the number of  
30 valid signatures contained and the number of signatures required.

31 (6) The date of filing of the declaration of candidacy of the candidate.

32 (7) Such other information as may aid the chief elections officer in arranging the official ballot  
33 [*or ballot label*] for the primary election.

34 **SECTION 23.** ORS 254.115 is amended to read:

35 254.115. (1) The official primary election ballot [*or ballot label*] shall be styled "Official Primary  
36 Nominating Ballot for the \_\_\_\_\_ Party." and shall state:

37 (a) The name of the county for which it is intended.

38 (b) The date of the primary election.

39 (c) The names of all candidates for nomination at the primary election whose nominating pe-  
40 titions or declarations of candidacy have been made and filed, and who have not died, withdrawn  
41 or become disqualified.

42 (d) The names of candidates for election as precinct committeeperson.

43 (e) The names of candidates for the party nomination for President of the United States who  
44 qualified for the ballot under ORS 249.078.

45 [(2) *If the election is conducted at polling places as provided in this chapter, any ballot to be issued*



1 *at a polling place shall also state the number or name of the precinct for which it is intended.]*

2 [(3)] (2) The primary election ballot may include any city, county or nonpartisan office or the  
3 number, ballot title and financial estimates under ORS 250.125 of any measure.

4 [(4)] (3) The ballot *[shall]* **may** not contain the name of any person other than those referred to  
5 in subsections (1) and [(3)] (2) of this section. The name of each candidate for whom a nominating
