Senate Bill 8

Sponsored by Senator COURTNEY; Senators BATES, MORRISETTE, Representatives GILLIAM, GREENLICK, TOMEI

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Requires health benefit plan that covers chemotherapy to cover orally administered agents as part of medical benefit.

A BILL FOR AN ACT

- 2 Relating to health benefit plan coverage of chemotherapy; creating new provisions; and amending ORS 750.055 and 750.333.
- 4 Be It Enacted by the People of the State of Oregon:
 - SECTION 1. Section 2 this 2007 Act is added to and made a part of the Insurance Code.
 - SECTION 2. (1) A health benefit plan that provides coverage for chemotherapy treatment shall provide coverage of a prescribed chemotherapy agent as a medical benefit, and not as a drug benefit, regardless of whether the agent is to be administered intravenously, orally or by injection.
 - (2) As used in this section, "health benefit plan" has the meaning given that term in ORS 743.730.
