

Senate Bill 803

Sponsored by Senators BATES, WALKER

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires health benefit plan to provide coverage for dental topical fluoride treatment for children under 18 years of age who are covered by plan.

A BILL FOR AN ACT

2 Relating to dental topical fluoride treatment for children; creating new provisions; and amending
3 ORS 750.055 and 750.333.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Insurance Code.**

6 **SECTION 2. (1) A health benefit plan, as defined in ORS 743.730, shall provide coverage**
7 **for dental topical fluoride treatment for children under 18 years of age who are covered by**
8 **the plan.**
