

# Senate Bill 84

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Judiciary for Office of the Legislative Counsel)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Makes nonsubstantive and technical changes in Oregon law. Corrects grammar and punctuation. Deletes obsolete provisions. Conforms language to existing statutes and legislative style.

13 1.560. In any case in which the judge desires the appointment of private counsel, the judge shall  
 14 so notify the State Court Administrator. The State Court Administrator, under the direction of the  
 15 Supreme Court, may authorize the judge to employ private counsel under the following circum-  
 16 stances:

17 (1) [Where] **When** the judge is a defendant in an action, suit or proceeding and there is no other

28 3.434. (1) No later than January 1, 1999, the presiding judge of each judicial district shall adopt  
 29 a plan to coordinate the provision of services to families involved in domestic relations or other  
 30 family court proceedings.

31 (2) The presiding judge of the judicial district shall establish a local family law advisory com-  
 32 mittee for the judicial district. The committee will prepare the plan required by subsection (1) of this  
 33 section. The membership of the local advisory committee must reflect the diversity of the judicial  
 34 district and must include, in addition to the presiding judge or a judge designated by the presiding  
 35 judge, the trial court administrator and business, social service, community and government repre-  
 36 sentatives who must be knowledgeable in family and family law issues. In judicial districts composed  
 37 of more than one county, the presiding judge may establish a local advisory committee in each

(b) The local advisory committee may include other elements in the plan, including but not limited to:

(A) The need for, and provision of, services relating to prevention and early intervention; and

(B) The use of settlement options such as mediation, conciliation, arbitration and settlement conferences.

(c) The local advisory committee shall include in the plan a list of mediators qualified to provide mediation in cases involving spousal support and division of property issues. Once the list is developed, the judicial district shall maintain the list.

(4) The local family law advisory committee shall present the plan to the county governing body of each county within the judicial district and to the presiding judge of the judicial district for their approval. The local advisory committee shall send copies of the plan to the Chief Justice of the [Oregon] Supreme Court and those members of the Oregon House of Representatives and the Oregon Senate who represent the areas within the judicial district.

(5) The local family law advisory committee may assist in implementing, monitoring and revising the plan. The local advisory committee, working in conjunction with legal service providers, may coordinate access to family law resources, including family law facilitation and other services.

E(3) These rules do not modify any statute or rule of this state relating to temporary restraining orders or preliminary injunctions in actions affecting employer and employee.

**SECTION 6.** ORS 18.845 is amended to read:

18.845. A notice of exemptions form must be in substantially the form set forth in this section. Nothing in the notice form described in this section is intended to expand or restrict the law relating to exempt property. A determination as to whether property is exempt from execution, attachment and garnishment must be made by reference to other law. The form provided in this section may be modified to provide more information or to update the notice based on subsequent changes in exemption laws.

AND INSTRUCTIONS FOR  
CHALLENGE TO GARNISHMENT

Property belonging to you may have been taken or held in order to satisfy a debt. The debt may be reflected in a judgment or in a warrant or order issued by a state agency. Important legal papers are enclosed.

YOU MAY BE ABLE TO GET YOUR PROPERTY BACK, SO READ THIS NOTICE CAREFULLY.

State and federal law specify that certain property may not be taken. Some of the property that you may be able to get back is listed below.

(1) Wages or a salary as described in ORS 18.375 and 18.385. Whichever of the following amounts is greater:

(a) 75 percent of your take-home wages; or

(b) \$170 per workweek.

(2) Social Security benefits.

(3) Supplemental Security Income (SSI).

(4) Public assistance (welfare).

(5) Unemployment benefits.

(6) Disability benefits (other than SSI benefits).

(7) Workers' compensation benefits.

(8) Exempt wages, Social Security benefits (other than SSI), welfare, unemployment benefits and disability benefits when placed in a checking or savings account (up to \$7,500).

(9) Spousal support, child support or separate maintenance to the extent reasonably necessary for your support or the support of any of your dependents.

(10) A homestead (house, *[mobile home or houseboat]* **manufactured dwelling or floating home**) occupied by you, or occupied by your spouse, parent or child. The value of the homestead is exempt up to the following amounts:

(a) For a *[mobile home or houseboat]* **manufactured dwelling or floating home** located on land that is not owned by you, \$20,000. If you jointly own the *[mobile home or houseboat]* **manufactured dwelling or floating home** with another person who is also liable on the debt, \$27,000.

(b) For a *[mobile home or houseboat]* **manufactured dwelling or floating home** located on land that is owned by you, \$23,000. If you jointly own the *[mobile home or houseboat]* **manufactured dwelling or floating home** with another person who is also liable on the debt, \$30,000.

(c) For any other homestead, \$30,000. If you jointly own the homestead with another person who is also liable on the debt, \$39,600.

(11) Proceeds from the sale of a homestead described in item 10, up to the limits described in item 10, if you hold the proceeds for less than one year and intend to use those proceeds to procure another homestead.

(12) Household goods, furniture, radios, a television set and utensils with a combined value not to exceed \$3,000.

\*(13) An automobile, truck, trailer or other vehicle with a value not to exceed \$2,150.

\*(14) Tools, implements, apparatus, team, harness or library that are necessary to carry on your occupation, with a combined value not to exceed \$3,000.

\*(15) Books, pictures and musical instruments with a combined value not to exceed \$600.

\*(16) Wearing apparel, jewelry and other personal items with a combined value not to exceed

2 (17) Domestic animals and poultry for family use with a combined value not to exceed \$1,000  
3 and their food for 60 days.

4 (18) Provisions and fuel for your family for 60 days.

5 (19) One rifle or shotgun and one pistol. The combined value of all firearms claimed as exempt  
6 may not exceed \$1,000.

7 (20) Public or private pensions.

8 (21) Veterans' benefits and loans.

9 (22) Medical assistance benefits.

10 (23) Health insurance proceeds and disability proceeds of life insurance policies.

11 (24) Cash surrender value of life insurance policies not payable to your estate.

12 (25) Federal annuities.

13 (26) Other annuities to \$250 per month (excess over \$250 per month is subject to the same ex-  
14 emption as wages).

15 (27) Professionally prescribed health aids for you or any of your dependents.

16 \*(28) Elderly rental assistance allowed pursuant to ORS 310.635.

17 (29) Your right to receive, or property traceable to:

18 (a) An award under any crime victim reparation law.

19 (b) A payment or payments, not exceeding a total of \$10,000, on account of personal bodily in-  
20 jury suffered by you or an individual of whom you are a dependent.

21 (c) A payment in compensation of loss of future earnings of you or an individual of whom you  
22 are or were a dependent, to the extent reasonably necessary for your support and the support of  
23 any of your dependents.

24 (30) Amounts paid to you as an earned income tax credit under federal tax law.

25 \*(31) Interest in personal property to the value of \$400, but this cannot be used to increase the  
26 amount of any other exemption.

27 (32) Equitable interests in property.

28 (33) Security deposits or prepaid rent held by a residential landlord under ORS 90.300.

29 (34) If the amount shown as owing on the Debt Calculation form exceeds the amount you actu-  
30 ally owe to the creditor, the difference between the amount owed and the amount shown on the Debt  
31 Calculation form.

32  
33 Note: If two or more people in your household owe the claim or judgment, each of them may  
34 claim the exemptions marked by an asterisk (\*).

35  
36  
37 **SPECIAL RULES APPLY FOR DEBTS THAT ARE OWED FOR CHILD SUPPORT AND**  
38 **SPOUSAL SUPPORT.** Some property that may not otherwise be taken for payment against the debt  
39 may be taken to pay for overdue support. For instance, Social Security benefits, workers' compen-  
40 sation benefits, unemployment benefits, veterans' benefits and pensions are normally exempt, but  
41 only 75 percent of a lump sum payment of these benefits is exempt if the debt is owed for a support  
42 obligation.

43  
44 **YOU MUST ACT PROMPTLY IF YOU WANT TO GET YOUR MONEY OR PROPERTY BACK.**  
45 You may seek to reclaim your exempt property by doing the following:

1 (1) Fill out the Challenge to Garnishment form that you received with this notice.

2 (2) Mail or deliver the Challenge to Garnishment form to the court administrator at the address  
3 shown on the writ of garnishment, and mail or deliver a copy of the form to the Garnishor at the  
4 address shown on the writ of garnishment. If you wish to claim wages or salary as exempt, you must  
5 mail or deliver the form within 120 days after you receive this notice. If you wish to claim that any  
6 other money or property is exempt, or claim that the property is not subject to garnishment, you  
7 must mail or deliver the form within 30 days after you receive this notice. You have the burden of  
8 showing that your challenge is made on time, so you should keep records showing when the chal-  
9 lenge was mailed or delivered.

10 (3) The law only requires that the Garnishor hold the garnished money or property for 10 days  
11 before applying it to the Creditor’s use. You may be able to keep the property from being used by  
12 the Creditor by promptly following (1) and (2) above.

13  
14 You should be prepared to explain your exemption in court. If you have any questions about the  
15 garnishment or the debt, you should see an attorney.

16 YOU MAY USE THE CHALLENGE TO GARNISHMENT FORM ONLY FOR THE FOLLOW-  
17 ING PURPOSES:

18 (1) To claim such exemptions from garnishment as are permitted by law.

19 (2) To assert that property is not garnishable property under ORS 18.618.

20 (3) To assert that the amount specified in the writ of garnishment as being subject to  
21 garnishment is greater than the total amount owed.

22  
23 YOU MAY NOT USE THE CHALLENGE TO GARNISHMENT FORM TO CHALLENGE THE  
24 VALIDITY OF THE DEBT.

25 IF YOU FILE A CHALLENGE TO A GARNISHMENT IN BAD FAITH, YOU MAY BE SUB-  
26 JECT TO PENALTIES IMPOSED BY THE COURT THAT COULD INCLUDE A FINE. Penalties  
27 that you could be subject to are listed in ORS 18.715.

28 When you file a Challenge to Garnishment form, the Garnishee may be required to make all  
29 payments under the garnishment to the court, and the Garnishor may be required to pay to the  
30 court all amounts received by the Garnishor that are subject to the challenge to the garnishment.  
31 The Garnishee and Garnishor are subject to penalties if they do not. For a complete explanation of  
32 their responsibilities, see ORS 18.705 and 18.708.

- 8 other party and when an order for compensatory spousal support is otherwise just and equitable in
- 9 all of the circumstances. The factors to be considered by the court in awarding compensatory
- 10 spousal support include but are not limited to:
  - 11 (i) The amount, duration and nature of the contribution;
  - 12 (ii) The duration of the marriage;
  - 13 (iii) The relative earning capacity of the parties;
  - 14 (iv) The extent to which the marital estate has already benefited from the contribution;

  - 23 (iv) The standard of living established during the marriage;
  - 24 (v) The relative income and earning capacity of the parties, recognizing that the wage earner's
  - 25 continuing income may be a basis for support distinct from the income that the supported spouse
  - 26 may receive from the distribution of marital property;
  - 27 (vi) A party's training and employment skills;
  - 28 (vii) A party's work experience;
  - 29 (viii) The financial needs and resources of each party;
  - 30 (ix) The tax consequences to each party;
  - 31 (x) A party's custodial and child support responsibilities; and
  - 32 (xi) Any other factors the court deems just and equitable.
- 33 (e) For the delivery to one party of such party's personal property in the possession or control
- 34 of the other at the time of the giving of the judgment.
- 35 (f) For the division or other disposition between the parties of the real or personal property, or
- 36 both, of either or both of the parties as may be just and proper in all the circumstances. A retire-
- 37 ment plan or pension or an interest therein shall be considered as property. The court shall consider
- 38 the contribution of a spouse as a homemaker as a contribution to the acquisition of marital assets.
- 39 There is a rebuttable presumption that both spouses have contributed equally to the acquisition of

27 [(1)] (2) A local government may adopt an exception to a goal if:

28 (a) The land subject to the exception is physically developed to the extent that it is no longer  
 29 available for uses allowed by the applicable goal;

30 (b) The land subject to the exception is irrevocably committed as described by Land Conserva-  
 31 tion and Development Commission rule to uses not allowed by the applicable goal because existing  
 32 adjacent uses and other relevant factors make uses allowed by the applicable goal impracticable;  
 33 or

34 (c) The following standards are met:

35 (A) Reasons justify why the state policy embodied in the applicable goals should not apply;

36 (B) Areas [which] **that** do not require a new exception cannot reasonably accommodate the use;

37 (C) The long term environmental, economic, social and energy consequences resulting from the

30 [(c) Complies with standards under subsection (1) of this section.]

31 [(9)] **(8)** An exception acknowledged under ORS 197.251, 197.625 or 197.630 (1) (1981 Replacement  
32 Part) on or before August 9, 1983, continues to be valid and is not [be] subject to this section.

 25 may be established as provided in ORS 215.275.

26 (e) A dwelling on real property used for farm use if the dwelling is occupied by a relative of the  
 27 farm operator or the farm operator's spouse, which means a child, parent, stepparent, grandchild,  
 28 grandparent, stepgrandparent, sibling, stepsibling, niece, nephew or first cousin of either, if the farm

33 (t) Alteration, restoration or replacement of a lawfully established dwelling that:

34 (A) Has intact exterior walls and roof structure;

35 (B) Has indoor plumbing consisting of a kitchen sink, toilet and bathing facilities connected to  
36 a sanitary waste disposal system;

37 (C) Has interior wiring for interior lights;

38 (D) Has a heating system; and

39 (E) In the case of replacement:

40 (i) Is removed, demolished or converted to an allowable nonresidential use within three months  
41 of the completion of the replacement dwelling. A replacement dwelling may be sited on any part of  
42 the same lot or parcel. A dwelling established under this paragraph shall comply with all applicable  
43 siting standards. However, the standards shall not be applied in a manner that prohibits the siting

24 (B) The farm stand does not include structures designed for occupancy as a residence or for  
25 activity other than the sale of farm crops or livestock and does not include structures for banquets,

27 (v) An armed forces reserve center, if the center is within one-half mile of a community college.  
28 For purposes of this paragraph, "armed forces reserve center" includes an armory or National  
29 Guard support facility.

30 (w) A site for the takeoff and landing of model aircraft, including such buildings or facilities as  
31 may reasonably be necessary. Buildings or facilities shall not be more than 500 square feet in floor  
32 area or placed on a permanent foundation unless the building or facility preexisted the use approved

44 (e) Community centers owned by a governmental agency or a nonprofit community organization

2 county governing body or its designee, a private campground may provide yurts for overnight

16 stricted, except for aircraft emergencies, to use by the owner, and, on an infrequent and occasional  
17 basis, by invited guests, and by commercial aviation activities in connection with agricultural op-  
18 erations. No aircraft may be based on a personal-use airport other than those owned or controlled  
19 by the owner of the airstrip. Exceptions to the activities permitted under this definition may be

34 (k) Dog kennels not described in subsection (1)(L) of this section.

35 (L) Residential homes as defined in ORS 197.660, in existing dwellings.

36 (m) The propagation, cultivation, maintenance and harvesting of aquatic species that are not  
37 under the jurisdiction of the State Fish and Wildlife Commission or insect species. Insect species  
38 shall not include any species under quarantine by the State Department of Agriculture or the United  
39 States Department of Agriculture. The county shall provide notice of all applications under this  
40 paragraph to the State Department of Agriculture. Notice shall be provided in accordance with the  
41 county's land use regulations but shall be mailed at least 20 calendar days prior to any administra-  
42 tive decision or initial public hearing on the application.

43 (n) Home occupations as provided in ORS 215.448.

44 (o) Transmission towers over 200 feet in height.

45 (p) Construction of additional passing and travel lanes requiring the acquisition of right of way

1 but not resulting in the creation of new land parcels.

2 (q) Reconstruction or modification of public roads and highways involving the removal or dis-  
3 placement of buildings but not resulting in the creation of new land parcels.

4 (r) Improvement of public road and highway related facilities such as maintenance yards, weigh  
5 stations and rest areas, where additional property or right of way is required but not resulting in  
6 the creation of new land parcels.

7 (s) A destination resort that is approved consistent with the requirements of any statewide  
8 planning goal relating to the siting of a destination resort.

9 (t) Room and board arrangements for a maximum of five unrelated persons in existing resi-  
10 dences.

11 (u) A living history museum related to resource based activities owned and operated by a gov-  
12 ernmental agency or a local historical society, together with limited commercial activities and fa-  
13 cilities that are directly related to the use and enjoyment of the museum and located within  
14 authentic buildings of the depicted historic period or the museum administration building, if areas  
15 other than an exclusive farm use zone cannot accommodate the museum and related activities or if  
16 the museum administration buildings and parking lot are located within one quarter mile of the  
17 metropolitan urban growth boundary. As used in this paragraph:

18 (A) "Living history museum" means a facility designed to depict and interpret everyday life and  
19 culture of some specific historic period using authentic buildings, tools, equipment and people to  
20 simulate past activities and events; and

21 (B) "Local historical society" means the local historical society, recognized as such by the

23 (v) Operations for the extraction and bottling of water.

24 (w) An aerial fireworks display business that has been in continuous operation at its current  
25 location within an exclusive farm use zone since December 31, 1986, and possesses a wholesaler's  
26 permit to sell or provide fireworks.

27 (x) A landscaping business, as defined in ORS 671.520, or a business providing landscape archi-  
28 tecture services, as described in ORS 671.318, if the business is pursued in conjunction with the  
29 growing and marketing of nursery stock on the land that constitutes farm use.

30 (3) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),  
31 a single-family residential dwelling not provided in conjunction with farm use may be established  
32 on a lot or parcel with soils predominantly in capability classes IV through VIII as determined by

45 (4) In counties that have adopted marginal lands provisions under ORS 197.247 (1991 Edition),



1 one single-family dwelling, not provided in conjunction with farm use, may be established in any  
2 area zoned for exclusive farm use on a lot or parcel described in subsection (7) of this section that  
3 is not larger than three acres upon written findings showing:

4 (a) The dwelling or activities associated with the dwelling will not force a significant change in  
5 or significantly increase the cost of accepted farming practices on nearby lands devoted to farm use;

6 (b) If the lot or parcel is located within the Willamette River Greenway, a floodplain or a  
7 geological hazard area, the dwelling complies with conditions imposed by local ordinances relating  
8 specifically to the Willamette River Greenway, floodplains or geological hazard areas, whichever is

14 (a) Owners of land that is within 250 feet of the lot or parcel on which the dwelling will be es-  
15 tablished; and

16 (b) Persons who have requested notice of such applications and who have paid a reasonable fee  
17 imposed by the county to cover the cost of such notice.

18 (6) The notice required in subsection (5) of this section shall specify that persons have 15 days  
19 following the date of postmark of the notice to file a written objection on the grounds only that the  
20 dwelling or activities associated with it would force a significant change in or significantly increase  
21 the cost of accepted farming practices on nearby lands devoted to farm use. If no objection is re-  
22 ceived, the governing body or its designee shall approve or disapprove the application. If an ob-  
23 jection is received, the governing body shall set the matter for hearing in the manner prescribed in  
24 ORS 215.402 to 215.438. The governing body may charge the reasonable costs of the notice required  
25 by subsection (5)(a) of this section to the applicant for the permit requested under subsection (4) of

45 (a) Adoption of an exception to the goal related to agricultural lands and to any other applicable

1 goal with which the facility or improvement does not comply; or

2 (b) ORS 215.296 for those uses identified by rule of the Land Conservation and Development  
3 Commission as provided in section 3, chapter 529, Oregon Laws 1993.

11 (d) Utility facilities necessary for public service, including wetland waste treatment systems but  
12 not including commercial facilities for the purpose of generating electrical power for public use by

14 may be established as provided in ORS 215.275.

15 (e) A dwelling on real property used for farm use if the dwelling is occupied by a relative of the  
16 farm operator or the farm operator's spouse, which means a child, parent, stepparent, grandchild,

18 operator does or will require the assistance of the relative in the management of the farm use and

40 (L) Reconstruction or modification of public roads and highways, including the placement of  
41 utility facilities overhead and in the subsurface of public roads and highways along the public right  
42 of way, but not including the addition of travel lanes, where no removal or displacement of buildings  
43 would occur, or no new land parcels result.

44 (m) Temporary public road and highway detours that will be abandoned and restored to original  
45 condition or use at such time as no longer needed.

1 (n) Minor betterment of existing public road and highway related facilities such as maintenance  
 2 yards, weigh stations and rest areas, within right of way existing as of July 1, 1987, and contiguous  
 3 public-owned property utilized to support the operation and maintenance of public roads and high-  
 4 ways.

5 (o) A replacement dwelling to be used in conjunction with farm use if the existing dwelling has  
 6 been listed in a county inventory as historic property as defined in ORS 358.480.

7 (p) Creation of, restoration of or enhancement of wetlands.

8 (q) A winery, as described in ORS 215.452.

9 (r) Farm stands if:

10 (A) The structures are designed and used for the sale of farm crops or livestock grown on the  
 11 farm operation, or grown on the farm operation and other farm operations in the local agricultural  
 12 area, including the sale of retail incidental items and fee-based activity to promote the sale of farm  
 13 crops or livestock sold at the farm stand if the annual sale of incidental items and fees from pro-  
 14 motional activity do not make up more than 25 percent of the total annual sales of the farm stand;  
 15 and

16 (B) The farm stand does not include structures designed for occupancy as a residence or for  
 17 activity other than the sale of farm crops or livestock and does not include structures for banquets,  
 18 public gatherings or public entertainment.

19 (s) Alteration, restoration or replacement of a lawfully established dwelling that:

20 (A) Has intact exterior walls and roof structure;

21 (B) Has indoor plumbing consisting of a kitchen sink, toilet and bathing facilities connected to

10 System or for any assistance by the State Board of Higher Education under ORS 243.920 as long as  
11 those employees are employed in the Oregon University System and the plan is in effect.

12 (6)(a) An administrative or academic employee who elects to participate in the Optional Retirement  
13 Plan, who has creditable service under ORS chapter 238 as defined by ORS 238.005 and who  
14 is not vested shall be considered by the Public Employees Retirement Board to be a terminated  
15 member under the provisions of ORS 238.095 as of the effective date of the election, and the amount  
16 credited to the member account of the member shall be transferred directly to the Optional Retirement

45 (E) An individual behavioral health or medical professional authorized for reimbursement under

1 Oregon law.

2 (2) The coverage may be made subject to provisions of the policy that apply to other benefits  
3 under the policy, including but not limited to provisions relating to deductibles and coinsurance.  
4 Deductibles and coinsurance for treatment in health care facilities or residential programs or facil-  
5 ities may not be greater than those under the policy for expenses of hospitalization in the treatment  
6 of other medical conditions. Deductibles and coinsurance for outpatient treatment may not be  
7 greater than those under the policy for expenses of outpatient treatment of other medical conditions.

8 (3) The coverage may not be made subject to treatment limitations, limits on total payments for  
9 treatment, limits on duration of treatment or financial requirements unless similar limitations or  
10 requirements are imposed on coverage of other medical conditions. The coverage of eligible expenses  
11 may be limited to treatment that is medically necessary as determined under the policy for other  
12 medical conditions.

13 (4)(a) Nothing in this section requires coverage for:

14 (A) Educational or correctional services or sheltered living provided by a school or halfway  
15 house;

16 (B) A long-term residential mental health program that lasts longer than 45 days;

45 from the last day of the month following the close of the month for which the assessment is imposed

1 until paid.

2 (3) There shall be added to every such assessment a penalty of 25 percent of the amount thereof.

3 (4) The department shall give to such person written notice of such assessment.

4 (5) Whenever the department has made an assessment pursuant to this section [*which*] **that** has  
5 become final the department may not reopen or reassess such taxes, fees, interest or penalties unless  
6 the department is satisfied that the taxpayer fraudulently or with intent to evade taxation destroyed,  
7 concealed or withheld any books, accounts, papers, records or memoranda required to be maintained  
8 by a person subject to this chapter or the rules of the department.
