

## HOUSE AMENDMENTS TO RESOLVE CONFLICTS TO SENATE BILL 91

1 On page 1 of the printed bill, line 3, before the period insert “and section 7, chapter \_\_\_\_\_,  
2 Oregon Laws 2007 (Enrolled House Bill 2109)”.

3 On page 3, after line 38, insert:

4 “**SECTION 1a.** If House Bill 2109 becomes law, section 1 of this 2007 Act (amending ORS  
5 701.055) is repealed and section 7, chapter \_\_\_\_\_, Oregon Laws 2007 (Enrolled House Bill  
6 2109), is amended to read:

7 “**Sec. 7.** [A partnership or corporation licensed under this chapter shall notify the Construction  
8 Contractors Board immediately upon any change in licensed partners or corporate officers. If a part-  
9 nership no longer has a licensed partner, the partnership may not conduct activities that require a li-  
10 cense under this chapter.] **A contractor licensed under this chapter shall immediately notify the**  
11 **Construction Contractors Board of any change in the identity, name or address of a person**  
12 **who holds a position with the contractor that is described in ORS 701.075 (1)(h) or (i) or of**  
13 **a responsible managing individual for the contractor as defined in ORS 701.078. If a partner**  
14 **or joint venturer departs from a contractor that is a partnership or joint venture, the con-**  
15 **tractor must obtain a new license before continuing to conduct activities that require a li-**  
16 **cence under this chapter.”.**

17 On page 5, after line 11, insert:

18 “**SECTION 3a.** If House Bill 2109 becomes law, section 3 of this 2007 Act is amended to read:

19 “**Sec. 3.** (1) The amendments to [ORS 701.055 by section 1 of this 2007 Act] **section 7, chapter**  
20 **\_\_\_\_\_**, Oregon Laws 2007 (Enrolled House Bill 2109), by section 1a of this 2007 Act requiring  
21 the reporting of identity, name or address changes apply to identity, name and address changes oc-  
22 curring on or after January 1, 2008. The amendments to [ORS 701.055 by section 1 of this 2007 Act]  
23 **section 7, chapter \_\_\_\_\_**, Oregon Laws 2007 (Enrolled House Bill 2109), by section 1a of this  
24 **2007 Act** restricting contractor activity following the departure of a partner or joint venturer apply  
25 if the departure of the partner or joint venturer occurs on or after January 1, 2008.

26 “(2) The amendments to ORS 701.075 by section 2 of this 2007 Act apply to license applications  
27 received by the Construction Contractors Board on or after January 1, 2008.”.
