# **A-Engrossed** House Bill 3626

Ordered by the House February 21 Including House Amendments dated February 21

Sponsored by COMMITTEE ON ELECTIONS, ETHICS AND RULES (at the request of Joint Interim Committee on Ways and Means)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Clarifies authority of officer of local government who has custody of public moneys.

Establishes Oregon Pre-Disaster Mitigation Fund and Oregon Disaster Response Fund. Continuously appropriates moneys in funds to Oregon Military Department for specified purposes.

Establishes Oregon Local Disaster Assistance Loan Account within Oregon Disaster Response Fund. Requires Oregon Military Department to establish Local Disaster Assistance Review Board to review and approve department loans from account. Specifies board membership.

Adjusts requirement for submitting proposed sale of Oregon Military Department real property to Legislative Assembly or Emergency Board for approval.

Requires Department of Higher Education to report to Joint Committee on Ways and Means or other designated legislative budget committee regarding University of Oregon arena capital construction project and certain athletic program financial matters. Specifies objective for Department of Human Services payment rates for patient-based

reimbursement system. Requires department to implement policies offering incentives for community-based care providers to enter into Medicaid contracts promoting care in residential setting.

Requires Department of Human Services to consider certain issues before granting initial license for residential care facility.

Advances sunset for temporary laws regarding licensing, certain plan and drawing fees and permit submission requirements for residential care facilities. Eliminates Residential Care Facility Licensing Moratorium Fee Subaccount.

Requires Department of Human Services to assess capacity of residential facilities and adult foster homes to serve residents qualifying for state medical assistance. Requires department to target expansion of capacity and make quarterly progress reports. Requires department to semiannually report findings and recommendations regarding capacity to Legislative Assembly or Emergency Board.

Establishes Veterans' Small Business Repair Loan Program within Department of Veterans' Affairs. Establishes Veterans' Small Business Repair Loan Fund. Appropriates fund moneys to department for funding loans under program.

Establishes grant program for improving access to and effectiveness of health care de-livery for families. Authorizes Department of Human Services to award two grants for projects furthering specified program objectives.

Sunsets grant program January 2, 2012. Requires Department of Human Services to assess and evaluate community mental health care component of mental health care delivery system. Requires department to report findings to specified interim committees of Legislative Assembly by October 1, 2008.

Advances sunset for law authorizing transfer of utility public purpose charge moneys. Repeals temporary law providing for transfer of Emergency Communications Account

moneys.

Declares emergency, effective on passage.

SECTION 4. (1) The Oregon Pre-Disaster Mitigation Fund is established in the State 17 18 Treasury, separate and distinct from the General Fund. Moneys received from federal grants for pre-disaster mitigation efforts shall be deposited into the Oregon Pre-Disaster Mitigation 19 Fund. Moneys in the fund are continuously appropriated to the Oregon Military Department 20to be used to: 21

22(a) Help state agencies and local government units with Federal Emergency Management Agency approved mitigation plans in this state prior to the occurrence of natural disasters; 23and 24

25(b) Ensure, to the extent possible, that state and local agencies and officials are prepared to respond to threats of human-caused disaster, including but not limited to acts of 2627terrorism.

(2) The Oregon Pre-Disaster Mitigation Fund may receive gifts, grants, bequests, 28endowments and donations from public and private sources for purposes related to the fund. 2930 (3) The Oregon Military Department shall adopt rules for the disbursement of moneys 31 from the Oregon Pre-Disaster Mitigation Fund.

SECTION 5. (1) The Oregon Disaster Response Fund is established in the State Treasury, 32separate and distinct from the General Fund. Moneys received from federal grants for dis-33 34 aster response efforts shall be deposited into the Oregon Disaster Response Fund. Moneys 35 in the fund are continuously appropriated to the Oregon Military Department to be used to: (a) Help state agencies and local government units with immediate disaster response and 36

37 recovery efforts related to federally declared disasters in this state; and

(b) Implement long-term hazard mitigation measures after a federally declared disaster in this state during the period of immediate recovery from the disaster. 39

(3) The Office of Emergency Management of the Oregon Military Department shall adopt 42rules for the disbursement of moneys from the Oregon Disaster Response Fund. 43

(4) If there are expenditures from the Oregon Disaster Response Fund, the Adjutant 44 General of the Oregon Military Department shall report to the Emergency Board, or to the 45

Legislative Assembly if it is in session, on: 1 2 (a) The nature and severity of the disaster; (b) The actual and projected deposits into the fund; 3 (c) The sources of actual and projected expenditures from the fund; 4 (d) The nature of in-kind donations received; and 5 (e) The rationale for expenditures and allocation of payments to state agencies and local 6 7 government units. 15 410.851. (1) The Legislative Assembly finds and declares that patients admitted to and cared for by long term care facilities in Oregon are more impaired than in the past. In keeping with the tra-16 ditional commitment of the State of Oregon to the care and protection of its citizens who are frail 17 18 or elderly or who have disabilities, as expressed in ORS 410.020 (1) to (6), the Legislative Assembly declares that a patient-based reimbursement system emphasizing quality incentives is appropriate for 19 long term care facilities. Such a system would reward long term care facilities for outcomes, such 20as maintaining or improving a patient's condition, and meet the legitimate costs of caring for pa-2122tients.

(2) As used in this section, "patient-based reimbursement" means reimbursement for direct
 patient care according to the needs of the patient, based on multiple levels of patient health, func tioning and impairment.

(3) [Notwithstanding the above,] A patient-based reimbursement system does not require the Department of Human Services to assess each patient and reimburse long term care facilities according to the constantly changing conditions of the patients except for changes between skilled and intermediate levels of care which shall result in prompt readjustment of rates.

30 [(3)] (4) The department [of Human Services] shall establish by rule definitions of levels of care 31 and the payment rates for the patient-based reimbursement system. The rates shall be designed 32 to maintain and enhance access to community-based care services.

(c) Administer the program. 19 (5) The department shall award grants under this section for projects that: 20(a) Create incentives for collaborative, community-based organizations to bring diverse 21 22stakeholders together to coordinate, communicate and improve access to health care for lo-23cal residents of the community; and (b) Improve health care delivery in the community by providing: 24 (A) Patient-centered care in which there is a sustained relationship between a patient 25and a culturally competent provider team and that utilizes patient-driven goals and 2627evidence-based practices; (B) Team-based care that takes advantage of nursing services, including care coordi-28nation, school-based health services, home visits, telephone triage and clinical case manage-2930 ment, and that maximizes services during each patient visit; 31 (C) Coordinated care that links patients to comprehensive services in the community, including specialty care, mental health care, dental care, vision care and social services; 32(D) Provider accessibility through the use of telephone and electronic mail, and the re-33 34 moval of transportation, language, cultural and other barriers to timely care; and (E) Collaboration with the community that ensures that health-related interests and 35 services are coordinated, psychosocial services are incorporated, resources are leveraged and 36 37 maximized and assessments are conducted on health status, disparities and effectiveness of 38 services. (6) To be awarded grants, applicants must demonstrate the ability to leverage nonstate 39 resources given the strengths and limitations of their geographic locations. 40 (7) Each project must include an evaluation component that accurately monitors and 41 measures: 42 (a) The impact of the project on the cost and quality of and access to health care; and 43 (b) How the structure and operation of the organization reflects the interests of and is 44 accountable to the diverse needs of the local community. 45

(1) During the 2007-2009 biennium, the Department of Human Services shall conduct an assessment and evaluation of the community mental health care component of 3 the mental health care delivery system in Oregon. 4 (2) The assessment conducted under subsection (1) of this section shall include but is not 5 limited to: 6 (a) An assessment of the gap between the number of Oregonians in need of community 7 mental health care and the number who receive community mental health care; 8 9 (b) An assessment of the investment that the Department of Human Services, the Department of Corrections and local governments make in community mental health care, in-10 cluding an examination of the amount spent on community mental health care; 11 12(c) As assessment of the community mental health needs of particularly vulnerable pop-13 ulations in this state; and (d) A catalog of the information that agencies and local governments use to evaluate the 14 15 performance of providers of community mental health care, including the data collected and the performance measures and outcomes that are tracked by each agency and local govern-16 ment. 17 18 (3) The assessment conducted under subsection (2)(a) of this section must include a separate analysis of the gap between the demand for community mental health care by vet-19 erans returning from tours in Iraq, Afghanistan and other hostile fire areas and the com-20munity mental health care that is provided at United States Department of Veterans Affairs 2122facilities. 23(4) The evaluation conducted under subsection (1) of this section must contain: (a) An analysis of the strengths and weaknesses in the state community mental health 24 care delivery system; 25(b) An overview of future community mental health care delivery system needs; and 2627(c) Recommendations from the Department of Human Services for improving the quality, effectiveness and efficiency of the community mental health care delivery system. 28(5) The department shall provide a written report of the results of the assessment and 2930 evaluation conducted under subsection (1) of this section to the Senate Interim Committee 31 on Health and Human Services and the House Interim Committee on Health Care no later than October 1, 2008. 32(6) The department may contract with a private entity or individual to conduct the as-33 34 sessment and evaluation and to produce the report required by this section. SECTION 24. Section 23 of this 2008 Act is repealed January 2, 2009. 35 SECTION 25. Sections 2, 3 and 5, chapter 911, Oregon Laws 2007, are repealed. 36 37 SECTION 26. This 2008 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2008 Act takes effect 38
