**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Imposes duties and restrictions on foreclosure consultants. Requires that provision of foreclosure consulting services to homeowners be pursuant to written contract. Makes violation of foreclosure consulting laws unfair trade practice. Makes violation of foreclosure consulting laws criminal offense with maximum penalty of one year's imprisonment, \$10,000 fine, or both. Applies to agreements for foreclosure services homeowner enters into 90 or more days after effective date of Act.

Imposes duties and restrictions on equity purchasers. Requires that conveyance of homeowner equity in residence in foreclosure be pursuant to written contract. Makes violation of equity conveyance laws unlawful practice. Makes violation of equity conveyance laws criminal offense with maximum penalty of one year's imprisonment, \$10,000 fine, or both. Creates private cause of action for damages arising from violation of equity conveyance laws. Applies to equity conveyance agreements equity seller enters into seven or more days after effective date of Act.

Requires sending of notice of home loss danger to grantor of trust deed in residential property for which notice of foreclosure is filed. Requires that notice of home loss danger contain telephone numbers for grantor access to loan information and consultant services. Specifies effect of failure to send notice of home loss danger. Applies to residential trust deed properties for which statutory notice of sale is sent 90 or more days after effective date of Act.

Requires Department of Consumer and Business Services to adopt rules specifying statewide telephone contact number and website address where grantors of residential trust deeds receiving notice of home loss danger may find possible sources of information and assistance.

Declares emergency, effective on passage.

**A BILL FOR AN ACT**

2 Relating to interests in residential real properties; creating new provisions; amending ORS 646.607  
3 and 646.608; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Sections 2 to 6 and 9 to 14 of this 2008 Act may be cited as the Mortgage**  
6 **Rescue Fraud Protection Act.**

7 **SECTION 2. As used in sections 2 to 6 of this 2008 Act:**

8 (1) **"Default" means having one or more homeowner obligations in arrears to an extent**  
9 **that a notice of default could properly be recorded against the residence.**

10 (2) **"Family" means a spouse, domestic partner, parent, stepparent, grandparent, child,**  
11 **stepchild, grandchild, sibling, aunt, uncle, cousin or in-law.**

12 (3) **"Foreclosure consultant," except as provided in section 3 of this 2008 Act, means a**  
13 **person that directly or through association with another makes a solicitation, representation**  
14 **or offer to a homeowner to perform, for or with the intent to receive compensation from or**  
15 **on behalf of the homeowner, a service that the solicitation, representation or offer indicates**  
16 **will accomplish one or more of the following:**

New sections are in **boldfaced** type.

- 1 (a) Prevent, postpone or stop a foreclosure sale.
- 2 (b) Obtain a forbearance from a beneficiary or mortgagee.
- 3 (c) Assist the homeowner in exercising a right of redemption.
- 4 (d) Obtain an extension of the period within which the homeowner may reinstate the
- 5 homeowner's obligation.
- 6 (e) Obtain the waiver of an acceleration clause that is:
  - 7 (A) Contained in a promissory note or contract; and
  - 8 (B) Secured by or contained in a deed of trust for, or mortgage on, a residence in fore-
  - 9 closure or in default.
- 10 (f) Assist the homeowner in obtaining a loan or advance of funds.
- 11 (g) Avoid or ameliorate an impairment of the homeowner's credit resulting from a re-
- 12 corded notice of foreclosure or default.
- 13 (4) "Foreclosure consulting contract" means an agreement between a foreclosure con-
- 14 sultant and a homeowner for the provision of services by a foreclosure consultant in regard
- 15 to a residence in foreclosure or in default.
- 16 (5) "Homeowner" means the record owner of a residence.
- 17 (6) "Residence in foreclosure" means residential real property:
  - 18 (a) Consisting of one to four single-family dwelling units;
  - 19 (b) On which the owner occupies a dwelling unit; and
  - 20 (c) Against which a notice of default has been recorded.
- 21 **SECTION 3.** The following are not foreclosure consultants for purposes of sections 2 to
- 22 6 of this 2008 Act:
  - 23 (1) An individual licensed to practice law in this state, if performing services within an
  - 24 attorney-client relationship.
  - 25 (2) A person that holds or is owed an obligation that is secured by a lien on a residence
  - 26 in foreclosure or default, if performing services in connection with the obligation or lien.
  - 27 (3) A person doing business under authority of an Oregon or federal law regulating banks,
  - 28 trust companies, savings and loan associations, credit unions or insurance companies, or as
  - 29 a licensee under ORS chapter 725, if performing business services within the scope of that
  - 30 authority or license.
  - 31 (4) A subsidiary, affiliate or agent of a person described in subsection (3) of this section,
  - 32 if performing business services within the scope of the person's authority or license as the
  - 33 person's subsidiary, affiliate or agent.
  - 34 (5) The judgment creditor of a homeowner, if the creditor's claim accrued before a notice
  - 35 of sale was sent to the creditor under ORS 86.740.
  - 36 (6) A title insurer authorized to conduct business in Oregon or an insurance producer
  - 37 licensed to conduct business in Oregon, if performing title insurance or settlement services
  - 38 within the scope of that authority or license.
  - 39 (7) A mortgage broker or mortgage lender licensed under ORS chapter 59 to conduct
  - 40 business in Oregon, if acting within the scope of that license.
  - 41 (8) A real estate licensee under ORS 696.022 or an escrow agent licensed under ORS
  - 42 696.511, if acting within the scope of that license.
  - 43 (9) A tax-exempt organization that offers counseling or advice to homeowners in fore-
  - 44 closure if the organization:
    - 45 (a) Is not directly or indirectly related to for-profit lenders or foreclosure purchasers;

1 (b) Does not contract to provide services to or receive services from for-profit lenders  
2 or foreclosure purchasers; and

3 (c) Has provided counseling or advice to homeowners for five years or more.

4 (10) A creditors' committee, trustee or debtor in possession participating in a proceeding  
5 under the jurisdiction of the United States Bankruptcy Court.

6 (11) Any person whose employment with regard to a residential real property matter  
7 under the jurisdiction of the United States Bankruptcy Court is approved by order of the  
8 bankruptcy court.

9 (12) A person that is a member of the homeowner's family or is owned or controlled by  
10 a member of the homeowner's family.

11 **SECTION 4.** (1) A written foreclosure consulting contract is required for any services  
12 that a foreclosure consultant provides to a homeowner. A foreclosure consultant shall pro-  
13 vide a homeowner with a copy of the foreclosure consulting contract at least 24 hours before  
14 the homeowner signs the contract. The foreclosure consulting contract must:

15 (a) Be written in a language that is spoken by the homeowner and that was used in dis-  
16 cussions between the homeowner and foreclosure consultant to describe the foreclosure  
17 consultant's services or to negotiate the contract and, except as provided in paragraph (f)  
18 of this subsection, be printed in at least 12-point type.

19 (b) Fully disclose the nature and extent of the services the foreclosure consultant is to  
20 provide.

21 (c) Fully disclose the terms and total amount of any compensation the foreclosure con-  
22 sultant or a person working in association with the foreclosure consultant is to receive.

23 (d) Be dated and personally signed by the homeowner and the foreclosure consultant.

24 (e) Contain on the first page the name and address, facsimile number and electronic mail  
25 address of the foreclosure consultant to which a notice of cancellation may be delivered.

26 (f) Contain, in immediate proximity to the space reserved for the homeowner's signature,  
27 a notice in substantially the following form and printed in at least 14-point boldfaced type:

42 **percent per year.**

1 you sign any lien, mortgage or deed that transfers an interest in your home or property to

5 \_\_\_\_\_ (name of foreclosure consultant) or any person working with

7 will be able to refinance your home or arrange for you to keep your home.

9 The law requires that this contract contain the entire agreement. You should not rely on  
10 any other written or oral agreement or promise.

13 (2) A foreclosure consulting contract provision is void if the provision provides for the  
14 homeowner to:

15 (a) Waive any rights of the homeowner under sections 2 to 6 of this 2008 Act;

16 (b) Consent to jurisdiction for litigation or dispute resolution in a state other than  
17 Oregon;

18 (c) Consent to a choice of laws provision that applies the laws of a state other than  
19 Oregon;

20 (d) Consent to venue in a county other than the county in which the residence in fore-  
21 closure or default is located; or

22 (e) Pay any costs or fees incurred by the foreclosure consultant to enforce the contract,  
23 other than court costs and filing fees incurred in a successful circuit court action.

24 **SECTION 5.** (1) In addition to any other cancellation or rescission right, a homeowner  
25 may cancel a foreclosure consulting contract as provided under this section at any time.

26 (2) Cancellation under this section occurs when the homeowner gives written notice of  
27 cancellation to the foreclosure consultant:

28 (a) At a physical address specified in the foreclosure consulting contract; or

29 (b) At a facsimile number or electronic mail address specified in the foreclosure con-  
30 sulting contract.

31 (3)(a) If the homeowner gives written notice of cancellation under this section by mail,  
32 the notice is effective when deposited in the United States mail with the proper address and  
33 postage.

34 (b) If the homeowner gives written notice of cancellation under this section by facsimile  
35 or electronic mail, the notice is effective upon receipt. Proof of a transmission by the  
36 homeowner to the facsimile number or electronic mail address specified in the foreclosure  
37 consulting contract creates a rebuttable presumption that the foreclosure consultant re-  
38 ceived the notice at the time of the transmission.

39 (4) A homeowner who cancels or breaches a foreclosure consulting contract under this  
40 section shall, no later than 60 days after the cancellation or breach, pay for any services  
41 performed in good faith under the contract by or on behalf of the foreclosure consultant  
42 prior to the cancellation or breach and repay any moneys paid or advanced under the con-  
43 tract by or on behalf of the foreclosure consultant. The homeowner shall also pay any in-  
44 terest allowed by the foreclosure consulting contract, not to exceed nine percent per year.

45 (5) Failure of the homeowner to repay moneys as provided in subsection (4) of this sec-

tion does not invalidate the cancellation of the foreclosure consulting contract.

(6) When both parties have signed the foreclosure consulting contract, the foreclosure consultant shall immediately provide the homeowner with a signed and dated copy of the contract and a cancellation form. The cancellation form must:

- (a) Be in duplicate;
- (b) Be on a separate sheet of paper attached to the foreclosure consulting contract;
- (c) Be easily detachable; and
- (d) Contain a statement in substantially the following form and printed in at least 14-point boldfaced type:

**YOU MAY CANCEL THIS CONTRACT WITHOUT PENALTY AT ANY TIME.**

To cancel the contract, mail or deliver a signed and dated copy of this Notice of Cancellation, or write something saying you want to cancel, and send it to \_\_\_\_\_ (name of foreclosure consultant) at \_\_\_\_\_ (address of foreclosure consultant). If you cancel, you must pay for any services that were provided under the contract before the cancellation and repay any money spent on your behalf under the contract. You have 60 days after cancellation to pay for services and to repay any money spent on your behalf. You must also pay any interest allowed under the contract, which may not exceed nine percent per year.

(7) A written notice of cancellation under this section is sufficient, however expressed,

1 if the notice indicates the intent of the homeowner to cancel the foreclosure consulting  
2 contract. The contract may not require the homeowner to use the notice of cancellation  
3 form set forth in subsection (6) of this section.

4 **SECTION 6. A foreclosure consultant may not:**

5 (1) Claim, demand, charge, collect or receive any compensation from a homeowner unless  
6 the foreclosure consultant has performed in good faith under the contract:

7 (a) Each service the foreclosure consultant contracted to perform for the homeowner;  
8 or

9 (b) Each service to be compensated, prior to the homeowner canceling or breaching the  
10 contract.

11 (2) Claim, demand, charge, collect or receive interest or other compensation that exceeds  
12 nine percent per year on any services performed, any loan by the foreclosure consultant to  
13 the homeowner or any moneys paid or advanced to the homeowner under the foreclosure  
14 consulting contract.

15 (3) Take a wage assignment, lien on real or personal property or other security for the  
16 payment of compensation.

17 (4) Receive consideration from a third party in connection with services provided by a  
18 foreclosure consultant to a homeowner, unless the consideration is first fully disclosed in  
19 writing to the homeowner.

20 (5) Directly or indirectly acquire an interest in a residence in foreclosure or default  
21 transferred by a homeowner with whom the foreclosure consultant has contracted, including  
22 any interest transferred to or through a member of the foreclosure consultant's family or  
23 to or through a subsidiary, affiliate or related entity in which the foreclosure consultant or  
24 a member of the foreclosure consultant's family is a primary member, shareholder or owner.

25 (6) Receive compensation from a third party for facilitating or arranging for entry into  
26 an equity conveyance as defined in section 9 of this 2008 Act by a homeowner with whom the  
27 foreclosure consultant has contracted.

28 (7) Facilitate or arrange for entry into an equity conveyance as defined in section 9 of  
29 this 2008 Act by a homeowner with whom the foreclosure consultant has contracted, if the  
30 foreclosure consultant knows or should know that the equity purchaser has failed to comply  
31 with section 11 (1) of this 2008 Act.

32 (8) Take a power of attorney from a homeowner except for the purpose of obtaining or  
33 inspecting documents.

34 (9) Induce or attempt to induce any homeowner to enter into a foreclosure consulting  
35 contract that does not comply in all respects with sections 2 to 6 of this 2008 Act.

36 (10) Directly or by implication make a statement or engage in conduct that is false, de-  
37 ceptive, misleading or likely to cause confusion or misunderstanding regarding a:

- 38 (a) Foreclosure consultant service;  
39 (b) Foreclosure consulting contract; or  
40 (c) Residence in foreclosure or default.

41 **SECTION 7.** ORS 646.608, as operative until July 1, 2008, is amended to read:

42 646.608. (1) A person engages in an unlawful practice when in the course of the person's busi-  
43 ness, vocation or occupation the person does any of the following:

- 44 (a) Passes off real estate, goods or services as those of another.  
45 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-

1 proval, or certification of real estate, goods or services.

2 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-  
3 ciation with, or certification by, another.

4 (d) Uses deceptive representations or designations of geographic origin in connection with real  
5 estate, goods or services.

10 reconditioned, reclaimed, used or secondhand.

11 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,  
12 or that real estate or goods are of a particular style or model, if they are of another.

13 (h) Disparages the real estate, goods, services, property or business of a customer or another  
14 by false or misleading representations of fact.

15 (i) Advertises real estate, goods or services with intent not to provide them as advertised, or  
16 with intent not to supply reasonably expectable public demand, unless the advertisement discloses  
17 a limitation of quantity.

18 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,  
19 or amounts of price reductions.

20 (k) Makes false or misleading representations concerning credit availability or the nature of the  
21 transaction or obligation incurred.

22 (L) Makes false or misleading representations relating to commissions or other compensation to  
23 be paid in exchange for permitting real estate, goods or services to be used for model or demon-  
24 stration purposes or in exchange for submitting names of potential customers.

25 (m) Performs service on or dismantles any goods or real estate when not authorized by the  
26 owner or apparent owner thereof.

27 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-  
28 vides the information required under ORS 646.611.

29 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give  
30 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of  
31 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or  
32 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,  
33 discount or other value is contingent upon occurrence of an event subsequent to the time the cus-  
34 tomer enters into the transaction.

35 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-  
36 cize a product, business or service.

37 (q) Promises to deliver real estate, goods or services within a certain period of time with intent  
38 not to deliver them as promised.

39 (r) Organizes or induces or attempts to induce membership in a pyramid club.

40 (s) Makes false or misleading representations of fact concerning the offering price of, or the  
41 person's cost for real estate, goods or services.

42 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any  
43 known material defect or material nonconformity.

44 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

45 (v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under

- 1 ORS 698.640, whether in a commercial or noncommercial situation.
- 2 (w) Manufactures mercury fever thermometers.
- 3 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal  
4 law, or is:
- 5 (A) Prescribed by a person licensed under ORS chapter 677; and
- 6 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and  
7 on the proper cleanup of mercury should breakage occur.

10 need not prove competition between the parties or actual confusion or misunderstanding.

12 torney General has first established a rule in accordance with the provisions of ORS chapter 183  
13 declaring the conduct to be unfair or deceptive in trade or commerce.

36 (i) Advertises real estate, goods or services with intent not to provide them as advertised, or  
37 with intent not to supply reasonably expectable public demand, unless the advertisement discloses  
38 a limitation of quantity.

39 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,  
40 or amounts of price reductions.

41 (k) Makes false or misleading representations concerning credit availability or the nature of the  
42 transaction or obligation incurred.

43 (L) Makes false or misleading representations relating to commissions or other compensation to  
44 be paid in exchange for permitting real estate, goods or services to be used for model or demon-  
45 stration purposes or in exchange for submitting names of potential customers.

1 (m) Performs service on or dismantles any goods or real estate when not authorized by the  
2 owner or apparent owner thereof.

3 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-  
4 vides the information required under ORS 646.611.

5 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give  
6 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of  
7 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or  
8 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,  
9 discount or other value is contingent upon occurrence of an event subsequent to the time the cus-  
10 tomer enters into the transaction.

11 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-  
12 cize a product, business or service.

13 (q) Promises to deliver real estate, goods or services within a certain period of time with intent  
14 not to deliver them as promised.

15 (r) Organizes or induces or attempts to induce membership in a pyramid club.

16 (s) Makes false or misleading representations of fact concerning the offering price of, or the  
17 person's cost for real estate, goods or services.

18 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any  
19 known material defect or material nonconformity.

20 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

21 (v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under  
22 ORS 698.640, whether in a commercial or noncommercial situation.

23 (w) Manufactures mercury fever thermometers.

24 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal  
25 law, or is:

26 (A) Prescribed by a person licensed under ORS chapter 677; and

27 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and  
28 on the proper cleanup of mercury should breakage occur.

29 (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to  
30 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be  
31 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the  
32 mercury does not become part of the solid waste stream or wastewater. For purposes of this para-  
33 graph, "thermostat" means a device commonly used to sense and, through electrical communication  
34 with heating, cooling or ventilation equipment, control room temperature.

35 (z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains  
36 mercury light switches.

- 28 **(jjj) Violates a provision of sections 2 to 6 of this 2008 Act.**
- 29 (2) A representation under subsection (1) of this section or ORS 646.607 may be any manifesta-
- 30 tion of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.
- 31 (3) In order to prevail in an action or suit under ORS 646.605 to 646.652, a prosecuting attorney
- 32 need not prove competition between the parties or actual confusion or misunderstanding.
- 33 (4) An action or suit may not be brought under subsection (1)(u) of this section unless the At-
- 34 torney General has first established a rule in accordance with the provisions of ORS chapter 183
- 35 declaring the conduct to be unfair or deceptive in trade or commerce.
- 36 (5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought
- 37 under subsection (1)(zz) of this section by a person other than a prosecuting attorney, relief is lim-
- 38 ited to an injunction and the prevailing party may be awarded reasonable attorney fees.
- 39 **SECTION 9. As used in sections 9 to 14 of this 2008 Act:**
- 40 **(1) "Bona fide purchaser" means a person that purchases a residential real property from**

- 42 **(a) For valuable consideration;**

6 (a) Means a transaction that involves:

7 (A) The transfer of an interest in a residence in foreclosure by an equity seller to an  
8 equity purchaser, or to another person acting in association with the equity purchaser, that  
9 allows the equity purchaser or other person to obtain legal or equitable title to all or part  
10 of the residential real property; and

11 (B) A subsequent conveyance, or agreement for a subsequent conveyance, of an interest  
12 in the residential real property from the equity purchaser or person acting in association  
13 with the equity purchaser to the equity seller to allow the equity seller to possess the prop-  
14 erty during, or after termination of, the foreclosure process.

15 (b) Does not mean a transfer of interest by means of a nonjudicial foreclosure sale or  
16 by means of a sheriff's sale or other judicial foreclosure action.

17 (4) "Equity conveyance contract" means a written contract between an equity seller and  
18 an equity purchaser that contains an agreement for an equity conveyance.

19 (5) "Equity purchaser," except as provided in section 10 of this 2008 Act, means a person  
20 that enters into an equity conveyance that transfers to the person, or to another acting in  
21 association with the person, an interest in residential real property sufficient to allow ob-  
22 taining legal or equitable title to all or part of the property.

23 (6) "Equity recapture payment" means the resale price for a property, less the following:

24 (a) Amounts owing as of the closing of the resale for liens or other encumbrances cre-  
25 ated or suffered by the equity seller.

26 (b) Amounts paid after the transfer of interest in the property by the equity seller and  
27 before the closing of the resale on liens or other encumbrances created or suffered by the  
28 equity seller.

29 (c) Cash received by the equity seller from the equity purchaser under the equity  
30 conveyance contract.

31 (d) Title, escrow and other customary closing costs incurred by the equity purchaser  
32 under the equity conveyance contract or because of the resale.

33 (e) Real estate commissions and charges incurred by the equity purchaser under the eq-  
34 uity conveyance contract or because of the resale.

35 (f) Charges for prorated taxes and homeowner association dues, attributable to a period  
36 of time prior to the transfer of interest in the property by the equity seller.

37 (g) Attorney fees incurred by the equity purchaser under the equity conveyance contract  
38 or because of the resale.

39 (h) Reimbursement of actual repair and maintenance expenses.

40 (i) Reimbursement for the construction of improvements to the property.

41 (7) "Equity seller" means a natural person who is the record owner of a residence in  
42 foreclosure at the time an interest in the residence is transferred under an equity  
43 conveyance to an equity purchaser or to a person acting in association with an equity pur-  
44 chaser.

45 (8) "Primary housing expenses" means the total amount required to pay regular princi-

1 pal, interest, rent, utilities, hazard insurance, real estate taxes and association dues on a  
2 residential real property.

3 (9) "Resale" means a sale by an equity purchaser to a bona fide purchaser of residential  
4 real property that is the subject of an equity conveyance contract.

5 (10) "Resale price" means the gross sale price of a residential real property upon resale.

6 (11) "Residence in foreclosure" means residential real property:

7 (a) Consisting of one to four single-family dwelling units;

8 (b) On which the owner occupies a dwelling unit; and

9 (c) Against which a notice of default has been recorded.

10 (12) "Settlement agent" means a provider of settlement services who:

11 (a) Is a licensed escrow agent, title insurance agent or attorney; and

12 (b) Is not the equity purchaser or an employee or associate of the equity purchaser.

13 (13) "Settlement conference" means an in-person meeting between an equity seller and  
14 a settlement agent:

15 (a) For the purpose of completing documents incident to the transfer of an interest as  
16 part of an equity conveyance; and

17 (b) During which the settlement agent provides the equity seller with the HUD-1 settle-  
18 ment statement used by the United States Department of Housing and Urban Development.

19 **SECTION 10.** The following are not equity purchasers for purposes of sections 9 to 14 of  
20 this 2008 Act:

21 (1) A party to a deed in lieu of foreclosure.

22 (2) A creditors' committee, trustee or debtor in possession participating in a proceeding  
23 under the jurisdiction of the United States Bankruptcy Court.

24 (3) Any person whose employment with regard to a residential real property matter un-  
25 der the jurisdiction of the United States Bankruptcy Court is approved by order of the  
26 bankruptcy court.

27 (4) A family or living trust in which the equity seller is the beneficiary or a member of  
28 the beneficiary.

29 **SECTION 11.** (1) A written contract is required for every equity conveyance. An equity  
30 purchaser shall provide an equity seller with a copy of the equity conveyance contract at  
31 least 24 hours before the equity seller signs the contract. The equity conveyance contract  
32 must:

33 (a) Be written in a language that is spoken by the equity seller and that was used in  
34 discussions between the equity seller and equity purchaser to describe the equity purchaser's  
35 services or to negotiate the terms of the contract and, except as provided in paragraph (f)  
36 of this subsection, be printed in at least 12-point type;

37 (b) Contain the entire agreement of the parties;

38 (c) Be dated and personally signed by the equity seller and the equity purchaser and  
39 witnessed by a notary public;

40 (d) Contain on the first page the name and address, facsimile number and electronic mail  
41 address of the settlement agent to which a notice of cancellation may be delivered;

42 (e) Describe in detail the terms of the equity conveyance including:

43 (A) The name and business address, and any telephone number, facsimile number and  
44 electronic mail address, of the person to whom the equity seller will transfer an interest in  
45 the residence in foreclosure;

1 (B) The address of the residence in foreclosure;

2 (C) The total consideration the equity purchaser and any other party are to give as a  
3 result of the transfer of interest;

4 (D) The time at which the interest is to be transferred to the equity purchaser or other  
5 person and the terms of the transfer;

6 (E) Any financial or legal obligations that the equity seller may remain subject to, in-  
7 cluding a description of any mortgages, liens or other obligations that will remain in place;

8 (F) Any services the equity purchaser will perform for the equity seller before or after  
9 the transfer of interest;

10 (G)(i) The terms of any post-transfer conveyance or agreement for a conveyance to the  
11 equity seller to allow the equity seller to remain in the home, including but not limited to  
12 the terms of any rental agreement, repurchase agreement, contract for deed, land install-  
13 ment contract or option to buy; and

14 (ii) Any provisions for eviction or removal of the equity seller in the case of late pay-  
15 ment;

16 (H) An explanation of how any repurchase price or fee associated with any conveyance  
17 of title or deed back to the equity seller will be calculated; and

18 (I) An explanation of the percentage of any equity recapture payment the equity seller  
19 is to receive if the equity seller does not exercise a right to receive back a conveyance of title  
20 or deed; and

21 (f) Contain, in immediate proximity to the space reserved for the equity seller's signa-  
22 ture, a notice in substantially the following form and printed in at least 14-point boldfaced  
23 type:

21 (b) Arrange for the equity seller and the settlement agent to complete a settlement  
22 conference before the equity seller transfers any interest under the equity conveyance con-

24 (c) Comply with the requirements of the federal Home Ownership and Equity Protection  
25 Act (15 U.S.C. 1639) and its implementing regulations for any equity conveyance in which the  
26 equity seller obtains a vendee interest in a contract for deed.

27 (d) Ensure that title to, or other interest in, the residential real property is timely re-  
28 conveyed to the equity seller as provided under the terms of the equity conveyance contract.

29 (e) If a residential real property is resold within 24 months after the equity seller enters  
30 into an equity conveyance contract, pay the equity seller cash or consideration in an amount  
31 equal to at least 82 percent of the equity recapture payment from the resale no later than  
32 15 days after the receipt of cash or consideration from or on behalf of the purchasers of the  
33 property.

34 (f) Timely record the memorandum of agreement required by section 14 of this 2008 Act.

35 (2) An equity purchaser may not:

36 (a) As part of an equity conveyance contract, enter into repurchase or lease terms that  
37 are commercially unreasonable or unfair to an equity seller, or engage in any other unfair  
38 conduct.

39 (b) Represent, directly or indirectly, that the equity purchaser is acting as a financial  
40 adviser or foreclosure consultant to the equity seller or otherwise is acting on behalf of the  
41 equity seller.

42 (c) Make a false representation regarding the equity purchaser's possession of profes-  
43 sional credentials that indicate knowledge or expertise regarding real property transactions.

44 (d) Represent, directly or indirectly, that the equity purchaser is assisting the equity  
45 seller in preventing a foreclosure, if the equity conveyance contract does not provide for the

1 equity seller to completely redeem the residential real property and regain title.

2 (e) Directly or by implication make a statement or engage in conduct that is false, de-  
3 ceptive, misleading or likely to cause confusion or misunderstanding regarding an equity  
4 conveyance, including but not limited to a statement or conduct with regard to:

5 (A) The value of a residence in foreclosure;

6 (B) The amount of proceeds the equity seller would receive after a foreclosure sale;

7 (C) An equity conveyance contract term; or

8 (D) The equity seller's rights or obligations incident to or arising out of the equity  
9 conveyance.

10 (f) Before the equity seller's right to cancel an equity conveyance contract has expired:

11 (A) Record or cause to be recorded an instrument of conveyance or other document the  
12 equity seller signed;

13 (B) Transfer or purport to transfer any interest in the residential real property to any  
14 third party; or

15 (C) Encumber or purport to encumber any interest in the residential real property with  
16 any third party.

17 **SECTION 14.** (1) For purposes of determining whether an equity purchaser has violated  
18 section 13 (1)(a) of this 2008 Act, there is a rebuttable presumption that:

19 (a) An equity seller has or will have a reasonable ability to pay for a subsequent  
20 reconveyance of a residential real property if, on the date the equity seller signs the equity  
21 conveyance contract, the monthly payments projected for the equity seller's primary housing  
22 expenses under the contract and monthly payments for regular principal and interest pay-

25 (b) The equity purchaser has failed to verify that the equity seller has a reasonable

29 (2) If a property is resold within 24 months after an equity seller enters into an equity

32 with a detailed accounting of the basis for the payment amount. The accounting shall include  
33 detailed documentation of the amounts subtracted by the equity purchaser from the resale  
34 price to determine the amount of the equity recapture payment.

35 (3) A bona fide purchaser that enters into a transaction with an equity seller or equity  
36 purchaser receives good title to the property, free and clear of:

37 (a) The rights of the parties to an equity conveyance contract or a memorandum of  
38 agreement; or

39 (b) Any cancellation of the equity conveyance contract.

40 (4) Sections 9 to 14 of this 2008 Act do not impose a duty on a property purchaser,  
41 settlement agent, title insurer or title insurance producer regarding the application of the  
42 proceeds of a resale of property by an equity purchaser.

43 (5) At the time of presenting an equity conveyance for recording, the equity purchaser  
44 shall present a memorandum of agreement for recording in the county where the residential  
45 real property is located. The memorandum of agreement must be signed by the equity pur-

27 **SECTION 15. Sections 9 to 14 of this 2008 Act do not preclude an equity seller from:**

28 (1) Seeking to have a transfer of interest under an equity conveyance declared to be an  
29 equitable mortgage; or

30 (2) Asserting any claim against an equity purchaser for an equitable mortgage.

31 **SECTION 16. ORS 646.607 is amended to read:**

32 646.607. A person engages in an unlawful practice when in the course of the person’s business,  
33 vocation or occupation the person:

34 (1) Employs any unconscionable tactic in connection with the sale, rental or other disposition  
35 of real estate, goods or services, or collection or enforcement of an obligation;

36 (2) Fails to deliver all or any portion of real estate, goods or services as promised, and upon  
37 request of the customer, fails to refund any money that has been received from the customer that  
38 was for the purchase of the undelivered real estate, goods or services and that is not retained by  
39 the seller pursuant to any right, claim or defense asserted in good faith. This subsection does not  
40 create a warranty obligation and does not apply to a dispute over the quality of real estate, goods  
41 or services delivered to a customer; [or]

42 (3) Violates ORS 401.107 (1) to (4); or

43 (4) Violates a provision of sections 9 to 14 of this 2008 Act.

44 **SECTION 17. (1) As used in this section, “equity seller” has the meaning given that term  
45 in section 9 of this 2008 Act.**

1 (2) In addition to any action by the Attorney General under ORS 646.607 or any other  
2 cause of action, an equity seller may bring an action for damages incurred by the equity  
3 seller resulting from a violation of sections 9 to 14 of this 2008 Act.

4 (3) If a court finds that a defendant in an action under this section committed a violation  
5 of sections 9 to 14 of this 2008 Act knowingly, in addition to any award of damages for other  
6 violations of sections 9 to 14 of this 2008 Act, the court shall award the equity seller three  
7 times the amount of the actual damages sustained by the equity seller as a result of the  
8 knowing violation.

9 (4) The court may award an equity seller prevailing in an action under this section rea-  
10 sonable attorney fees, costs and expenses. If a court finds that an equity seller brought an  
11 action under this section in bad faith or solely for purposes of harassment, the court may  
12 award a prevailing defendant reasonable attorney fees.

13 (5) An action under this section must be commenced within six years.

14 SECTION 18. Violation of a provision of sections 2 to 6 or 9 to 14 of this 2008 Act is a  
15 misdemeanor punishable by not more than one year’s imprisonment, a fine of not more than  
16 \$10,000, or both.

17 SECTION 19. Sections 20 and 21 of this 2008 Act are added to and made a part of ORS  
18 86.705 to 86.795.

19 SECTION 20. (1) If a notice of default is recorded for property that is subject to a resi-  
20 dential trust deed, the sender of a notice of sale under ORS 86.740 shall, on or before the date  
21 the notice of sale is served or mailed, give notice under this section to the grantor by both  
22 first class and certified mail with return receipt requested. Subject to any rules adopted  
23 under subsection (2) of this section, the notice must be in substantially the following form

24 **SECTION 21.** If a notice required by section 20 of this 2008 Act is not sent to a grantor,

27 holder of a junior lien or interest who was omitted as a party defendant in a judicial fore-  
28 closure proceeding. The purchaser at the trustee's sale, or the purchaser's heirs, assigns or  
29 transferees, shall have the same rights possessed by a purchaser at a sheriff's sale following

31 **SECTION 22.** (1) Sections 2 to 6 of this 2008 Act apply to agreements for services by a  
32 foreclosure consultant entered into by homeowners beginning 90 or more days after the ef-  
33 fective date of this 2008 Act.

34 (2) Sections 9 to 14 of this 2008 Act apply to agreements for equity conveyances entered  
35 into by equity sellers beginning seven or more days after the effective date of this 2008 Act.

36 (3) Section 20 of this 2008 Act applies to residential trust deed properties for which a  
37 notice of sale under ORS 86.740 is sent beginning 90 or more days after the effective date of  
38 this 2008 Act.

39 **SECTION 23.** This 2008 Act being necessary for the immediate preservation of the public  
40 peace, health and safety, an emergency is declared to exist, and this 2008 Act takes effect  
41 on its passage.
