

A-Engrossed House Bill 3631

Ordered by the House February 7
Including House Amendments dated February 7

Sponsored by COMMITTEE ON ELECTIONS, ETHICS AND RULES (at the request of House Interim Committee on Consumer Protection)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Prohibits retailer from selling or offering for sale, leasing, subletting or otherwise distributing children's product subject to recall notice or warning issued by United States Consumer Product Safety Commission, [or] subject to warning issued by children's product manufacturer or [*agency of this state*] **subject to rule or declaration that children's product is banned hazardous substance**. Requires retailer to subscribe to or arrange to receive recall notices and warnings issued for children's products and to dispose of children's products identified in recall notice or warning in strict compliance with instructions.

Directs Attorney General to assist retailers in obtaining information necessary to subscribe to or receive recall notices related to children's products.

[*Provides that in enforcement actions retailers are presumed to have actual or constructive knowledge of recall notices and warnings.*] Authorizes enforcement of violation as unlawful trade practice.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to children's products; creating new provisions; amending ORS 646.608; and declaring an
3 emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. As used in sections 1 to 3 of this 2008 Act:**

6 **(1)(a) "Children's product" means a consumer product that is designed or intended:**

7 **(A) For the care of or use by a child under 12 years of age; or**

8 **(B) To come into contact with a child under 12 years of age at the time the product is**
9 **used.**

10 **(b) "Children's product" does not include:**

11 **(A) A medication, drug, food or other product that is intended to be ingested; or**

12 **(B) A crib, as defined in ORS 646A.504.**

13 **(2) "Retailer" means a person that, in the ordinary course of the person's business, sells**
14 **or offers for sale, leases, sublets or otherwise distributes a children's product to consumers**
15 **in this state.**

16 **SECTION 2. (1) A retailer may not sell or offer for sale, lease, sublet or otherwise dis-**
17 **tribute a children's product to consumers in this state if the children's product is:**

18 **(a) Subject to a recall notice issued by or in cooperation with the United States Consumer**
19 **Product Safety Commission or another federal agency;**

20 **(b) The subject of a warning issued by the children's product manufacturer, the Con-**
21 **sumer Product Safety Commission or another federal agency that the intended use of the**
22 **children's product constitutes a health or safety hazard; or**

1 (c) Subject to a declaration by the Director of Human Services under ORS 453.055 or
2 under rules adopted by the Department of Human Services that the children's product is a
3 banned hazardous substance.

4 (2) A retailer shall subscribe to or arrange to receive recall notices and warnings issued
5 by the Consumer Product Safety Commission and warnings issued by manufacturers from
6 which the retailer receives children's products.

7 (3) A retailer shall dispose of a children's product identified in a recall notice or warning
8 issued by or in cooperation with the Consumer Product Safety Commission or another fed-
9 eral agency in strict compliance with disposal instructions included with or related to the
10 recall notice or warning.

11 (4) A retailer shall comply strictly with all return, repair, retrofitting, labeling or reme-
12 diation instructions issued with or related to a warning or finding issued by the Consumer
13 Product Safety Commission or another federal agency, an agency of this state or the chil-
14 dren's product manufacturer.

15 **SECTION 3.** The Attorney General shall assist retailers in obtaining information the
16 retailers may need to subscribe to or arrange to receive recall notices issued by the United
17 States Consumer Product Safety Commission for children's products. The assistance shall
18 include, but is not limited to, providing links from the Attorney General's website to a
19 website maintained by or in cooperation with the Consumer Product Safety Commission for
20 the purpose of disseminating product recall notices.

21 **SECTION 4.** ORS 646.608 is amended to read:

22 646.608. (1) A person engages in an unlawful practice when in the course of the person's busi-
23 ness, vocation or occupation the person does any of the following:

24 (a) Passes off real estate, goods or services as those of another.

25 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-
26 proval, or certification of real estate, goods or services.

27 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-
28 ciation with, or certification by, another.

34 (f) Represents that real estate or goods are original or new if they are deteriorated, altered,
35 reconditioned, reclaimed, used or secondhand.

36 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
37 or that real estate or goods are of a particular style or model, if they are of another.

38 (h) Disparages the real estate, goods, services, property or business of a customer or another
39 by false or misleading representations of fact.

40 (i) Advertises real estate, goods or services with intent not to provide them as advertised, or
41 with intent not to supply reasonably expectable public demand, unless the advertisement discloses
42 a limitation of quantity.

43 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,
44 or amounts of price reductions.

45 (k) Makes false or misleading representations concerning credit availability or the nature of the

1 transaction or obligation incurred.

2 (L) Makes false or misleading representations relating to commissions or other compensation to
3 be paid in exchange for permitting real estate, goods or services to be used for model or demon-
4 stration purposes or in exchange for submitting names of potential customers.

5 (m) Performs service on or dismantles any goods or real estate when not authorized by the
6 owner or apparent owner thereof.

7 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-
8 vides the information required under ORS 646.611.

9 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
10 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
11 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or
12 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,
13 discount or other value is contingent upon occurrence of an event subsequent to the time the cus-
14 tomer enters into the transaction.

15 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-
16 cize a product, business or service.

17 (q) Promises to deliver real estate, goods or services within a certain period of time with intent
18 not to deliver them as promised.

19 (r) Organizes or induces or attempts to induce membership in a pyramid club.

20 (s) Makes false or misleading representations of fact concerning the offering price of, or the
21 person's cost for real estate, goods or services.

22 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any
23 known material defect or material nonconformity.

24 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

25 (v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under
26 ORS 698.640, whether in a commercial or noncommercial situation.

27 (w) Manufactures mercury fever thermometers.

28 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
29 law, or is:

30 (A) Prescribed by a person licensed under ORS chapter 677; and

31 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and
32 on the proper cleanup of mercury should breakage occur.

33 (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to
34 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be
35 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the
36 mercury does not become part of the solid waste stream or wastewater. For purposes of this para-
37 graph, "thermostat" means a device commonly used to sense and, through electrical communication
38 with heating, cooling or ventilation equipment, control room temperature.

16 (5) Notwithstanding any other provision of ORS 646.605 to 646.652, if an action or suit is brought
17 under subsection (1)(zz) of this section by a person other than a prosecuting attorney, relief is lim-
18 ited to an injunction and the prevailing party may be awarded reasonable attorney fees.

19 **SECTION 6. Sections 1 to 3 of this 2008 Act and the amendments to ORS 646.608 by**
20 **sections 4 and 5 of this 2008 Act apply to a person that operates as a retailer on or after the**
21 **operative date of sections 1 to 3 of this 2008 Act and the amendments to ORS 646.608 by**
22 **sections 4 and 5 of this 2008 Act.**

23 **SECTION 7. Sections 1 to 3 and 6 of this 2008 Act and the amendments to ORS 646.608**
24 **by sections 4 and 5 of this 2008 Act become operative on May 1, 2008.**

25 **SECTION 8. This 2008 Act being necessary for the immediate preservation of the public**
26 **peace, health and safety, an emergency is declared to exist, and this 2008 Act takes effect**
27 **on its passage.**
