A-Engrossed Senate Bill 1075

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates Task Force on Mental Health and Addiction Services for Underserved Populations. Declares emergency, effective on passage.

2	Relating to Task Force on Mental Health and Addiction Services for Underserved Populations; and
3	declaring an emergency.
4	Be It Enacted by the People of the State of Oregon:
5	SECTION 1. (1) There is created the Task Force on Mental Health and Addiction Services
6	for Underserved Populations consisting of 27 members appointed as follows:
7	(a) The President of the Senate shall appoint two members from among members of the
8	Senate.
9	(b) The Speaker of the House of Representatives shall appoint two members from among
10	members of the House of Representatives.
11	(c) The Governor shall appoint 23 members as follows:
12	(A) Two representatives of the Department of Human Services who are experienced with
13	community-based issues, services and programs related to seniors and persons with disabili-
14	ties;
15	(B) Two representatives of the Department of Human Services who are experienced with
16	community-based issues, services and programs related to mental health and addiction ser-
17	vices;
18	(C) Two representatives of area agencies on aging;
19	(D) Three representatives of county mental health programs, including one program
20	consumer or one family member of a consumer;
21	(E) Two persons who are providers of mental health and addiction services;
22	(F) Two persons from the office of multicultural health in the Department of Human
23	Services;
24	(G) Two persons who are consumers of services provided by the Department of Human
25	Services;
26	(H) Four persons representing advocacy or consumer organizations that act on behalf
27	of seniors, persons with disabilities or racial and ethnic populations;
28	(I) One representative of an organization providing advocacy on behalf of persons with

mental health needs; 1 2 (J) One person representing the Department of Corrections who provides treatment and services for persons with mental illness; 3 (K) One person representing public employees in the employee representative unit de-4 scribed in ORS 243.061 (1)(b)(A); and 5 (L) One person representing public employees in the employee representative unit de-6 scribed in ORS 243.061 (1)(b)(B). 7 (2) The task force shall develop a plan for a comprehensive, integrated system of mental 8 9 health and addiction services for seniors, persons with disabilities and persons in underserved racial or ethnic communities. 10 (3) The task force may: 11 12(a) Study, assess and recommend programs and projects, including pilot projects, to en-13 courage coordinated efforts at the state and local levels to improve the state's mental health and addiction services delivery system; 14 15 (b) Develop recommendations for appropriate and adequate screening of mental health and addiction needs in community settings; 16 (c) Assess and make recommendations concerning the treatment of offenders with men-17 tal illnesses; and 18 (d) Undertake any other strategy designed to increase and improve mental health and 19 addiction services for seniors, persons with disabilities and persons in underserved racial or 20ethnic communities. 2122(4) A majority of the members of the task force constitutes a quorum for the transaction of business. 23(5) Official action by the task force requires the approval of a majority of the members 24of the task force. 25(6) The task force shall elect one of its members to serve as chairperson. 2627(7) If there is a vacancy for any cause, the appointing authority shall make an appointment to become immediately effective. 28(8) The task force shall meet at times and places specified by the call of the chairperson 2930 or of a majority of the members of the task force. 31 (9) The task force may adopt rules necessary for the operation of the task force. (10) The task force shall submit a report, and may include recommendations for legis-32lation, to an interim committee related to human services no later than October 1, 2010. 33 34 (11) The Department of Human Services shall provide staff support to the task force. (12) All agencies of state government, as defined in ORS 174.111, are directed to assist 35 the task force in the performance of its duties and, to the extent permitted by laws relating 36 37 to confidentiality, to furnish such information and advice as the members of the task force 38 consider necessary to perform their duties. SECTION 2. Section 1 of this 2008 Act is repealed on the date of the convening of the 39 regular legislative session of the Seventy-sixth Legislative Assembly. 40 SECTION 3. This 2008 Act being necessary for the immediate preservation of the public 41 peace, health and safety, an emergency is declared to exist, and this 2008 Act takes effect 4243 on its passage.
