SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires person to provide proof of legal presence in United States and Social Security number before Department of Transportation may issue, renew or replace driver license, driver permit or identification card. Provides that license issued to person who is not citizen or permanent legal resident of United States is valid until date licensee is no longer authorized to stay in United States, **but no longer than eight years**, or until one year from date of issuance of license. Provides exemption from collection of biometric data for certain persons applying for issuance,

Provides exemption from collection of biometric data for certain persons applying for issuance, renewal or replacement of driver license or driver permit.

Permits person to use photograph on file for issuance, renewal or replacement of driver license in certain circumstances.

Directs Department of Transportation to provide ombudsman services to applicants for driver license, driver permit or identification card who have difficulty producing required documentation. Declares emergency, effective on passage.

tion, as defined by the department by rule, that includes a Social Security number that has
