SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows public safety officer to prevent disclosure of home address and home telephone number contained in records of Department of Public Safety Standards and Training.

Requires county clerk to record certain final orders and decisions on claims arising out of restriction of use of real property that are attributable to land use regulation.

Declares emergency, effective on passage.

2 Relating to public records; amending ORS 192.501 and 205.246; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 192.501 is amended to read:

5 192.501. The following public records are exempt from disclosure under ORS 192.410 to 192.505
6 unless the public interest requires disclosure in the particular instance:

7 (1) Records of a public body pertaining to litigation to which the public body is a party if the
8 complaint has been filed, or if the complaint has not been filed, if the public body shows that such
9 litigation is reasonably likely to occur. This exemption does not apply to litigation which has been
10 concluded, and nothing in this subsection shall limit any right or opportunity granted by discovery
11 or deposition statutes to a party to litigation or potential litigation[;].

12 (2) Trade secrets. "Trade secrets," as used in this section, may include, but are not limited to,
13 any formula, plan, pattern, process, tool, mechanism, compound, procedure, production data, or
14 compilation of information which is not patented, which is known only to certain individuals within
15 an organization and which is used in a business it conducts, having actual or potential commercial
16 value, and which gives its user an opportunity to obtain a business advantage over competitors who
17 do not know or use it[;].

18 (3) Investigatory information compiled for criminal law purposes. The record of an arrest or the
19 report of a crime shall be disclosed unless and only for so long as there is a clear need to delay
20 disclosure in the course of a specific investigation, including the need to protect the complaining
21 party or the victim. Nothing in this subsection shall limit any right constitutionally guaranteed, or
22 granted by statute, to disclosure or discovery in criminal cases. For purposes of this subsection, the
23 record of an arrest or the report of a crime includes, but is not limited to:

24 (a) The arrested person's name, age, residence, employment, marital status and similar bi-
25 ographical information;

- 5 (f) The circumstances of arrest, including time, place, resistance, pursuit and weapons used; and
- 6 (g) Such information as may be necessary to enlist public assistance in apprehending fugitives

7 from justice[;].

8 (4) Test questions, scoring keys, and other data used to administer a licensing examination,
9 employment, academic or other examination or testing procedure before the examination is given
10 and if the examination is to be used again. Records establishing procedures for and instructing
11 persons administering, grading or evaluating an examination or testing procedure are included in
12 this exemption, to the extent that disclosure would create a risk that the result might be

17 lish production quotas, and the amounts of such fees or assessments payable or paid, to the extent
18 that such information is in a form which would permit identification of the individual concern or
19 enterprise. This exemption does not include records submitted by long term care facilities as defined
20 in ORS 442.015 to the state for purposes of reimbursement of expenses or determining fees for pa-
21 tient care. Nothing in this subsection shall limit the use which can be made of such information for
22 regulatory purposes or its admissibility in any enforcement proceeding[;].

23 (6) Information relating to the appraisal of real estate prior to its acquisition[;].

24 (7) The names and signatures of employees who sign authorization cards or petitions for the
25 purpose of requesting representation or decertification elections[;].

26 (8) Investigatory information relating to any complaint filed under ORS 659A.820 or 659A.825,
27 until such time as the complaint is resolved under ORS 659A.835, or a final order is issued under
28 ORS 659A.850[;].

29 (9) Investigatory information relating to any complaint or charge filed under ORS 243.676 and

35 the need for the information is related to that Indian tribe's cultural or religious activities. This

37 known and publicized tourist facility or attraction[;].

2 manipulation of data from such computer system, and any associated documentation and source

5 (b) Analyses, compilations and other manipulated forms of the original data produced by use of
6 the program; or

7 (c) The mathematical and statistical formulas which would be used if the manipulated forms of
