**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

*[Permits]* **Requires** juvenile court to suspend or revoke driving privileges of youth offenders adjudicated for traffic offenses that have suspension or revocation penalties for adult traffic offenders. **Provides that order finding youth offender within jurisdiction of juvenile court for traffic offense that has suspension or revocation penalties for adult offenders is ground for suspension or revocation.**

**Applies to juvenile court orders entered on or after January 1, 2004.**  
**Declares emergency, effective on passage.**

**A BILL FOR AN ACT**

2 Relating to juvenile driving privileges; creating new provisions; amending ORS 809.412; and declar-  
3 ing an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2008 Act is added to and made a part of ORS chapter 419C.**

6 **SECTION 2. If a juvenile court finds a youth to be within the jurisdiction of the court**  
7 **under ORS 419C.005 because the youth committed an act that, if committed by an adult,**  
8 **would constitute an offense that is a ground for suspension or revocation of driving privi-**  
9 **leges upon conviction of the offense, the order of the court finding the youth to be within**  
10 **the jurisdiction of the court constitutes a ground for suspension or revocation of the youth's**  
11 **driving privileges.**

12 **SECTION 3. ORS 809.412 is amended to read:**

13 809.412. *[A determination by a juvenile court that a child within its jurisdiction has committed any*  
14 *act that is grounds for suspension or revocation of driving privileges under ORS 809.409 or 809.411*  
15 *is equivalent to a conviction and the juvenile court has the same authority to order suspensions of*  
16 *driving privileges and take other actions in relation to the driving privileges of the child as other courts*  
17 *have in relation to adult traffic offenders.] **If a juvenile court finds a youth to be within the ju-***  
18 **isdiction of the juvenile court under ORS 419C.005 for committing an offense that is a**  
19 **ground for suspension or revocation upon conviction under ORS 809.409, 809.411, 809.413,**  
20 **813.400 or 813.403 or any other law requiring suspension or revocation of driving privileges**  
21 **upon conviction of an offense, the juvenile court shall impose the suspension or revocation**  
22 **of driving privileges that is required upon conviction of the offense.**

23 **SECTION 4. Section 2 of this 2008 Act and the amendments to ORS 809.412 by section 3**  
24 **of this 2008 Act apply to orders finding youths within the jurisdiction of the juvenile court**

2 SECTION 5. This 2008 Act being necessary for the immediate preservation of the public  
3 peace, health and safety, an emergency is declared to exist, and this 2008 Act takes effect  
4 on its passage.
